Jim Sligar Releases Seven Point Platform

J. H. (Jim) Sligar, candidate for state representative 112th Floterial district, has authorized this newspaper to make formal announcement of his platform. The flatorial district is composed of Wilbarger and Wichita counties, and Sligar



seeks the post being vacated by Leslie King of Vernon.

Sligar has based his campaign upon the following points:

1. **Crime:** Work to keep Texas free of all organized crime.

2. **Schools:** The state has embarked upon a broad program of providing a better education for our children. This program must be fostered and encouraged if Texas is to progress. Let us train the hands and minds of our children.

3. **Tidelands:** Assist in every way possible those who are fighting to retain for our schools the valuable income from our submerged coastal lands.

4. **Old Age Assistance:** Our rich and growing state of today was largely made possible by the hard and devoted toil of our old folks. They deserve to live in comfort and peace of mind. Those who would deny them this must be stopped. In such times as these we must remember the high cost of living and base our pension plan accordingly so that they shall not want.

5. **Good Neighbor Policy:** Texas is the gateway to Mexico. As a growing manufacturing state, we are in a very favorable position to find a vast market for sale of our products in Mexico. In return, Mexico has many products we now need, and of which our needs will increase in the future. Let us implement a policy of sound trade with our neighbor to the end that industries of both shall benefit and thus provide greater employment and gain to all citizens. New jobs must be created for our growing population.

6. **Taxes:** The present cost of our state government for one month would, a few short years ago, pay the cost of our government for one year. This tremendous cost of doing business has come both from many added services and increased cost of old established services. No one can deny that improved methods and greater efficiency can save some of the money now being spent. The last legislature, one-third of whose members were students in the university, spent the huge wartime accumulated surplus along with greater appropriations than the present income is providing. The burden of providing a balanced budget will be thrown upon the next legislature. Jim Sligar will, if elected, examine thoroughly the present tax structure. If new taxes are voted upon, and prove to be necessary, attention will be focused upon those great and thriving industries and businesses of the state, many of them new, who are now bearing none or very little of their fair share of the cost of our government.

7. **Farm-to-Market Roads and Highways:** These should be soundly financed. Over a period of several years the cost of maintaining a road or highway is greater than the first construction cost. Let us build the future maintenance into the roads and the savings will allow additional roads at less total cost. If we do not adopt this policy we will ultimately face the prospect of spending almost all road funds on maintenance with little left for new construction.

More than 250 farm leaders from 125 counties have filed tuition fees for the second annual Institute of the Texas Farm Bureau Federation to be held at College Station, July 30 through August 4. It has been announced by J. Walter Hammond, federation president. Instructors of outstanding prominence in Farm Bureau and related agricultural fields will have charge of the eight courses which have been arranged for the week's schooling.

Courses will be offered on the following topics: philosophy and policies of Farm Bureau, membership acquisition, public speaking, salesmanship, Farm Bureau structures, techniques for presiding officers, county and community organizations, and recreational activities.

Hammond will be toastmaster at the banquet on Friday evening, August 4, and will award certificates to leaders who complete courses.

J. E. Stanford, executive secretary, Kentucky Farm Bureau, will deliver the banquet address. His subject will be "Service, the Cornerstone of Farm Bureau."

Registration will begin at 2 p.m., Sunday, July 30. A vesper service that evening will be the first session of the institute. Classes will begin on Monday morning. A recreation party will be held at the Slab on Monday evening and a square dance party on Wednesday evening, also at the Slab.

Farmers have only 10 days to file applications for free government classing and market news services. Sam W. Martin said today. Martin is in charge of the Dallas cotton classing office, U.S. department of agriculture's production and marketing administration.

Meticulous work on the part of the helpers is required. Their duties include:

Two persons to fill out record slips;

One to record names on master list and number records;

One to direct traffic and see that all metals are removed from pockets and clothing;

One to check X-ray number on patient with number on X-ray machine;

One to assist X-ray technician;

One to hand out literature and explanation slips and pin X-ray tag on patient as he leaves bus.

In Texas during 1949 TB killed 2,446 people. This is 184 less than died of TB in the previous year. The TB death rate in Texas for 49 is 32.5.

Despite the remarkable progress made against the menace of TB, the Texas Tuberculosis Association and its affiliated local units must work ceaselessly to help maintain these gains and to push TB back still farther in this state. There is an estimated number of over 22,000 cases of TB in Texas. The State has only 2,702 beds for tuberculosis patients (exclusive of beds in Federal, mental and penal institutions). The average number of deaths annually from TB for the past five years (1945-1949) is 2,742. The minimum standard of 2 1/2 beds, and preferably 3, per average annual death indicates that approximately 4,500 additional beds are needed for tuberculosis patients in Texas.

Of the estimated 22,000 cases of TB in Texas, only 5,864 were reported to the State Health authorities. TB causes more deaths among people between 15 and 44 than any other disease.

TB costs millions of dollars in lost hours of work, hospitalization for the sick, and welfare for the patients' families.

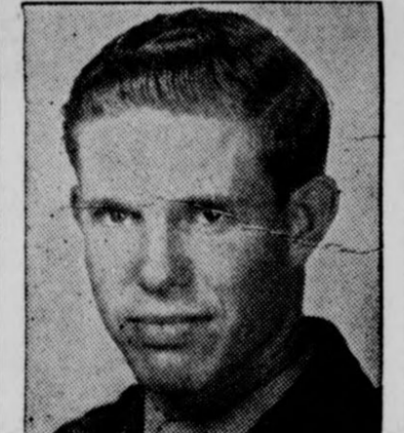
TB can be eliminated by public action. It can be wiped out—if individuals take the necessary steps to detect, diagnose and treat the disease, and to arrest its spread. The tuberculosis associations are dedicated to getting those steps taken.

The sole fund-raising drive of the Texas Tuberculosis association and its affiliated locals is the annual sale of Christmas seals. Proceeds from this sale support the educational work, case-finding services, medical research and rehabilitation activities carried on year-round by the TB associations.
