Presbyterians Report General Assembly

The Rev. Mr. A. M. Dorsett, pastor of United Presbyterian church in Electra and of Presbyterian church U.S. in Iowa Park, presided at a joint meeting of the two congregations in Iowa Park, Sunday evening.

A buffet meal provided by both churches was served in the recently air-conditioned fellowship hall. Fathers were honored as special guests. Gale Lowrance, 80, was the oldest father present.

Major purpose of the occasion was that members might hear a report by Bob Birk and Dr. Earl Crawford of First church, Wichita Falls, and Joe Sherrill, elder, of Wichita Falls. Bob is one of six commissioners from Central Texas Presbytery headquarters in Fort Worth, who attended the meeting of General Assembly of Presbyterian church U.S. in Memphis, Tenn., last week.

Dorsett served as moderator of the panel.

Relation of the state of the church to the world, as lifted up at the Assembly, as seen by those in attendance, might be summarized in these statements:

"Last year was a year of creative turbulence in the ecumenical movement. In the 1930's the world had an economic crisis . . . producing major changes in production and distribution.

"Our nation today is both prosperous and plagued: plagued by a war we can neither understand nor find a way out of; by Black demands which society cannot deny and is willing only slowly to meet; by disintegration of city life; by confusion about our real goals.

"America's self-assurance has been shaken. But the end of com-

placency may be the beginning of hope."

One sign of hope, according to records as reported by Birk, is that U.S. seminary enrollment increased the past year. Also, the church seems to be searching for more adequate ways of evangelism, of worship, of service, and of attack upon social evils.

As to re-uniting the bodies of the Presbyterian church, Bob says conversation is taking place between Presbyterians U.S. and the United Presbyterians in the USA, and it will be voted on in 1974 at a joint meeting in Louisville, Ky. They are also inviting six other Presbyterian communions to join them.

Discussion revealed that the Assembly felt abortion should be a matter to be settled by the woman in conversation with her doctor and her minister.

After many motions and much debate, the following was adopted as a recommendation from the Assembly regarding the war in Southeast Asia:

"The Presbyterian church, U.S. views with dismay the continuing war in Southeast Asia. We are convinced that the stated purpose of the US intervention—the self-determination of the people of Southeast Asia—cannot be realized through too lengthy (nor too precipitous an end to) US military participation in this tragic conflict. Therefore, we urge our government to continue and, in so far as possible, accelerate the orderly withdrawal of all American troops from Southeast Asia and to announce its firm intention to provide massive economic aid for the reconstruction of the countries involved."

Gary A. Batte has been named to head up the Soil Conservation Service office in Wichita Soil and Water Conservation District. His transfer will be effective on July 26, according to Wayne Chapman, area conservationist.

Batte is to replace Bill Royal, who leaves next Monday to take over his family's ranching operation near Menard.

Gary and his wife Sue and two children Lorri 7 and John 4 plan to move to Iowa Park soon. They are members of Baptist church.

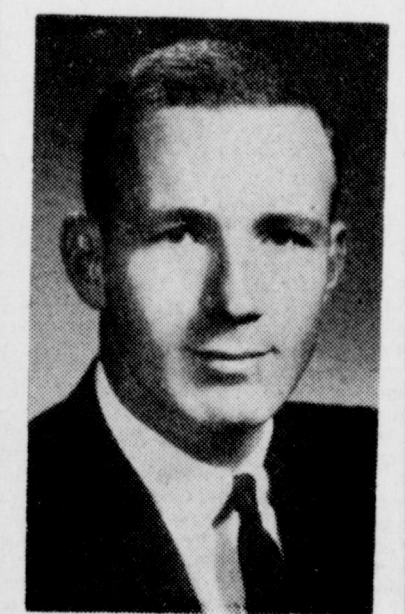

VV & IP to Vote on Merger

Following many meetings of both superintendents and school boards, petitions seeking consolidation of Valley View and Iowa Park school districts were submitted Monday to County Judge Calvin Ashley.

An election to submit the proposal to voters in the area has been requested for July 7. Ashley has announced he will call the election for that date.

Under the proposal the combined districts will be named Iowa Park Consolidated Independent School District.

One petition from each school district has been submitted with 99 signatures on the one from Iowa Park and 31 on the petition from Valley View.

Voting places for the election will take place at Bradford and Kidwell schools. Valley View patrons will vote at the Valley View school.

The election order calls for Virgil Woodfin to serve as presiding judge and Gerald Tidwell as alternate at Bradford school. Herschel Nipper and Norman Mays will be presiding judge and alternate at Kidwell school.

Mrs. Mary Lakey will be judge at Valley View with Mrs. Opal Boniol as alternate.

Voting hours will be from 7:00 a.m. to 7:00 p.m. Ballots will give the choices—For and Against consolidation. To carry, both sets of voters must okay the proposal.

Iowa Park schools have enrollment of 2,062; Valley View, 200. Officials of both districts have collaborated in issuing the following "Points to Consider for Consolidation of Iowa Park ISD and Valley View ISD"

I. Keep elementary school at Valley View as long as Texas Education Agency permits and it is economically practical to do so. A determining factor would be the number of students residing in that area. It would be operated by the same standard of teaching as that maintained at Kidwell and Bradford.

A. We would expect to maintain a school of the same quality that we have in the Iowa Park district.

B. 55.64 square miles would be added to the IPI School District.

II. Employ all professional personnel that are now under contract with Valley View.

III. The broader tax base brought about by consolidation would offer a more stable tax structure. This would assist in protecting a district from any sudden decrease in tax revenue. It will also afford the taxpayers of each district a lower tax rate for the coming year than would be possible without consolidation.

IV. A better curriculum could be offered the students at a more economical cost to the taxpayer. Advanced math, foreign languages, some social studies, choral music, and band will be available that Valley View does not offer. High school students to be transferred to the Iowa Park system include 17 seniors, 15 juniors, 19 sophomores and 10 freshmen.

V. The "incentive aid" based on an estimated figure furnished by Texas Education Agency would amount to \$21,126 per year for a period of 10 years. This money must be used to retire bonded indebtedness or build needed buildings.

VI. Nor-Tex Planning Association recommends that highways with overpasses over the railroad on both East and West side of the new high school campus be constructed to connect with highway 368 South toward Valley View. This will shorten the distance and time required to travel between

communities. After consolidation, greater pressure could be applied by more people to cause the State Highway Department to expedite this program sooner.

VII. School purchasing by larger quantities will make for more economy.

Yes, Yes!

Iowa Park Herald reporters get about the same answer from all the folk in both Valley View and Iowa Park school districts, when they ask "What do you think of the consolidation plan?"

Typical is this statement of Mr. and Mrs. D. H. Ford, who have lived many years in Valley View community and now reside in Iowa Park:

"Knowing the academic and financial condition of both Valley View school district and Iowa Park school district, we feel consolidation at this time would be good for both school districts."

Absentee Voting Now Available

Bill Steger has been appointed as absentee ballot clerk. Voters can see him at Iowa Park administration building. Boxes will be set up for both Valley View school district and Iowa Park school district patrons.

Absentee voting will close July 3rd.

What's right about America?

Today, the surest means of a book becoming a best seller is for the author to highlight and denounce bitterly the faults of this country. The same can be said of television and the movies, which prefer in these modern days to depict the seamy side of life in America.

But there's hope. As I have moved across this state, I have sensed that our people are growing weary of gloom. It's becoming easier to strike up a conversation on what's right about America.

I always suggest that there are a lot more level heads in this country than we are sometimes led to believe. There are a lot more decent, law-abiding citizens than there are criminals and cheats and sharks. There are a lot more young people in the "now" generation who want to improve America than the handful of radicals who want to burn it to ashes and start all over.

I can understand why the "majority" has broken its "silence." There's a growing impatience with agitation and controversy. But I feel we should continue to approach our nation's problems with a cool head and an open mind.

I've listened to the voices of dissent. I think I know what they're asking of their government.

One thing they want is confidence. They want the assurance that their public officials have the courage to meet the issues of the 1970's with imagination and integrity, and not with some form of "old politics" that thrashes around with problems but never quite locates the workable solutions.

It was my desire to answer this urgent need that prompted me in January to seek the office of United States Senator.

ORDINANCE NUMBER 155 Article I. Title, Purpose, Interpretation and Application, Jurisdiction, Severability, and Repeal of Conflicting Ordinances.

Section 101. Title. 101.1. This Ordinance shall be known as and may be cited and referred to as the "Zoning Ordinance of the City of Iowa Park, Texas."

Section 102. Purpose. 102.1. This Ordinance is enacted for the purposes of promoting the health, safety, morals, and general welfare of the community; lessening congestion in the streets, securing safety from fire, panic, and other dangers; providing adequate light and air; preventing the overcrowding of land; avoiding undue concentration of population; facilitating the adequate provision of transportation, water, sewerage, schools, parks, and other public requirements; conserving the value of buildings and encouraging the most appropriate use of land throughout the community;

and promoting the development of the community in accordance with a comprehensive plan.

Section 104. Jurisdiction. 104.1. This Ordinance shall be in full force and effect in the corporate limits of the City of Iowa Park, Texas. Territory annexed to the corporate limits of the City of Iowa Park, Texas, subsequent to the effective date of this Ordinance shall immediately be subject to the provisions of this Ordinance and shall be deemed to be designated as A-G General Agricultural District until altered or reclassified in the manner provided by law.

Article II. Establishment of Districts

Section 201. Zoning Districts. 201.1. Zoning Districts Established. For the purpose of this Ordinance and the promotion of public health, safety, and general welfare of the community, the following Districts are hereby established for the City of Iowa Park, Texas:

- A-G General Agricultural District
R-S Single-Family Residential District
R-G. General Residential District
C-C Convenience Commercial District
C-A/R Automotive Commercial and Commercial Recreation District
C-G General Commercial District
I-L Light Industrial District
I-H Heavy Industrial District
P-1 Public Use District

201.4. Maintenance of Official Zoning Map. It shall be the duty of the City Secretary to maintain an up-to-date official "Zoning Map of the City of Iowa Park, Texas," including all amendments directly adopted by the City Council.

Section 303. Violations and Penalties. 303.1. Fines. A violation of this Ordinance shall be deemed a misdemeanor and shall be punishable

by fine. Any person, firm or corporation who violates or refuses to comply with any of the provisions of this Ordinance shall be fined not less than Twenty-five Dollars (\$25.00) for more than One Hundred Dollars (\$100.00) for each offense. Each day that a violation is permitted to exist shall constitute a separate offense.

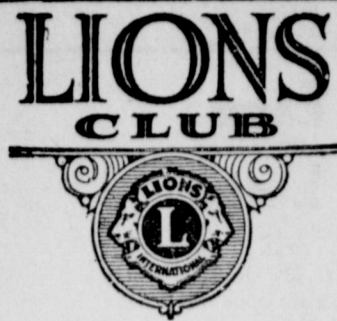

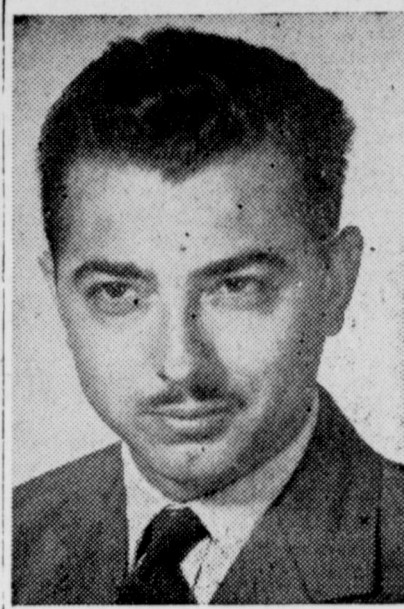

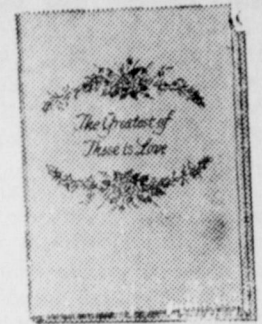
