One of our enterprising citizens, Mr. Murray Schenck, of the Artesia Machine Shop, has lately returned from the east, where he secured the agency of one of the leading machine companies, and is already expecting a carload and consignment of cars suited to the needs of this vicinity.

The machines in transit are the Jackson Motor Cars manufactured at Jackson, Michigan, and as an evidence of their popularity it has only to be stated that the company manufacturing them has been unable to meet the demand, notwithstanding the fact that no special effort has been made to crowd them upon the market.

As comparatively few autos have been brought to the Territory, the Jackson cars as well as other makes are not well known here, but further north they are well and favorably known as indicated by the increasing demand for them. They have been on the market but about seven years and their success during that time is a guarantee of their worth. The manufacturers claim for them that, "No sand is to deep--no hill too steep for the Jackson car."

Mr. Schenck is bringing in four different styles of cars, ranging in price from \$850 to \$2000. As is well known, there has been a great reduction in the prices of the autos lately so that these prices represent a very high grade car as compared with the prices of last year. These are strictly high grade cars and are sold upon merit.

The principal event in 1905 was the Chicago-St. Paul non-stop run. The only car that finished ahead of the Model "C" \$1,250 Jackson was a Pierce Great Arrow. In the same year the Jackson two-cylinder car went against the five-mile world's record at Grand Rapids, Mich., and succeeded in lowering same. Numerous victories were won in every part of the country, including important races at Detroit, St. Louis, and Newark, N. J.

economy cup in this contest. In a hill-climbing contest May 30th of the same year at stock model Jackson car won. The Jackson also won the great 50 mile race at Detroit on July 20th and perfect scores were secured by three Jackson machines entered in the Chicago, Elgin and Aurora Endurance Contest. In the Algonquin Hill Climb the Jackson won the first prize in Class C. Important hill-climbing contests were won at Denver and Minneapolis as well as races with stock cars all over the country.

The principal event of 1907 was the 24-hour International race at St. Louis, Mo., which was won by the Jackson with the Matheson second, 85 miles behind. Other cars that took part in this remarkable race were the Apperson, White Steamer, Stearns, Locomobile, Pope, Toledo and Columbia. Five prizes were won by the Jackson in the International Hill Climbing Contest at Cleveland, Ohio, and five perfect scores were allowed the Jackson in the Chicago Motor Club's Reliability Contest. The Jackson was the only machine to climb Devil's Glade, 2 1/2 mile hill in the Pennsylvania Reliability Contest. In the Algonquin Hill Climbing Contest in 1907, a two-cylinder Jackson, on account of its cylinder capacity, was placed in the same class as four cylinder cars. On the steepest incline on Perry Hill it was only beaten by one-fifth of a second.

As a result of challenges to demonstrate to prospective purchasers which was the best car under \$1,500 for all-around use, an interesting contest took place at Elgin, Ill., between the Jackson, Buick and Rambler. Probably no rougher hill could have been selected than Walnut Avenue, with its ruts, boulders and sudden curves. On this incline the first contest was held, and each driver given two trials, that his best time might be selected. The order of the finishing and best time being: JACKSON 34 3/4 seconds, Buick 43 1/3 seconds, Rambler 45 3/5 seconds.

The second race was pulled off on National Street between the bridge and Hill Street, and in this the Jackson again captured the laurels with ease--with the Rambler second. The long grade was made by the Jackson 43 1/5 seconds, the Rambler in 50 3/5 seconds, and the Buick in 53 2/5 seconds.

The most interesting of all was the two-heat race, all cars starting abreast on National Street. Killip forced the Jackson to the front, finishing twenty feet in advance of the Buick, which led the Rambler by only a few inches. In the second heat the Jackson duplicated the first victory.

The final event, a slow race on high speed, proved too stiff a game for both the Buick and Rambler and the Jackson alone crossed the line. The Rambler engine died altogether before the machine had covered fifty feet of the route; the Buick fought hard, but refused to run when the foot of the hill at Raymond Street was reached, the Jackson, however, went steadily and easily up hill on high speed."

J. L. Johnson, the Roswell lawyer, who was at one time sent to Santa Fe to work for Artesia county, and who afterwards was arrested on a fraud charge but escaped, has finally been located at San Antonio, Texas, where he is in jail awaiting trial in the Federal courts.

In the dispatch to the Roswell Record the charge was not stated. After the Federal authorities get through with him Johnson will be returned to Chaves county for trial.

When the charge of fraud was brought against him, Johnson attempted to make his get-away on foot across the mountains, but was captured. The officer, who caught him, hand-cuffed Johnson and both went into a lunchroom to get something to eat before starting home on the auto line. While the officer was paying for the meal, Johnson slipped outside and has not been heard from since until the dispatch came from San Antonio.

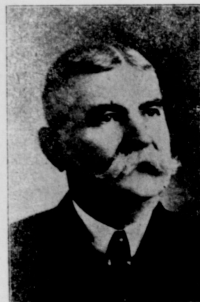

What has Larrazolo done to help New Mexico? Has he brought in capital from the land of his birth to build railroads and develop the country? Has he interested influential friends in our Territory? What movement for the good of New Mexico has he aided in the least? How many friends has he in Washington or elsewhere, who will assist us in getting statehood? These are questions which every voter should ask himself before he lends his aid in placing an alien in the most responsible position in the Territory.

The Albuquerque newspapers have certainly done efficient work in the way of letting the outside world know what was doing at the Irrigation Congress. It was a great show and the papers of the town let the world know it.

The democrats under on pretext or another, have succeeded in delaying the vote upon the bridge question until the regular election when, by all means, the petition should have been submitted to the Board at the July meeting. They hope, by this move to bring out the strength of the party and thereby increase the vote for Larrazolo and from a political standpoint it is alright. We believe, however, that results will show that it is an exhibition of bad judgment so far as the interest of Artesia is concerned, but perhaps this is unworthy of consideration. We urge upon the Republican voters the necessity of voting upon this important question as every vote will be needed to carry the proposition.

EDITOR MULLANE, also, is "skeerd," notwithstanding the fact that the Republicans decided several weeks ago not to nominate a county ticket, at least two Democratic editors appear to lack faith in the running qualities of their nominees. 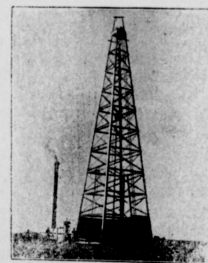

It appearing from the abstract and data submitted to the board by the Traveling Auditor that the counties of Eddy, Mora, Otero, Rio Arriba, Socorro, and Santa Fe show a considerable decrease in the assessed valuation for the year 1908, as compared with the year 1907, and

Therefore, be it resolved, That the traveling auditor be requested to call the attention of the taxing authorities of these counties to these evidences of neglect, incompetency or indifference in such a manner as he may deem advisable, and that he report the result of his action to the board at its next meeting.

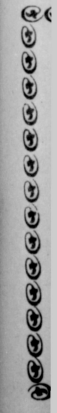

Hagerman is considering a proposition to extend the limits of the town.

Ten sites have been offered the government for the new public building at Roswell.

The stockholders of the Pecos Valley railroad held a meeting in Avery Turner's car in the yards at Roswell last week and elected directors for the coming year. The directors are, Avery Turner, D. L. Meyers, A. E. Meyers, J. J. Hagerman, John W. Poe, E. A. Cahoon, E. P. Ripley, J. E. Hurley, J. C. Paul and J. N. Freeman. The directors re-elected the old officers.

Rev. R. H. H. Burnett, formerly of the Pecos Valley Echo and the Roswell Democrat is preparing to establish a paper at the thriving little town of Hope. Hope has been after a good man to put in a newspaper there for some time, and it seems as though they have struck pay dirt when they land "Uncle Dick."

Wild Horse Hill, the well known cowboy and broncho buster, is at Abilene, Tex., under a seven years' sentence in the penitentiary for horse stealing. The case has been appealed.

Carlsbad is working on a plan to have a poultry exhibit in that city, sometime this coming January, at which will be shown every kind of chicken raised in the Valley, either by irrigation or dry farming.

The Roswell Register-Tribune reports that the oat crop on the deBremont farm near that town, will run 100 bushels to the acre. It weighs 37 pounds to the bushel, or five pounds over standard weight.

The Cotton gin at Carlsbad is at last in full operation. Other varieties of gins have been in operation at that place for many years, but at present the cotton gin is occupying all the local attention. There is about 2,000 acres in cotton around Carlsbad this year, and it will probably average a bale per acre.

A bunch of big guns, viz, Al P. Davis, Louis C. Hill and W. M. Reed, all connected with the reclamation service, visited Carlsbad last week and took a look at the big dam. They also visited the Hondo Project, but so far no official report of their cogitations has been given out.

The socialists of Chaves county have put a full ticket into the field and hope to make things interesting for both of the "old parties."

Captain E. P. Bujac and wife, of Carlsbad, are mingling among the visitors to the Irrigation Congress and Exposition in Albuquerque. Captain Bujac is a lawyer and well known Democratic poli-

tician of Eddy county, which is one of the strongholds of Democracy in New Mexico. Captain Bujac served in the Boer war against the English in Africa and after the close of the war he emigrated to this country.---New Mexican.
