City Council Hears Bond Application Status


A. E. Todd Surprised on 84th Birthday

A.E. Todd was surprised on his "84" birthday, Tuesday, March 9, with a party from 7:30 a.m. until 8:15 a.m. in the board room of the administrative office at Shallowater School by the faculty and friends of the community.

The lovely birthday cake was iced in white with "Happy Birthday" inscribed on it, made by Mrs. Hap Covington. An appropriate verse taken from Psalms 71:18 also decorated the cake. A money tree of \$105 was presented to him.

Mr. Todd was born March 9, 1892 in Bryan near Texas A&M College, and went to school in the Harvey Community at a country school, walking three miles one way each day. He married Estelle Dyess on December 7, 1913, she died Dec. 2, 1970.

He has resided in the Shallowater area for 50 years where he farmed when he first moved here. He held the position of school janitor, tax-assessor collector and school manager for 7 years, resigning June 1, 1937, and went back to farming. He returned to work for the Shallowater Schools in 1947 and has worked for the school the past 29 years. The city's application to the Farmers Home Administration for approval of a \$300,000 bond issue to build a ground storage reservoir and water and sewer lines is in order, an attorney told city council members Monday night.

"All the work has been done in making bond application to the FHA," Mack Ed Swindle said.

Swindle noted he still had to examine the right of way document and easement from the Santa Fe Railroad to locate a water line on railroad property. But the attorney said he "feels like they probably will lease us the property for \$100 per year."

If the railroad approves the right of way easement for the city, the final obstacle to the FHA's purchase of the bonds will be cleared. Present plans for construction of the 350,000 gallon reservoir call for work to begin in the summer if the application is accepted. Shallowater voters approved the bond issue in November, 1974.

The attorney said he expects to hear "shortly whether the railroad has approved our application to put a line on their property."

In the Monday night meeting, city council members also voted to discontinue the use of aluminum wiring in home construction, and to update a city ordinance on abandoned motor vehicles so that it complied with the state's abandoned motor vehicle act.

City - School Elections To Be Held April 3rd

The annual city and school elections will be held on Saturday, April 3, with 5 candidates vieing for 3 places on the city council and 8 running for 3 positions on the Shallowater Trustee election.

In the city election, terms of W.A. "Dub" Hardin, C.E. Pair, and Philip Gerig, expire. Hardin is running unopposed on Place 3. On

Place 1, Leroy Grawunder and Mrs. Doris Epperson are candidates for that position; and Bob Grice, Danny Jones and Harry Leonard are running on Place 5.

On the trustee election, terms of Melvin Stewart, Walter Hutton and Donald Martin expire. All three men chose not to run again. The 8 candidates who have entered the race are Joe Randolph, Tommy Pointer, Clyde Wyche, G.W. Gates, Jr., Billy Hayslip, LaVon McAuley, Pat Cobb, and Bryan Burgett.

Absentee voting began Monday, March 15 through March 30 in both elections. Absentee votes can be cast at city hall during office hours until the deadline and at the school business office during opening hours with the exception of March 22-26 when school spring holidays begin and voters may cast their ballots absentee these 5 days from 9 a.m. until 12 noon.

City Secretary, Jessie Lee Vance, is the absentee voting clerk for the city and Mrs. Ruth Walker is the absentee voting clerk for the school.

If you plan on being out of town on election day, April 3, be sure and cast your absentee ballot during the designated time.

The city election will be held April 3 at city hall with Mrs. George Blackmon as election judge. Bob Grice will be judge for the school election, to be held at the community building.





You shouldn't either. The whole of Lubbock should attend this one. This is a British and Italian co-production which was filmed in the arid lands of Israel. It is a curiously hybrid kind of picture, since Burt Lancaster as Moses is American; Anthony Quayle as Aaron is British; Ingrid Thulin as Miriam is Swedish; and Irene Papas as Zipporah is Greek!

The remainder of the cast is a mix of Israeli, American, Italian and the

The film is well photographed and traces, naturally, the setting adrift of the baby Moses in the basket to be found by the Princess and raised as a prince of Egypt. There is the splitting from his "cousin," the Pharaoh Ramses II, and Moses' return to his people. The Passover, the beginning of the flight from Egypt, the parting of the Red Sea, the Burning Bush, the fall from grace and the Golden Calf, the laws and the ultimate victory into the Promise Land-all are told faithfully and with care.

The picture is told less lavishly and less overwhelmingly than the epic Biblical films from the Hollywood master of the genre, the late Cecil B. DeMille. It has validity, this "Moses," and the playing is sincere and

direct.

The sequence, incidentally, of the parting of the Red Sea is a far better and more credible handling than the similar DeMille version in "The Ten Commandments."

Burt Lancaster, the one time trapeze artist and "Elmer Gantry," handles his Moses assignment with low-keyed honesty and quiet professionalism. Anthony Quayle's Aaron is a sad, troubled and sometimes uneasy portrayal. Miss Thulin makes a sincere Miriam, while Miss Papas gives her skills to Zipporah.

Two others score handily in this cast, Mario Ferrari as the Pharaoh and Yousef Shiloah as the wily Dathan.

The film, at the Cinema West, runs two hours and 20 minutes and is PG rated. It has had a dual reputation, for much of its content was seen on television under the title of "Moses: The Lawgiver" earlier. This film contains much material not seen in that TV presentation.

Talked with Less Adams of the Lubbock Theatre Centre's Act IV this week. He's deeply involved, as all members are, in formulating plans for the second annual Summer Mummers set for a July opening at the Koko Palace. If I must be immodest, it was during last July-August run that I made my "stunning debut" as a soft shoe dancer in the olio, playing all performances in white tie, tails, top hat, stick and all. My ego enjoyed it;I hope the audiences did. They seemed to do so; they were kind!

Well, there'll be another big Summer Mummers show this year and if you have any talent for acting or for an act in the olio, pick up the phone and call the Lubbock Theatre Centre and ask for one of the Act IV members or Les Adams. They'll love hearing from you, believe me. All the proceeds go to help the city's prime community theater, Lubbock Theatre Centre.

And, remember, in closing, one other date. That is this Saturday, March 20. That's the positively last time that you can purchase your memberships for the upcoming season of Lubbock Community Concerts. The headquarters is the Lubbock Inn and you can contact them by dialing 799-2105. Don't delay. Remember, no tickets at the door for the four events; only memberships admitted.

As I am such a slow writer, I would like to take this method of thanking Each of those who had a part in the surprise on my "84th" birthday. It was a grand party and I appreciate such thoughtfulness.

The polls at the above designated polling places shall on election day be open from 7:00 o'clock a.m. to 7:00 o'clock p.m.

4. Mrs. Mary Ruth Walker is hereby appointed Clerk for absentee voting, and Mrs. Peggy Cowart and Mrs. Wana Beth Cook are hereby appointed Deputy Clerks for absentee voting. The absentee voting for the above designated election shall be held at School Administrative Offices within the boundaries of the above named School District and said place of absentee voting shall remain open for at least eight hours on each day for absentee voting which is not a Saturday, a Sunday, or an official State holiday, beginning on the 20th day and continuing through the 4th day preceding the date of said election. 
This week's senior spotlight shines on Elvira and John Perez, daughter and son of Mr. and Mrs. John Perez.

The state act says partially wrecked, dismantled, or inoperable vehicles without current license tags and a state inspection sticker can be declared a public nuisance. If the vehicle was in sight of the streets, the city could declare it a public nuisance, giving the owner 10 days to dispose of it. If the owner refused, the city would be empowered to remove the hulk. An owner has the right to a public hearing to contest the city's claim that his vehicle is a public nuisance, according to the state law.

Jimmy Lamb, the city's inspector, appeared before the council Monday night, telling officials that recent National Safety Council figures show 87 per cent of electrical fires are caused by aluminum wiring. Lamb said the wire was still sanctioned in the national safety code, though the safety council "is trying to outlaw it completely."

The ordinance, which does not affect homes currently under construction, was made effective immediately for new housing starts in the city. Lamb estimated it would cost home builders 25 per cent more for the copper wiring. "Everything else is the same," he

"If we kill it, we're decreasing the possibility of someone getting burned," Lamb told council members.

In other action, the council tabled for further study proposals

-employ reserve officers for

the police department; -purchase the services of a street sweeper;

-initiate a retirement program for city employees; and

-purchase land to construct a city building.

Council members will look into ordering telephone cables to control three of the city's wells, "providing the installation charge is not exorbitant."
