"Remember When"

The car radio obliged by playing songs from the 60s. And that's exactly where I was headed. The year was 1988, but I was going back in time to my high school reunion.

Judy Fortune Porter, a classmate from Cross Plains High School, encouraged me to return that year. And ever since that day three years ago I've been anxiously awaiting this year's reunion--especially since the class of 1966 will be celebrating our 25th anniversary.

But to be honest, I was more than a little nervous about going back in 1988. I had not seen most of my classmates since we graduated from CPHS. Most of my classmates still lived in Texas, while I moved to the Pacific Northwest. I had lost touch with those with whom I had shared those important years of life. I flew into Dallas-Fort Worth and began to drive home to Cross Plains. Texas reflected its unique beauty. Oaks on the green hills, fog in the creek bottoms. On the farm-to-market road the solitude is broken by those friendly waves from drivers passing in the opposite direction. Mesquite trees, a country cemetery, an oil pump, prickly pear, road kills (an armadillo and a raccoon), faded ads on the side of an old barn, turkey, vultures--all those things that most Texans take for granted--are welcome signs of home. The anticipation builds as I get closer to Cross Plains. I'm saddened by the demise of the old Pioneer Drive-In, where we occasionally watched a movie. We simply enjoyed being together, even if we had to sneak 'in (crouched in the floorboard of the backseat or crawling through the barbed wire fence). Memories of my first kiss (I won't tell). I drive past the old Pancake's truck stop on the edge of town. More memories of hamburgers and coffee at 2 a.m. If we couldn't afford that, it was coffee, crackers and French dressing. I remain stopped at the blinking stop light far longer than is necessary. Looking back to 1966, I can see Koenig's Humble Station where Oscar Koenig let me charge gas (19.9 cents a gallon; give me a dollar's worth). Now there's a Dairy Queen on the opposite corner. I drove to the school but decided to head back to the Dairy Queen to gain a little courage. I ordered a cup of coffee and saw faces that looked so familiar. But the names were hidden by the years. Then my mind wanders to Jones' Dairy Bar, where we gathered to meet other carloads of kids. From there we'd go to the City Park or maybe some deserted dirt road. A voice brings me back to 1988. "Skipper. Skipper Nichols, is that you?" It was Jerry Strickland. We spent many hours riding a school bus together from Cross Plains to Burkett, not to mention too many miles in my old '55 Chevy. We talked about the those days (and nights) as if they happened last week, not two decades ago. Finally I get enough courage to head to the school to register. I'm still nervous. Now I'm in the midst of faces and voices from 1966. The old school is gone. I'd be lying if I didn't admit that I miss walking down those halls I was so anxious to leave in 1966. 
--Understand the scientific principles of nutrition.


Although the football season is still relatively young (two scrimmages and one game,) the Cross Plains football team is already having to contend with major injuries to two of the Senior ball players.

I am horrified by the thought that someone so uncaring and thoughtless could torture my families dear pets by trapping and poisoning them.


No one will ever know the grief and devastation that I felt as I picked up the pawsless bodies of my lifeless cats.

### PUBLIC NOTICE BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS SPECIAL ELECTION **NOVEMBER 5, 1991**

#### **PROPOSITION NO. 1 ON THE BALLOT**

House Joint Resolution 114 proposes a constitutional amendment that would authorize home rule cities having a population of 5,000 or fewer inhabitants to amend their city charters by a majority vote of a city's qualified voters at an election held for that purpose. The amendment makes clear that home rule cities that have declined in population below the population required to initially adopt a charter may nevertheless continue to amend their charters.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment allowing home-rule cities with a population of 5,000 or less to amend their charters by popular vote."

#### **PROPOSITION NO. 2 ON THE BALLOT**

House Joint Resolution 10 proposes a constitutional amendment that would allow the legislature to authorize the Texas Department of Transportation to expend money, from any source available, for the costs of the turnpikes, toll roads, or toll bridges of the Texas Turnpike Authority, provided that any monies expended from the state highway fund shall be repaid to the fund from tolls or other turnpike revenue.

tion institutions, and youth corrections institutions, to repair and renovate existing facilities of those institutions and to acquire, repair, or renovate other facilities for use as state prisons or substance abuse felony punishment facilities. The \$1.1 billion is in addition to the \$900 million currently authorized by the constitution to be expended on bond issues for facilities of correctional and mental health and mental retardation institutions. The bonds would constitute a general obligation of the state. The bonds and interest on the bonds would be paid from the first money coming into the state treasury that is not otherwise appropriated by the constitution, less any amount in a sinking fund at the end of the preceding fiscal year that is pledged to payment of the bonds or interest.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment authorizing the issuance of up to \$1.1 billion in general obligation bonds for acquiring, constructing, or equipping new prisons or other punishment facilities to confine criminals, mental health and mental retardation institutions, and youth corrections institutions, for major repair or renovation of existing facilities of those institutions, and for the acquisition of, major repair to, or renovation of other facilities for use as state prisons or other punishment facilities."

members of different political parties appointed by the governor from a list of at least ten names submitted by the members of the senate from each major political party; two members of different political parties appointed by the speaker of the house of representatives from a list of at least ten names submitted by the members of the house from each major political party; and two members of different political parties appointed by the lieutenant governor from a list of at least ten names submitted by the members of the senate from each major political party. A major political party is a political party required by law to hold a primary. With the exception of the initial appointees, commission members would serve for four-year terms. A member who has served for one term and any part of a second term would not be eligible for reappointment. The commission would be authorized to recommend the salary of the members of the legislature and may recommend that the salary of the speaker of the house of representatives and the lieutenant governor be set at an amount higher than that of other members. If the commission recommends a change in salary, the voters would be authorized to accept or reject the salary change at the next general election for state and county officers. If the voters approve the recommended salary, that salary would take effect January 1 of the next odd-numbered year; if the voters reject the recommended salary, no change in salary would occur. The commission would set the per diem of the members of the legislature and of the lieutenant governor. The per diem could be raised or lowered biennially as necessary to pay members' costs, but could not exceed the amount allowed as of January 1 that year as a federal income tax deduction for living expenses incurred in a legislative day in connection with a member's business as a legislator, disregarding any federal income tax exception for legislators residing near the Capitol. The commission would have other powers and duties provided by the commission's enabling act (Senate Bill 1, 72nd Legislature, Regular Session). The amendment would also provide that an increase in the emoluments of the office of Lieutenant Governor would not make a legislator ineligible to serve in the office of Lieutenant Governor.

A law enacted in anticipation of the election on a proposition is valid if, by its terms, it is enacted subject to approval of the related proposition. The proposed amendment will be described on the ballot as follows:

"The constitutional amendment authorizing the voters of this state to consider state debt questions in the form of ballot propositions that must clearly describe the amounts, purposes, and sources of payment of the debt only after approval of the propositions by a two-thirds vote of each house of the legislature."

#### **PROPOSITION NO. 9 ON THE BALLOT**

Senate Joint Resolution 11 proposes a constitutional amendment that would authorize the commissioner of the General Land Office to issue patents for certain public free school fund land for which there is not a valid transfer of title from either the State or the Republic of Texas to a private party. A patent is a document of title issued by the state. On application to the School Land Board, a person is entitled to receive a patent if: (1) the land is surveyed public free school fund land, (2) the land was not patentable under the law before the adoption of this proposed amendment, (3) the person acquired the land without knowledge of the title defect out of the State of Texas or the Republic of Texas and held the land under color of title, the chain of which dates from at least January 1, 1941, (4) the person has a recorded deed on file in the county courthouse and, in conjunction with his predecessor in interest, has claimed the land for at least fifty years as of January 1, 1991. and (5) the person, in conjunction with his predecessor in interest, for at least 50 years has paid taxes on the land together with all interest and penalties associated with any delinquency. If the applicant is denied a patent, the applicant may file suit against the School Land Board in a district court in the county where the land is located within 60 days from the date of denial. The proposed amendment does not apply to beach land, submerged land. or islands, and may not be used to resolve a boundary dispute. The proposed amendment also does not apply to land found by a court to be stateowned or to land on which the state has given a mineral lease that is in effect when a patent is sought. A patent under this proposed amendment for land within five miles of mineral production shall reserve minerals to the state in the manner provided by law for reservations of minerals in sales to claimants of unsurveyed school land within five miles of production. An application for a patent under this proposed amendment must be filed with the School Land Board before January

The transferred assets must be property that is reasonably necessary for and used for water supply and wastewater services.

The proposed amendment will be described on the ballot as follows: "The constitutional amendment authorizing the legislature to exempt from ad valorem taxes certain property of a nonprofit corporation that supplies water or provides wastewater service."

#### **PROPOSITION NO. 11 ON THE BALLOT**

House Joint Resolution 8 proposes constitutional amendment that would allow the legislature to pass laws to authorize the State of Texas to operate lotteries and to enter into a contract with one or more legal entities that will operate lotteries on behalf of the State of Texas.

The proposed amendment will be described on the ballot as follows:

"The constitutional amendment authorizing a state lottery."

#### **PROPOSITION NO. 12 ON THE BALLOT**

Senate Joint Resolution 34 proposes a constitutional amendment that would increase the total amount of bonds that may be issued by the Texas Water Development Board to provide wholesale and retail water and wastewater facilities to economically distressed areas of the state. The proposed amendment increases the maximum principal amount of the bonds from 20 percent to 50 percent of the \$500 million amount authorized by article III, section 49-d-7, of the Texas Constitution. The proposed amendment would increase the maximum aggregate dollar amount of bonds that the Texas Water Development Board could issue from \$100 million to \$250 million.

#### **PROPOSITION NO. 3 ON THE BALLOT**

Senate Joint Resolution 26 proposes a constitutional amendment that would authorize the Veterans' Land Board to invest, as authorized by law, moneys of the Veterans' Land Fund which are not immediately committed to the payment of principal and interest on bonds issued by the Veterans' Land Board, the purchase of lands, or the payment of expenses. Investment of such moneys would no longer be restricted to investments in bonds or obligations of the United States. The proposed amendment would also authorize the Veterans' Land Board to invest, as authorized by law, moneys of the Veterans' Housing Assistance Fund which are not immediately committed to the payment of principal and interest on general obligation bonds issued by the Vetpenses. Investment of such moneys would no longer be restricted to investments in bonds or obligations of the United States. The proposed amendment gives the legislature power to implement the amendment and to delegate such duties and authority to the Veterans' Land Board as it deems necessary.

#### **PROPOSITION NO. 5 ON THE BALLOT**

Senate Joint Resolution 39 proposes a constitutional amendment that would allow a county, junior college district, or municipality to exempt tangible personal property from ad valorem taxation if: (1) the property is acquired or brought into the state in an enterprise zone to be forwarded outside the state, (2) the property is assembled, stored, repaired, maintained, manufactured, processed, or fabricated in the enterprise zone, (3) the property is transported outside the state not later than 175 days after being acquired or brought into an enterprize zone, and (4) the person who acquired or brought the property into an enterprise zone is a qualified business. A county, junior college district, or municipality may exempt such property by entering into a written agreement with a qualified business that states the duration of the exemption and the terms on which the exemption is granted. Any action to exempt property must be taken before April 1 of the first year in which the property would otherwise be taxed. The term "enterprize zone" means an area that (1) has been designated as such by a state agency responsible for economerans' Land Board for the benefit ic development, and (2) has perof the Veterans' Housing Assistance vasive poverty, unemployment, and Fund, the making of home mor- economic distress. "The constitutional amendment creating the Texas Ethics Commission and authorizing the commission to recommend the salary for members of the legislature and the lieutenant governor, subject to voter approval, and to set the per diem for those officials, subject to a limit."

#### **PROPOSITION NO. 7 ON THE BALLOT**

Senate Joint Resolution 6 proposes a constitutional amendment that would allow the board of trustees of each statewide public retirement system to invest the funds of the system in such manner as the board considers prudent. The board would no longer be limited to investing the funds of the system in securities.

The proposed amendment will be described on the ballot as follows:

The amendment would also authorize the legislature to provide for the investment of bond proceeds and to establish an interest and sinking fund to pay the bonds and provide for the investment of such fund.
