Cross Plains And Surrounding Communities Experience Flooding Last Tuesday, March 3

Last Tuesday evening, March 3, thunder clouds built in the south that brought approximately 4¹/₂ inches of rainfall to Cross Plains and surrounding communities.

The hard, blowing rain fell on already saturated soil, resulting in greater runoff. The excess water took its toll extensively on one local business, Lakeway Grocery.

The convenient store is located south of the stop light on the Brownwood highway. As much as 2¹/₂ feet of rushing water came through the store flooding the building and destroying merchandise. Bill and Barbara Young, the owners, suffered severe damages to the property and merchandise.

After a major clean-up project, Lakeway is now open for business. "It takes more than a flood to keep Neighbors and friends of the family have already started a cleanup and rebuilding barns. The Koenigs were very appreciative.

I would like to thank Lois Garrett, Dick's aunt, for providing this information.

Shirley Hunter of the Burkett Community reported fences and water-gaps down on their property. One fence was moved from one side of the road to the other with the force of the huge stream of water. The bridge near the Bill Hunter house was flooded and they have never seen this happen in the past 37 years until twice this year. The amount of erosion and fencing repairs will have farmers and ranchers busy.

Calvin Champion reported the road to his house was impassible and his family was staying in town with his brother. A flood of water over 100 yards wide came across fields destroying fences and roads in its path.

Wright Right; Two County Runoffs Due

Allen Wright, who works out of the district attorney's office in Abilene, defeated incumbent Brad Harris for Callahan County attorney, but two other county officials were forced into runoffs in Tuesday's Democratic Primary voting.

Although Sheriff Bill Skinner of Baird had a wide lead on the ticket with 1357 votes, he did not escape a runoff with fellow Baird resident Eddie Curtis, who gathered 962 votes. Don Childers of Cross Plains was a close third with 927 votes in final unofficial returns while Don Griffith polled 277.

Likewise, incumbent Wauneta Estes of Clyde gathered 1608 votes for county tax assessor-collector, but did not escape a runoff with Bun Barry of the Baird area, who had 982. Nancy Turnbow was in a close third with 897. Wright, who lives in the Eula area, had 2079 votes to Harris' 1408. A runoff also developed in the Clyde county commissioner race. Incumbent Roy LaFoy ran second to challenger Harold Hicks, 378 votes to 307. Former county commissioner Eugene Kitchens was third with 213 votes.

Another runoff developed in the Clyde constable race. David Blalock of Clyde led the ticket with 703 votes but must face Dahyl Bradshaw of Eula, who received 454. Former Clyde policeman Tom Mabb got 403 votes.

In the first test of Clyde versus the rest of the county under the new redistricting boundaries, the rest of the county won. Paul Yarbrough of the Clyde area was defeated for Cross Plains constable by Ernest Cortez of Cross Plains 497 to 229.

In the Baird constable race, Tommy Higgins outpolled Dale Coley, 601 to 421.

Callahan County went along with the

West Texas Utilities also found their office under approximately two inches of water following the downfall, as water came in from the alley. Other businesses and homes have experienced water leaks, water blown between the foundation, flooding, and hail damage.

Dick and Sharon Koenig narrowly escaped the path of the tornado, which swept through and destroyed five barns and a grainery. The width of the tornado was estimated at four city blocks as they traced its destruction through the pasture. Tin and metal was twisted in the trees from the flying debris from the barns.

The tornado was headed directly to Cross Plains when it either lifted or changed direction.

The Koenigs sought refuge in their two story home, which is 100 years old. The house was built in 1892 by Andy DeBusk and has proudly been inhabited by members of the DeBusk family throughout the years.

When the strong wind and rain hit, Dick tried to open the windows and doors of the house so that it wouldn't explode, but each time they slammed shut. In despair, he and Sharon lay under a mattress in their bedroom between their bed and their granddaughter's, Savanah's, baby bed.

Dick recalled thinking "I wonder who will find us and dig us out?" The couple remembers the darkness and the sound of a train, just before losing consciousness when the tornado struck. The vacuum produced by the force of the wind caused this state.

When they awoke they looked out the sliding glass doors and in the lightning saw that the barns were gone. The balcony of the house was lifted up and set back down.

They heard the sound of nails being pulled from the house during the storm. The ceilings were buckled in some rooms and the walls were shifted in the bedrooms.

Every cabinet door in the large kitchen was open, but miraculously not a dish was broken. Nothing inside the house was damaged and no flooding.

The telephone was out, and when they tried to drive for help the road was so fuli of trash and debris that they had to turn back. No one knew about their dilemma until Friday morning.

The horses that were in one of the barns were found in the pasture unharmed, but they were traumatized. They appeared frozen to the ground from sheer panic. roads have been stranded due to small bridges washing out or water running over them. The bridge just west of Joe Oglesby's house was flooding when the basketball fans returned home after the Area game at Sweetwater.

All these folks missed the big storm, but witnessed the high water on their return. The tops of the tables in the Treadway Park on Highway 36 were even under water.

Bridges on the Coleman and Brownwood roads were affected by rushing water. One vehicle was reported washed off the road.

The KTAB television crew ran into some high water on their way back to Abilene and came through our city in time to film the water flowing through Lakeway. Cross Plains has been featured on the news several times the last few days.

12 Players Recognized In All-District Basketball

Six girls and six boys were named to All-District teams for 1992. Cross Plains High School had the distinction of having two Most Valuable Player awards. Shana Bagley was named MVP for the girls, and Colby Walker was Co-MVP for the boys.

The coaches of all the teams in the district voted on the players which determined the outcome.

The Lady Buffs are individually featured with their All-District honors. Sophomore Shana Bagley was

named MVP of the district. Overall she averaged 10.7 points per game and led the team with 4.2 assists and 3.8 steals per game. Her game high was 20 against Baird.

Senior Angie Purvis was named to the 1st Team All District. She was the leading scorer, averaging 12.8 points and 6.7 rebounds per game. Her game high was 29 points against Baird, which included 6 three pointers.

Sophomore Heather Montgomery was also named to the 1st Team All District. She averaged 11.1 points per game and led the team with 7.7 rebounds per game. Her game high was 18 against May. "These six girls are to be congratulated not only on a successful season, but also for their individual contributions to the team. Senior Angie Purvis will be greatly missed next year; however, players to look for are Amy Welch and Sam Newman," Coach Shedd remarked. Other team members were Jamie Jones, Tamara Flippin, and Tonya Stover.

Gasoline Fire At Skinny's Threatening

Last Thursday evening at 8:25 the Cross Plains Volunteer Fire Department was called to the scene of a gas fire at Skinny's convenient store, located on Highway 36. The blaze was extinguished within 10 minutes, according to Fire Chief Bob Harrell.

Jason Allen Koch, 17, of Dallas, allegedly set fire to pumping gas with a cigarette lighter as George Wilmaker, 16, was filling his mother's car.

Wilmaker dropped the hose and ran to safety when the gas ignited. Gasoline was still pumping in the area. Roy Isbell, employee at Skinny's, said, "I heard a 'whoosh' sound and saw a glare like a headlight pulling in. I looked and there were flames clear up to the canopy (over the gas pumps) and curling around."

Isbell shut the gas pumps off and summoned the local fire department.

A former firefighter, Isbell, explained that the car did not explode because the gas tank was full. "The fuller it is, the less likely that it will ignite, because there is no oxygen in the tank to create a vacuum," he said.

The plastic around one of the light fixtures over the gas pumps was melted by the heat and flames. The canopy was also blackened and damaged.

Justice of the Peace Rolan Jones estimated the fire caused thousands of dollars of damage. Skinny's is still estimating damages, which will prove substantial.

Damage to the Wilmaker vehicle was considerable, including two melted tires.

"It was stupid," Justice of the Peace remarked. "It was a wonder someone didn't get killed."

Koch, who was visiting relatives in Cross Plains, was taken to Baird County Jail where he was charged with a 2nd degree felony. He was released on a \$2,000 bond.

McAlister Bounds.



Abilene Drivers License Office To Conduct Special C.D.L. Testing

The Abilene Drivers License Office will conduct special testing for Commercial Drivers License (C.D.L.) on Saturday, March 14, and Saturday, March 28, at the Texas Engineering Extension Service Facility, located at 3650 Loop 322 in Abilene.

The testing will begin at 8:30 a.m. Saturday and will close at 2:30 p.m. each day and is only for the C.D.L.



Commercial drivers who need to take the tests, need to bring with them their current drivers license, their original issued Social Security card, or current employment record that indicates their Social Security number. No commercially produced Social Security cards will be accepted.

Persons who need the new Commercial Drivers License are those individuals who drive vehicles with registered gross weight in excess of 26,000 pounds, those who transport hazardous cargo that requires a placard, and those who drive buses designed to transport 16 or more passengers (including the driver).

Church bus drivers are not exempt from these requirements. Volunteer drivers also are required to secure a C.D.L.

Nitrogen **Level Low** In Soil

Wheat producers have been asking about possible Nitrogen losses on wheat planted and fertilized last fall, according to Greg Gerngross, County Extension Agent.

A sampling of four sites on J & B Farms wheat variety and soil fertility test plots were sent to the soils lab at Texas A & M University recently and all four soil tests showed a very low reading on Nitrogen availability

Over 70 pounds of actual Nitrogen was applied last fall prior to planting of the test plots. Soil test results showed only 4-7 pounds/acre remaining in the soil as of March 1.

Extension Agronomists are recommending topdressing Nitrogen if weather allows. Wet field conditions the past 90 days have halted all field operations and wheat is starting to joint in many fields. Heavy equipment used to topdress wheat will likely damage some of the earlier maturing wheat.





FFA Competes At San Angelo Stock Show







Free Income Tax Service

Through the Tax-Aide program, volunteers provide free personal income tax assistance to the Senior Citizens, low income families, and the general public with basic tax returns. Individuals with complex tax returns will be advised to seek professional tax assistance.

Volunteers are specially trained, in cooperation with the U.S. Internal Revenue Service (IRS), to understand those provisions of the tax code that affect the Senior Citizens as well as the low and middle income people. Tax-Aide volunteers provide personal, one-on-one assistance to help you complete your federal and/or state tax returns (including special rebate programs).

Tax-Aide volunteers are available from February 1st to April 15th each year. There will be three volunteers working the Cross Plains area using the Multi-Purpose Center on East 8th Street as their headquarters. Tax returns will be prepared by appointment only, so you will need to call the volunteers personally for appointments. Volunteers are Pauniece Oglesby 725-6772, Bobbie Ryan (915) 784-6991, and Yuna Vee Burkett (915) 624-5274. However, Mrs. Ryan prefers to have Wednesday appointments and Mrs. Burkett Thursday appointments.

When you meet with a Tax-Aide volunteer, you should bring the following: (1) a copy of last year's (1990) income tax return, (2) any W-2 forms you have received (showing your income from working), (3) all 1099 forms you have received which show the interest and/or dividends, (4) all 1099-R forms which show all pension monies paid to you, (5) form SSA-1099 which shows the Social Security paid to you, (6) records of any other income you have received, and (7) receipts or cancelled checks for any of your medical/dental expenses and any contributions you have made to charities. This is a community service available to those stated above and the Tax-Aide volunteers are eager to be of assistance, so please call and let us help you.
