# Incumbents Do Well In Democratic Primary

Three incumbents claimed victory in the March 12 Democratic Party Primary Election in Callahan County.

Incumbent County Attorney Allen Wright won re-election over challenger W.L. (Dub) Burke, incumbent Clyde Commissioner Harold Hicks defeated challenger W.H. Blackburn, III and incumbent County Sheriff Eddie Curtis defeated Rod Waggoner.

Sheriff Curtis must face Republican challenger Paul Jaworski in the November General Election. Wright and Hicks have no Republican opponent in November.

Wright won six of the seven voting precincts against his challenger. The only precinct Wright lost was the Precinct #7

box at Oplin. Wright won with 1079 (66%)

votes to Burke's 489 (30%) votes.

Curtis won six of the seven county voting precincts as well. Curtis lost the Precinct #6 box in Clyde to Waggoner.

Curtis won with 1009 (61%) votes to Waggoner's 564 (34%) votes.

Hicks was re-elected to his Precinct #1 commissioner seat with 285 (70%) votes. Challenger Blackburn tallied 111 (27%) votes.

In the contested Precinct #3 Constable position, Howard Bredehoft won with 314 (52%) of the votes to Tommy Cooper's 192 (31%) votes. Bredehoft won the Baird voting precinct, while Cooper won the Putnam voting box.

Voter turnout in the Democratic Primary Election was light with only 1,630 ballots cast.

February was particularly rough on equipment as the grass fires rarely allowed the trucks time to cool down creating greatly elevated maintenance

#### **ICA Board Urges USDA** To Complete Packer Inspection

AUSTIN-The board of directors of the Independent Cattlemen's Association of Texas (ICA) is urging the U.S. Department of Agriculture (USDA) to complete a comprehensive investigation of packer concentration. The investigation is being conducted by a commission organized by U.S. Secretary of Agriculture Dan Glickman. The panel is due to issue its findings in June.

The investigation will focus on the fact that three major meat packing companies are buying more than 80 percent of the cattle in the United States. Packer profits have risen steadily in recent years, while prices at the producer level have dropped 50

"We are looking for avenues to get something done," said ICA President Jim Selman. "The packers are causing prices to be depressed."

The ICA board voted to make its views known to USDA after a presentation by Cuero ranchers David Warzecha and Stayton Weldon.

"As a result of a monopoly by packers, prices at the cow-calf producer level have dropped drastically since the first quarter of 1994," Warzecha said.

At that time, Warzecha said, calves were averaging \$400 a head. In January of this year, the average was \$213 a head.

"We are asking everyone to write their congressman and to urge Secretary of Agriculture Dan Glickman to expedite the completion of his investigation," Warzecha said.

# **Congress Proposes Deep Education Cuts** For Texas

Editor's Note: The following information was received from the United States Department of Educa-

The latest short-term budget bill, which represents the ninth in a series of continuing resolutions and runs through March 15, would cut almost \$3 billion from education. For Texas alone, the cuts would total \$130.,557,869 for the six areas listed at the end of this article.


"This continuing resolution neither continues the level of investment we need in quality education nor resolves the vital question of how much assistance will go to local schools," U.S. Secretary of Education Richard W. Riley said. "Instead it leaves the parents and teachers in the dark and threatens massive reductions that would leave many of our schoolchildren out in the cold.

"These punishing and senseless cuts would set back the effort to improve teaching and learning in communities all across this country. That's wrong for children, wrong for families, and wrong for America.

# **FEMA Approves Aid** To Help Texas Fight 1996, at a Brownwood hospital. Graveside services were held at The Windy Fire

WASHINGTON-The Federal Emergency Management Agency (FEMA) reported today, March 7. that the uncontrolled Windy fire was added to the string of recent state blazes designated for assistance under the federal fire suppression grant

FEMA Director James Lee Witt said the state's request for the aid was granted early this morning immediately after it was reported that the fire was threatening two large ranches located in Wise County. The fire, which started on Wednesday, March 6, had burned more that 700 acres of land at the time of the request, according to the state.

The action brings to seven the number of Texas fires that have been authorized for FEMA fire suppression aid over the past two weeks. Under the authorizations, all eligible costs associated with fighting the designated fires are currently being funded at 70 percent federal share.

Fires previously approved for the funding were the Seven-One-Seven Complex fire in Stephens County (March 5); the Clyde fire in Callahan County (March 4); the Filibuster fire in Young County (March 3); the Bowie fire in Montague County (March 2); the Northwest Amarillo Complex fire in Potter County (February 26); and the North Texas Complex fire in Parker county (February 22).

In neighboring Oklahoma, three fires also have been declared for FEMA fire suppression aid since

February 23.

Federal fire suppression aid is provided through the President's Disaster Relief Fund and made available by FEMA to assist in fighting fires when they threaten to cause a major disaster. Eligible state firefighting costs covered by the aid can include expenses for field camps; equipment use, repair and replacement; tools, materials and supplies; and mobilization and demobilization activities.

George McDonald, Scottish poet and novelist, said: "The first thing a kindness deserves is acceptance; the second is transmission." Among Mr. McDonald's works is The Miracles of our Lord, and because of this I am inclined to believe that his short sermon on kindness came from his gleanings of Bible truths, especially the teachings of the Galilean.

Some people find it difficult to show kindness -- and some find it difficult to accept kindness showed them. The very teaching of "Be kind to one another," Ephesians 4:32, not only encourages us to be kind, but also to accept kindness at the hands of others. If we fail to accept kindness, we rob others of the opportunity to do good and the privilege of being Christ-like in doing so. Inherent in the admonition to "be kind to one another" is the necessity of ones to accept kindness -- then to pass it

Notice the "fruit of the Spirit," Galatians 5:22-23: love, joy, peace, longsuffering, kindness, goodness, faithfulness, gentleness, self-control. But the point George McDonald is stressing is that kindness accepted deserves a transmission -- a passing of it on to another (and not necessarily back to the one who showed kindness in the first place). Often it is good to reciprocate kindness, but the best policy is to be alert of someone needing kindness showed them -- and show it! Jesus was kind. He taught kindness, accepted kindness, and He passed kindness on to others. It would be very good for us to do the same, so put/keep KINDNESS on your acceptance list -- and on your giving list.

# LOCAL **FREE** TAX SERVICES

Through the Tax-Aide program, volunteers provide free personal income tax assistance to the Senior Citizens, low-income families and the general public with basic tax returns. Individuals with complicated tax returns will be advised to seek professional tax assistance.

Volunteers are specially trained, in cooperation with the U.S. Internal Revenue Service (IRS), to understand those provisions of the tax code that affect Senior Citizens as well as the low and middle income families. Tax-Aide volunteers provide personal, one-on-one assistance to help you complete your federal tax returns, including special rebate pro-

Tax-Aide volunteers are available from February 1 to April 15 each year. There will be only one volunteer working the Cross Plains area using the Multi-Purpose Center on East 8th Street as headquarters. Tax returns will be prepared by AP-POINTMENT ONLY so you will need to call the volunteer (Pauniece Oglesby, 817-725-6772) for an appointment. The volunteer in Cross Plains is Pauniece Oglesby. Mrs. Oglesby prefers to volunteer on Tuesday, but will make appointments on other days if necessary.

When you meet with a Tax-Aide volunteer, you should bring the following: (1) a copy of last year's (1994) income tax return, (2) any W-2 forms you have received showing your income from working, (3) all 1099 forms you have received which show the interest and/or dividends, (4) all 1099-R forms which show all pension monies paid to you, (5) form SSA-1099 which shows the Social Security paid to you, (6) records of any other income you have received, and (7) receipts or cancelled checks for any of your medical/dental expenses and any contributions you have made to charities.

This is a community service available to those stated above the Tax-Aide volunteers are eager to be of assistance, so please call for an appointment and let me assist you.

# **Texas Department Of Licensing & Regulation News and Information**

AUSTIN—The Texas Department of Licensing and Regulation (TDLR) has issued hundreds of enforcement letters to air-conditioning contractors throughout the state alerting them that continued operation without liability insurance, or current proof of liability insurance, will cost them an administrative penalty and may cost them their license to operate in Texas.

State law requires that air-conditioning contractors be licensed to do business in Texas. In addition to being required to have so many years of experience and passing a written exam, a contractor must carry certain amounts of liability insurance to protect the consumer against property damage, personal injury, and uncompleted work.

"The liability insurance requirement is the biggest consumer protection element to the air-conditioning contractor law," comments Pauline Denson, TDLR consumer

A Class B licensed contractor, which is the minimum license required for contractors working on residential systems, must carry at least \$100,000 per occurrence (combined for property damage and bodily injury), \$100,000 aggregate, and \$100,000 completed operations.

The enforcement letter states that a contractor who has not maintained insurance, and has not shown proof of insurance, will be charged with both violations for each year they have not provided a certificate. This could result in up to a \$2,000 administrative penalty for each year, and a possible hearing to revoke their license.

Consumers can contact TDLR to determine if there are any pending complaints against a contractor and if they have a current license and certificate of insurance. Denson warns against doing business with an unlicensed contractor; the time to check

is before the consumer does business with the contractor.

#### **Special Tax Credit For** Low-Income Familes

The EIC (Earned Income Credit) is a special credit for certain workers. It reduces tax you owe, and it may give you a refund even if you don't owe

To be eligible for the credit, you must meet the following situations: (1) Have a qualifying child under 18 years of age or 21 and a full time

(2) And your taxable income is less than \$24,350 for one child and \$26,650 for two or more children.

(3) If you don't have a qualifying child and yo (or your spouse if filing a joint return) is at least 25 years old but under age 65 at the end of 1994. (4) You cannot be claimed as a

dependent on another claim. (5) And you lived in the United States more than half of 1994.

(6) Your taxable earned income is

less than \$9,000.

This year there is a EIC available for taxpayers without children if you meet the guidelines stated above.

The credit can be as much as \$314 if you don't have a qualifying child. If you have a qualifying child, the credit can be as much as \$2,094, and \$3,110 with two or more qualifying children.

The Earned Income Credit was provided to give low-income parents an extra incentive for working and staying off welfare rolls.

Earned Income Credit is the only credit that is refundable. That means it can go to a family whose income is so low that it owes no tax but can receive a refund check of up to \$3,110.

# **Texas Businesses Have April** 15 Deadline For Filing **Property Tax Renditions**

(AUSTIN) -- In accordance with state law, Texas businesses must render their property with county appraisal districts by April 15. To render is to list the taxable property that businesses owned or managed as of January 1, 1996.

"While state law requires business owners and operators to render, any property owner -- including homeowners, farmers and ranchers -- may render their property with county appraisal districts," State Comptroller John Sharp said.

"Property owners who render are in a better position to exercise their rights as taxpayers," Sharp noted. "They are ensuring that the appraisal district has their correct address so they will receive notices of any actions that affect their property or tax

If the tax collector cannot deliver a tax bill because of an incorrect or old address, the property owner is responsible for paying the taxes, plus late payment penalties, Sharp added.

State law requires anyone who owns or manages income-producing personal property on January 1 to render with the local appraisal district. An exception is a business that receives the freeport exemption for managing cotton stored in a ware-

"For example, businesses must report their inventories, furniture and fixtures, machinery and equipment and other tangible personal property by filing this annual report," Sharp said. "Appraisal districts use the reports to set business property values. When a business owner doesn't render his or her property, the chief appraiser estimates the value."

Sharp also announced that property owners who had property damaged by a storm, flood or fire last year may file a special decreased value report that could lower their final tax bills. Property owners may file the decreased value report about their property's condition on January 1,

Property owners may ask the chief appraiser for additional time -through April 30 -- if the owners can demonstrate good cause. The chief appraiser must grant owners of property regulated by the Public Utility Commission or the Railroad Commission an extension to April 30 to file the reports and may extend the deadline another 15 days if the owners request it in writing and show good cause.

On the renditions, property owners can record their opinions of their property's value. By stating their opinion, property owners make sure that the appraisal district sends them a notice before placing a higher value on their property. This notice allows property owners the time to gather information to protest the appraisal if they believe the appraisal district's value is too high.

If more than one appraisal district appraises a property, the property owner should render in each appraisal district office. Taxpayers may contact the county appraisal district office for the rendition forms, or they may call the Comptroller's property tax hotline at 1-800-252-9121.
