Phillips Brothers To Perform In "Dead Man's Walk" Sunday, May 12

Glen Dale and Howard Phillips will be background characters in Larry McMurtry's "Dead Man's Walk" which will air May 12, on ABC Sunday Night Movie. They may be seen as extras in various street scenes. Glen Dale is also the driver of a buggy which delivers characters to the hotel. The C.F. Ranch between Alpine and Fort Davis was the location for part of the filming. A town was constructed on the ranch replicating Austin in the

1800's. The Phillip brothers will be seen on horseback with a group of riders as they travel around a mountain on the Poor Farm Ranch located in Marfa. Other film shooting was completed at Lajitas and Van Horn. "Dead Man's Walk" is the prequel to "Lonesome Dove" which appeared as a television mini series several years ago. It recounts the story of Gus

McRae and Woodrow Call as young men when they first joined the Texas Rangers. David Arquette, Keith Carradine, F. Murray Abraham and other stars will be featured in the movie. Thrasher, Florida's First Heart Transplant Recipient Dies At 53

TAMPA—When his time was up, Tom Thrasher faced death with the courage he brought to life: He discontinued the drugs that kept his body from rejecting his transplanted heart. He asked his priest to deliver last rites. Then he said his good-byes.

More than 50 friends tramped past his hospital bed Sunday, including three transplant recipients who survived because of Thrasher.

"Tom approached death the way he approached everything. Head on. He didn't give up fighting. He just knew when the end was," said Emily Ortiz, who got her heart transplant in

1986 after Thrasher, then a stranger, donated \$25,000 toward her bills and guaranteed the balance.

Thrasher died Thursday, May 2, 1996, at Tampa General Hospital of kidney failure. He was 53. Memorial services were held Saturday in Tampa, Florida and funeral services and burial were held Tuesday, May 7, 1996, in Waco directed by Connelly-Compton Funeral Home.

He became the state's first successful heart transplant recipient in 1985 and started NOTE, National Organization for Transplant Enlightenment, to raise money and awareness to help transplant patients without insurance. He used his newfound celebrity to help other recipients with bills that can top \$200,000 and parachuted out of airplanes 27

times after his transplant to spotlight organ shortages.

"I couldn't stop him from doing it," said Dr. Michael Sweeney, who gave Thrasher his new heart on June 6, 1985. "Heart transplants just put you back in the vagaries of normal life. The heavens don't open up and protect you, and Tom was quick to understand that. He wanted to make the most of the time he had left."

In April 1985, Thrasher developed viral myocarditis, an infection that weakened his heart. Tampa General had just hired Sweeney from Houston to start the heart transplant program, but he wasn't due until July 1. The men met in Houston and talked of doing the operation in Tampa that summer.

"Tom had a little bit of a pioneer

spirit. He knew he was the first in Florida and that wasn't unattractive to him," Sweeney said.

But Thrasher's condition suddenly declined, and Sweeney was rushed in from a conference in Baltimore. Someone leaked word of the groundbreaking surgery, and the media clogged the Davis Islands bridge leading to Tampa General.

Chamber Submits Downtown Walkway Application

The Cross Plains Chamber of Commerce announced that it had completed and submitted an application for funding renovations and improvements to downtown walkways to the Texas Department of Transportation under the Statewide Transportation Enhancement Program. The Program is funded under the Intermodal Surface Transportation Act of 1991. Program guidelines provided for communities to submit applications to the state for funds needed for transportation projects which normally would not fall under district project funding. Approximately \$40 million of funding is currently available for funding in the state of Texas.

Cross Plains' downtown walkways are in a sad state of disrepair. The Chamber has been working for a couple of years on a project which has been named the Downtown Pedestrian Beautification and Scenic Preservation Project. The application that was submitted calls for total funding of \$289,800 to remove and replace broken and decayed concrete, add new retaining walls and pedestrian ramps/rails, preservation

of the historic "horse rings," and to add landscaping and benches for the three blocks on Main Street from 7th to 10th Streets. The Cross Plains Community will be required to match fund 20 percent of the project cost. Thanks to the City of Cross Plains and the Cross Plains Economic Development Corporation, the commitment for the match funding was made available.

The application was put together through an enormous amount of time and effort by a special committee of the Chamber. Julene Franke was Chairperson of the committee and other members included Rolan Jones, Susan Schaefer, Mike Cary, and Steve Mack. The Application was submitted to the District Office of the Texas Department of Transportation on May 1, 1996. The Application will go through a number of review processes before it will be known in late 1996 whether the project was selected for funding. The project selection will be a competitive process. A state panel appointed by the governor will provide final approval of applications from all over the state of Texas.

Thrasher

Sweeney, pumped up on coffee and no sleep, implanted a heart from a 19-year-old Hialeah man who had died of an aneurysm. Doctor and patient became friends. On New Year's Day 1986, they watched the Cotton Bowl at Thrasher's home in Carrollwood, two fellow Texans, hooting at the Aggies and reflecting on the year. "That's when he was thinking about starting NOTE," said Sweeney. "He knew he was not likely to live to 75." He wanted to make a difference. Friends said Thrasher was struck during his hospital stay by the number of heart disease patients without money for a transplant. He was president of a cable television installation company and was insured. He was lucky. "That's what drove him," said Ortiz, who administers fund-raising accounts for eight transplant recipients NOTE. "He was a well-to-do businessman. Not everyone is. What do poor people do who can't afford a transplant?" Thrasher attacked his life with new zeal. He remarried and is survived by his wife, Linda, their son Ronald, 5, and a daughter, Tyra, from a previous marriage; and his parents, Dick and Blanche Thrasher of Cross Plains. He played tennis and climbed the Stairmaster. He met former President George Bush as he campaigned for donor organ awareness. Last year, his kidneys began to fail. His heart had begun to deteriorate, and he wasn't eligible for a transplant. Thrasher was close to death in November when his daughter, Tyra, came to Tampa for Thanksgiving to announce her engagement. "She told him he had to stay alive to give her away," said his friend, Steve Millwee. The announcement gave him new will to survive. He flew to Irving, Texas, on April 6 and walked her down the aisle. He told friends it was his final act of love for his family. This week, 10 doctors and nurses came by his room in the last hours to tell him good-bye. In Houston, Sweeney heard the news with sorrow. He has transplanted hundreds of hearts since 1985, but Thrasher was among his favorite patients. "He was able to keep energy and perspective and optimism despite his troubles," he said. "Guys like Tom, those are really the heroes. They're the ones that have to look in the mirror each day and wonder a month from now if he'll still be here. That's heroic behavior to me. The fact that he was able to maintain his spirit."

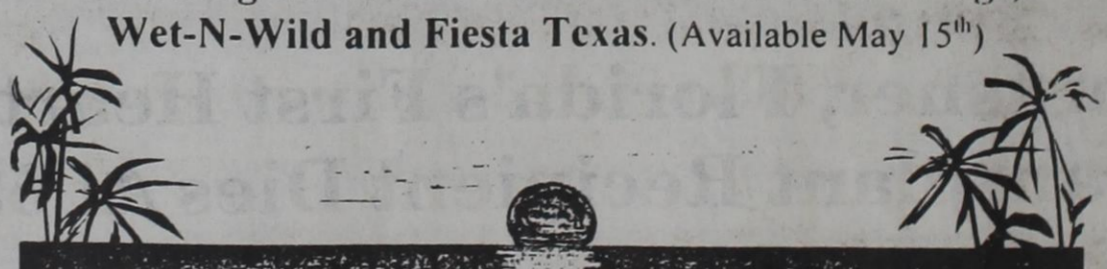

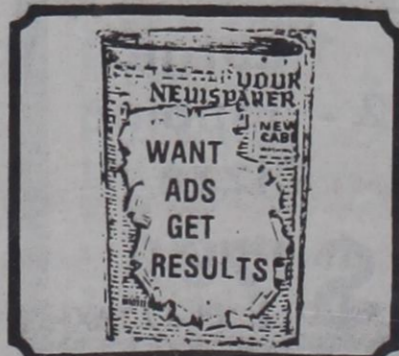

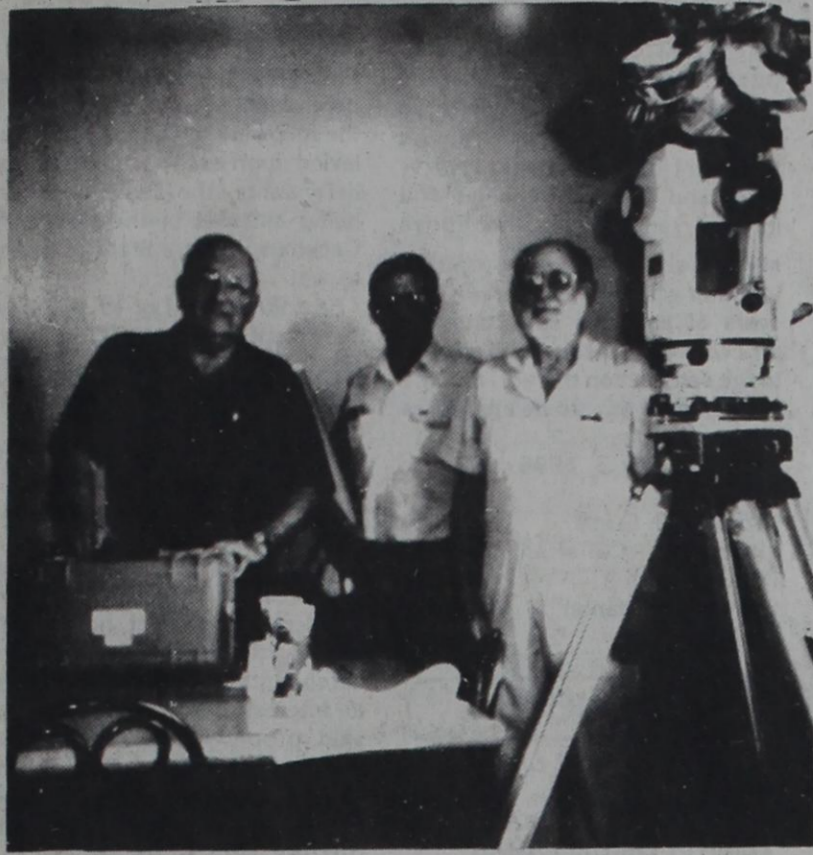

Rev. & Mrs. Billy Graham Receive Congressional Gold Medal

Billy and Ruth Graham received the Congressional Gold Medal on Thursday, May 2, in a ceremony in the Capitol Rotunda. I was privileged to join with my colleagues in this tribute. My wife Cindy and I attended the Gold Medal Banquet that evening to honor these two very special people who have contributed so much to family and faith.

The Congressional Gold Medal is regarded as a means of expressing public gratitude, through the Congress, for distinguished contributions to American society. George Washington received the first medal in 1794, and the Grahams are only the second husband and wife team to receive this honor.

The award was used by the Grahams as an occasion to focus on the Ruth and Billy Graham Children's Health Center in Asheville, North Carolina. This center will offer preventative and educational health services to children in the Southern Appalachians, and will cover a 10,000 square mile area.

Gasoline Price Increases

There has been much discussion and understandable concern in Washington, Texas and around the nation about recent gasoline price increases. There are several reasons for the increases, which appear to be the result of market forces.

The coldest winter in years caused much of the oil supply to be used up; with fuel supplies low, prices went

up. Refineries were busy processing large amounts of heating oil well into the spring and delayed production of gasoline. The world oil market has also been jittery about what will happen if Iraq is allowed to release \$2 billion worth of oil in the international marketplace.

President Clinton has called for investigations by the Department of Energy and Justice Department. He has also ordered the sale of 12 million barrels of oil from the Strategic Oil Reserve. Our nation consumes 17 million barrels per day, so I am not sure this will have any significant impact. Frankly, I am reluctant to see these reserves drawn down; their purpose is to be a reserve in times of national emergency.

There have been calls to repeal the 4.3 cent gasoline tax passed in 1993. My opposition to that tax increase caused me to vote against the final version of the 1993 budget. Repeal of this tax would cost the federal budget \$30 billion over the next six years. Replacing that revenue must be considered in the overall budget.

I think it is encouraging that some of our independent oil and gas producers are interested in doing some drilling again. We as a nation should be doing everything we can to develop our remaining oil and gas reserves.

Among the groups from Texas visiting Washington this past week were the Farm Credit Bank of Texas, Texas Associated Builders and Contractors, Texas Rural Water Association, Texas Ag Extension Agents, and the Texas Association of Realtors.

Commissioners Approve Sale Of County Owned Land

Callahan County Commissioners, meeting in a regular commissioner's court meeting Monday, April 22, voted to sell one and one-half acres of county owned land in the Cottonwood area of the county.

Callahan County Judge Bill Johnson said back in the 1850's the land, north of the Cottonwood area on Turkey Creek, was given to the county for use as a school. However, Judge Johnson said no school was ever built and no improvements were made to the property.

Johnson said Butch Nelson recently purchased a parcel of land from Ray Faircloth which joins the county owned property.

Commissioners voted to sell the one and one-half acre of land to Nelson at the same per acre price he paid for the adjoining property.

Other items brought before commissioners included:

—Commissioners voted to reappoint board members to the MHMR Board of Trustees. The reappointed board members all reside in Abilene.

—Commissioners voted to grant the Cross Plains Housing Authority a tax waiver for the 1996 fiscal year.

—Commissioners reviewed and signed the minutes of the previous commissioners meeting and to pay all approved bills.

Gov. Bush, TDCJ Announce Beginning Of An Automated Crime Victim Notification Program For Texas

AUSTIN — Governor George W. Bush and the Texas Department of Criminal Justice will operate the program.

Governor Bush and Chairman Polunsky announced the new program as part of their recognition of Texas Crime Victim's Rights Week, April 21-27. The program should help authorities implement requirement of a new 1995 law approved by the Texas Legislature and signed by Governor Bush. It requires authorities to notify all victims of family violence and stalking when their offender posts bail or is released.

"This system will allow frightened victims of rape, domestic violence or other violent crimes to know instantly that the criminal who victimized them is behind bars and know exactly where he or she is located," said the Governor. "Many crime victims have told me that knowing the whereabouts of the criminals who attacked them is important to their peace of mind and ability to live normal lives," said Governor Bush.

The TDCJ will seek bids for a state-of-the-art notification system which will make the Texas inmate database accessible to citizens 24 hours a day through a toll-free number. The program will also automatically notify victims of domestic or stalking by telephone when the perpetrator is released. Start up costs will be funded through a grant from the Governor's Criminal Justice Division (CJD) and

the Texas Department of Criminal Justice will operate the program.

Governor Bush and Chairman Polunsky announced the new program as part of their recognition of Texas Crime Victim's Rights Week, April 21-27. The program should help authorities implement requirement of a new 1995 law approved by the Texas Legislature and signed by Governor Bush. It requires authorities to notify all victims of family violence and stalking when their offender posts bail or is released. The Tarrant County Sheriff's Department has installed a computerized notification system called Victim Information and Notification Everyday (VINE) to conduct the require notifications.

The TDCJ currently maintains a "1-800" number for those victims seeking to learn the status of their offenders. In addition, victims are notified by mail when the status of their offender changes. The new system should increase the number of crime victims served by the program and provide unsolicited telephone notification of status change. The Governor's Criminal Justice Division has budgeted approximately \$30,000 in State Criminal Justice Planning grant funds to help start the automated notification program.

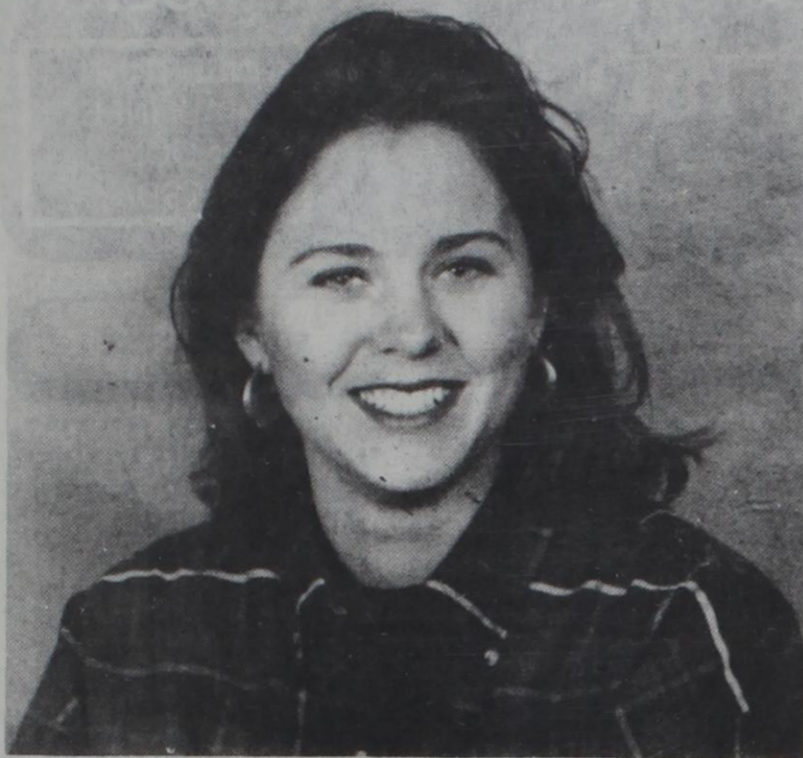

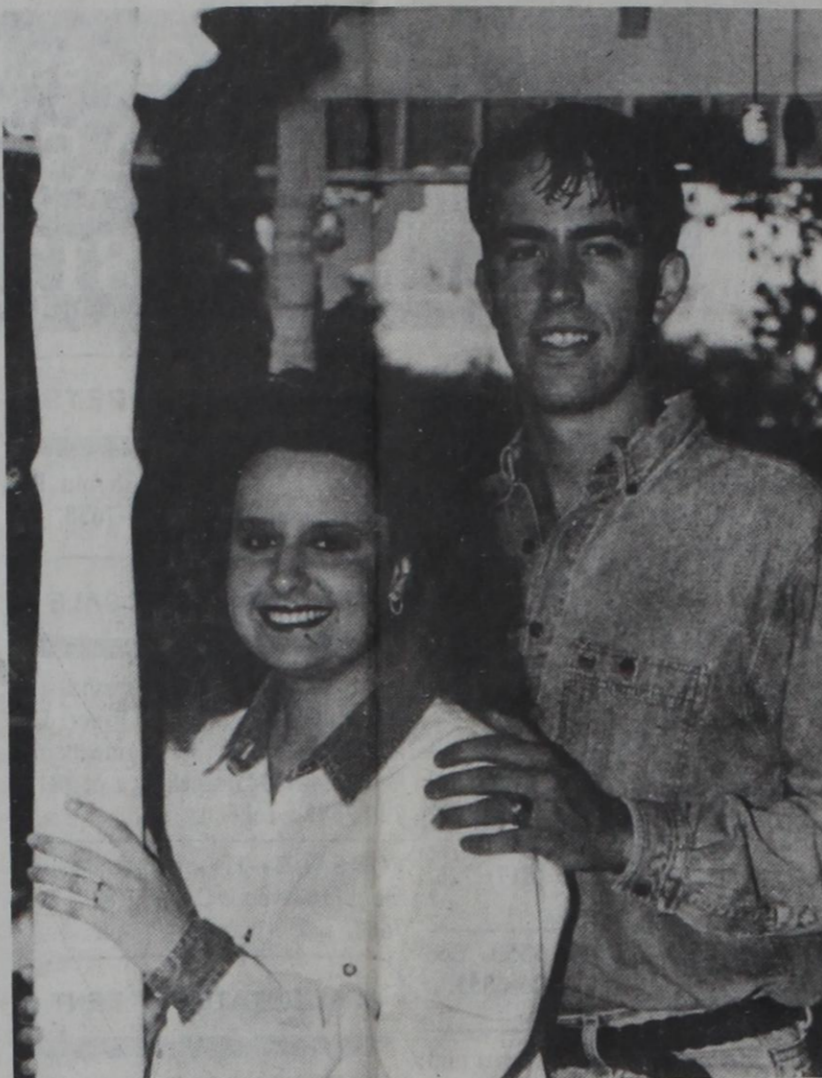

Disaster Counties Named

WASHINGTON, D.C. -- Jones County, Texas has been designated a primary disaster area by the drought and high winds that occurred from January 1, 1995 through February 5, 1996, according to Congressman Charles Stenholm.

"After reviewing the Damage Assessment Report, and the information submitted by the Farm Service Agency (FSA) office in Texas, Jones County sustained sufficient production losses to warrant a Secretarial disaster designation," said Stenholm.

In keeping with the provisions contained within the Consolidated Farm and Rural Development Act, the following counties were designated as contiguous disaster counties: Callahan, Fisher, Haskell, Nolan, Shackelford, Stonewall, and Taylor.

Family-sized farm operators in both primary and contiguous counties will now be eligible to be considered for low-interest emergency loans from FSA. Applications will each be considered on their own merit, taking into account the extent of losses, security available, repayment ability, and other eligibility requirements.
