Tom Melton is always bringing in clippings to the *Review* and he found one concerning Communist Rules for Revolution. The article in its completion is as follows.

She Finds A Reminder On Marxist Rules For Conquest

Editor, Avalanche-Journal:
In going through some clippings the other day, I ran across the following and think it worth printing for everyone to see. It was entitled:
"51 Years Ago"

The following excerpt from a file on "Communist Rules for Revolution" was obtained by the Armed Forces in Dusseldorf in May, 1919. It might explain some of today's happenings:

1. Corrupt the young; get them away from religion. Get them interested in sex. Make them superficial; destroy their ruggedness.
2. Get control of all means of publicity and thereby:
3. Get people's minds off their government by focusing their attention on athletics, sexy books, and plays and other trivialities.
4. Divide the people into hostile groups by constantly harping on controversial matters of no importance.
5. Destroy the people's faith in their natural leaders by holding the latter up to contempt, ridicule and obloquy.
6. Always preach true democracy, but seize power as fast and as ruthless as possible.
7. By encouraging government extravagances, destroy its credit. Produce fear of inflation with rising prices and generous discount.
8. Ferment (sic) unnecessary strikes in vital industries, encourage civil disorders, and foster a lenient and soft attitude on the part of government toward such disorders.
9. By specious argument cause the breakdown of the old moral virtues, honesty, sobriety, continence, faith in the pledged word...
10. Cause the registration of all firearms on some pretext with the view of confiscation of them and leaving the population helpless.

The above was printed in the Bartlesville Examiner-Enterprise in 1919. Does there seem to be a parallel of thought here in the present trend of action and events?

It is now 60 years later instead of 51 and all this coming to pass right on schedule. I think it was Stalin who said the Russians would take us without firing a shot. What do you think?

Volunteer Fire Department Announces New Officers

The Cross Plains Volunteer Fire Department elected new officers for 1988 last week. Mike McClure, Jr., was chosen Fire Chief. McClure served as Rural Chief for the past three years.

Assistant Chief-Rex Beggs, Secretary-Treasurer-Alvin Hutchins,

Rural Chief-Jimmy McNutt, and Fire Marshall-James Oscar Koenig were all elected.

The number of fire calls this year have increased 50 percent with a total of 107 calls to date. There have been 66 grass and brush related fires fought. Many involved 100 acres or

more.

The largest fire the department has helped with was on the edge of Callahan County moving into Coleman County with over 2,000 acres burning. Up to 19 fire departments assisted with this incident.

During the past year 13 structure fires, 8 oil or gas related fires; and 13 wrecks were acted upon.

The Jaws of Life has been used in 5 rescue situations, and 6 weather watches were engaged. The Cross Plains Volunteer Fire Department has been busy, especially with the extremely dry conditions that exist.

Must Register To Vote By February 5

Persons who are not currently registered to vote and are interested in voting in the March 8 "Super Tuesday" primaries should plan to register by Friday, February 5.

Employees at the Callahan County Tax Office in the courthouse recently mailed out new voter registration cards to all people currently registered to vote in Callahan County. The new cards are white, and should be signed and kept by the voter, according to tax assessor/collector Wauneta Estes.

"Some people have signed the cards and mistakenly returned them to our office," she said. "The white cards are simply a new form used by the state, and must be used when voting in the March primaries."

"We've had lots of cards returned that we mailed simply because many people have moved and no longer live here," said Ms. Estes.

"Even though it is a madhouse right now, this should clear up the records. We will report all changes to the state, and the state roll should be brought up-to-date," Estes added.

Estes advises any county resident with an error on his voter registration card to bring the card to the tax office in the courthouse and corrections will be made. She advises all voters to check their name and address, as well as their precinct number. Ms. Estes added that county residents that have moved from one address to another within the county, will not have their

voter registration cards forwarded to them. Those voters can also come to the courthouse in Baird to receive the voting card.

For those not registered to vote, persons must be 18 years of age or older and must be a U.S. citizen. County residency is also a requirement.

Applicants must have not been declared mentally incompetent or convicted of a felony offense in order to be eligible to vote.

Several local races are being contested in the March Democratic Primary, that county residents should be interested in.

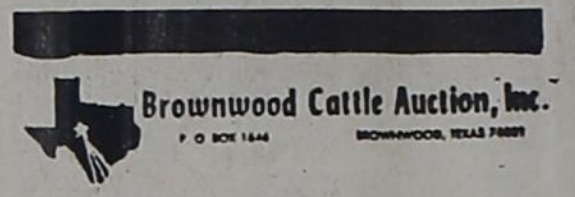
Mrs. Jewel Foster's daughter-in-law, Fern, is at home and is improving. Jewel said they had good attendance at the quilting last week.

Orders For Windbreak Trees Still Being Accepted

"The Callahan Soil and Water Conservation District will be accepting orders for windbreak trees for the next month," says Tony Baeza, Range Conservationist for the Soil Conservation Service in Baird. "Due to an increasing interest in windbreaks, trees are in short supply and anyone interested in ordering windbreak trees should order them as soon as possible to assure they get what they want."

Evergreens which are presently available are Afghanistan pine, Austrian pine, Eastern Redcedar, Arizona cypress, Ponderosa pine, and Arborvitae. These trees are available in various sizes and prices.

"Afghanistan pines are the fastest growing windbreak trees and are well adapted to this area. If properly watered and fertilized, trees may grow from 3-4 feet each year," Baeza said. Baeza also added that the younger a tree is planted, the less of a shock it will experience. This will result in a healthier and faster growing tree in the long run.

In addition to evergreens, barerooted hardwoods are available. These hardwoods not only make good windbreaks, but also provide food for wildlife. Hardwoods which are presently available are green ash, honeylocust, desert willow, Russian olive, little walnut, bois d'Arc, and bur oak.

For more information on windbreak trees, contact the Soil Conservation Service in Baird, or a member of the Callahan Divide Soil and Water Conservation District.

According to the American Cancer Society, one out of ten women in the United States will develop breast cancer sometime in her lifetime. It is currently estimated that over 37,000 women die each year as the result of breast cancer.

Ninety percent of breast cancers are diagnosed by women or their physicians finding a lump in the breast. Women who are diagnosed with a lump large enough to feel have a 50 percent five year survival rate. A woman who is diagnosed as having breast cancer by mammography, before a lump can be felt, has a 97% five year survival rate and a 90% 10 year survival rate.

The American Cancer Society has established guidelines for mammography in asymptomatic women. (Women who have no symptoms of disease). Those guidelines have been adopted by the American Academy of Family Physicians, American College of Obstetricians and Gynecologists, and The American College of Radiology. Those guidelines are:

I. 35-40 years of age - One baseline mammogram.

II. 40-50 years of age - A mammogram every 1-2 years depending on breast type and risk factor.

III. 50 years of age and over - An annual physical examination and annual mammogram.

IV. Asymptomatic women under 50 years of age with

significant high risk factors should be examined at appropriate intervals. These risk factors include previous breast cancer and family history of cancer.

V. A symptomatic woman should have a mammogram at any age when she experiences a mass, nipple discharge, skin changes or unexplained breast pain.

A screening mammogram is an x-ray of the breast using extremely low dosages of radiation (usually comparable to dental x-rays) and is designed to find very early cancers.

A female technologist who is highly trained in mammography will perform the examination.

How To Become An Ombudsman

Many members of a great generation live in our community nursing homes. They fought in World War I, or kept the home fires burning for their warriors. Many remember their first ride in an automobile or when electricity first entered their homes.

They have witnessed a great expanse of change and progress in the world. They have gone from riding horseback to seeing a man walk on the moon. Now they view the world from their nursing home rooms.

They gave fully to life and now they deserve our attention. Nursing home residents can benefit from your concern and watchful eye. As nursing homes come under the close scrutiny of state inspectors and are occasionally found to be lacking in quality care, nursing home visitation takes on an added dimension.

The West Central Texas Council of Governments Ombudsman Task Force is a volunteer group of individuals who currently give a few hours a month to visit in local nursing homes. Ombudsmen are trained advocates for nursing home residents and their families. They are trained by the Texas Department on Aging in conjunction with the Texas Department of Health. 'Enlightened' Legislation

I've said it before, but it bears repeating, especially now.

When our "esteemed" State Legislature goes into session, we're in danger.

To small business people over the state, that's becoming evident again in early 1988 as some of the "enlightened" legislation they concocted in the last session goes into effect.

What this unaugust body did in last year's special session to bail the state out of its funding problems should make us all run for cover.

First, after spouting off how they were going to cut spending, they passed the biggest tax increase in the state's history. All this time, Governor Bill was sounding like John Wayne and saying he wouldn't allow such a thing. Then he sounded more like Peewee Herman when he changed his tune and okayed the tax hike.

But if this wasn't bad enough, our "lawmakers" sneaked in a bunch of hidden taxes and fees aimed directly at the segment which could least afford them—the business community.

Most likely intentionally, little publicity was put out about these hidden taxes and fees until now and then, BANG, here they are, in place and ready to go.

For instance:

—Every business that collects the sales tax for the state, cities and other entities now has to pay the state \$25 a year for the "privilege" of doing so. Now if that's not a deal. How would you like to have somebody go out and collect your fees for you and then turn around and pay you \$25 a year to do it?

—Service station owners found out recently that they now have to pay \$25 a year for each underground tank they have. With this revelation came no explanation as to why they had to do it, just that they had to. That's all the folks in that cut-throat business needed, another expense.

—In a story in Tuesday's *Abilene Reporter-News*, Mary Scott Nabers, commissioner of the Texas Employment Commission, informed us that state unemployment insurance rates (it should be called a tax rather than insurance) are going up something like 270 per cent for, get this, employers with the best records (no claims or few). At the same time, employers with the worst records (most claims) had their rates jumped only 90 per cent. The story didn't say why, but it's obvious—there are many more businesses with good records than with bad, so by raising these good-record businesses more, it's just that much more money for the state.

And all this at a time when business activity in the Great State of Texas is at an all-time low (look at the number of bank failures in the state last year and tell me that's not true).

Come on, legislators, give us a break!

Child Care: Fast Becoming Everyone's Problem

Dear Readers: Your local Texas Employment Commission office is the site of the newly created Child Care Resource Clearinghouse — a resource and referral service for individuals needing child care.

The Clearinghouse was established by the 70th Texas Legislature as a result of efforts by the Texas Working Group on Child Care. The decision was made to house the service in TEC local offices because that is where the information would be immediately available to those looking for work.

Every local TEC office now has one placement interviewer designated to provide a list of agencies that make direct referrals to day care providers. The

TEC itself cannot make direct referrals.

Employers should know that there will soon be a publication for them on child care options which will include technical assistance in setting up model programs for employees. Employers are beginning to realize that child care problems relate

directly to absenteeism and productivity loss in their own business.

The Clearinghouse is only a beginning, but it is a much needed beginning in an area which has been neglected for too long.

the big gainer in recent weeks, moving from about eight percent to 17 percent.

Gary Hart still leads Democrats with 28 percent, while among Republicans, Vice President George Bush leads Robert Dole 55 percent to 24 percent.

As explained by a well-respected Black leader in Texas, some Southern Democrats who fear Jackson could not win nationally were spurred to rally around a more acceptable candidate, and Gore is the recipient of that activity.

Jackson's supporters are not upset. In fact, they are encouraged by the role he is playing.

With Jackson playing more to the mainstream, his role as a broker, perhaps kingmaker, appears to be expanding.

Jackson, a minister, also scored the highest negative rating, 19 percent. So did TV evangelist Pat Robertson, 21 percent, on the Republican side.

Texas Land Commissioner Garry Mauro is offering 357 tracts of land for public bid sale with 95 percent financing by the Texas Veterans Land Board for both veterans and non-veterans.

Bids will be opened Feb. 23. Mauro has a toll-free line for inquiries: 1-800-292-VETS.

All the tracts up for public auction were forfeited by veterans under the loan program.

On the down side for Mauro, his name was forged on bank notes totaling \$5.5 million and used for land deals, according to a handwriting expert.

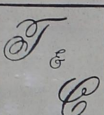
