'Star Gazing'

How long has it been since you have really looked at the sky at night in search of constellations? For most of us, we live at such a fast pace, we simply ignore the beauty around us in our efforts to make it to one more function.

I recall watching the stars when I was a child. Back then, people still slept outside in their yards, at least in the country. The main objective was to be cooler, but it also was a great opportunity to do some star gazing.

My grandparents, Ethel and the late Almer Anderson, always slept outside in the summer and I thought it was neat. Granddad could tell you all the constellations and he fascinated me with his knowledge.

However, I do remember the night Granny shot a rattlesnake at the head of the bed, while Granddad was still laying there. Seems the snake was just after the kittens playing in the bed springs, but that was a little too close for comfort. It also ended my desire to sleep in the yard.

On the nights of October 18, 19, 20, and 21 the availability of viewing many constellations was exceptional. Leah had been studying about the stars under Kim Childers, local science teacher, and everyone was fired up about locating the formations.

On three nights we drove out into the country, away from the lights, and looked at the stars. We were able to find the Pleiades star cluster (sometimes known as the Seven Sisters), the Big Dipper, the Little Dipper, the Milky Way, Altair, Great Square of Pegasus, and the Polaris (North Star).

The planet Mars could be seen all night because it had risen 2 1/2 hours after sunset. It is easy to find because of its bright, orange-red color.

These particular days were noted for meteorite showers. This is simply falling stars and we did witness many. One of the best places we found was at Caddo Peak, but the cold, dusty winds kept us from looking for very long.

With the aid of binoculars you could close-in on some of the constellations, but not like a telescope. Even if we didn't find them all, we had a great time looking and it was kind of an adventure.

The eerie wind blowing at Caddo Peak and it nearing Halloween created a spooky atmosphere. I was teasing about the Caddo Critter and Leah started scratching on the interior of the door and I almost missed a curve. Guess you know who was scared now!

Refuge Service Rates Increase Effective October

At October's regular City Council meeting, BFI, local trash contractor, asked the city to consider the annual rate review for trash service. Normal consideration time is January and the increase or decrease will correspond with the Consumer Price Index (CPI).

BFI asked for a 6% rate increase effective immediately. BFI spokesman, Len Lyons, informed City Manager, Debbie Gosnell, that the expected CPI rate could be much higher in January than the 6% asked for by the trash company. He stated that the rate would not go up in January if the index was higher, however, if the index should be lower than the 6%, the trash company will lower its rate to correspond with the decrease.

The increase will amount to an increase in residential rates in the amount of 53 cents, making residential rates \$9.28. Business customers may figure their monthly rate by adding 6% to their normal charge.

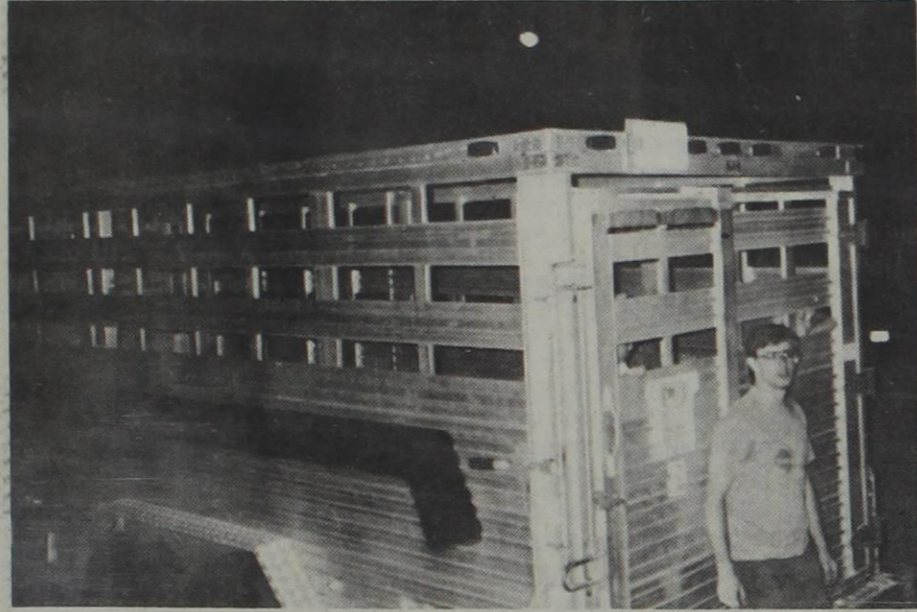

No Antlerless Deer Permits Required For Callahan County

Texas Parks and Wildlife Department's Wildlife Technician Trey Carpenter, reminds landowners and hunters that no antlerless deer permits will be required for taking antlerless deer in Callahan County for the 1990-1991 regular deer season. Antlerless deer taken in Callahan County will only require being tagged with the appropriate tag from the hunter's valid hunting license.

Please refer to the 1990-1991 Texas Hunting Guide for all season's bag limits, and means and methods of taking animals. The regular gun season for white-tailed deer is November 3, 1990 through January 6, 1991, with a bag of 1 Buck and 2 Antlerless in Callahan County.

Deer populations vary from area to area and ranch to ranch. The either-sex regulations allows more flexibility in regulations to enable the landowner

to harvest deer on his property at the proper rate. It does not necessarily mean that a heavy harvest of antlerless deer is needed. Recommended harvest rates for bucks and antlerless deer provided by the Texas Parks and Wildlife Department should be used as a guideline for harvesting deer in Callahan County.

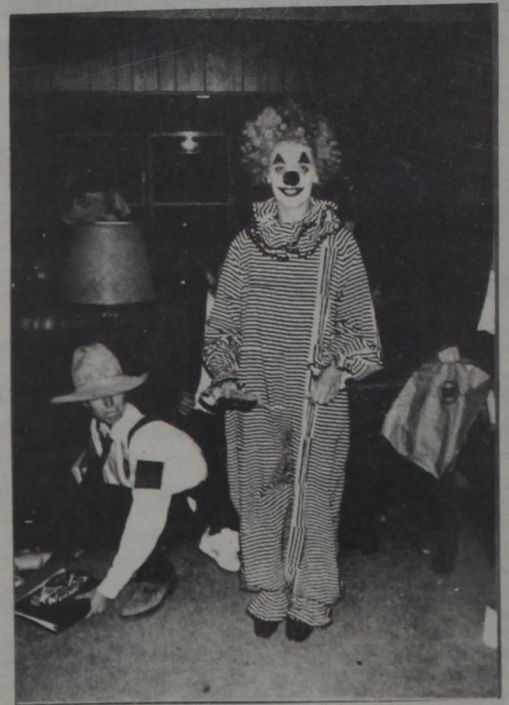

Nell Fleming reported that she and Joe visited with JoVeda and Bill Watson at Byrd's Store Sunday afternoon and had supper with them.

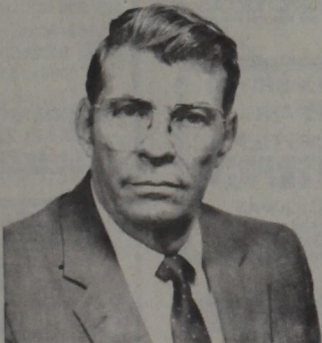
