### Highway Department Says No To Political Signs On Right-Of-Way

Political campaign signs may be beautiful to candidates and their supporters, but they're litter to the highway department. The highway beautification act prohibits most campaign signs within sight of the main lanes of any federally funded highway in Texas. Safety rules ban the signs from all highway rights-of-way in the state.

Campaign signs, like any advertisement, can be posted on private property if they are licensed and permitted under current billboard guidelines. However, most campaign signs don't qualify.

Signs are allowed on private property along farm-to-market roads and other state-funded roadways as long as they can't be seen from federally funded roads and don't violate local laws against such signs.

"We have two very legitimate concerns regarding these campaign signs," said highway department Engineer-Director Arnold Oliver. "Safety concerns and litter control laws dictate that we keep the rights-of-way free of clutter, whether it's for political candidates, real estate companies or anyone displaying advertising on the highways."

## City Council Changes Decision On Senior Citizens Center

September 13, 1990

There was a special called meeting of the Cross Plains City Council. Members present were Donald Beeler, Ted McKeehan, Betty Lewis, Edwin Weiss, Leon Nixon, and Mayor Ross Gerking.

The meeting was called to order at 7 p.m.

After lengthy discussion of the financial position of the Senior Citizens Center and Callahan County Nutrition Project, the Council was in unanimous agreement to pay the

utilities for the Center. The Council felt that the Center should not be penalized because the board members representing Cross Plains had not kept the Council informed as to the current position of the Project. Therefore, Councilman Donald Beeler moved to fund the Center for their utilities as well as the \$4,000 previously funded. Leon Nixon seconded. Motion carried unanimously.

Donald Beeler moved to adjourn. Betty Lewis seconded and motion carried.

## Cross Plains Sales Tax Payments Higher

The City of Cross Plains is reporting 1990 one percent city sales tax payments running 7.88 percent higher than the 1989 payments of the tax. Cross Plains 1990 sales tax payments have amounted to \$36,692.39, while the 1989 sales tax rebates were \$34,011.10.

The city's monthly sales tax check for August 1990 was 22.18 percent higher than the August 1989 check, Bullock reported. Cross Plains' August 1990 check was \$3,146.01, while the August 1989 check amounted to \$2,574.99.

### Library Rummage, Bake N' Book Sale October 4-6

The Library Rummage, Bake N' Book Sale is just around the corner — October 4, 5, 6 to be exact. Donations are coming in, but there is a need for a whole lot more. The expenses of running a library are going up and up just like they are in the average home. Therefore, the sale organizers are hoping to clear over \$1,000 this year.

The success of this annual benefit sale has always depended on the cooperation of many, many people. People who have a few items worth selling, but not enough to conduct their own sale, have always found satisfaction in helping the local facility. Several people have donated items left from estate sales. And many very special folks would rather just give all their good, usable items to benefit the library rather than having their own sale.

The Friends of the Library are once again looking forward to the community coming forth to help keep the facility going and growing. The sale this year is being held in the building formerly occupied by the Slim Gym next door to the library.

As in the past, the Friends will offer free coffee to the United Fund workers after they have finished their rounds on Friday A.M. The Bake Sale will be held in the library on Saturday.

Retail sales in the City of Clyde this year are continuing to run seven percent behind last year, according to sales tax figures released by State Comptroller Bob Bullock on Thursday, September 6.

Bullock said that during the payment period in August 1990, payment of the city one percent sales tax were 10.85 percent lower than in August 1989. The payment to the City of Clyde in August 1990 amounted to \$4,597.97, while the August 1989 payment to the city was \$5,157.79.

Bullock reported that sales tax payments to the City of Clyde so far in 1990 have amounted to \$59,981.94, a 7.33 percent decrease from last year. The 1989 sales tax payments to the city to date were \$64,725.53.

According to Bullock's report, almost half of all retail sales in Callahan County still occur in the City of Clyde. Of the \$129,845.39 collected in the one percent sales tax in the county, \$59,981.94 occurred in Clyde.

Other Callahan County towns reporting sales tax payments include:

— The City of Baird reported that sales tax payments in 1990 are 2.22 percent higher than the 1989 payments. The city had received \$26,312.15 so far in 1990, while the 1989 tax payments to the city were \$25,739.83.

The town's monthly payment for August 1990 was 6.58 percent lower than the August 1989 payment, according to Bullock. The August 1990 check to the city was \$1,490.30, while the August 1989 payment to Baird was \$1,630.63.

— The City of Putnam is reporting 1990 city sales tax payments amounting to \$6,858.91 so far, a 2.36 percent decrease from tax payments to the city in 1989. The 1989 checks to Putnam amounted to \$7,024.98.

Putnam's August 1990 tax rebate amounted to \$686.89, while the August 1989 payment was \$674.55, a 1.83 percent increase in tax payment from a year ago.

Countywide sales tax payments for 1990 in Callahan County are running 1.26 percent lower than the 1989 payments to the county. Callahan County has received sales tax payments in 1990 amounting to \$129,845.39, while the 1989

## State Sales And Use Tax Reported

The state sales and use tax analysis for Callahan County has been reported for the first quarter of 1990 by State Comptroller Bob Bullock's office.

Bullock reported gross sales, for all industries in Callahan County, for the first quarter of 1990 at \$10,965,702, which is two-tenths of one percent higher than the gross sales of \$10,943,024 reported during the first quarter of 1989. Gross sales is the total amount of all sales, leases and rentals of tangible personal property and all labor and service charges made during the reporting period.

Use tax purchases for the first quarter of 1990 for all industries in Callahan County amounted to \$133,001. Use tax purchases are the cost of all taxable items removed from inventory for personal or business use and all purchases on which no Texas sales tax was paid or use tax accrued.

The amount subject to state sales and use tax in the first quarter of 1990 in Callahan County was \$4,129,331. The amount subject to state sales and use tax is calculated by taking taxable sales and adding use tax purchases.

The number of individual business locations in Callahan County with a sales and use tax permit who filed a return is 230.

The gross sales for the retail trade division in Callahan County for the first quarter of 1990 was \$7,466,225, which is 5.9 percent higher than the 1989 first quarter gross sales of \$7,050,312.

The use tax purchases for the retail trade division in Callahan County for the first quarter of 1990 was \$4,803.

The amount subject to state sales and use tax for the first quarter of 1990 was \$2,891,337 for the retail trade division in Callahan County.

The number of reporting outlets in the retail trade division in Callahan County is 123.

payments to the county totalled \$131,501.44.

Some area towns reporting sales tax payments for the month of August 1990 and whether it's an increase or decrease over August 1989 sales includes: Albany, \$4,433.35, 22.39 percent decrease from August 1989; Anson, \$3,808.29, 1.55 percent increase from 1989; Cisco, \$6,880.54, 18.23 percent decrease from 1989; Eastland, \$22,139.76, 5.36 percent increase from 1989; Merkel, \$4,415.03, 50.24 percent increase from 1989; Ballinger, \$21,472.43, 78.25 percent increase from 1989; Haskell, \$8,707.83, 13.13 percent decrease from 1989; and Stamford, \$15,744.24, 10.18 percent increase from 1989.

For the month of August 1990, countywide sales tax payments are 0.83 percent lower than tax payments made in August 1989. Callahan County's total payments in August 1990 were \$9,954.17, while August 1989 payments were \$10,037.96.

Statewide, sales tax payments in 1990 are 8.29 percent ahead of 1989 rebates, according to Bullock's figures. The state has sent out check's totalling \$840,112,960.69 in 1990, while the 1989 payments to the state's cities were \$775,800,562.31.

For the month of August 1990, sales tax payments are running 5.42 percent ahead of August 1989 checks. The state sent out checks amounting to \$76,450,202.85 in August 1990, while the August 1989 payments amounted to \$72,519,174.39.

Comptroller Bullock said Monday, September 10, that his office sent checks totaling \$84 million in monthly local sales tax rebates to cities and counties in Texas.

"Merchants reported healthy sales statewide so the sales tax money they collected shows a good increase over last year," Bullock said.

Merchants collect the state and local sales tax and send it to the Comptroller's office with their tax returns. The state keeps its 6 percent share and returns the local one percent sales tax each month to local governments. Cities and counties may levy a combined tax of up to two percent above the state's sales tax, however all Callahan County town's only levy a one percent city sales tax, Bullock said.

This month's checks reflect taxes collected on July sales and reported in August by businesses filing monthly tax returns.

Merchants collect the state and local sales taxes and send them to the Comptroller's office with their tax returns. The state keeps its 6 1/4 percent share and each month sends cities and counties their portion of the sales tax.

All local sales taxes must be approved by local voters and may be used for any legal city or county expenses. Most areas put the money in their General Fund and use it for normal operations like fire fighting, maintaining roads and law enforcement, Bullock said. Some cities use an additional 1/2 percent city sales tax to help fund local economic development and to reduce property taxes.

## AARP Tax-Aide Program

American Association of Retired Persons Tax-Aide Program is accepting applications of persons interested in assisting the elderly with their Income Tax.

TAX-AIDE is a unique service which relies upon the efforts of volunteers to provide free income tax assistance to older persons and low income persons who are not able to afford professional help. TAX-AIDE is sponsored by the AARP in cooperation with the Internal Revenue Service through its taxpayer educational program. The I.R.S. provides the training, instructions and all material to support volunteers with their income tax counseling.

The primary responsibilities of a Tax-Aide Counselor centers on helping older persons with their tax forms. This is accomplished by explaining special tax benefits that are available to them and preparing or advising of the tax forms. The counselor completes the forms but does not sign nor mail them for the taxpayer.

Persons volunteering to serve as income tax counselors should have a sincere interest in serving older adults. They should also be willing to participate in an Internal Revenue Training course and agree to devote at least four hours a week to provide counseling.

Volunteers need not be retired nor do they need to be a member of AARP. Persons of any age are welcome. Volunteers provide assistance without charge and are not legally liable for the information which they provide.

Training for becoming a Tax-Aide Counselor is provided, by IRS tax trainers or by certified Tax-Aide Instructors and is provided free of charge. Training sessions will be held in January and usually complete within a five day period. All material will be furnished by the IRS.

Tax-Aide Counselors are reimbursed, after completing the training and serving season, for any expenses incurred in carrying out their program related activities.

## Social Security Confidentiality

A recent Supreme Court decision has restricted the situations in which the Social Security Administration can release information without the written consent of the individual according to Glyn Hammons, district manager in Abilene. There have always been restrictions on release of confidential information because of the Privacy Act and Federal Regulations on

disclosures, but the court decision broadened the restrictions.

Under the new rules, the Social Security Administration will no longer be able to furnish Medicare numbers, entitlement dates or similar information to Private Hospitals, Medical Suppliers, Clinics or Doctors' offices without written consent of the individual. The consent statement must be directed to the Social Security Administration, must specify what information is to be disclosed, must specify the individual or organization to receive the information, must show a timeframe during which the information is to be disclosed and must be presented to SSA within a reasonable time after it is signed, usually within 60 days.

These restrictions on releasing information also apply to private sector landlords or private housing management companies, State Legislators, and other private organizations or individuals even if they are trying to help someone.

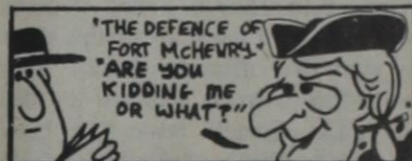
## 2nd Annual KRBC-TV Talent Find

5. A request by Tommy Merryman to transfer part of his property into the Cross Plains School District was approved.

6. The following items were discussed by the board but no action was taken at this time.

A. Equipment for new Primary Building

B. Adoption of additional school policies

C. Student Handbook

7. The formation of an advisory committee was discussed by the board. It was decided by the board that the organization of the committee would be formed on a position-based model.

8. The superintendent reported to the board that the school had been notified of a transportation audit by TEA on October 4, 1990. The superintendent also told the board that the school had been notified that documentation of corrective actions by the school was now complete and the

school could expect the next visit by an accreditation team the week of February 11, 1991.

9. The board hired Sheri Bennett as part-time aide in the superintendent's office.

10. After the financial report was given the board voted to pay the monthly bills and adjourned.

## Texas Exes Offer Excellence Award Scholarships

AUSTIN — Top Texas high school seniors are eligible to apply for a \$16,000 Texas Excellence Award for Scholarship and Leadership to The University of Texas at Austin. Up to nine awards are granted annually to entering freshmen by UT's Ex-Students Association. With the same application, prospective liberal arts students will be considered for the Dedman Scholarships in the College of Liberal Arts at UT. Dedman Distinguished Scholars will receive \$6,000 per year, renewable up to three years.

Some of Texas' most outstanding students stay in the state for their college education, they say, because of the scholarships. David Perez, for example, was chosen to receive the award in 1986, and decided to attend UT instead of Harvard, Yale, or Georgetown University — because of the Texas Excellence Award.

Perez is now a senior International Business/Liberal Arts major from Houston. After attending UT Austin for four years, he said the scholarship is not only preparing him for a career but, "Receiving the Texas Excellence Award taught me that success isn't defined by achievement and prestige but rather by actions that will enrich the lives of others," he explained.

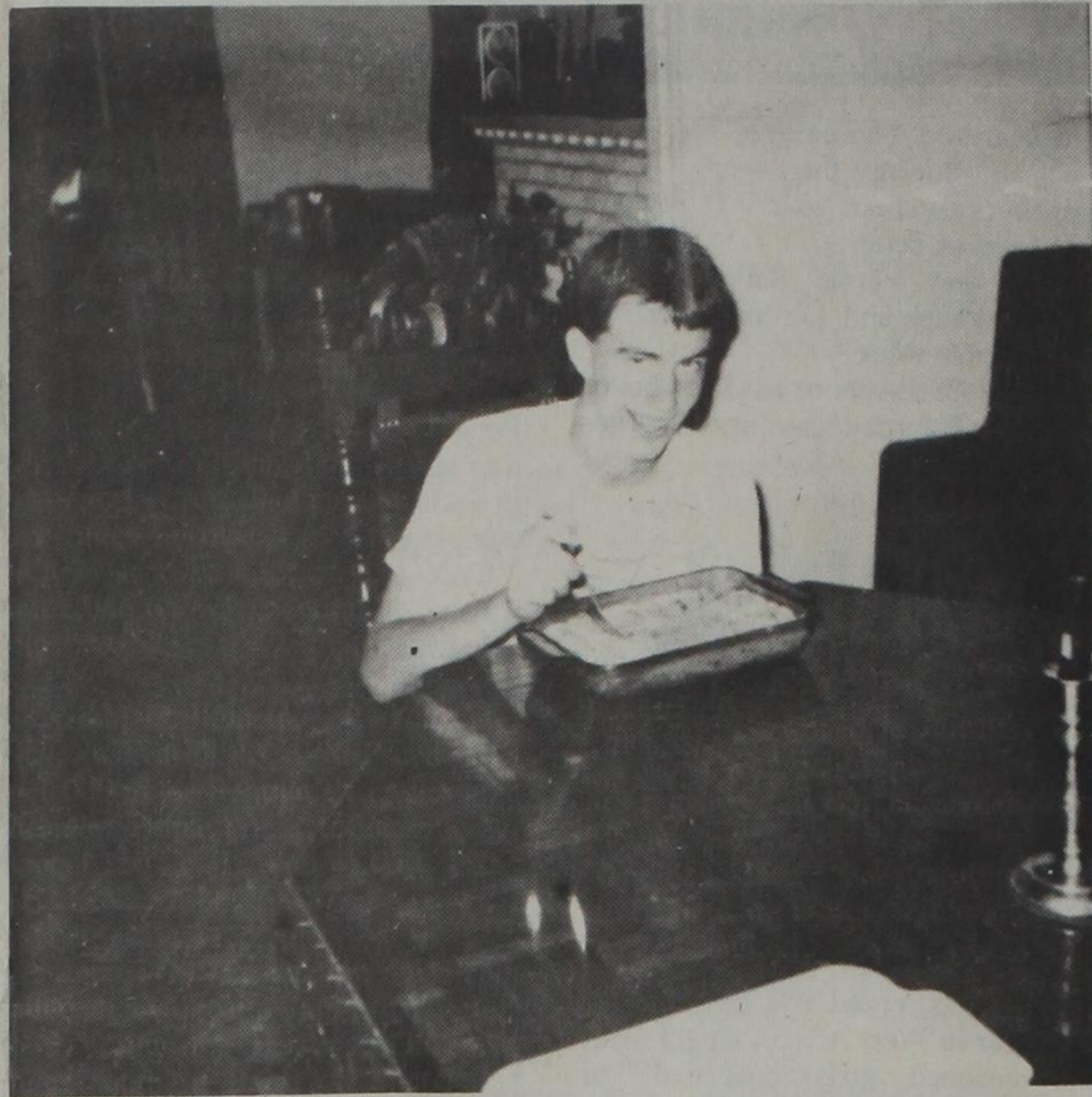
Applicants for both the Texas Excellence Award and the Dedman Scholarships must be in the top five percent of their classes and demonstrate leadership ability in the classroom and/or extracurricular activities. Application forms will be available from high school counselors by mid-September; the return deadline is November 1.

More than 15,000 Texas students have applied for the scholarships since they were first offered in 1982. "This scholarship program was just an idea in the mind of a few Texas Exes back in the early eighties; today one in five of the best students in Texas are applying for this award," said Roy Vaughan, executive director of The Ex-Students' Association. "Aside from attracting top scholars, this program is about developing leadership," he added.

For the seventh consecutive year, UT Austin is second only to Harvard/Radcliffe in the number of National Merit Scholars, with 217 enrolled. Thanks to the efforts of UT alumni, 33 outstanding Texas students, including four new National Merit Scholars, are attending The University of Texas on excellence scholarships, totaling \$132,000 from The Ex-Students' Association's Annual Fund for Excellence. Over 300 other scholarships are administered by the association, funded through local alumni clubs and personal contributions.

The Ex-Students' Association is an independent partner with The University of Texas and its purpose is to serve the University and its alumni. Association programs are dependent on the 50,000 annual dues-paying members.

### Frosty Strawberry Squares

- 1 C. Sifted all-purpose flour
- 1/4 C. Brown Sugar
- 1/2 C. Chopped Nuts (pecans or walnuts)
- 1/2 C. Melted Butter
- 2 Egg Whites (beaten)
- 1 C. Granulated sugar
- 2 C. Sliced fresh strawberries\*
- 1 Tbsp. Lemon juice
- 1 C. Whipped Cream

Stir together first 4 ingredients and spread evenly in a shallow baking pan. Bake in 350° oven 20 minutes, stirring occasionally. Sprinkle 2/3 of the crumbs in 13 x 9 x 2 inch baking pan. Combine egg whites, sugar, berries and lemon juice in large bowl; with electric beater, beat at high speed to stiff peaks, about 10 minutes. Fold in whipped cream. Spoon over crumbs, top with remaining crumbs. Freeze 6 hours or overnight. Cut in 10 or 12 squares. (Trim with whole strawberries and whipped cream if desired.)

\*Use 1 10 oz. package frozen berries partially thawed and reduce granulated sugar to 2/3 C.

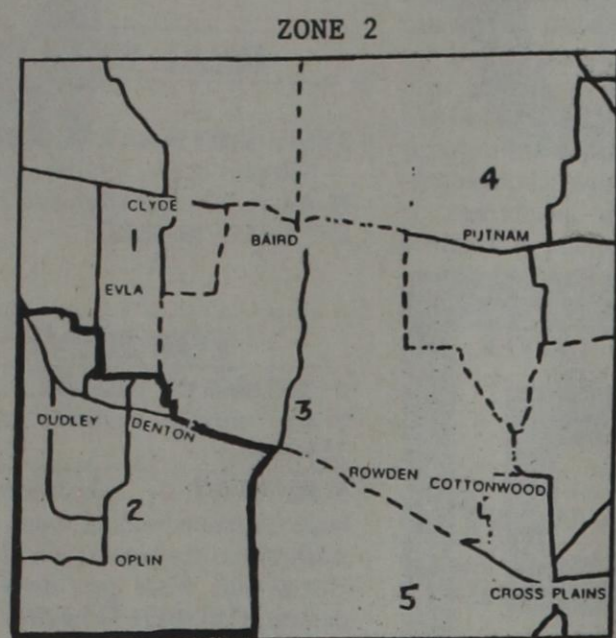
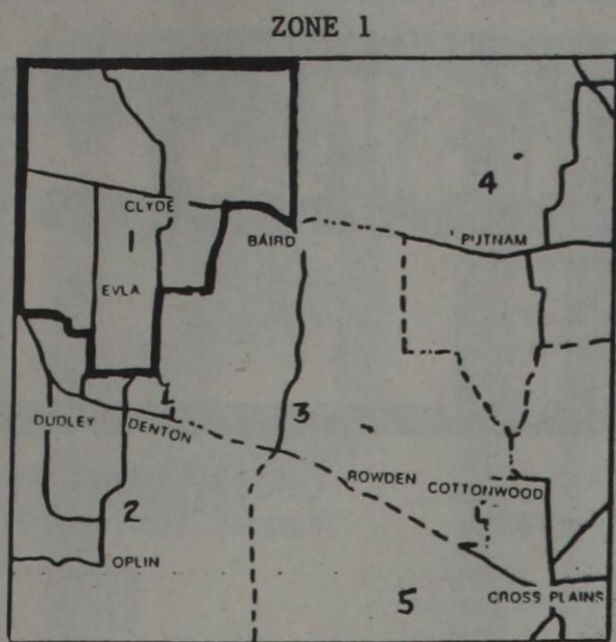

## Announcement Of The Callahan Divide Soil & Water Conservation District Director Election

An election of the Callahan Divide Soil and Water Conservation District directors serving Zones one and two is scheduled for October 15 at the County Courthouse on the second floor of the Courthouse in Baird announced A.H. Ringhoffer, chairman of the board. The election will start at 1 p.m. State law decrees that to be eligible to vote in a soil and water conservation district director election, a person must own agricultural land within the district where the election is being held. The person must also live in a county all or part of which is in the district and the voter must be 18 years old.

Legal qualifications state that a candidate for the office of a soil and water conservation district director must own land in the zone he represents, be 18 years old and be actively engaged in farming or ranching. He must also live in a county all or part of which is in the district. Soil and water conservation district directors serve four year terms of office.

The purpose of the Callahan Divide SWCD, headquartered in Baird is to promote sound soil and water conservation programs on farm and ranch lands within the district and to serve as a voice for farmers and ranchers on conservation matters. The district board of directors coordinates the conservation efforts of various local, state and federal agencies and other organizations and has authority to enter into working agreements with these governmental agencies and private concerns to carry out its pur-

pose. All conservation programs managed by the district are of a voluntary nature to the landowner or operator.

Current members of the board of directors of the Callahan Divide SWCD are Charlie Tom Straley for Zone 2 and Jack Farmer for Zone 1.

### Soybean Oil Ink Good Idea

It sounds like a good idea. I, and probably every other newspaper publisher in Texas, recently got a letter from State Agriculture Commissioner Jim Hightower touting the use of soybean oil-based inks as an alternative to inks based on expensive imported petroleum.

He made a good case for the changeover.

— Soy inks produce cleaner, brighter colors and, because of their higher viscosity, don't rub off on readers' hands.

— With expected price hikes for all petroleum-based products, soy inks will be more economical.

— It is easier to recycle newspaper printed with soy inks because vegetable oil is easier to wash out of newsprint than petroleum.

— Wastewater from both the production of soy ink and from the recycling of newsprint printed with soy ink has lower levels of toxic and hazardous by-products than processes involving petroleum inks.

— Lower levels of toxicity in municipal sewage sludge means more land applications can be found for sludge. This is particularly true for agriculture, where sludge is now being used by some farmers as an alternative to artificial fertilizers.

Hightower also points out that increased usage of soy inks will be a big boost to the economy of Texas, which produces 12.5 million bushels of soybeans a year.

Like I said, it sounds good and I'm going to try the soy ink the next time I have to buy.

There is only one thing that puzzled me about Hightower's letter. It made a good case for the benefits of recycling newsprint, thus saving a resource, paper.

However, the letter, which was written on an expensive laid paper, was about a page and a half long. Instead of writing on the front and back of one sheet of paper, Hightower used two sheets. This may seem like nit-picking, but it amounts to quite a bit of paper if he sent out a number of copies of the letter, which he probably did.

It looks like he might not have been practicing what he was preaching.

(While talking about recycling, I saw a TV ad the other day that kept talking about a "recycling container." What they were showing looked an awful lot like an old-fashioned waste basket.)

### Operation Desert Shield Packaging Tips

The Postal Service has some helpful hints for Americans mailing parcels or packages to military personnel deployed to Operation Desert Shield. Following these guidelines, your packages will get there promptly and efficiently.

Use a sturdy carton, large enough to accommodate the contents.

Use some form of cushioning to protect the articles inside. Seal the parcel securely. Use pressure-sensitive tape. Avoid using brown wrapping paper, cord or string on the outside.

Print the service member's name and address on the address portion of the package on one side only. It should include the service member's name, rank and service number, military organization or unit, and the APO/FPO address. It's important to have the current APO/FPO address, which should be available from that service member's base in the United States.

Put your return address in the upper left hand corner of the package. Also, include your return address on a piece of paper on the inside of the package.

Remember the hot temperatures and heat of the Saudi Arabian climate when considering what to send to the troops there. Temperatures in the desert exceed 100 degrees regularly. Items to send which are popular with the troops include audio cassette tapes, newspaper clippings, gum and hard candy. Use padded bags or boxes. Don't put articles in regular envelopes.

Make sure to attach a parcel post customs declaration form (Form 2966-A, available at local post offices) on all your packages.

The fastest way for packages to get there is Priority or First-Class Mail which allows for a 5-10 day delivery.

Service men and women in Operation Desert Shield can now mail letters and cassettes home free of charge. To get the free service they should place their name, military grade and complete military address in the upper left corner and should write the word "Free" in the upper right hand corner.

## Check For Pecan Weevils

Homeowners and other pecan producers should begin checking trees for the presence of the pecan weevil. In some years, this insect can destroy a large portion of the pecan crop.

Feeding of adult weevils causes the nuts in the water stage to drop. After the kernel has entered the dough stage, the nut is susceptible to egg laying and attack by the developing larvae. During most years, the major damage is due to larvae damage which completely destroys the kernels.

The adult is a brownish weevil about 3/8 inch long. The female's snout is as long as the body; the male's is somewhat shorter.

After kernels have reached the dough stage, the female chews a hole in the shell and deposits her eggs in little pockets in the nuts. Creamy white grubs with reddish-brown heads hatch and feed inside nuts completely consuming the kernel.

Emergence of weevils usually occurs after rainfall in September in this area. One method of determining the presence of the pecan weevil is to lay a tarp or plastic sheet under the tree and shake several limbs vigorously. The weevils should fall on the tarp. If you find weevils, treatment should be applied as soon as possible. Sevin (50% W.P.) or Guthion are the recommended chemicals for weevil control.

Notice May Require Contact With Social Security

Starting in October, some people in the Big Country area may receive a notice from their financial institutions indicating that the Social Security number and/or the name in the institution's records are different than the ones in the records of the Internal Revenue Service, Glyn Hammons, Social Security manager in Abilene, said recently.

In some cases, Hammons said, it may be necessary for the person to contact the Social Security to change his or her name in Social Security records or to verify the information already in those records.

If the person needs to change the information in Social Security records, he or she should have documentary evidence showing both his or her old and new names, as well as evidence of identity, Hammons said.

It is a good idea to call Social Security first to make sure what action is needed. That way, an unnecessary visit to the office may be avoided. It is easy to call Social Security's toll-free telephone number, 1-800-234-5772.

Toll-free telephone service is available from 7 a.m. to 7 p.m. on weekdays. The best times to call are early in the morning and late afternoon. And if you can, it is best to call later in the week and later in the month.

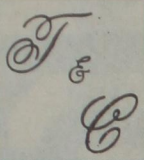

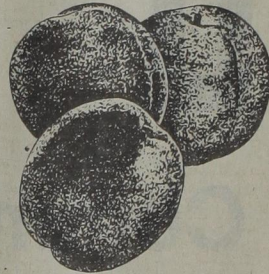
