He was the cutest when he stood behind a skinny, little tree in the pasture and thought he was hiding from me. Of course, I never gave up. Poor thing.

He would sometimes see me coming and just fall over like he was dead, thinking surely she will leave me be. In desperation, he even ran at me, but like a fool I stood there and he slammed on the breaks just before he reached

Pogo did know how to get rid of his riders when he'd had enough. He would just run under the low branches of the pear trees and rake everyone off.

One day my neighbor, Gene Thomas, and I decided we were going to make a show animal out of the little burro. First, we washed him in Tide soap and he was sparkling clean. We managed to get Pogo to lay down and we placed a blanket on him and he would jerk it off. He would bow and just cooperated so good, until performance time. When everyone was watching, he never did a trick again. I guess that wasn't his calling.

The Rising Star Rodeo was Friday night and my friend, Connie Goble Griffith, decided we would ride Pogo in the grand entry. Good idea, WRONG! We got him all cleaned up and even platted his tail and placed a bright red ribbon in it. We were doing fairly well until we were about halfway down the side of the fence and then Pogo noticed the people in the audience.

He just stood there in awe. Connie was in charge of the quirt and I had the reins. Every time she popped him he would kick up both back legs. We were getting nowhere fast. The crowd was roaring with laughter. Then to top off the embarassment, the rodeo announcer made the statement that someone had better get this white donkey out of the arena. (Actually, he didn't say it that kind.) The only way Pogo would move was to follow Daddy's horse, Outlaw. Real neat way to exit. I guess that was the only time the Rising Star Rodeo had clowns and a donkey, too!

Later, we sold Pogo to the late Joe Bryson who lived just east of town. Pogo had it made with Joe. He gave him a chew of tobacco every day. He really loved the tobacco.

The late Eddie Heard used Pogo as part of his act. Being a professional wrestler, his character was a miner and the burro was perfect for his image. Pogo led well and Eddie could sport him around the wrestling arena easily. The white donkey was in the spotlight often in his lifetime, it

Pogo died at the Bryson place years ago, but he will never be forgotten by many.

# City Announces Evans' Resignation 2 Positions Now Available

The City of Cross Plains has the unpleasant task of announcing the loss of their Utility Superintendent, Max Evans. Max submitted his resignation with a two weeks' notice, effective immediately. He has worked for the city for the last 8 years. Cross Plains will suffer a great loss in the absence of Max, as he is knowledgeable in all aspects of city duties, as well as being truly concerned about the progressive movement of the city.

Max has been certified and holds a Class C license in both water and waste water operations. Max's resignation comes at a time when the city is nearing the construction of a new waste water facility, and due to this fact, the city will be accepting applications for two positions. The city has always employed 3 maintenance men until the retirement of Bill Dillard. At that time only the managerial position held by Dillard was replaced and not his maintenance knowledge or duties that he held at that time.

The city feels that with the extra work load being created by the new sewer facility, a 3-man crew will be needed. Applications may be obtained at City Hall and will be accepted until July 27, 1990. A closed meeting has been set for July 30 to review all applications and select an appropriate time for interviews of applicants.

Applicants are not required to be certified as a pre-requisite for employment; however, after sufficient on-the-job training, they will be required to attend classes in order to obtain certification according to Water Commission Standards.

Evans has accepted a position of employment with Silver Brook Ranch, effective August 1, 1990. He has been very instrumental in the progressive movement of updating the city's waste

water system, as well as many other projects the city has been involved in. He has shown considerable devotion to these duties as well as his everyday responsibilities. Everyone at City Hall wish you well in your new job and hope the very best for you and your family.

## Purchase Of New City Hall Property Clarified

The following information was submitted by Debbie Gosnell, City Manager of Cross Plains.

The City of Cross Plains would like to make public a matter of business conducted last year. When the City decided to build a new City Hall last year, due to the deteriation of the existing building, the City Council advised City Manager, Debbie Gosnell, to begin looking for a suitable sight for the location of the new structure.

Upon finding 4 city lots, which were listed with real estate agent, Rolan Jones, Gosnell was informed that the property owners were asking \$1,000 for the property.

Gosnell notified the City Council of her discussion with Jones, and consequently was advised to arrange with Jones the transaction for the purchase of the lots. Attorney Ross Jones was contracted to handle the transaction and was given a \$1,000 check for the aforementioned lots. No other expenditures were necessary for the acquisition of the 4 lots which now house the construction underway for the new City Hall building.

All documents reflecting these transactions are on record at the City Hall and are available for public viewing, and may be verified by Attorney Ross Jones and Rolan Jones, real estate agent.

## Wetlands Issue

WACO - Texas Farm Bureau Executive Director Vernie Glasson urged Texas farmers and ranchers to participate in a series of public meetings to address wetland issues.

Glasson said, "The wetlands issue should concern all Texas farmers and ranchers, no matter what they farm or where they farm."

Farmers are often confused about the exact definition of wetlands, and whether or not they can be found on their property. Some areas that hold water for only a few days per year can be designated wetlands, and there can be serious fines and even jail terms for people that violate laws pertaining to

A series of four public meetings have been scheduled by the U.S. Environmental Protection Agency and the Galveston District, Corps of Engineers to address wetland issues of the Clean Water Act, Section 404.

The meetings are to clarify the normal agricultural activities affecting wetlands. Such activities are exempt from Section 404 requirements. Also to be discussed are details concerning agriculture exemption for discharges that are part of normal farming, ranching, and forestry activities.

The first meeting was held July 25 in San Benito from 9 a.m. to 11 a.m., in the Community Room of the San Benito Community Building, 210 East Heywood, San Benito.

The second meeting will be held August 1 in Corpus Christi from 10 a.m. to 12 noon, at the Warren Theatre, Center for Fine Arts at Corpus Christi State University.

The third meeting will be held August 9 in Houston from 10 a.m. to 12 noon in the Hotel and Restaurant Building at the University of Houston, second floor, room 275.

The last meeting will be held August 15 in Beaumont from 10 a.m. to 12 noon at the John Gray Institute at Lamar University.

The Cross Plains ISD Board of Trustees re-convened on July 19. Motion was approved to pay the bills for the month.



## **Emergency Room Renovation**

DYESS AFB, TEXAS — Based on an Emergency Room renovation project scheduled to start July 23, the level of emergency services at the 96th Strategic Hospital was changed effective July 20

Operational limitations require the downgrade of the present Emergency Room to an Acute Care Clinic and relocation to the current Obstetrics and Gynecology Clinic area.

All major emergency medical problems must be treated downtown at a civilian facility regardless of the time of day. These conditions include, but are not limited to: chest pain, difficulty in breathing, abdominal pain, severe burns, stabbing or gunshot wounds and other major trauma, alternated states of consciousness including suspected seizures of stroke, multiple injuries such as those sustained in a motor vehicle accident or a fall from a height and fractures.

The entrance, parking area and waiting room for the Acute Care Clinic is located on the north side of the 96th Strategic Hospital (current OB-GYN clinic entrance). Patients for OB-GYN clinic are asked to use the pharmacy entrance and waiting area for their scheduled appointments.

The Acute Care Clinic is open seven days a week. The hours of operation are 7 a.m. to 8 p.m. weekdays and 10 a.m. to 8 p.m. on weekends and holidays. Medical care for minor problems during other than Acute Care Clinic operating hours must be obtained from civilian sources.

Personnel on flying status or Personal Reliability Program must notify the 96th Strategic Hospital at 696-2334 immediately after receiving medical care from a civilian source. Also, all active-duty personnel, must notify patient administration at 696-5353 within 72 hours after medical care is received from a civilian source.

The emergency room renovation project is scheduled to take 120 days to

## Contel And GTE To Merge

Contel and GTE Corporation jointly announced today that the board of directors of both companies have agreed in principle to merge the two telecommunications giants in a transaction valued at approximately \$6.2 billion, as of yesterday's closing price.

Under the proposed merger agreement, which is subject to approval by the directors and stockholders of both companies as well as various regulatory agencies, GTE will issue 1.27 shares of its common stock in a tax-free exchange for each Contel common share, or about 200 million GTE shares.

James L. "Rocky" Johnson, chairman and chief executive officer of GTE, characterized the merger as a "perfect combination of two great companies. GTE's telecommunications businesses and organizational structure complement those of Contel, and this alliance will both position the company strategically and enable us to exploit more fully the many opportunities for growth that exist in the worldwide telecommunications marketplace." He noted that the merger will result in an organization that ranks as the country's largest local-exchange telephone company and the second-largest cellulartelephone operator.

The combined company's localexchange operations would have a total of 17.7 million access lines, and its cellular-telephone business would serve approximately 50 million "POPs."

Charles Wohlstetter, Contel's chairman, said, "This merger will provide the critical mass and financial strength Contel has sought in order to accelerate the many initiatives we have recently taken across a wide spectrum of ventures in the field of telecommunications. These plans fit so well with those of GTE that it is hard to imagine any other two companies in such an ideal position to move forward together. All of this leads me to the firm conviction that the agreement to merge is in the best interests of Contel's shareholders and employees."

Wohlstetter also noted that Contel stockholders will benefit from an increased dividend resulting from the exchange of shares. GTE currently pays a dividend of \$1.46 per share, whereas Contel pays a dividend of \$1.10. "Given the common stock exchange ratio, this would equate to a dividend of approximately \$1.85 per Contel share," Wohlstetter said.

GTE subsidiaries operate in 46 states and 41 countries, with combined revenues and sales of \$17.4 billion and net income of \$1.4 billion in 1989. GTE is a leader in its three core businesses — telecommunications, lighting and precision materials-providing products and services worldwide. It has 158,000 employees.

"Aside from the obvious synergy of our telephone and cellular operations," Johnson said, "both companies have other areas of interest

Don Weber, president and chief executive officer of Contel and a veteran of more than 27 years in the telephone industry, will occupy a key position in the merged entity.

Wohlstetter, who is slated to chair the Strategic Issues, Planning and Technology Committee of the new board, said, "Our two companies have a very consistent outlook on the opportunities that are at hand in the world marketplace for telecommunications, and we have a common understanding of the value of size and reach in the highly competitive environment in which these opportunities must be grasped. We share a strong conviction that the combination of our respective resources will create a market force that neither of our companies could have achieved alone. And the timing," he added, "could not be

It is unknown how the proposed merger agreement will effect the restructuring of Contel's Telephone Operations.

## Sales Tax Totals Listed

The City of Cross Plains is reporting 1990 one percent city sales tax payments running 7.35 percent higher than the 1989 payments of the tax. Cross Plains 1990 sales tax payments have amounted to \$26,210.69, while the 1989 sales tax rebates were \$24,416.09.

The city's monthly sales tax check for June 1990 was 23.50 percent lower than the June 1989 check, Bullock reported. Cross Plains' June 1990 check was \$1,929.40, while the June 1989 check amounted to \$2,522.10.

Retail sales in the City of Clyde this year are continuing to run slightly behind last year, according to sales tax figures released by State Comptroller Bob Bullock on Wednesday, July 4.

Bullock said that during the payment period of June 1990, payments of the city one percent sales tax were 23.41 percent lower than in June 1989. The payment to the City of Clyde in June 1990 amounted to \$3,671.43, while the June 1989 payment to the city was \$4,793.71.

Bullock reported that sales tax payments to the City of Clyde so far in 1990 have amounted to \$44,494.77, a 5.83 percent decrease from last year. The 1989 sales tax payments to the city to date were \$47,248.37.

According to Bullock's report, almost half of all retail sales in Callahan County still occur in the City of Clyde. Of the \$95,682.92 collected in the one percent sales tax in the county, \$44,494.77 occurred in Clyde.

Other Callahan County towns reporting sales tax payments include:

The City of Baird reported that sales tax payments in 1990 are 6.87 percent higher than the 1989 payments. The city had received \$19,871.91 so far in 1990, while the 1989 tax payments to the city were \$18,593.91.

The town's monthly payment for June 1990 was 9.31 percent lower than the June 1989 payment, according to Bullock. The June 1990 check to the city was \$1,453.37, while the June 1989 payment to Baird was \$1,602.53.

—The City of Putnam is reporting 1990 city sales tax payments amounting to \$5,105.55 so far, a 5.83 percent increase from tax payments to the city in 1989. The 1989 checks to Putnam amounted to \$4,824.25.

Putnam's June 1990 tax rebate amounted to \$686.62, while the June 1989 payment was unreported.

Countywide sales tax payments for 1990 in Callahan County are running 0.63 percent higher than the 1989 payments to the county. Callahan County has received sales tax payments in 1990 amounting to \$95,682.92, while the 1989 payments to the county totalled \$95,082.62.

Some area towns reporting sales tax payments for the month of June 1990 and whether it's an increase or decrease over June 1989 sales includes: Albany, \$4,582.45, 13.88 percent increase from June 1989; Anson, \$3,131.34, 8.11 percent decrease from 1989; Cisco, \$8,144.53, 11.16 percent increase from 1989; Eastland, \$22,556.77, 2.15 percent increase from 1989; Merkel, \$3,578.52, 20.07 percent increase from 1989; Ballinger, \$17,216.26, 39.40 percent increase from 1989; Haskell, \$8,562.74, 4.39 percent decrease from 1989; and Stamford, \$14,796.25, 4.98 percent increase from 1989.

For the month of June 1990, countywide sales tax payments are 13.20 percent lower than tax payments made in June 1989. Callahan County's total payments in June 1990 were \$7,740.82, while June 1989 payments were \$8,918.34.

Statewide, sales tax payments in 1990 are 8.05 percent ahead of 1989 rebates, according to Bullock's figures. The state has sent out checks totalling \$628,111,551.41 in 1990, while the 1989 payments to the state's cities were \$581,337,825.99.

For the month of June 1990, sales tax payments are running 9.63 percent ahead of June 1989 checks. The state sent out checks amounting to \$75,387,934.07 in June 1990, while the June 1989 payments amounted to \$68,763,374.49.

State Comptroller Bullock said Monday, July 9, that this month's rebate checks to the cities and counties in Texas totaled \$84 million.

"That's a comfortable jump ahead of last year's payments and another indication that our economy continues to grow," Bullock said.

Merchants collect the state and local

sales tax and send it to the Comptroller's office with their tax returns. The state keeps its 6 percent share and returns the local one percent sales tax each month to local governments. Cities and counties may levy a combined tax of up to two percent above the state's sales tax, however all Callahan County towns only levy a one percent city sales tax, Bullock said

This month's checks reflect taxes collected on April sales and reported in May by businesses filing monthly tax returns.

All local sales taxes must be approved by local voters and may be used for any legal city or county expenses. Most areas put the money in their General Fund and use it for normal operations like fire fighting, maintaining roads and law enforcement, Bullock said.

## Working Disabled Can Earn More Now

Disabled Social Security beneficiaries who receive disability benefits can work at higher earnings levels now without risk of losing their disability benefits, Glyn Hammons, Social Security Manager in Abilene, said today.

Changes in Social Security regulations that became effective in 1990 raised the monthly earnings amount which counts in a "trial work period" from \$75 to \$200. A trial work period is a 9-month period during which a disabled person can test returning to work without a loss of benefits.

For self-employed people, the work hours that count for a trial work period increased from 15 to 40 hours per month.

At the end of a trial work period, work activity is evaluated and a determination is made of the person's ability to continue working. If a person's earnings level is considered "substantial gainful activity," disability benefits will be continued 3 more months and then stopped. The 1990 wage levels which are considered substantial gainful activity have increased from \$300 to \$500 a month. (The monthly earnings limit for the blind is \$780 in 1990.)

"This change means a significant expansion of the opportunities available to disabled people who wish to return to work," Social Security Commissioner Gwendolyn S. King

People who receive Supplemental Security Income (SSI) because of disability should contact Social Security for more information about work because the rules are different.





## **Ticks Remain** A Problem

The tick problem is continuing to cause various diseases and illnesses throughout the Callahan County area. An infestation of ticks can cause great discomfort to a dog or cat, contribute to generalized skin problems, and create anemia leading to death. They also pose a serious threat by transmitting diseases from infected to noninfected dogs or cats.

Tick-borne diseases have been diagnosed with increasing frequency in the last few years. With the spread of these diseases into our area, including the infection of humans, the frequency of their diagnosis is expected to continue to increase. Suspicious animals should be tested so infected ones can be treated to eliminate the reservoir of the disease and prevent its spread.

Even though we are seeing these new tick-borne problems, the most common complication in our area is severe infestation resulting in anemia you all. and occasionally death. If dogs become infested with ticks, they should be dipped, sprayed or powdered as frequently as recommended to kill the ticks. If they have access only to a limited area, a tick eradication program should be followed in that area to eliminate ticks that may be harboring disease organisms and to prevent re-infestation. All label instructions on any dip, spray or powder should be strictly followed for safety and effectiveness.

Cats will occasionally be affected by tick problems. Ticks seem to be located around the head and in the ears, but fleas are still their most common external parasite.

Humans may become seriously ill with Rocky Mountain Spotted Fever or Lymes Disease if bitten by an infected tick. Check yourself and your children for ticks whenever in tickinfested areas such as woods, underbrush and watered lawns. See a doctor if you develop fever, chills, rash, headache or muscle aches 3-10 days after tick bites.

After the recent rain, our problem is expected to last the remainder of the summer. Your veterinarian will be able to help you with a disease control and tick elimination program.



## Stenholm Balanced **Budget Amendment Comes Close In House**

WASHINGTON, D.C. - An amendment to the constitution, proposed by Congressman Charles W. Stenholm (D-TX) and requiring balanced federal budgets, surprised critics by coming within seven votes of passage on Tuesday.

After six hours of debate, the U.S. House of Representatives voted 279-150 in favor of H.J. Res. 268. Two-thirds of those present and voting, or 286 House Members in this case, are necessary for passage of a Constitutional change.

A different version of the Balanced Budget Amendment failed 236-187 in the House in 1982. Stenholm attributed this year's 43-vote gain to "tremendous and growing frustration with the budget process and deficit spending, among liberals as well as among moderates and conservatives," the latter being the amendment's traditional supporters.

"During the debate there was a lot of talk about having the guts to make the tough decisions," said Stenholm. "Our 279 supporters went on record to say they were ready for those tough decisions on balancing taxes and spending. I ask the 150 who voted no, 'What's your plan?' After 29 deficits in 30 years, after running up \$3.1 trillion in debt for our children to repay, we just don't believe Congresses and Presidents will face up to the tough decisions without a Constitutional mandate."

A nationwide survey completed by Market Facts, Inc., one of the country's largest polling firms, just a week before the vote showed that respondents favored a constitutional amendment requiring the government to balance its budget by a 75.5 percent to 14.8 percent margin.

H.J. Res. 268 went to the floor, cosponsored by 250 of the House's 433 Members. The other principal authors of the legislation were Congressmen Larry Craig (R-ID), Tom Carper (D-DE), and Bob Smith (R-OR).

The amendment would have, beginning in 1995, required the President and Congress to agree on a single revenue estimate at the beginning of the annual budget process. It also would have required a three-fifths vote in both Houses before the federal government could spend more than it takes in. A bill to raise taxes would not have become law unless approved by an absolute majority, 218 in the House and 51 in the Senate, in a roll call vote.


