Paul L. Whitton, Jr. Among **Finalists For Superintendent** Of The Year Award

Frenship Superintendent Paul L. Whitton Jr. is one of five finalists for the annual Superintendent of the Year Award sponsored by the Texas Association of School Boards. His selection as a finalist placed him in a group of outstanding superintendents.

Other finalists include Larry Appel, Dumas Independent School District; Gordon M. Anderson, Spring ISD; Richard J. Clifford, Southwest ISD; and Charles Patterson, Killeen ISD. They were selected from a field of 13 superintendents originally nominated for the

The 11-year-old award recognizes superintendents for excellence and achievement in educational leadership.

This year's winner will be announced October 1 in Houston during the joint annual convention of the school board association and Texas Association of School Administrators.

CFSA ANNOUNCES CROP INSURANCE DEADLINE

Sales closing dates for crop insurance are much earlier than last year for fall planted crops and certain perennials. According to Scott Odom, County Executive Director of the local CFSA office, "Last year, sales closing dates were extended to accommodate producers because the crop insurance law was changed during the growing seasons. This year's closing dates are the standard 'old' dates" This year, sales closing dates in Callahan County are: September 30th for wheat, oats, barley, and nursery crops.

In most cases, crops insured last year are automatically insured this year. If you are planning to grow insurable crops that you did not plant last year, at least the catastrophic level of insurance must be purchased to be eligible for many USDA farm programs and loans.

Finally, changing your insurance provided or contract must be done by the appropriate sales closing dates. "As farmers become aware of the benefits of additional coverage, we expect that many producers will want more protection," said Odom. Additional coverage can only be purchased through a crop insurance agent. An agent directory is available at the Callahan County Consolidated Farm Service Agency office.

fice had a record month for the year in August District and County Clerk's records reflect that 46 cases were disposed during the month of August-a record month for the year. Those figures accounted for 7 felony and 39 misdemeanor cases closed.

The 46 cases accounted for 20 percent of the total cases pending including fugitives who have yet to be arrested and approximately 28 percent of the appre-

The key to quick case disposition, according to County Attorney Allen Wright, is court settings. In each of the months with large disposition numbers there were significant court settings, says Wright

Wright said the felony case load has been reduced about 30 percent since he took office in 1993. The misdemeanor case load has been reduced by well over 50 percent in the same time period.



Lunch anyone??? At our regular monthly meeting Mr. Rolan Jones presented the program "Unusual Flowers and Vegetables". Some of the food items we were familiar with and some we were not. I thought it might be interesting to include in this weeks column some recipes and ways of preparing one or two of these vegetables and

flowers.

Acorn Squash - Wash, halve and remove seeds. Rinse in cold water. Place both halves on a cookie sheet. Fill cavities with either two Tablespoons honey or brown sugar and one teaspoon margarine or sprinkle with butter buds and cinnamon, cover tops of squash with foil. Cover bottom of cookie sheet about half way up with water and bake at 350 degrees until fork tender; (the flesh, not the outer shell) about 35 to 45 minutes. Promise to Challenge Welfare Being Fulfilled

Telfare, as the American people have experienced it over the last 25 years, is a thing of the

Both the U.S. Senate and the House of Representatives have passed legislation to redesign America's welfare programs. When the dust settles - that is, when a conference committee has hammered out a final bill that both houses of Congress finally approve - we will have fulfilled one of our primary 1994 campaign promises: to recreate the country's welfare system into one that is better both for beneficiaries and for the taxpayers who provide it.

Already, we have a pretty good idea of what the new system is going to look like.

A key part of the Senate bill is the Hutchison funding formula I devised to accommodate the needs of states with growing populations, such as Texas. But more important, it moves us toward the primary goal of cutting overall welfare spending and putting people back to work.

Our new system of public assistance, if signed into law by the President, will end welfare as a way of life. People no longer will qualify automatically for a welfare check and the decisions beneficiaries make will have conse-

The Temporary Family Assistance Block Grant incorporates rigorous work requirements. States will be required to put welfare recipients to work within two years, and impose a five-year, lifetime limit on receiving welfare benefits. Half of all adult welfare recipients in one-parent households must be working by the year 2000. And we are imposing even stiffer work participation rates - 90 percent beginning in 1999 - on two-parent welfare households. States that fail to achieve these participation rates will be penalized as much as 5 percent of their block grant

Welfare recipients whose cash assistance is reduced for failing to work no longer will get an offsetting increase in food stamp benefits or housing assistance - no more playing Uncle Sam for a sucker.

The welfare situation didn't get to this point overnight, nor will it be quickly remedied. But you walk a mile one step at a time. We have started this walk toward making welfare a hand up, not a hand out.

The battle is not over — it won't be over until our welfare rolls are back to the level they were in 1965 (when the Great Society social experiment began), and until selfreliance is again a predominant value in our country.

Garden Tip Of The Month

By ROLAN JONES

START A FALL GARDEN! Now is the ideal time to start a fall garden using cool weather vegetables.

Vegetables which do not withstand the summer heat in this area of Texas do very well in the fall.

September and October are the best times for establishing radashes, spinach, beets, turnips, swiss chard, cabbage, broccoli, cauliflower, kolrabi, turnips, lettuce, carrots, and all types of

greens.

There are many advantages to fall gardens, including fewer insects, no weeds after frost, and less watering is required. All of the above vegetables will withstand frost and most will withstand hard freezes. In some winters you will have fresh vegetables until the beginning of spring garden season.

September is considered the best month to start bermuda grass and set out your flowering bulbs for next year.

Transplanting shrubs, small trees, and dividing prennenial flowers at this time give them all winter and spring to establish a root system.

If you use salt based commercial fertilizer, you should consider beginning an organic approach to all of your gardening. The continued use of commercial fertilizers tend to deplete the natural occurring microorganisms in the soil, creating a hard lifeless, unhealthy soil.

Start a compost pile using grass clippings, leaves, small sticks, and kitchen waste. Along with helping to create a more healthy soil, you will also decrease the amount of material going to the trash and landfill and will be helping the en-

Use organic fertilizers such as cottonseed meal and bone meal, and use fall leaves to mulch between rows and around plants to keep down winter





CONSTITUTIONAL AMENDMENTS

SPECIAL ELECTION **NOVEMBER 7. 1995**

PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 50 proposes a constitutional amendment providing that the legislature by general law may authorize the Texas Higher Education Coordinating Board to issue general obligation bonds of the state in an amount not exceeding \$300 million to finance educational loans to students. The maximum interest rate to be borne by the bonds must be set by law. The legislature may provide for the investment of bond proceeds and may establish an interest and sinking fund to pay the bonds.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the issuance of \$300 million in general obligation bonds to finance education loans to students."

PROPOSITION NO. 2 ON THE BALLOT

Senate Joint Resolution 36 proposes a constitutional amendment that would authorize the legislature to exempt from ad valorem taxation the property of an orga-nization chartered by the Congress of the Republic of Texas if the property is used primarily for the charitable, benevolent, or public service activities of the organization as defined by general law. The Comptroller's Property Tax Division has identified the Grand Lodge of Texas, also know as the Masonia Lodges, as the priknow as the Masonic Lodges, as the primary organization which would qualify for this tax exemption.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the legislature to exempt from ad valorem taxation property of an organization chartered by the Congress of the Republic of Texas that is used primarily for the charitable, benevolent, or public service activities of the organization."

PROPOSITION NO. 3 ON THE BALLOT

Senate Joint Resolution 51 proposes a constitutional amendment that provides that the farm and ranch finance program fund shall be administered by the Texas Agricultural Finance Authority and not by the Veterans' Land Board, as provided by current law. In addition, the proposed amendment provides that the proceeds of \$200 million of the \$500 million in bonds authorized by the Texas Constitution for the farm and ranch finance program fund may be diverted to the agricultural fund and the rural microenterprise development fund, also authorized by the Texas Constitution, to be used for agricultural and rural economic development programs.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment allowing the use of existing bond authority of the farm and ranch finance program to include financial assistance for the expansion, development, and diversification of production, processing, marketing, and export of Texas agricultural products."

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 46 proposes a constitutional amendment that would allow an encumbrance to be fixed on homestead property for an owelty of partition. In divorce and probate situations, a piece of property may be owned jointly by two

or more people, and each person owns an undivided interest in the property, as op-posed to a specific portion of the property. If one owner wishes to purchase the other person's interest in the property and wishes to obtain a loan to finance the purchase, the lending institution requires all interests in the property to be used as security for the loan; this is called an owelty of partition. Senate Joint Resolution 46 would allow the lending institution to foreclose on the homestead property for an owelty of partition if the purchaser defaulted on the loan. In addition, the proposed amendment would allow the refinance of a lien against a homestead. Finally, the proposed amendment would allow a purchaser or lender to rely on an

affidavit that states that the property to

be conveyed or encumbered is not the

homestead of the affiant.

"The constitutional amendment permitting an encumbrance to be fixed on homestead property for an owelty of partition, including a debt of a spouse resulting from a division or award of a homestead in a divorce proceeding, and for the refinance of a lien against a homestead, including a federal tax lien resulting from the tax debt of the owner."

PROPOSITION NO. 5 ON THE BALLOT

House Joint Resolution 34 proposes a constitutional amendment which would increase by \$500 million the constitutional authorization of the Veterans' Land Board to issue and sell general obligation bonds of the state to provide housing financing to Texas veterans. The proceeds from the bonds authorized by this amendment shall be used to augment the Veterans' Housing Assistance Fund II to be administered and invested as provided by law. The bonds authorized by this amendment shall be incontestable after execution by the Veterans' Land Board, approval by the attorney general, and delivery to the purchaser.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to increase by \$500 million the amount of general obligation bonds that may be issued to augment the veterans' housing assistance fund II."

PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 64 proposes a constitutional amendment which would extend the tax exemption under article VIII, section 1-b(b) of the Texas Constitution for the residence homestead of a person age 65 or older to the surviving spouse of a person who received the exemption. The surviving spouse must be age 55 or older when the deceased spouse died, and the property must be the residence homestead of the surviving spouse when the deceased spouse died and remain the surviving spouse's residence homestead. A surviving spouse who already receives an exemption under this section of the Texas Constitution is not entitled to an additional exemption under the amendment.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment exempting from ad valorem taxation the residence homestead of the surviving spouse of an elderly person."

PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that would reduce the amount of general obligation bonds authorized for the superconducting super collider fund from \$500 million to

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment reducing the amount of general obligation bonds authorized for undertakings related to the superconducting super col-lider research facility from \$500 million to \$250 million."

PROPOSITION NO. 8 ON THE BALLOT

House Joint Resolution 80 proposes a constitutional amendment abolishing the office of constable in Mills, Reagan, and Roberts counties. In Mills County, the office of constable is abolished, and the powers, duties, and records of the office are transferred to the sheriff. In Reagan and Roberts counties, the office of constable is abolished and the powers, duties, and records of the office are transferred to the sheriff only if a majority of voters in each of the respective counties favors the proposed amendment.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the abolition of the office of constable in Mills, Reagan, and Roberts counties."

PROPOSITION NO. 9 ON THE BALLOT

Senate Joint Resolution 7 proposes a constitutional amendment that would allow investment of money from the Texas growth fund in a business without the business's disclosure of its investments in or with South Africa or Namibia. Currently, such investments are prohibited by article XVI, section 70(r) of the Texas Constitution, which would be repealed.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment allowing investment of money from the Texas growth fund in a business without the business's disclosure of its investments in or with South Africa or Namibia."

PROPOSITION NO. 10 ON THE BALLOT

Senate Joint Resolution 1 proposes a constitutional amendment that would abolish the constitutional office of state treasurer effective September 1, 1996. The transfer of specific constitutional powers and duties to the comptroller of public accounts takes effect on that date. The statutory powers and duties and the property and other obligations of the state treasurer are transferred to officers and agencies of state government as the legislature provides by general law.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment abolishing the office of state treasurer."

PROPOSITION NO. 11 ON THE BALLOT

House Joint Resolution 72 proposes a constitutional amendment requiring that land devoted to wildlife management be taxed on the basis of its productive capacity. The proposed amendment also adds a temporary provision to the Texas Constitution validating the changes to the law made by Chapter 560, Acts of the 72nd Legislature, Regular Session, 1991, which amended the Tax Code to allow land used for wildlife management to be appraised as agricultural land. The temporary provision also provides that a property owner is not authorized to claim a refund of taxes paid unless the tax payment was challenged before the effective Texas 78711 date of the proposed amendment. The temporary provision expires on January

The proposed amendment will appear on the ballot as follows:

The constitutional amendment to allow open-space land used for wildlife management to qualify for tax appraisal in the same manner as open-space agricultural land, subject to eligibility limitations provided by the

PROPOSITION NO. 12 ON THE BALLOT

House Joint Resolution 31 proposes a constitutional amendment providing that the legislature may exempt from ad valorem taxation income-producing personal property and mineral interests that have a taxable value which is insufficient to recover the costs of administering the tax.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to exempt from ad valorem taxation personal property and mineral interests having a value insufficient to recover the administrative costs of collecting the taxes."

PROPOSITION NO. 13 ON THE BALLOT

House Joint Resolution No. 35 proposes a constitutional amendment authorizing the governing body of a political subdivision to exempt from ad valorem taxation boats and other equipment used primarily in the commercial taking or production of fish, shrimp, shellfish, and other marine life.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the governing body of a political subdivision to exempt from ad valorem taxation boats and other equipment used primarily in the commercial taking or production of fish, shrimp, shellfish, and other marine life."

PROPOSITION NO. 14 ON THE BALLOT

House Joint Resolution 68 proposes a constitutional amendment that allows the legislature to raise the current ad valorem tax exemption for disabled veterans and their surviving spouses and minor children. The tax exemptions would be raised based on a veteran's disability

The spouse and children of any veteran who dies while on active duty may be granted an exemption of up to \$5,000. The amounts of the exemptions provided for in this proposed amendment may be repealed by the legislature by general

"The constitutional amendment relating to raising the limits of the exemption from ad valorem taxation of property owned by disabled veterans or by the surviving spouses or surviving minor children of disabled veterans."




