Baird Bears Victorious In Albany Tournament December 6th

The Bears played Albany Tuesday, December 6th, with the Bears winning 59 to 57 in a close game. Scoring for the Bears were: Norman, 25 points; Casey, 10 points; Harris, 9 points; Graham, 6 points; Fox, 5 points; Tatum, 4 points.

The Baird Varsity then played in the Albany Tournament playing Merkel in the first round with the Bears coming out on top 56 to 43. Scoring went as follows: Norman, 16 points; Tatum, 10 points; Harris, 8 points; Fox and Casey each scoring, 7 points; Graham, 5 points; Ash, 2 points, and Allen with 1 point.

The Bears then played Breckenridge in the second round winning that game 61 to 47. Harris was leading scorer with 13 followed by Norman and Tatum each with 12 points; Casey, 10 points; Fox, 8 points; Graham, 4 points; Ash, 2 points.

Baird then played Anson in the finals

of the Albany Tournament. The Bears defeated the Tigers 62 to 45. Scoring went as follows: Tatum, 17 points; Norman, 14 points; Casey and Harris each scoring 10 points; Graham, 6 points; Corn, 3 points; and Fox with 2 points.

Scott Norman was selected to the All-Tournament team.

The Bears will play in the Eula Tournament this weekend and will open the tournament by playing Santa Anna in the first round at 5:00.

BAIRD J.V. PARTICIPATES IN JIM NED TOURNAMENT

Baird J.V. played Albany on Tuesday, December the 7th, and won a close game 40 to 39. Scoring for the Bears were Moore, 16 points, Freehling, 8 points; Holland, 7 points; Cerda, 5 points, and S. Cohn with 4 points.

Baird J.V. then traveled to the Jim Ned Tournament playing Wylie in the first round, with the Bears winning 43 to 38. Scoring for the Bears were Freehling, 18 points; Graham, 9 points; Penkert, 6 points; Moore and S. Cohn each scoring 4 points; and Cerda with 2 points.

The Bears played Clyde in the second round and fell to a good Clyde team 64 to 32. Scoring went as follows: Freehling, 17 points; Graham, 11 points; and Cerda and S. Cohn scoring 2 points.

The Bears then played for 3rd place and lost to Jim Ned on a shot at the buzzer, 34 to 33. Scoring for the Bears were Graham, 11 points; Moore, 8 points; Freehling, 5 points; S. Cohn, 4 points; Penkert, 3 points; and Cerda with 2 points.

The J.V. will be idle until after the Christmas holidays when they will play Anson on January the 4th.

B.H. Fillmon Assumes Post of Night Watchman For City

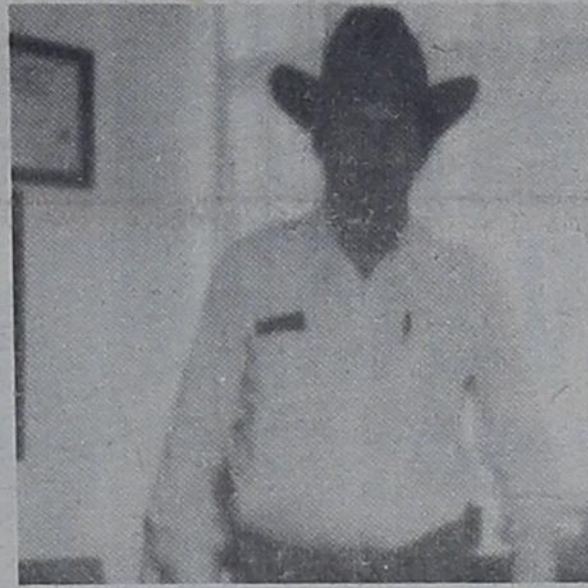
B.H. Fillmon, of Clyde, assumed the duties of night watchman for the City of Baird Monday night.

Clyde Man Plea Bargains Charges On Cockfight Offense

Ronald Dee Bond, 37, of Route 2, Clyde, and 3 others had charges against them dismissed Monday, by Taylor County Court-at-Law Judge Nathan Newman.

Misdemeanor "cruelty to animals" charges were filed against Bond and 10 other men after plain-cloths deputies attended a cockfight in southern Taylor

County on April 4th to check out a complaint that the fights were being held.

Deputies observed 10 men handling the fighting roosters, that were equipped with steel spurs tied to their legs, and one serving as "referee." The chickens were allowed to fight until one was dead, while handlers pulled the heads off some of the disabled chickens.

Hospital Census Up, Improvements Make Big Difference

New carpet, vannies and paint have brighten the interior of Callahan Memorial Hospital considerably. And with the census up, the hospitals future looks brighter as well.

The lab with its new equipment can now do all routine test and the majority of X-Rays can also be done.

Russell Payne, hospital administrator, said that elective surgery is to be offered in the near future, depending on the needs of local physicians.

This week all rooms will be completely painted and papered, and all have new ceilings. A vinyl material will cover the walls in the halls, and new furniture will be placed in the lobby.

The Hospital Auxiliary raised between \$700 and \$800 at their recent bake sale

and luncheon, with proceeds going to buy new curtains.

Mr. Payne said that in the next 2 weeks an audio-nurses-call system, and a paging-music system will be throughout the hospital. Telephone jacks and EKG hook-ups are to be installed also.

He went on to say the United Hospitals was very impressed with the hospitals improvements, and that every thing was running smooth.

Payne said the hospital has the "best nursing staff in the world," and their motto is "lots of tender loving care."

It just goes to prove, that with community participation and hard work the County has a hospital they can be proud of.

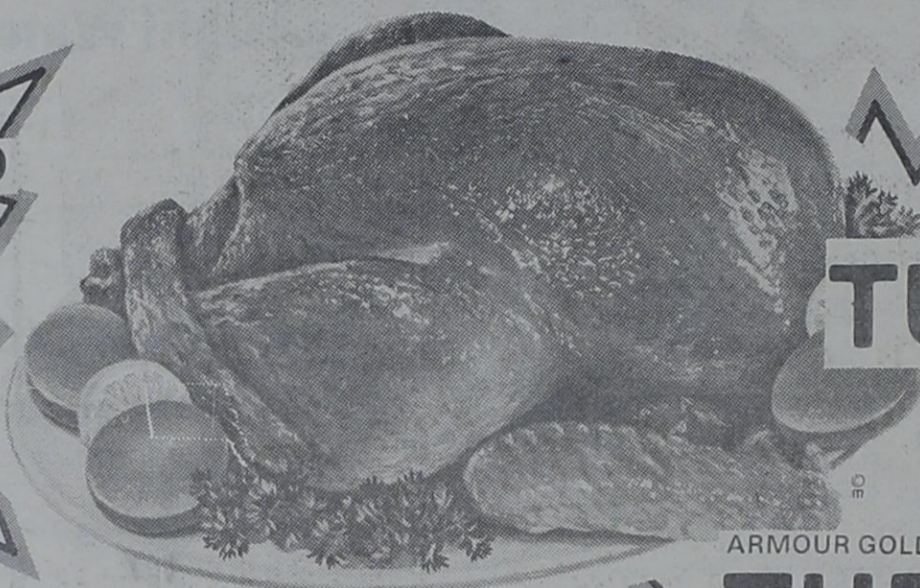

This week in Bearette basketball saw the previously unbeaten varsity fall to an overpowering Breckenridge team, then bounce back to bring home a 3rd place trophy with a sound whipping of the Albany Lionettes. The week also saw the J.V. team bring home a 2nd place trophy in the Jim Ned Tourney.

Tuesday night, Dec. 7th, both high school girls teams walked home with victories against Albany in the opening district game of the 82-83 season. LeAnna Parker and Anita Mendez led the J.V.'s with 8 points each. Tina Weeks and Candi Creecy each added 6 more. Following the 46-25 J.V. win, the varsity posted a 45-19 win. Ester Mendez was high point with 14 pts., following closely by Beth Ringhoffer with 10. Ringhoffer also was the game leading rebounder with 9. Lisa Perryman added 6 points and 6 rebounds.

Tournament action completed the week as the J.V.'s traveled to Jim Ned and the Varsity entered the Albany Invitational. In the J.V.'s first game they beat Wylie 33-24. Lactetia Grant led the team in scoring with 8 pts. and Parker chipped in 7 more. In the semi-finals the J.V.'s defeated Clyde 27-22. Grant again led the Bearettes with 12 big points. Creecy had 6, LeAnn Hodges had 5 and Jil Turnbow added 2 more. The Final Game saw the J.V.'s lose to always tough Hawley by a 16-26 tally. Parker was high point with 7 followed by Turnbow with 4 points.

In Varsity action the "Lady-Bears" took on Merkel in the initial round beating team 43-22. Mendez again assumed her

high point role pouring in 16. Ringhoffer followed with 8 and led the team in rebounds with 13. Senior Paula Fears added 6 more points and her counter parts, Perryman and Holland pulled down 8 rebounds each as Baird completely dominated the boards.

Baird suffered a devastating lose in the Semi-finals as the previously hot-shooting Bearette's froze completely up. Shooting just 20% from the floor the varsity lost 28-49. In the 3rd quarter the percentage fail to an all-time low of 8.3% Ringhoffer led the "cold" Bearettes with 8 points. Breckenridge shot 61% on the night and completely dominated every statistical category.

The Breckenridge loss put the Bearettes into the 3rd place finals where they defeated Albany 43-34. Mendez had 16 points to tie with Albany's hot shooting Yolanda Garcia. Perryman had 9 and Holland scored 8. In the rebound stats, Holland had 11, Perryman had 7, and Tresa Hatchett, who had missed the Tuesday night game because of sickness in her family, pulled down 6.

At weeks end the varsity's record was 8 and 1 and the J.V.'s was 5-3 for an overall 13-4 high school girls record. December 14 the teams travel to Winters and then the varsity will enter the Eula tourney to play Santa Anna at 4:00 Thursday before taking a much needed Christmas break. Coaches Graves and Fox would like to wish all the Bearettes and their parents a very Merry Christmas. Graves also said that the varsity Bearettes will workout during the holidays on December 28th, 29th, and 30th at 10:00 A.M. in the New Gym.

New Kiwanis Club To Be Called Kiwanis Club Of Greater Clyde

As of Monday, Dec. 6th, the community of Clyde now has two Kiwanis clubs, with the organization by thirty-four charter members of the new Kiwanis Club of Greater Clyde which is sponsored by the Kiwanis Club of Clyde—one of the top clubs of the Texas-Oklahoma District and home club of District Governor-elect Marvin W. Sapaugh.

The Kiwanis Club of Greater Clyde was organized in a noon meeting at the Clyde Dairy Queen. It will be a Monday noon club, while the Kiwanis Club of Clyde which also meets at the DQ and was organized in 1974 is a Monday morning breakfast club. The two clubs plan to work closely together to serve the community of Clyde. The new Clyde Club is in the 18th Kiwanis Club of the T-O District Division 35. Clubs now serving in Division 35 include five clubs in Abilene, two in Sweetwater, two in Clyde, and then one club each in the following communities: Albany, Anson, Baird, Breckenridge, Cisco, Cross Plains, Eastland, Haskell, and Stamford.
