Bank Joins RECDS on Streamlining Farm Loans

Temple: "The Wellington State Bank of Wellington, Texas has been accepted as a Certified Lender in a new Rural Economic and Community Development Service (RECDS), formerly Farmers Home Administration, plan to streamline its guaranteed loans for farmers," George Ellis, RECDS Texas Acting State Director, said today.

Under the program, RECDS guarantees farm operating and ownership loans made by commercial lenders against a certain percentage of loss.

"The Certified Lender Program was created to reduce paperwork and expedite the actual processing of loan applications," Ellis said. "For lenders that meet our requirements, we pledge to give them a reply in 14 days when they send us an application."

"This helps the lender and the farmers, and keeps our work flow moving faster. It cuts the normal processing time by more than one half."

To become a Certified Lender, banks must have a certain level of experience in making farm loans, have designated staff for those loans, and agree to certain training practices.

"We welcome the Wellington State Bank of Wellington as a Certified Lender because this helps us serve the farm community more efficiently and effectively," Ellis said. "We look forward to working with them and their borrowers."

Rural Economic and Community Development Service, as an Equal Opportunity Lender, makes loans or grants to individuals or groups and guarantees to approve lenders without regard to race, color, religion, sex, national origin, familial status, and handicap. Financial Training for FmHA/RECD Borrowers

Social Security News

Age 60? You May Get Benefit Statement Next Year

"If you're age 60 or older and not yet receiving Social Security benefits, you can expect to get a statement sometime in 1995 telling you approximately how much you could receive in benefits," reports Jim Talbot, Social Security manager in Amarillo. In February, the Social Security Administration will begin mailing Personal Earnings and Benefit Estimate Statements to everyone who is age 60 or older, has earnings posted under his or her Social Security number, and is not currently receiving Social Security benefits.

The statements are intended to help people become better informed about what they can expect to receive in benefits and how much money they have invested in Social Security. They show the taxable earnings reported by the worker's employer(s) and the estimated Social Security taxes the worker has paid on those earnings. By the end of the century, Social Security expects to be sending the annual statements to everyone age 25 or older.

"You don't have to do anything when you receive your statement unless you believe the earnings information is incorrect," says Talbot. If the error involves earnings reported by your current employer, contact your payroll office or your supervisor to see about having it corrected. If the error involves earnings from a former job, report the discrepancy to Social Security's toll-free number, 1-800-772-1213. When you call, be sure to have your records of the correct earnings such as W-2s, pay stubs, and tax returns handy.

Talbot, says the initial mailings will continue through September.

ber. And in October 1996 and each year thereafter, statements will be sent to individuals who reach age 60 during the year.

The statement shows the benefit amount the worker and his or her family can anticipate at ages 62, 65, or 70 -- based on the person's current age. If, for example, you're 63, your statement will show the estimated benefits for your current age and for ages 65 and 70. If you're 68, you'll receive an estimate for both 68 and age 70. People who are past age 70 will get an estimate based on their current age. The statements also include estimates of benefits that may be paid should the worker become disabled or die

before retirement.

If, after you receive your statement, you decide to apply for retirement or disability benefits, call the toll-free number, 1-800-772-1213, to arrange for an appointment to talk with a Social Security representative. You can speak with a service representative between the hours of 7 a.m. and 7 p.m. on business days. The lines are busiest early in the week and early in the month, so if your business can wait, it's best to call at other times.

If you're over age 60, not receiving Social Security benefits, and don't receive a statement by September 30, 1995, call the toll-free number and ask for a form 7004 (Request for A Personal Earnings and Benefit Estimate). The toll-free number responds to these requests around the clock throughout the week.

Funeral Directors May Fax Beneficiary Death Notices

"Funeral directors are the quickest and most effective source of information about a Social Security beneficiary's death," according to Jim Talbot, Social Security manager for Amarillo. "They can now provide us with even faster service by faxing the information to us. In turn, it will help us process the claims of survivors who may be eligible for benefits even faster than before," he said.

Funeral directors usually report the information by mail to Social Security on Form SSA-721, "Statement of Death by Funeral Director," within a few days after a beneficiary's death. In addition to helping locate survivors who may be eligible for benefits, the faster transmission of death information should help prevent incorrect payments after the beneficiary's death.

Funeral directors can get the fax number by contacting their local Social Security office.

Another Chance to Sign Up for Medicare

"If you're age 65 or older and don't have Part B Medicare coverage, you'll have a chance to

sign up for the coverage during the 1995 annual enrollment period," said Jim Talbot, Social Security manager in Amarillo.

Talbot said every year, the government offers a three-month general enrollment period from January 1 to March 31. This period is to give you a second chance if you didn't enroll when you were first eligible or you dropped your coverage. If you enroll during the current sign-up period, your coverage will begin July 1, 1995.

For 1995 the cost for Part B coverage is \$46.10 per month. Most beneficiaries who delay enrollment pay a 10 percent surcharge for every 12 months they could have been enrolled but weren't.

Part B coverage, also called "medical insurance," help pay for doctors' care, outpatient hospital visits, and other medical services. People are offered the option of signing up for Part B at the same time they are automatically enrolled in Medicare's Part A program. Part A helps pay for inpatient hospital care and certain other services and is paid for by the Medicare tax you paid while working.

People who want to sign up for Part B Medicare coverage should call the Amarillo Social Security office or call Social Security's toll-free number, 1-800-772-1213, between 7 a.m. and 7 p.m. any business day. "The lines are busiest early in the week and early in the month, so it's best to call other times," said Talbot.

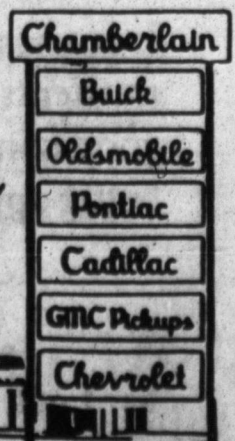
