Panhandle Community Services finalized paperwork of April 13, 1994 to purchase property at 416 S. Kearney for relocation of their office and projects occupancy by May 3, 1994. PCS geographically extended their service to include a Clarendon office in an old grocery store in the early 70's. As time progressed staff delivered a wide variety of programs. Providing child care was the big focus from 197-1985. Unfortunately, the office PCS operated was burned to the ground from an electrical accident during this period. After that, PCS moved to the old courthouse where they have resided for 13 years.

## Jackson Honored In TRC Newsletter

Lee Jackson, Clarendon College Electronics Instructor, was recently recognized in the Texas Rehabilitation Commission's Newsletter for his continued work in showing students that there are no limits to what one can do. Jackson has played the role of mentor and instructor for many TRC clients over the years.

Jackson's involvement in TRC evolved after the loss of his arm in a farming accident in 1953. He was inspired to visit with a TRC counselor about possible job opportunities by then Donley County School Superintendent, Ruth Richardson, who was also an amputee.

"TRC was a turning point in my life," said Jackson. "Without TRC, I don't know if I would have had the support to make it through electronics school."

Jackson has been the electronics instructor at Clarendon College for 21 years.

## Judging Contest Attracts Record Number

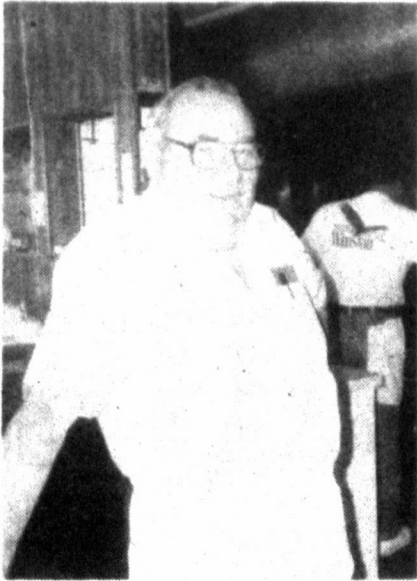

This year, members will elect directors from Districts 3, 6 and 7 to serve three-year terms. District 3 is composed of all the Collingsworth County north of the Salt Fork River. District 6 includes all of Donley County west of Highway 70, and District 7 is all of Donley County east of Highway 70.

### Crop Loans Available

Farmers have one more week to sign up and become eligible for program benefits on their 1994 wheat, feed grains and cotton crops, Drew Thornberry, County Executive Director of the ASCS office said. The sign up period ends April 29, 1994.

Producers will not have the opportunity to change their mind and sign up after the deadline. Producers who have already enrolled and those who sign up before April 29, 1994, have the option of withdrawing and returning any advance payments.

To be eligible for price support loans, LDP, and target price protection on this year's crops, farmers are required to meet acreage reduction requirements of 11 percent for upland cotton and 0 percent for wheat, corn, oats, and grain sorghum.

Target prices protect farmers income if market prices fall below the federally established levels. Through the ASCS price support loan program, farmers can obtain interim financing to operate and have time to wait for a better market. Additionally, the 1994 farm program offer advance payments in cash and flexible planting options.

If producers do not sign up, they should clearly understand that they will not be eligible for benefits offered under the 1994 farm

programs. Also remember that May 15, 1994, is the last day to report any small grains for grain, grazing, baled, left standing, or any other uses.

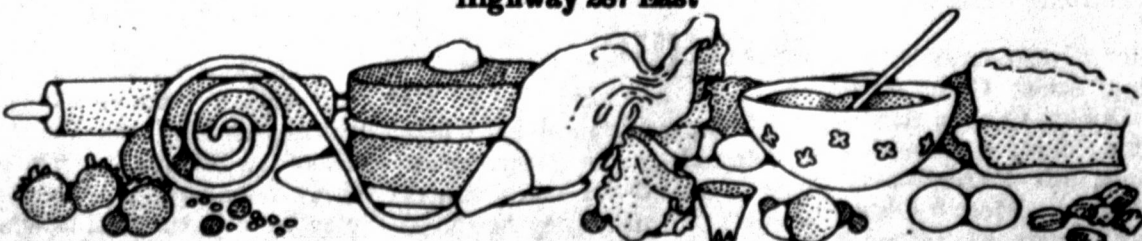

Staff has enjoyed working in the old courthouse and has appreciated the cooperative efforts of County Judge Christal, who also has been a Board member since 1981. Coordination with other agencies at the courthouse and local agencies over the years has helped many clients needing assistance with basic needs. Robbie Hill, Regional Manager explains, "People in Clarendon just work for the common good. We have great, caring people here that are concerned about their neighbors. I am excited about the new office, as it will provide easier access, have more office privacy and a nice cheerful waiting room for those who apply for services." The Senior Citizen Walk passes by the building as well as being close to the Post Office and other businesses frequented by most are residents.

The building consists of over 4,000 square feet of which portion is occupied and will remain occupied by Panhandle Council on Alcoholism and Drug Abuse. PCS purchased the building from the Jehovah's Witnesses, who have owned the building since 1991. They will build a church near Clarendon College sometime between June and August. Church members from this area as well as other regions according to spokesperson, Michael Rhinehart.

Clarendon office is one of 13 full time and one part-time offices located throughout the Panhandle to serve all eligible residents in the 26 counties. Current programs include: Energy Assistance, Commodities, Weatherization, Rural Transportation, HUD Rental Assistance, (Families in Training, a housing program) and sponsorship of RSVP in 10 counties. In addition, PCS contracts with local agencies in youth and adult services, as well as delivering Texas Education Agency grants coordinated with Panhandle ISDs for At-Risk Youth in Vocational Assessment Services.

Additional staff include: Center Coordinator, Carlene Hollar, Betty Farley, Transportation Driver and support staff, and Eugene Johnson and Jerry Mulanax Transportation drivers. Staff invites the public to come by to see their new location and will announce an Open House later in the month.

**Freeland David Davis**

Funeral services for Freeland David Davis, age 77, were held at 1:00 p.m. on Wednesday, April 20, 1994 in the Howardwick Baptist Church with Rev. Clarence Jones, Pastor of the Sanborn Baptist Church in Amarillo, officiating. Interment was in Hillcrest Cemetery in McLean with arrangements under the direction of Robertson Funeral Directors, Inc.

Mr. Davis died at 10:05 a.m. on Sunday, April 17, 1994 in St. Anthony's Hospice in Amarillo following a lengthy illness. He was born in Grandbury, Texas on October 24, 1916 and was married to Dorothy Gertrude "Trudy" Roach on November 17, 1946 at Pampa. He had been a resident of Amarillo for 16 years before moving to Howardwick in 1982. He had worked for Excel Helium Plant in Amarillo for 26 years and was a shift foreman before retiring in 1980. He was a US Army Veteran of World War II, having served in the US Army Air Corp. He was a former mayor of Howardwick and a former member of the Howardwick Volunteer Fire Department. He was a member of the Howardwick Lions Club, the Donley County Senior Citizens Association, the Senior Citizens Dance Club, and a member of the Paramount Baptist Church in Amarillo.

Survivors include his wife, Trudy Davis of Howardwick; one daughter and son-in-law, Carrie and George Thomas of Dumas; two brothers, W.A. **Anti-Smoking Efforts**  
**Focus on Teens**

(NU) - More than one-fourth of U.S. high school students smoke and the rate is gradually increasing. In bygone days, teen smoking was considered a social problem. Today, however, research has shown it to be a matter of life and death.

Experts agree that the earlier a person begins to smoke, the more likely the habit will result in premature disease and death.

That's one of the alarm bells sounded by a new radio documentary, "Teens and Smoking," which follows U.S. Surgeon General Joycelyn Elders' acknowledgment that young people who smoke are far more likely to abuse drugs and be sexually promiscuous.

In the documentary, a number of prominent experts outline the devastating results of smoking on young people and their families.

The report continues a series, "Times and Seasons," produced by

the Church of Jesus Christ of Latter-day Saints and distributed free to about 750 radio stations and to schools, service clubs and community organizations. Earlier documentaries in the 30-part series have focused on numerous social problems, including drug addiction, child abuse and religious tolerance.

**Teens as Targets**

The teen smoking documentary reveals how smoking advertisements are aimed at young people, endeavoring to convince them that smoking is fun and that it will make them appear more "macho," more feminine, or more popular or sophisticated.

The documentary's producers counter that message by reporting on how young nonsmokers are "turned-off" by the tobacco odor and stained teeth of potential dating partners.

Experts discuss how tobacco has been shown to be a gateway to other drugs. One specialist describes how secondhand smoke can harm children and others in a household even if they never smoke themselves.

Also featured is "Jeff," a former smoker who took up the habit at 15, but has since gone through the painful process of overcoming his addiction. Despite Jeff's success, only 1.5 percent of teens who start smoking are reportedly able to quit the habit.

Other findings include:

- The lower the education, the higher the smoking rate.
- Poor self-esteem contributes to young people smoking.
- Although selling tobacco to minors is illegal, the law is rarely enforced.

Authorities interviewed, such as Allen Davis, a vice president of the American Cancer Society, say that

educational efforts and parental example can prevent young people from taking up smoking.

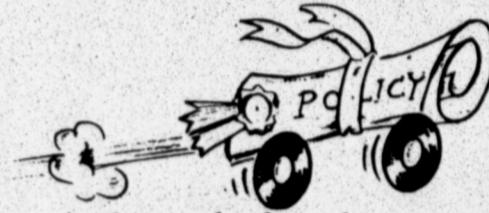
They also say personal commitment and motivation can help those already addicted to give up the habit.

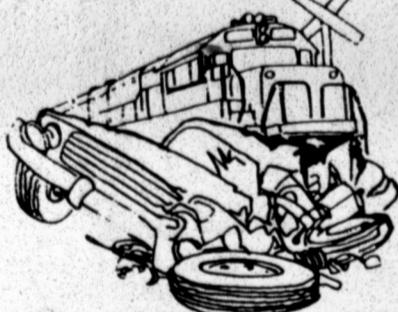

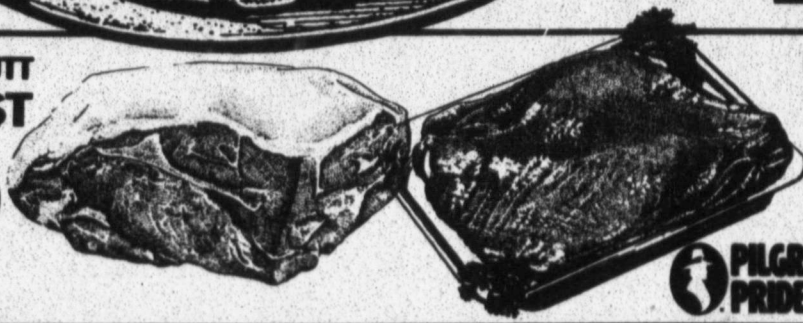

### Check It Out

Are you familiar with Max Lucado's writings? Mr. Lucado who preaches, teaches, writes, and lives with his family in San Antonio, Texas, has been listed among the seven most admired Christian writers in America. He writes with a unique style which holds the reader's interest from the first page to the last. His talent enables him to present a serious point in an interesting, clever, modern way which is quite thought-provoking. Personal applications tend to "draw" the reader right in to the reality of the situations.

In the book, *He Still Moves Stones*, examples of our own problems and feelings are discussed. The author makes it evident that these same feelings were experienced by many of the strong people who lived during biblical times and about whom you've read. Possible and uplifting solutions are offered to situations such as overcoming shame; facing discouragement; overcoming a bad attitude; when others let you down; when you wonder if your prayers matter; when you wonder if God cares; when you're confused by God's actions; how to love growing old (I really needed that one). This is not a book of advice, but rather, it conveys the fact of "God doing for people what people cannot do for themselves."

### Tax Deferral Available

Texans aged 65 or older can postpone paying delinquent and current property taxes on their homes. They can take advantage of a tax option called "over-65 deferral" by signing an affidavit at the Donley County Appraisal District office.

Once a homeowner files an over-65 tax deferral affidavit with the appraisal district, no taxing unit can start or continue a lawsuit for delinquent taxes as long as that person owns and lives in that home.

Taxpayers need to be aware that tax deferral for the elderly only postpones paying delinquent taxes on the home; it does not cancel them. During the deferral time, taxes and interest of eight percent continue to add up. When the elderly taxpayer no longer owns or lives in the home, the taxes become due. Taxing units can then sue to collect all of the deferred tax and interest.

Filing of the deferral affidavit does not forgive penalties that are already due. Also, if the taxes remain delinquent more than 90 days after the deferral ends, an added penalty may be charged if the account goes to a delinquent tax attorney.

### Spring Home Safety Tips

It's that time of the year again... when spring cleaning fever hits the air and everyone decided to take on those tough chores around the house. This is a good time to perform a home safety check. Inspecting your home and creating a hazard-free environment will reduce your chances of having an accident.

West Texas Utilities Company and the National Safety Council recommend spring cleaning as the best time to conduct a home safety checklist:

Avoid overloading electrical outlets.

All appliances should have Underwriters Laboratories (UL) labels.

Replace cracked or damaged cords and plugs.

Cover electrical outlets if you have small children in the house.

Label all fuses and circuit breakers to show which outlets and fixtures they serve.

Washer and dryers should be electrically grounded. Be careful: damp or wet floors can lead to electric shock.

When remodeling, position light switches in accessible areas. Accidents can happen when people stumble through the dark. Place locations around the house for emergency use.

Good lighting should be provided at the stove, sink, and countertop work area, especially where food is chopped.

Place night lights in bathroom or hallways to act as a guide to prevent falls.

Make sure a home safety list is part of your spring plans this year. Take the time to ensure the health and safety of you, your family and your home.



### Cancer Scams Hurt Innocent

Ann Landers, Attorneys General in several states, many medical doctors and numerous newspapers have issued warnings against organizations which claim to support cancer research, but actually expend only a few percent on research. Generally the person operating the scam gets a big salary, while the research gets almost nothing.

Virtually the only legitimate cancer research organization that raises funds from the public is The American Cancer Society. The trademark for the American Cancer Society is a stylized sword of Aesculapius, the Greco-Roman god of healing. If the fund raising effort has the sword and the words "American Cancer Society", then a person can be sure that most of his gift will go for research. If it lacks those marks, then a person should be skeptical.

At least one scam operator makes a practice of moving every three or four months, and changing the name of his organization. Apparently he often solicits money from people who are themselves the victim of cancer or relatives of victims.



### Minding Your Own Business

OLD-FASHIONED BUSINESS ETHICS

Small business enjoys a good reputation. People usually think of entrepreneurs as honest, hard-working and ethical. My experience in working with hundreds of small businesses reinforces this reputation. In addition, I believe that business ethics play a vital role in small business success.



DON TAYLOR

Our free enterprise system was founded on principles of conduct that have become blurred today. Recent Washington scandals, the savings and loan industry boondoggle, and business and political graft have become the norm. The message is clear: Cheat, if you have to, but win at any cost.

Maybe I'm old-fashioned, but I don't believe that cheaters are ever winners. One of the greatest joys I derive from owning my own businesses is knowing that I built them honestly. However, following the principles of honesty and integrity is not always easy.

Ethical Dilemmas

The following incidents are true-life examples that area business people have shared with us. The names and genders have been changed for reasons of confidentiality.

Joe had an opportunity to hire his competitor's area manager. The manager promised to bring Joe the competitor's customer lists, pricing policy and sales records. This information would help Joe's struggling business. Should he hire the manager?

Frequently, Mary is paid in cash for her work. Her business is not very profitable, and she wonders if it would be OK to spend the cash and not report the revenue as income. Mary's friends have told her that the Internal Revenue Service is corrupt and already collects too much tax money. Should Mary report the cash?

Bill just closed a big loan at the bank. A few days after the papers were signed, he noticed a large error. The bank inadvertently omitted the largest piece of equipment used to collateralize the loan. Should Bill point out the error?

#### A THREE POINT CHECK

The answer to many ethical questions can be found in a book written by Kenneth Blanchard and Norman Vincent Peale. In "The Power of Ethical Management," they suggest using a three-question test to establish ethical behavior. The questions are: 1) Is it legal? 2) Is it fair to all? 3) Would I be happy if the whole story was made public?

These three questions make it easier to tackle any issue that involves questionable ethics. "Is it legal" establishes a minimum criteria. If it is against the law, don't get involved. The fairness question asks if it would be OK if I were on the receiving end of the deal. The third question asks if it would be all right if the whole story was printed on the front page of the local newspaper.

The ethical dilemmas faced by Joe, Mary and Bill become fairly simple decisions using this test method. While it is legal for Joe to hire the manager, the manager's proposal is not fair to all parties. The information that the manager will bring to Joe's company will give Joe an unfair advantage. Joe wouldn't want the situation reversed or made public knowledge.

Mary's dilemma is answered by the first question. Not reporting cash income is tax evasion, a punishable crime. Even though we may not like the IRS, the law says that we must pay taxes on all income.

Bill's situation may not involve legality. However, the question of fairness certainly is relevant. It will not be fair to the bank if the error is not reported. Bill can further his good working relationship with the bank by pointing out the irregularity.


Many of life's toughest problems can be solved by asking the ethics test questions. Is it legal? Is it fair? Would I want everyone to know about it? Remember, there's no right way to do a wrong thing.



### New Program Helps Reduce Cost Of Treating Depression

(NAPS)—Most people greet each day with enthusiasm. Yet, for some, the thought of getting out of bed and starting another day is overwhelming. These unfortunate individuals may be suffering from a debilitating condition—depression.

One in five Americans will be affected by depression at some point in his or her lifetime. This year, 12 to 14 million Americans will suffer from it. For many, the cost of depression extends beyond the emotional suffering. There also is the financial strain due to costs for diagnosis, treatment, and care, as well as societal costs associated with lost productivity such as days lost from work.

Depression is a chronic condition that causes more days lost from work and greater use of health care services than other chronic medical conditions (such as diabetes and hypertension), with the exception of chronic heart disease. According to a recent study published in *The Journal of Clinical Psychiatry*, the annual cost of depression to the American economy is approximately \$44 billion, of which \$12.4 billion is assigned to direct costs, \$7.5 billion comprises loss of lifetime earnings, \$11.7 billion is attributed to lost work days and \$12.1 billion is associated with decreased productivity while at work. With these staggering numbers it is not surprising that Dr. Jan Fawcett, professor and chairman of the Department of Psychiatry at Rush Presbyterian St. Luke's Medical Center in Chicago, says that "the long-term and recurrent nature of depression, as well as the significant costs associated with undertreat-
