## Pre-Registration Dates Set

### Clarendon Elementary

Clarendon Elementary Principal, Mike Word, has set a date for pre-registration for all new students and returning students who have not pre-registered for the 1994-1995 school year. Students in grades kindergarten thru fifth grade should come for pre-registration on August 4, 1994 from 9:00 a.m. to 12:00 p.m. to 4:00 p.m., in the cafeteria.

## Early Childhood Education Screening Set

Clarendon Elementary Principal, Mike Word, has set a date for the screening and testing of students who may be eligible for the Early Childhood Education class offered at the Elementary Campus. ## Emergency CRP Haying And Grazing Authorized

Adverse weather conditions during the 1994 growing season have affected the growth and yield of pasture, hay, fed grains, and other forage supplies in Donley County. To remedy these conditions, USDA's Agricultural Stabilization and Conservation Service recently authorized farm program participants here to (Graze Livestock or Harvest Hay) on land in the

Conservation Reserve Program (CRP) through September 30.

"Our objective is to help livestock producers through this difficult period while also preserving the cover and wildlife that nest there," Drew Thornberry, County Executive Director of the ASCS office, said.

"Several restrictions apply to haying and grazing on CRP lands, so as to sustain the environmental protections that are the heart of the program," Thornberry said. To qualify, farmers and ranchers must show a 40 percent loss in hay and pasture production.

CRP participants who use the emergency haying and grazing program will have their current rental payment reduced by 25% as established by the State ASC Committee. They must also agree to leave at least 25 percent of each field or contiguous fields undisturbed for wildlife. Producers must designate the CRP acreage to be either hayed or grazed, but not both on the same acreage. Only one cutting of hay may be removed.

Hay harvested from CRP acres may be used by CRP participants to maintain their own livestock, or may be sold only to an approved livestock producer in an approved county. The same restrictions apply to grazing. "Producers who violate these conditions will be subject to having

Thornberry said vegetative cover specifications in the CRP contract will not be waived because of participation in this special authority, and any permanent destruction of CRP cover must be re-established at the owner's expense. No assistance will be provided for livestock facilities such as fences or water equipment on CRP acres.

"To take advantage of these options, farmers and ranchers must apply in person and report any acres harvested and/or grazed to our office," the ASCS official said. No haying or grazing is permitted without prior USDA approval.

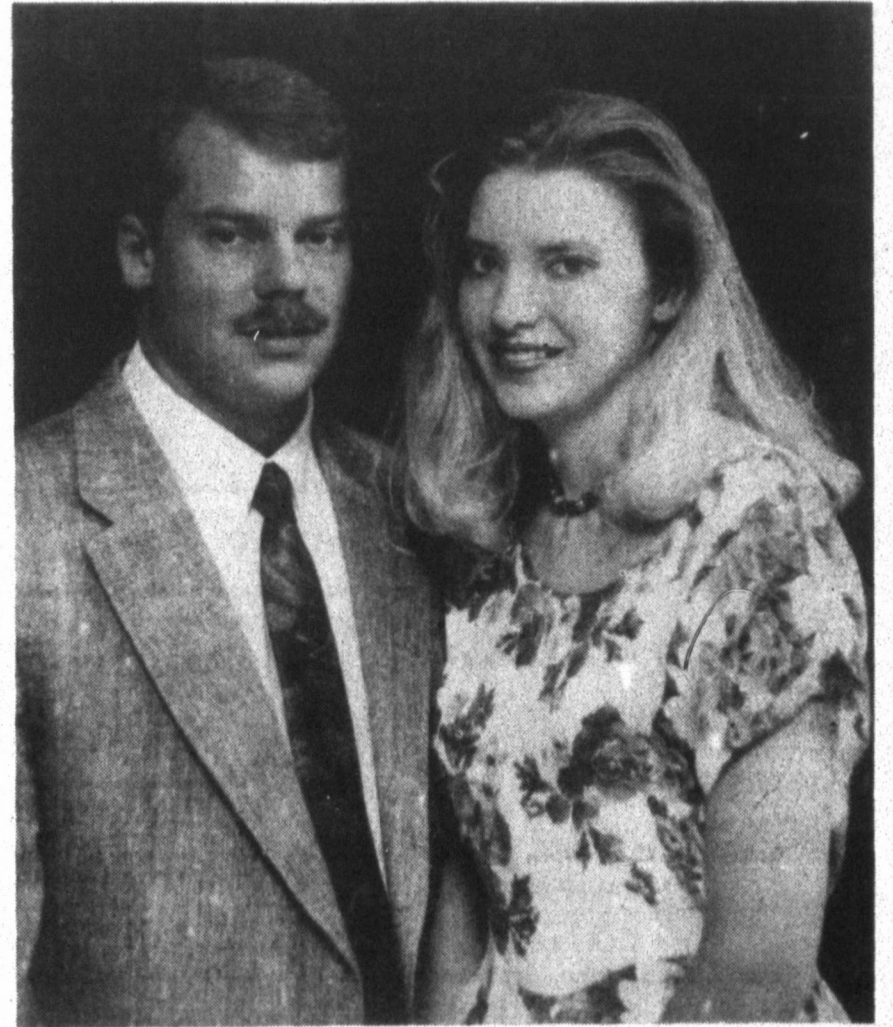

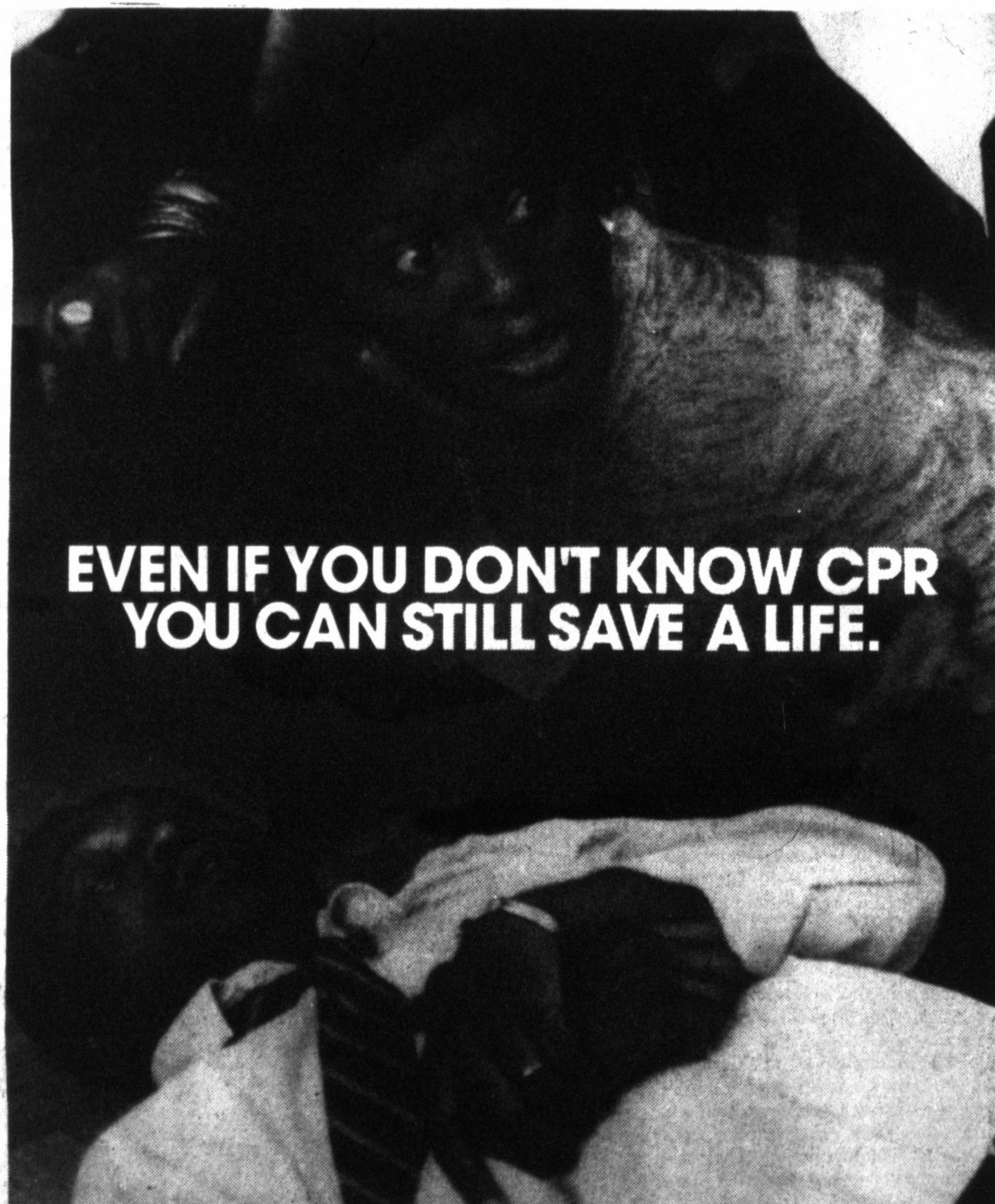

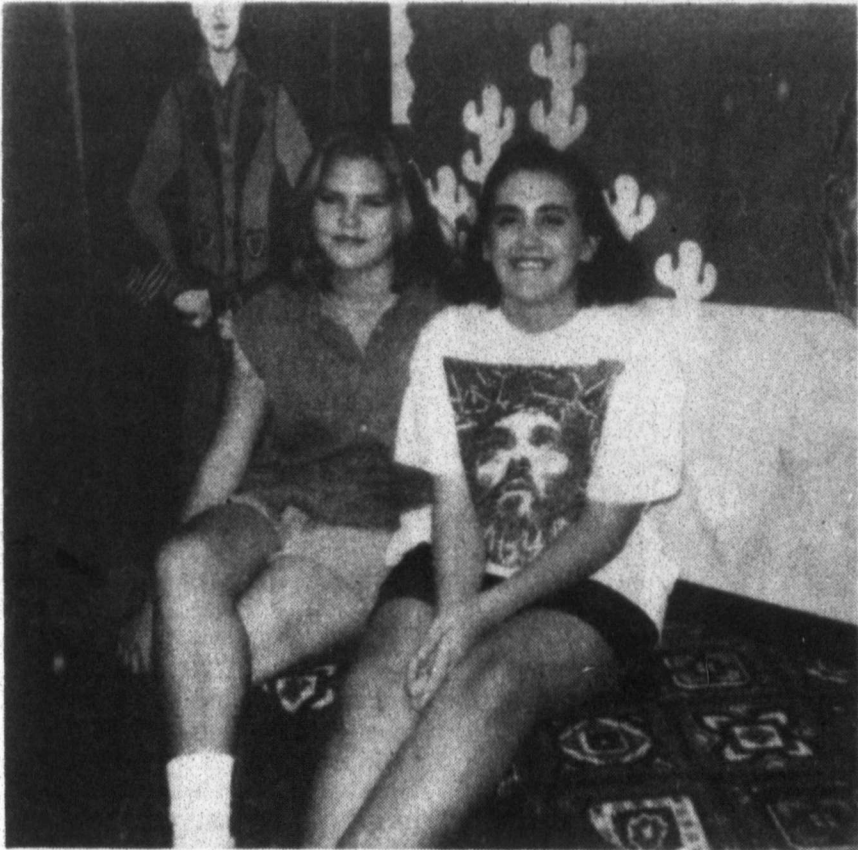

## Dr. Dobson Answers Your Questions

**QUESTION:** Our 15-year-old son literally seethes with hostility at home—at his mother and me, at his sisters, and at the world. Believe me, we have done nothing to provoke this anger, and I don't understand what has caused it.

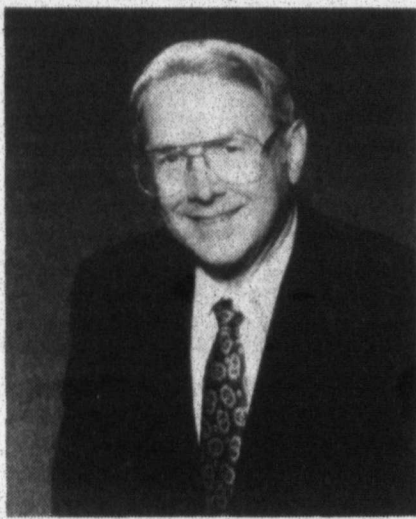
But other parents of teens report the same problem. Why are so many adolescents angry at their parents and families? Sometimes they seem to hate the people who love them the most!

**DR. DOBSON:** At least part of the answer to that question can be explained by the "in-between" stages of teenagers. They live in an era when they enjoy neither the privileges of adulthood nor the advantages of childhood.

Consider the plight of the average 15-year-old. All of the highly advertised adult privileges and vices are forbidden to him because he is "too young." He can't drive or marry or enlist or drink or smoke or work or leave home. And his sexual desires are denied gratification at a time when they scream for release.

The only thing he is permitted to do, it seems, is stay in school and read his dreary textbooks. This is an overstatement, of course, but it is expressed from the viewpoint of the young man or woman who feels disenfranchised and insulted by society. Much of the anger of today's youth is generated by their perception of this injustice.

There is another side to this issue of adolescent volatility. I'm now convinced that the hormonal changes occurring in a developing body may be more important to feelings than we thought earlier. Just as a woman's emotions are set on edge by premenstrual tension, menopause and extreme fatigue, it



is entirely possible that the adolescent experience is largely hormonal as well.

How else can we explain the universality of emotional instability during these years? Having watched thousands of children sail from childhood to early adolescence, it still amazes me to witness textbook characteristics suddenly appearing on schedule as though responding to a pre-programmed computer.

**QUESTION:** Alright, so my kid feels disrespected and hostile. I still have to impose some limits and discipline on him, don't I?

**DR. DOBSON:** Yes, but it is possible to lead teenagers without insulting and antagonizing them unnecessarily.

I learned this lesson when I was a junior high school teacher. It became clear to me very early that I could impose all manner of discipline and strict behavioral requirements, provided I treat each young person with genuine dignity and respect.

I earned their friendship before and after school, during lunch and through classroom encounters. I was tough, especially when challenged, but never discourteous, mean or insulting. I defended the underdog and tenaciously tried to build each child's confidence and self-respect.

However, I never compromised my standards of deportment. Students entered my classroom without talking each day. They did not chew gum, behave disrespectfully, curse or stab one another with ball point pens. I was clearly the captain of the ship, and I directed it with military zeal.

The result of this combination of kindness and firm discipline stands as one of the most pleasant memories of my professional life. I loved my students, and I had every reason to believe that I was loved in return. I actually missed them on weekends (a fact my wife never quite understood).

At the end of the final year when I was packing my books and saying goodbye, 25 or 30 teary-eyed kids hung around my gloomy room for several hours and finally stood sobbing in the parking lot as I drove away. And yes, I shed a few tears of my own that day.

(Please forgive this self-congratulatory paragraph. I haven't bothered to tell you about my failures, which are far less interesting.)

### Assistance Program Available

Confined animal feeding operations in Donley County who are not required to have a state or federal water quality permit are advised of the opportunity to receive technical assistance through the Donley County Soil and Water Conservation District to develop a site specific water quality management plan to prevent or minimize the potential of their operation contributing to a non-point source pollution problem.

"The advantage of participating in this program is that if a operator voluntarily develops and maintains a site specific water quality management plan (WQMP) through our district and has that plan certified by the Texas State Soil and Water Conservation Board (TSSWCB), the operator

will be compliant with state water quality law and exempt from other state regulatory processes regarding nonpoint source discharge of pollutants," said Diek Bode chairman of the Donley County SWCD.

"Of course the producer will have to maintain his or her plan to retain their certification," added Mr. Bode.

In explaining a water quality management plan Bode said that a WQMP includes appropriate land treatment practices, production practices, management measures, technologies or any combination to achieve a level of pollution prevention or abatement.

S.B. 503, which has passed in the last regular session of the Texas Legislature names the TSSWCB as the lead agency in Texas for activities relating to abating agriculture and silvicultural nonpoint source pollution.

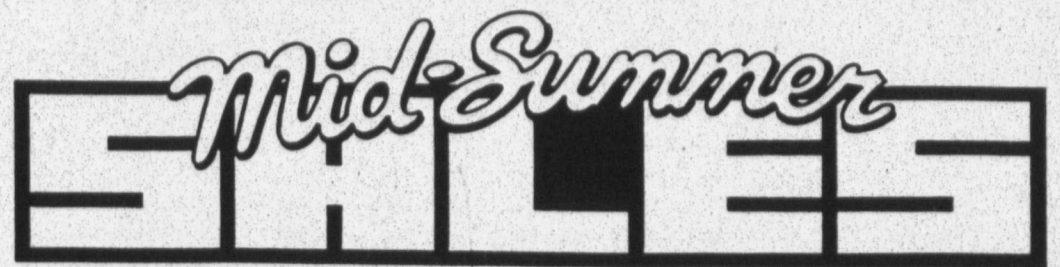
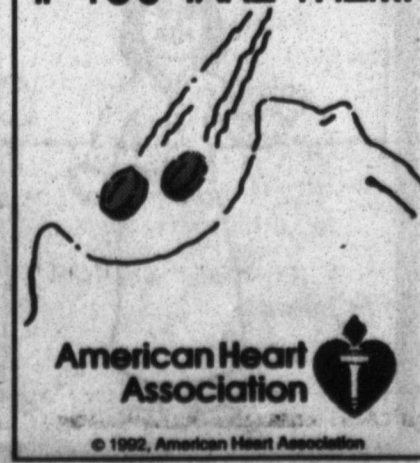
The TSSWCB is responsible for assuring that individual water quality management plans comply with state water quality standards established by the Texas Natural Resource Conservation Commission.

"As a result each WQMP developed, maintained and implemented by a landowner or operator through a SWCD must meet rules and criteria adopted by the TSSWCB," said Bode.

"With a little fine tuning and certification of an existing soil and water conservation plan for a confined animal feeding operation, a producer might find that his or her operation will adequately meet state water quality goals," said Mr. Bode.

Best management practice standards will be based on criteria in the current USDA Soil Conservation Service field office technical guide for our district Mr. Bode said.

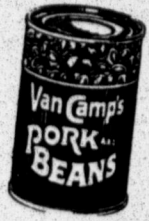
