## Donald Garman Receives Silver Beaver Award

John E. Corbally, President of the Foundation, states, "Until now, most libraries could usually afford only moderately priced feature films. Our support is making the best programs in the arts, the science, and the humanities available to everyone with a library card."

## Cotton Production Meeting Scheduled

Donley County cotton producers will have an opportunity to prepare for the 1989 year by attending a cotton production meeting that will be held on Monday, February 13, 1989, at the Lelia Lake Community Center in Lelia Lake. The meeting will start at 9 a.m. with registration, and last until approximately 12:30 p.m.

The big topic that I have heard about since I have been here is the expected Boll Weevil problems. This will be addressed by Dr. Carl Patrick, District I Extension Entomologist. Carl will also discuss the Diapause program, which seems to be getting increasingly more interest by producers in this area. Diapause is a state of reduced activity that weevils must go into to make it through the winter. To reduce the spring population of

boll weevils in cotton fields, weevils can be suppressed before they leave the field for hibernation sites with fall insecticide treatments. There are other management practices that the producers have to follow also to make the diapause program work, and Carl will discuss these.

Dr. Michael Hickey, Extension Soil Specialist, will be on the program to discuss soil fertility, and Dr. James Supak, Extension Cotton Specialist, will be present to discuss cotton varieties, weed control, harvesting and other management practices.

Donuts will be provided by Clarendon Gin and coffee provided by Paymaster Gin.


Mrs. Woody said, "We have been a long time in getting this far on the history book, and we would like to get this project finished soon as possible, so please help us by getting your reservation in soon."

Midshipman Brent W. Hayworth of Clarendon, Texas recently returned to the U. S. Merchant Marine Academy, Kings Point, N.Y. where he is a student, after a six month training period at sea.

Midshipman Hayworth sailed on a variety of U.S. Flag Merchant vessels in an academy work-study program designed to provide our nation's future merchant marine officers with shipboard experience. Among the countries he visited

were Russia, Sicily, Germany, Holland, England, Peru, Panama, Brazil, Liberia, Senegal, South Africa, Cape Verde, Ethiopia, Sudan Djibouti, and Yemen.

A graduate of Clarendon High School, Midshipman Hayworth worked a full eight hour day aboard ship in the engine department and was required to complete an academy sea project after working hours.

The Academy, operated by the Maritime Administration of the U.S. Department of Transportation, offers an accredited four-year program leading to a merchant marine license, a Naval Reserve commission, and a Bachelor of Science Degree in Marine Engineering Systems.

## Purchase Plan--cont'd from p.1

Letters explaining the purchase offer should reach borrowers throughout the State early this week, he said.

FmHA is required to raise \$584 million from asset sales this fiscal year, the third sale mandated by the 1986 Reconciliation Act. Last year, more than \$900 million was collected when borrowers bought 3,300 loans nationwide.

"We don't know what to expect in terms of purchases this year," Futch said. "But if we don't raise enough in that way, we will have to consider other approaches, including a sale of loan assets, to enable us to meet the target."

Futch said no deposits will be required for loans purchased by March 9. For loans purchased between March 10 and May 9, a 5 percent good-faith deposit is required by March 9, and the sale must be completed by May 9.

The discount will depend on factors such as the loan's interest rate, type of financing, and maturity. Letters have been sent to the borrowers including a "pricing grid" to help borrowers determine their discount.

Medicines for Relief of Diarrhea

Diarrhea is usually defined as a watery stool or bowel movement. Symptoms sometimes encountered with diarrhea include abdominal cramps, nausea, and feverishness. Diarrhea occurs as one of the mechanisms used by the body to counteract the presence of irritating or toxic substances. There are many causes of diarrhea including diet, medications, stress and food allergies. Acute diarrhea comes on quickly and usually lasts for no more than two or three days. Diarrhea which lasts a week or longer should be evaluated by a physician.

One nondrug approach to diarrhea care is body fluid replacement. Drinking carbonated beverages that have lost their "fizz," solutions of liquid gelatin dessert, or commercial electrolyte solutions may be helpful.

Prescription and nonprescription medicines for diarrhea often contain narcotic-like agents. These medicines decrease the propulsive movement of the intestines, thereby correcting diarrhea and reducing cramping that is sometimes associated with this condition. Other popular anti-diarrhea medicine ingredients are pectin, kaolin, and activated charcoal. These agents absorb toxins, bacteria, and other irritating substances.

## City Minutes

January 24, 1989

### PUBLIC HEARING

The Board of Aldermen of the City of Clarendon met in regular session on January 24, 1989, in the Board Room, City Hall, at 7:00 p.m.

Members present: Mayor David Davidson, Aldermen James Thomas, Benny Osburn and Lynn Floyd.

Others present: City Secretary Donna Edwards, Arthur G. Grant and Keith Cunningham of Mission Cable Company, Perna Strickland from PRPC, Terry and Kay Bernabe, Ricky Rattan, Darrell Lefew, Gordon Maddox, and Gayla Fletcher.

Minutes of the January 10, 1989, meeting were read, and approved. Motion carried.

Mayor Davidson then opened the Public Hearing for the purpose of discussing the Texas Capital Fund grant program. Perna Strickland from the Panhandle Regional Planning Commission outlined the various aspects of the Texas Capital Fund grant program and answered questions pertaining to the requirements to be met for this program. Some of the requirements to be met by anyone interested in this source of funding are as follows:

The purpose of the program is to create jobs.

Will not fund businesses relocating within the State of Texas.

The Texas Department of Commerce will not consider competing applications.

The Texas Department of Commerce will not fund bankrupt businesses.

Applications will be accepted every two months. The City may only submit one application at a time.

February 15, 1989, is the next application deadline.

The maximum that can be funded is \$500,000 and the minimum that can be funded is \$50,000.

The Texas Capital Fund provides funding for 25% to 40% of the project. Local injection into the project is also required.

Up to 800 points can be assigned to the application based on the areas of Unemployment Rate, Minority Hiring, and Project Design.

Ms. Strickland discussed some of the projects that have been funded in the Texas Panhandle and other details relevant to the program. After all questions had been answered, the Board determined that this program is worth pursuing. Another Public Hearing will be held when any business interested in securing funding through the Texas Capital Fund program has assembled all the required information necessary to have the City make application to the Texas Department of Commerce. The Public Hearing portion of the meeting was then closed.

Mr. Keith Cunningham of Mission Cable Company explained to the Board that his company has purchased Cablevision of Texas and that they plan to provide good service to the community.

Discussion followed about the City joining the Panhandle Regional Planning Commission. Motion was made to join PRPC. Motion carried.

Gordon Maddox, CPA, presented the audit for the 1987-88 Fiscal Year to the Board. After going over each aspect of the audit, the Board of Aldermen, voted to approve the audit.

The Board agreed to purchase a humidifier for City Hall because of the amount of static electricity being generated and the harm it could do in regard to the computer.

Aldermen voted to pass an ordinance providing for a penalty to defray costs of collection of delinquent taxes.

### ORDINANCE #277

WHEREAS, the City Commission of the City of Clarendon deems it necessary to have a declared policy regarding the expense of collecting delinquent taxes due the City of Clarendon, and

WHEREAS, the City Commission of the City of Clarendon is of the opinion that said expense of collecting said delinquent taxes should be borne by the delinquent properties and their owners who are responsible for causing such expenses.

Now THEREFORE, BE IT ORDAINED by the City Commission of the City of Clarendon:

Section 1: Whenever any accounts for delinquent taxes owed the City of Clarendon are given to its tax attorney for collection, on or after July 1 of the year they become delinquent, the City of Clarendon shall be entitled to, and shall collect, an additional penalty of fifteen (15%) percent of the delinquent taxes and penalty (including any interest owed) due on each delinquent property at the time of collection, either before or after suit and or foreclosure sale, as provided by Section 33.07 of the Texas Property Tax Code.


Section 2: In addition to the collection expenses provided for in Section 1 above, the City of Clarendon

WHEREAS, the Texas Legislature has adopted Article 6081r, V.A.C.S., for the purpose of allowing the State of Texas, and its political subdivisions, to participate in the federal program established under said Public Law 88-578, or such other programs as are hereinafter established by the federal government; and

WHEREAS, the City of Clarendon is fully eligible to receive assistance under this Program; and

WHEREAS, the City Council of the City of Clarendon is desirous of authorizing its administrative staff to represent and act for the City in dealing with the Texas Parks and Wildlife Department concerning this Program;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CLARENDON, TEXAS:

Section 1: That the City Council of the City of Clarendon hereby certifies that the City is eligible to receive assistance under Public Law 88-578; as augmented by Article 6081r, V.A.C.S.

Section 2: That the City Council hereby authorizes and directs its Mayor to represent and act for the City in dealing with the Texas Parks and Wildlife Department for the purpose of this Program. The Mayor is hereby officially designated as the City's representative in this regard.

Section 3: The City Council hereby designates its City Treasurer as the official authorized to serve as the City's fiscal officer to receive federal funds for purposes of this Program.

Section 4: The City Council hereby specifically authorizes the City officials herein designated to make application to the Texas Parks and Wildlife Department concerning the tracts of land to be known as the City of Clarendon City Park in the City of Clarendon for use as a park site. That the City of Clarendon City Park is hereby dedicated for public outdoor recreation purposes.



## Exercise Leads To A Healthy Heart

Exercise is one of the most effective safeguards against America's number one killer—cardiovascular disease—says The National Exercise For Life Institute. In 1986, heart disease claimed the lives of 978,500 Americans or one every 32 seconds, according to the American Heart Association.

"February — National Heart Month—is a good time to think about the health of your heart and to make some permanent changes in your lifestyle attitudes and habits," says Diane DeMarco, executive director of the Twin-Cities based Institute.

Today, 65.9 million Americans have cardiovascular disease, and the AHA estimates that more than 500,000 Americans will die from heart attacks this year.

The main cause of heart disease is atherosclerosis, a slow build up of cholesterol and fatty tissue in the arteries. Eventually, your arteries harden and narrow as the build up increases, restricting blood flow. When the arteries supplying blood to the heart muscle narrow to about two-thirds of their normal width, you may be a candidate for a heart attack.

However, the good news is that healthier lifestyles and preventive medicine can help deter cardiovascular disease. Experts say that the best way to prevent the disease is to stop smoking, lower your blood pres-

sure, eat a proper diet (in order to reduce your blood cholesterol levels) and engage in regular aerobic exercise.

Aerobic exercise involves continuous and rhythmic physical motion that elevates your heart rate to 70 to 85 percent of its maximum capacity. Examples are brisk walking, swimming, cycling, jogging and cross-country skiing. To be effective, it generally needs to be done about half an hour, three days a week.

"The toughest part of exercising is keeping it up week after week. Many people who start a new exercise regimen don't stick with it because of boredom, lack of time, or choosing the wrong activity," explains DeMarco.

"When choosing your exercise program, select an aerobic activity you really enjoy. Then make a contract with yourself to work out regularly. Try to anticipate excuses for not exercising, and find answers to deal with them. Finally, set goals for yourself and keep a log of your progress," continues DeMarco.

DeMarco also advises that people consult with their physician before embarking on a exercise program.

Today, many people's personal exercise programs include cross-training, which combines in-home exercise equipment,

such as the NordicTrack cross-country ski exercise machine, with outdoor exercises. Cross-training allows for variety in an individual's exercise program.

"At-home exercise equipment such as the NordicTrack is quickly gaining popularity because it duplicates the motion of cross-country skiing, which is considered by fitness experts to be the most efficient aerobic exercise," says Ed Pauls, inventor and founder of NordicTrack.





Lakeview boys and girls both won consolation by defeating the Hedley teams.







## Doorposts

Deuteronomy 6:7-9

"I cannot come down"

"We need to set up a meeting to discuss the situation."

"I'm busy. Why should I stop my work just to talk to you?"

A reasonable request? A rude, arrogant response? This is a paraphrase of a discussion recorded in the sixth chapter of Nehemiah. The request was made by Sanballat and Tobiah. The response was Nehemiah's.

Nehemiah was a Jew living in exile in Persia, and was cupbearer to the king of Persia. "Cupbearer" sounds much like just another servant to us, but it was a position of responsibility and prestige, and one which allowed considerable familiarity with the king. In such a

position, Nehemiah was able to share with the king his concern for the deplorable condition of Jerusalem and its residents. He also obtained permission to go to Jerusalem to rebuild the city, and even received considerable financial help from the Persian monarch (Nehemiah 2:4-9).

How did Nehemiah, in effect a prisoner of war, receive such favor from a foreign king? How did he ever secure such a position as cupbearer in the first place? related to them (the rulers of Jerusalem) how God's hand of blessing had been upon me." (Nehemiah 2:18). "We know that for those who love Him, for those called in agreement with His purpose, God makes all things work together for good" (Romans 8:28).

Nehemiah encountered opposition from the very beginning, mainly from Sanballat, Tobiah, and their cohorts (Nehemiah 2:10). Far from being a reasonable request, the desire of Sanballat and Tobiah to meet with Nehemiah was a last-ditch effort to hinder his rebuilding. And far from being a rude, arrogant response, Nehemiah wisely saw through their scheme: "...They planned to harm me" (Chapter 6, verse 2). But even more important to Nehemiah than his personal safety was the realization that he was doing the Lord's work, and must not be sidetracked. "...God had put in my heart" the desire to rebuild the city, he tells us in chapter 2, verse 12. That is how he could say, without a trace of arrogance or conceit, "...I am doing a great work, so that I cannot come down..." (6:3).

"I cannot come down." How often do we let the devil's crowd scare us away from making a strong stand for the Lord? How often do we let things that are good in themselves pull us away from the "great work" that He intends for us to do?

"...The wall was finished, having taken a total of fifty-two days," we are told in the sixth chapter—a feat so remarkable that we would be inclined to disbelieve it, except that Nehemiah reminds us, "...this work had been accomplished through our God" (6:16). May the Lord grant us the wisdom to see what is important and what is not, and the courage to stand in His strength and say to those who would distract us, "I am doing a great work: I cannot come down."

taxing unit...may provide for taxation of all automobiles."

Now THEREFORE, BE IT ORDAINED by the Board of Aldermen of the City of Clarendon that all automobiles, vans, trucks, recreational vehicles, motorhomes, travel trailers, trailers, and aircraft required to be registered and licensed for use in Texas of the United States shall be assessed and taxed on their market value in this tax district.

## Old Dreams Hunted at Dump Site

I am writing this week's column from Hedley city dump. This isn't a sanitary landfill. It is a genuine old-time dumpground. I've come here to look for old dreams.

Hedley is one of many little railroad towns sprinkled across West Texas. When you drive in this part of the state, you see lots of them. This particular community sprang up beside the tracks of the Fort Worth and Denver Railway in Donley County in 1907. By 1940 it had as many as 650 people. Today it has about half that many.

On more than one occasion I have tramped through the Hedley dump. The last time I was looking at cast-off kitchen ranges to find replacement springs to go onto the oven door of my 1931 Magic Chef.

This time I'm back searching for dreams...dreams by people I never knew and never even saw.

As I write, I'm sitting on the rusty hood from a 1940's Chevrolet. It's the kind that has a hinge down the middle and latches on right and left to open from either side. I wonder whether it belonged to a local person or maybe to a traveler who broke down or had an accident at Hedley.

Just a dozen feet away lays the upturned body of a turquoise and white '56 Chevy two-door. Someone probably saved or made payments for months to have this dream of status 30 years ago.

Around me cocked at odd angles are white enamel cabinets of stoves and refrigerators. Farm wives in Donley County half a century ago dreamed of the day when these shiny new appliances might grace the linoleum floors in their kitchens.

On one of the mounds of trash is a child's old metal toy wagon less its wheels. It looks forlorn. I wonder if maybe it was a Christmas wish that Santa answered and where its former child owner is today.

Sticking out of the red Hedley sand is a rusted Model T fender. It may have been the dream of that car's owner to have the freedom from mules and wagons to drive from the farm to town to sell eggs, butter and produce anytime he wished, or maybe he wanted to stay in Hedley on Sundays long enough to attend both morning and evening church services and yet get home by late bedtime.

Nearby are rusty bedsprings half buried in the sand. Did they see dreams of happiness and bliss con-

summated on a matrimonial evening? I hope so.

All around me lay broken shards of glass, pottery and china. They bear the trademarks of products that farm wives and mothers throughout this century dreamed of having for themselves and their families, but all too often they couldn't afford to buy them on their cotton farmer husband's earnings. The words embossed in the glass read Noxema, Big Top Peanut Butter, Milk of Magnesia, Ponds Cold Cream, and St. Joseph's Aspirin for Children.

Here in the Hedley dump my only living company is found in the cottontails and birds that I startle, but I keep returning here to walk around in the knee-deep weeds next to the railroad tracks...to keep returning to the place where dreams of the past can be found.


