## City To Take Over Sanitation Operation

Beginning in April, the City of Clarendon will be taking over its own sanitation operation. The contract the City has had with BFI will expire, and it was decided to borrow the money for the purchase of equipment, and hire local people to operate the sanitation department. Although the cost of the operation will most likely be comparable to what it has been, the money will stay at home. The City has no plans at this time to raise the cost for trash collection, but the cost cannot be lowered due to the fact that the City has to pay for a trash truck, dumpsters, and other equipment necessary for the efficient handling of the sanitation operation in Clarendon. A new trash truck for the City arrived last week and training for the operation and maintenance of the truck has been completed by Ernie Johnston who will be overseeing all phases of the sanitation operation.

The City will purchase the BFI dumpsters already in place, after BFI has done needed repairs on them, and trash will be hauled to the nearest landfill that will accept it.

According to "Texas Town and City" published by the Texas Municipal League, there were about 14,000 landfills operating in 1978 in this country. Today, there are about 5,500, and that number is expected to decrease to about 3,300 in 1993, and 2,200 in the year 2000. When the new EPA regulations go into effect in May, cities will have 18 months to comply with the stringent requirements. The expense involved in meeting the new regulations will be too great for cities under 50,000 population and will force them to close their landfills and begin hauling their trash to larger landfills. Ultimately, regional landfills will be the only

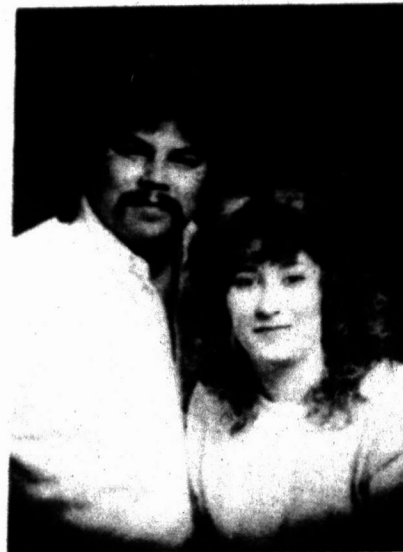

## Looking To The Future

Over the past several weeks, I have been trying to communicate the need for the expansion of the Medical Center Nursing Home. There are several reasons which necessitate a close look into this possibility. Some of the reasons that I feel are important are:

1. There is a need to provide for the present and the anticipated increase in the number of Donley County residents who will require long term care. If our area is moving in the same direction as present national trends, there will be an increasing need for more nursing home beds in the Clarendon area. According to statistical data from the Panhandle Regional Planning Commission the area including Donley, Hall, Briscoe, Armstrong, and Collingsworth counties will all be experiencing and increase in the population of the 70 and above age group.

2. In the three years since I became the administrator of the Medical Center, we have noticed a continuing increase in the cost of operations. I am sure that nearly anyone who is in business for them-

selves can identify with this situation. We have seen an increase in labor costs, tax liability, food costs, nursing supply costs, maintenance and repair costs, utility costs, and the list goes on. With the maximum capacity of the nursing remaining at 43 beds, there is an increasing problem with keeping up with the cost of operating the nursing home. That is very graphically illustrated when you consider the size of the average nursing home in the state of Texas is about doubled the size of the Medical Center.

3. With the signing of the Omnibus Budget Reconciliation Act of 1987 (OBRA '87), the nursing home industry was faced with the most sweeping changes it has experienced since the late 60s and early 70s. With the changes are new regulations which have and will continue to create an additional financial burden on the facility. Most of these changes are in regard to the new Life Safety Code for building construction and fire safety, and increased staffing requirements and educational upgrading of staff members. We have recently completed partial compliance with new Life Safety Code requirements which cost \$30,000.00, and there are more changes in the future.

4. We feel that an expansion of the Medical Center will have a positive impact on the community. We will be able to hire additional staff personnel and hopefully that will have its effect on our local economy. It also will help to give a progressive, forward-moving impact on the community. In a time of slow or declining growth in so many areas of the state and area, it might be a breath of fresh air to see some growth. I see this type of impact personally as I see the renovation and expansion of the public schools.

5. Finally, I feel that to be viable over the next 5 years this expansion will prove to be more of a necessity than a luxury. We need to have the additional tax increases be generated by such a project. The answer to the future is not additional tax increases each year, but a planning for the future that will enable the Medical Center to do a better job than we are doing now. After all, if we're not moving forward we are in all likelihood moving backward! That can provide to be tragic if not fatal. I can't help but think of what the Book of Proverbs says when the writer states, "Without a vision, the people perish."

Think about it. As always, your comments are needed and appreciated.

## Public Notice

Southwestern Bell Telephone Company intends to file an application with the Texas Public Utility Commission to introduce new optional services - Call Control Options. The initial service areas will be Laredo, McAllen and Austin. Expansion into other service areas will be based on availability. Customers in other areas will be notified when these services become available.

Call Control Options include six new services - Call Blocker, Call Cue, Call Return, Priority Call, Call Trace and Selective Call Forwarding. The features will be available to single-line residence and business customers.

**Call Blocker** - enables the customer to block incoming calls from a maximum of three specified telephone numbers and/or to block the last incoming call.

**Call Cue** - enables the customer to automatically redial the last outgoing telephone number dialed. If the recalled number is busy, equipment will monitor the line for a maximum of 30 minutes and will let the customer know when the call can go through.

**Call Return** - enables the customer to automatically redial the telephone number of the most recent incoming call. If the number is busy, Call Return will continue to dial the number for up to 30 minutes, or until it completes the call.

**Priority Call** - provides the customer with a distinctive alerting signal, ring or Call Waiting Tone (if the customer has subscribed to Call Waiting), when the customer is called from a maximum of three preselected telephone numbers.

**Call Trace** - enables the customer to initiate a trace of the last incoming call received. The number, date and time will be recorded by Southwestern Bell Telephone so that the call's origin can be identified.

**Selective Call Forwarding** - enables the customer to forward incoming calls from specified telephone numbers (maximum of three) to another telephone number.

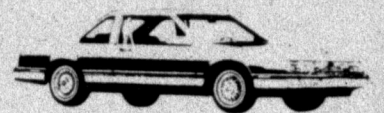

## Additional Exemptions May Lower Your Taxes

If you became 65 or disabled during 1989 you may qualify for additional property tax exemptions on your homestead. If you bought a different home during 1989 you may need to file a new homestead exemption application. Applications should be filed by May 1.

If you received a homestead exemption on your present home in 1989 you will not need to reapply for 1990.

Farmers and ranchers who need to apply for productive valuation must do so by May 1. Applications are available at the Appraisal District office.

By filing an affidavit, over-65 homeowners may be granted a deferral on their property taxes. For complete details contact the Appraisal District Office.

## NOTICE OF TARIFF CHANGE TO CENTRANET® SERVICE

The names of the three CentraNet® packages have changed from Standard, Premium, and Deluxe to CentraNet® 1000, CentraNet® 2000, and CentraNet® 3000, respectively. Direct Call Pickup has been added to the three CentraNet® packages while Multiple Call Park and Shared Speed Call 30 have been added to CentraNet® 2000, and Speed Call 30 and Call Forward Busy/No Answer Split have been added to CentraNet® 3000. Flexible Night Answer and Automatic Route Selection also have been added as new optional features.

The proposed changes and new service offerings have been assigned Docket No. 9251, and pursuant to Section 43(d) of the Public Utility Regulatory Act will become effective June 23, 1990. Rates for service will be applicable to customers who subscribe to the service as well as existing customers. Therefore, there will be no effect on any other rates of the company. The company's gross annual revenues will increase by approximately \$399,600, or less than one percent annually.

The proposed rates are on file with the Public Utility Commission of Texas, and are available for public inspection at the offices of GTE Southwest Incorporated. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission. The deadline to intervene in this docket is 3:00 p.m., April 9, 1990.

option and will force cities to haul trash many miles for disposal. Under the new EPA regulations, landfills will no longer accept tree limbs, grass clippings, and tires, (unless the tires are quartered). Reducing the volume of garbage that must be buried is becoming an urgent priority for cities. This will make mandatory recycling programs the only solution for the future.

The City will need your help to comply with the new regulations. Even though it will be several months before we are forced not to carry grass clippings and tree limbs and tires to a landfill disposal site, our new trash truck will not be able to handle these items beginning in April as it has a smaller capacity than the BFI trucks and there is only one truck as opposed to the three trucks that BFI was using for garbage pick-up. Tree limbs can be carried to the large open top dump box (north of Thriftway) and a key to the gate can be obtained at City Hall as before. (Later, these limbs will have to go to a wood chipper or other alternate plan.) Grass clippings should be spread in the alley or composted. Tires must be quartered. Cooperation from all our residents will help enormously to ensure a successful, efficient, sanitation operation in Clarendon.

Maybe it was his three bank accounts containing a total of \$207,421.00.

Ten years ago, Morris' father died and left the money to him. When Morris did not claim it, the Division of Unclaimed Property tracked him down, and his family forced him to accept it. He did not show up at the ceremony when the cash was handed over. He took enough of the money to buy an old car, where he slept in bad weather. Relatives rented him an apartment; he never went there. He died December 14, 1989 with three dollars in his pocket and an untouched fortune in the bank.

Sound crazy? Well, figure this one out.

A couple of thousand years ago, our Heavenly Father ratified His will, and left all of his children eternal wealth--life, peace, victory. To this day many have not claimed the windfall and some have refused to spend any of it. Lost people shuffle down blind alleys of an empty existence, facing hell for eternity, and ignore the salvation promised in Christ. Many Christians, who have heaven for their final destination, content themselves with a grubby, isolated, unproductive life on this earth.

Old Morris lived a wasted life and died a futile death, but I can't be too quick to point the finger at him. He was only dealing with the temporary, while many of us play the same losing game with the eternal.

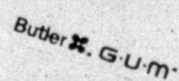

## Private Applicator Training To Be Held

Donley County producers will have the opportunity to complete training to meet one of the requirements for obtaining a private applicator license at a program scheduled for April 5, 1990, at 8:00 a.m. at the Clarendon College Ranch Operations Classroom in Clarendon, Texas, according to Tim Trimble, County Extension Agent.


To become a licensed private applicator, a producer must attend a Texas Agricultural Extension Service private applicator training program, make a passing score on a Texas Department of Agriculture (TDA) private applicator examination and submit an application to TDA along with a required \$50 fee. The TDA private applicator license is valid for five years.

Producers holding TDA private applicator certificates dated prior to January 10, 1989, may continue to buy and use restricted-use and state-limited-use pesticides.

Producers holding TDA private applicator certificates dated January 10, 1989 and after, but prior to January 1, 1990, may also continue to buy and use restricted-use and state-limited-use pesticides. However, persons holding private applicator certificates dated January 10, 1989 and after, but prior to January 1, 1990, will be required to become licensed private applicators within five years.

The private applicator training program is available to those persons not previously certified and to those previously certified who will be supervising the application of restricted-use and/or state-limited-use pesticides and who wish to obtain a TDA private applicator license.

Texas Department of Agriculture personnel will offer testing at the same location beginning at 1:00 p.m. on April 5, 1990. Persons who plan to attend the training session and take the TDA test are encouraged to obtain a copy of "Using Pesticides - Private Applicator Manual" from the county Extension office for review and study prior to attending the training session.



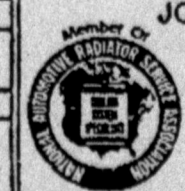
