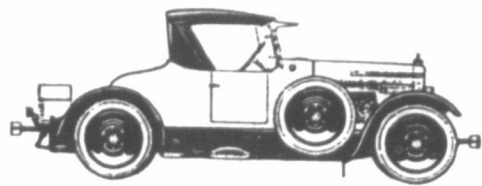

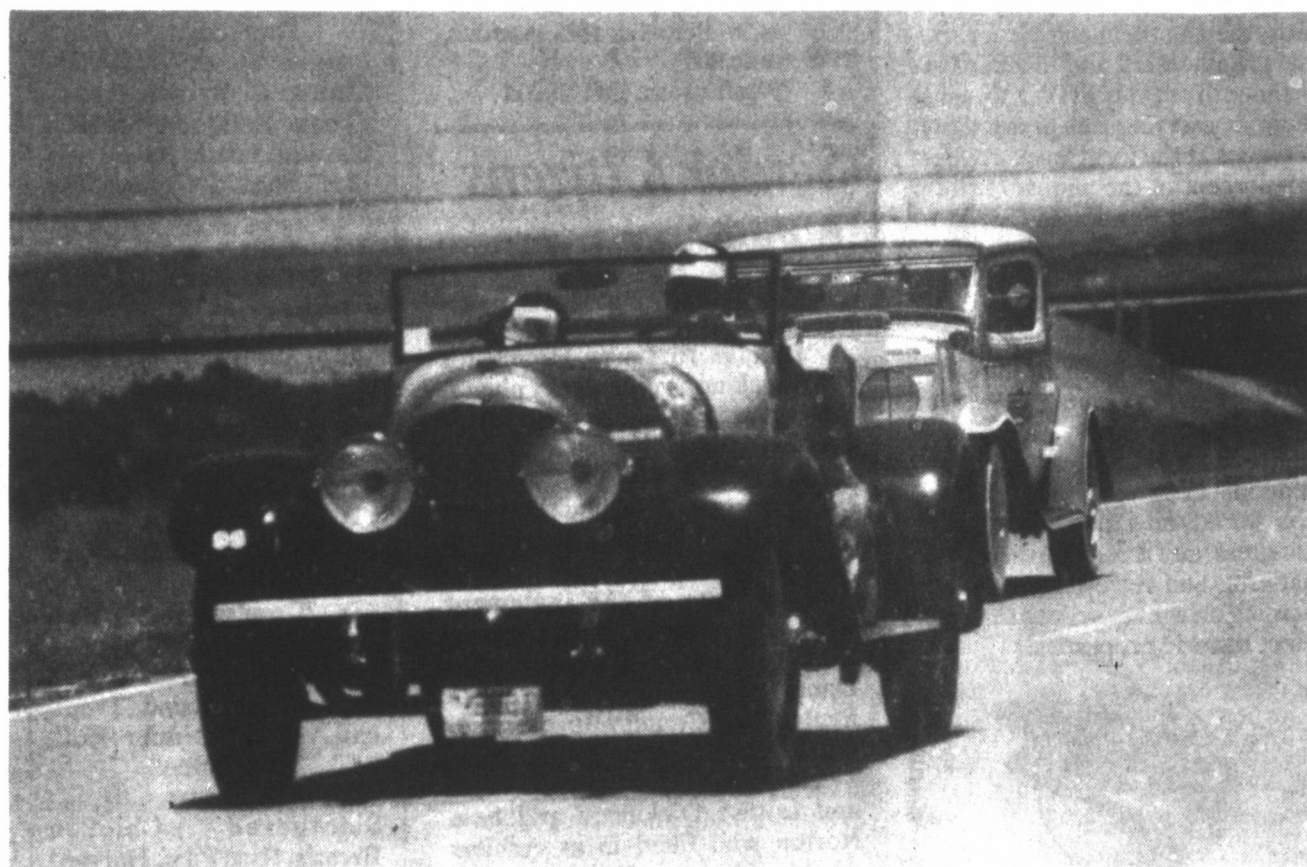

Grain Elevator Removed From List

Any grains put into storage in Clarendon Grain Elevators, Inc. will not be eligible for price support loans during the period this facility is removed from the list of warehouses approved by the commodity Credit Corporation, the County Agricultural Stabilization and Conservation Service Office said today.

Removal action was taken by the Agricultural Stabilization and Conservation Service Commodity Office at Kansas City, Missouri, due to the warehouseman's request to cancel the Uniform Grain Agreement which controls the storage of Government-owned grain.



BUSY TIME IN THE BACK COUNTRY. Like its 9 predecessors, The 10th Annual Interstate batteries Great American Race will cross America June 21-July 4 using back roads 90% of the time. Paper Gets New Software

Subscriptions to *The Clarendon News* are now handled by a new software package that is vastly superior to the one in use for the last four years. The new program was developed by Terry Bernabe of KCR Corporation.

The new program keeps track of subscription dates and addresses, prints out the labels for the papers, sorts the labels into appropriate groups and into sequence within each group. It also counts the number of papers going to each section, zip or zone and fills out the postal report for each week. When a subscription expires, the computer drops the name and address back into an inactive file.

Your paper will soon have a bar code on the address label, too. Bar codes are easily read by computerized sorting machines. With this new technology, the paper hopes to get the subscriber's paper into his box as quickly as possible.

KCR has spent hours and hours getting the program perfected. The company has given exceptional customer support in making sure that everything worked as intended. The transition has been far smoother than anticipated.

As a result of the new program, the Clarendon Post Office gets each week's newspaper boxed several hours quicker, and out-of-county subscriptions should reach their destination several days earlier.

According to Genevieve Caldwell, President of the local chapter of the American Cancer Society, area residents are getting letters from a group calling itself "The Cancer Fund of America". That organization is highly suspect, and people should investigate before donating to it.

According to a recent response by Ann Landers, the Cancer Fund of America has deliberately tried to copy the appearance of the American Cancer Society, but is not approved by the National Charities Bureau nor the Better Business Bureau. The nationally syndicated column wrote that the Cancer Fund of America is being sued by 12 states.

Fly-by-night "charities" hurt legitimate organizations like the American Cancer Society.

"There are only two major, nationwide, cancer organizations," Mrs. Caldwell said, "The American Cancer Society and the National Cancer Institute. The National Cancer Institute is Federally funded and is not soliciting funds." Donor would be wise to restrict their cancer gifts to the American Cancer Society.

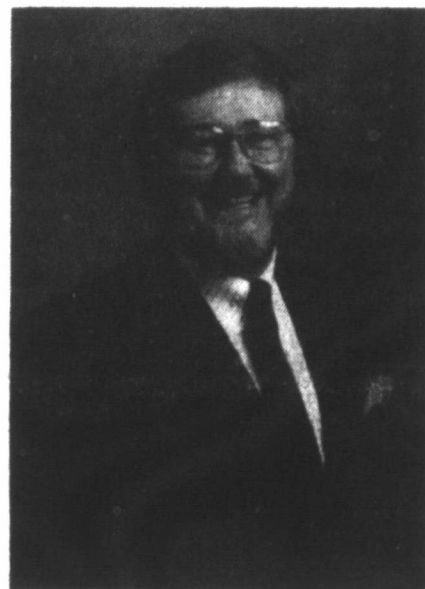

Donley County has the opportunity to become a Historic Community. Information to property owners begins with:

What is The National Historic Preservation Act?

The National Historic Preservation Act of 1966, as amended (16 U.S.C. 470) is the nation's central historic preservation law. It establishes the legal land administrative context within which local historic preservation commissions relate to, and participate in, the national historic preservation program.

Passed at a time when Americans were becoming increasingly aware of the damage being done to their heritage by modern development, and strengthened and elaborated upon several times since, the Act is designed to encourage preservation and wise use of our historic resources. The Act does several important things:

National Policy: The Act sets forth the policy of the U.S. Government regarding historic preservation. In a nutshell, the policy is to promote conditions in which historic properties can be preserved in harmony with modern society, and fulfill modern society's needs.

The National Register: The Act authorizes the Department of the Interior to establish, maintain, and expand a National Register of Historic Places. The Register is maintained by the National Park Service; it is a computerized listing of properties that have been nominated and accepted as having historic, architectural, archeological, engineering or cultural significance, at the national, State, or local level. The Register is growing steadily as more properties are identified and nominated each year.

The SHPO: The Act establishes the responsibilities of State Historic Preservation Officers, or "SHPO's," the State officials who administer the national historic preservation program at the State level. Each SHPO is responsible

for developing a statewide plan for preservation, surveying to identify historic properties, nominating properties to the National Register, providing technical assistance to Federal, State, and local agencies and the public, participating in the review of Federal undertakings that affect historic properties, helping local governments become certified to participate in the program, and other activities.

Grants-in-Aid: The Act establishes a program of matching grants-in-Aid by which the National Park Service assists the SHPO's in carrying out their work. SHPO's may subgrant portions of these funds to local governments and others for approved preservation projects.

Certified Local Governments: The Act provides for the certification of local governments whose historic preservation programs meet prescribed standards, making them eligible for special grants-in-aid and technical assistance from the SHPO to assist them in carrying out preservation activities at the local level. At least ten percent of the annual Historic Preservation Fund grant made to a State under the National Historic Preservation Act must be distributed among Certified Local Governments.

Advisory Council on Historic Preservation: The Act creates the Advisory Council on Historic Preservation, an independent Federal agency responsible for advising the President and Congress on historic preservation matters, and reviewing and commenting on agency actions that may affect historic properties.



Fishing Report

The water is clear at 68 degrees; black bass are slow; white bass are good with limits on minnows; crappie are good on minnows in 10 feet of water; catfish are good on water dogs in 20 feet of water; walleye are good in the 22-27 inch range or in the 4-6 pound on minnows at night.

Federal Agency Responsibilities: The Act directs Federal agencies to name "Agency Preservation Officers" to coordinate their historic preservation activities, to seek ways to carry out their activities in accordance with the purposes of the Act, to identify historic properties under their jurisdiction, to consider such properties when planning actions might affect them, to give the Advisory Council an opportunity to comment on such actions, and to document historic properties that cannot be preserved.

The National Historic Preservation Act, and the programs it created are the major components of the national historic preservation program.

Antihistamines With No Drowsiness

One of the most common warnings pharmacists provide to patients is to be careful about taking certain medicines during times when staying alert is essential. You may see an auxiliary label attached to medicines advising you to exercise caution while driving a car, flying a plane, or working with dangerous equipment because of the tendency of the medicine to "cause drowsiness." Antihistamines usually are included in the list of medicines that cause drowsiness. According to a recent article in *American Family Physician*, 10 to 20 percent of all persons who take antihistamines experience drowsiness. In some instances, the effect is so severe that it limits the medicine's therapeutic usefulness.

Until recently, all antihistamines available in the United States were thought to cause some degree of drowsiness. Since the mid-1980s, two antihistamines that do not cause drowsiness have become available. These are terfenadine (*Seldane*) and astemizole (*Hismanal*). Both differ in chemical structure from other antihistamines but are just as effective. Unlike conventional antihistamines, terfenadine and astemizole do not enhance impairment of psychomotor skills caused by alcohol. They do not impair automobile driving skills. Because of a long half-life, astemizole can be given once-a-day.

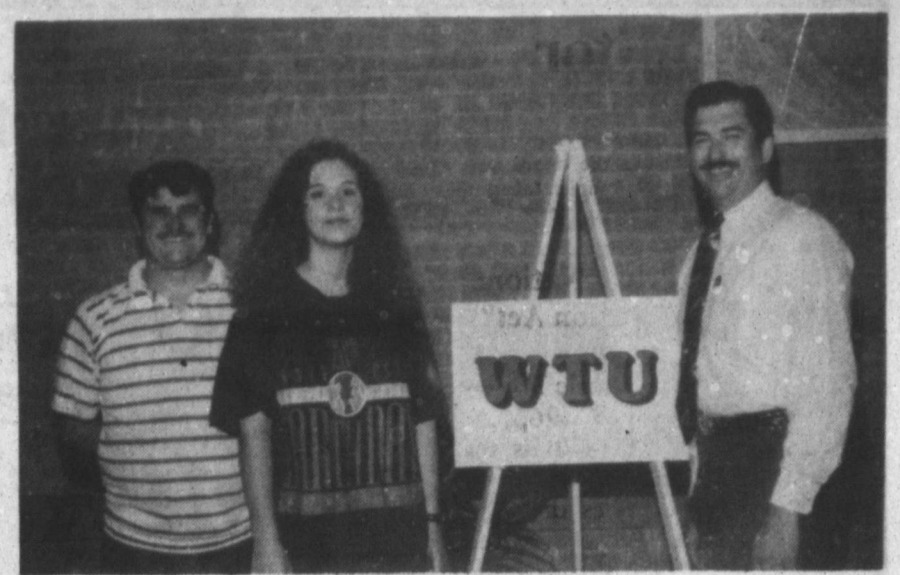
Scholarship Available

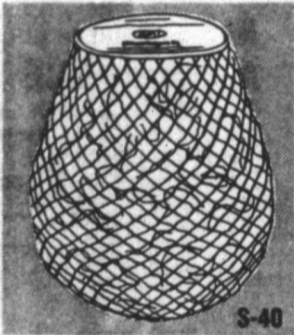

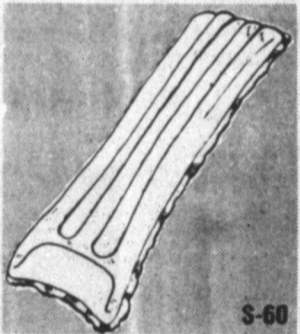

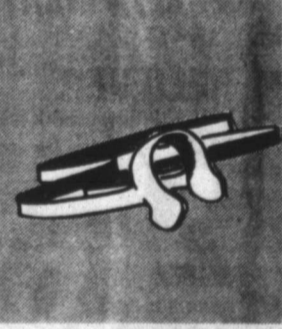

Home Lawn Diseases

By Tim Trimble/CEA-AG

With the continued wet, cool weather in the Panhandle some disease problems may start appearing on many lawns in the area.

The first one that will be noticed and is already appearing particularly on buffalo grass is slime mold. Fortunately, slime mold does not hurt the grass, except it looks bad. The most common one is a dark gray to black fungus, sooty-type growth on grass blades which rubs off easily onto shoes and clothing. This fungus is washed off easily with rain or with

Monitor Crop For Optimal Harvest

By Tim Trimble

LATE-BLOOM MAPPING

At late bloom, as before, the first step will be to look at sample plants that represent average conditions throughout each field.

Plant mapping at this time of year will help you learn how to interpret your cotton's signals. You won't waste time, money, inputs and worry trying to keep your plants going when the only cotton you'll harvest has already been made.

Since the mapping technique is once again counting "nodes above white bloom" (NAWB), you don't need to remove the plants from the field, although that often will help you do a better job of analyzing the samples.

Remember, the white bloom you see today will be a boll tomorrow, so it can be considered the "dividing line" on your cotton plant.

Above the bloom all the fruit sites are squares, and the terminal will continue to form new squares, leaves and branches until the plant cuts out.

The late-bloom NAWB mapping samples will tell you whether the bolls you're tempted to wait on really stand a good chance of ever being harvested.

DEFOLIATION CLUES

At mid-bloom, the ideal was to find 7 to 8 nodes (branches) between the first-position white bloom and the tip (terminal) of the plant.

Now it's late in the season, and your main motive is to guide that crop in to a successful landing by maturing the bolls already on your plant.

Even though defoliation isn't widely used in this area at this stage, you can use NAWB as a very accurate guide on when to defoliate your crop, being confident that it has reached cutout and has essentially stopped setting bolls.

The signal to look for is when the first white bloom on the fruiting branch is only five nodes from the terminal -- five NAWB. That means the terminal has essentially stopped growing and cutout is imminent.

Start accumulating heat units (DD60s) starting at zero when the NAWB first reaches 5. The optimum defoliation time is 850 DD60s after NAWB drops to 5. This number of heat units is the time required for late set bolls to reach sufficient maturity that an application of a harvest aid won't reduce weight or quality.

In addition to counting NAWB, two other important plant mapping techniques can help you time defoliation: "nodes above the

cracked boll" (NACB) and "percent open boll and mature."

A worksheet available from the National Cotton Council is useful for counting NACB. The basic idea is to record the number of first position bolls above the lowest first-position cracked boll, that is, the boll that is just beginning to open. With that number and a chart or equation that helps you calculate plant density, you can figure the total pounds you would lose due to premature defoliation if the field was treated with a defoliant that day.

Percent open boll and mature boll is a little simpler. Collect your five plants from four areas in the field. For each plant record the number of open bolls, mature unopened and immature bolls. To determine if bolls are mature, use a sharp knife to cut them open. Mature bolls will be hard to cut with full seeds and lint that strings.

After you've counted the bolls on all 20 plants, divide the number of open bolls by the total number of bolls and multiply by 100 to figure the percent open bolls. To calculate the percent mature bolls, add the number of open bolls and unopened mature bolls together, divide by the total number of bolls and multiply by 100.

The optimum time to defoliate based on percent open boll will vary but normally a defoliant may be applied at 65 or more open bolls.

For percent mature bolls, optimum defoliation time depends on the time in the harvest season. When adverse weather threatens or it's late in the season, a lower threshold (96 percent mature boll) is acceptable. Early in the harvest season or when weather is good, wait for a higher percentage to mature (98 percent mature boll) before defoliating.

This concludes this series on cotton plant monitoring. A copy of the four articles can be obtained from the Donley County Extension Office.

College Selects Contractor

Bids for the construction of the Courson Ranch and Feedlot Operations Center to be built at Clarendon College have been reviewed by the Board of Regents. Reynosa Construction, Inc., of Amarillo bid a total of \$496,800, the lowest bid from the nine firms from Abilene, Lubbock, and Amarillo that competed for the construction contract.

The Courson Ranch and Feedlot Operations Center, which will have approximately 8,500 square feet of floor space, will be built immediately south of the Bairfield Activity Center on the west side of the Clarendon College Campus. The new facility which will include three classrooms, a study room, and offices will accommodate an expanded enrollment in the Clarendon College Ranch and Feedlot Operations Program.

Dr. Jerry Stockton, President of Clarendon College, says that most of the funding for the new building has come from individuals, businesses and foundations. The Harold Courson family of Perryton has contributed very generously toward the construction of the new building which will bear their name.

Construction of the building is expected to be completed within a 180 day time period. The 1992-93 Ranch and Feedlot Operations classes will immediately occupy the facility upon completion.

the waterhose and will likely be gone when open, sunny weather returns.

Another disease that is common in the area on bermudagrass is "Helminthosporium." Symptoms include leaf spots, blights and crown rot. Disease occurrence is usually irregular and the lawn may appear mottled or blotched. Control is best achieved by utilizing both cultural and chemical control techniques. Limiting thatch development and using fungicides (Chlorothalonil, Mancozeb, or PCNB) during critical periods of disease development permits satisfactory control.

Other diseases, such as, Brown Patch or Dollar Spot may also show up but are not as common.

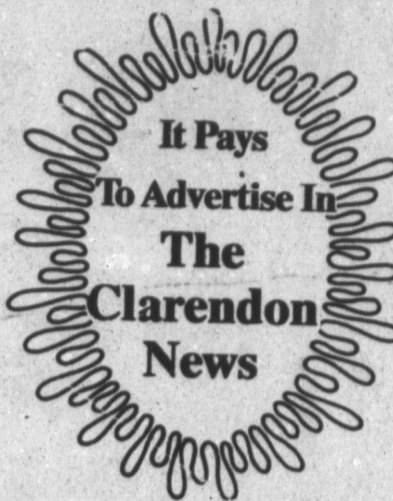
