WTU Changes Announced

West Texas Utilities Company has completed a study to determine the best organization and staffing levels to meet future electric service needs of its customers.

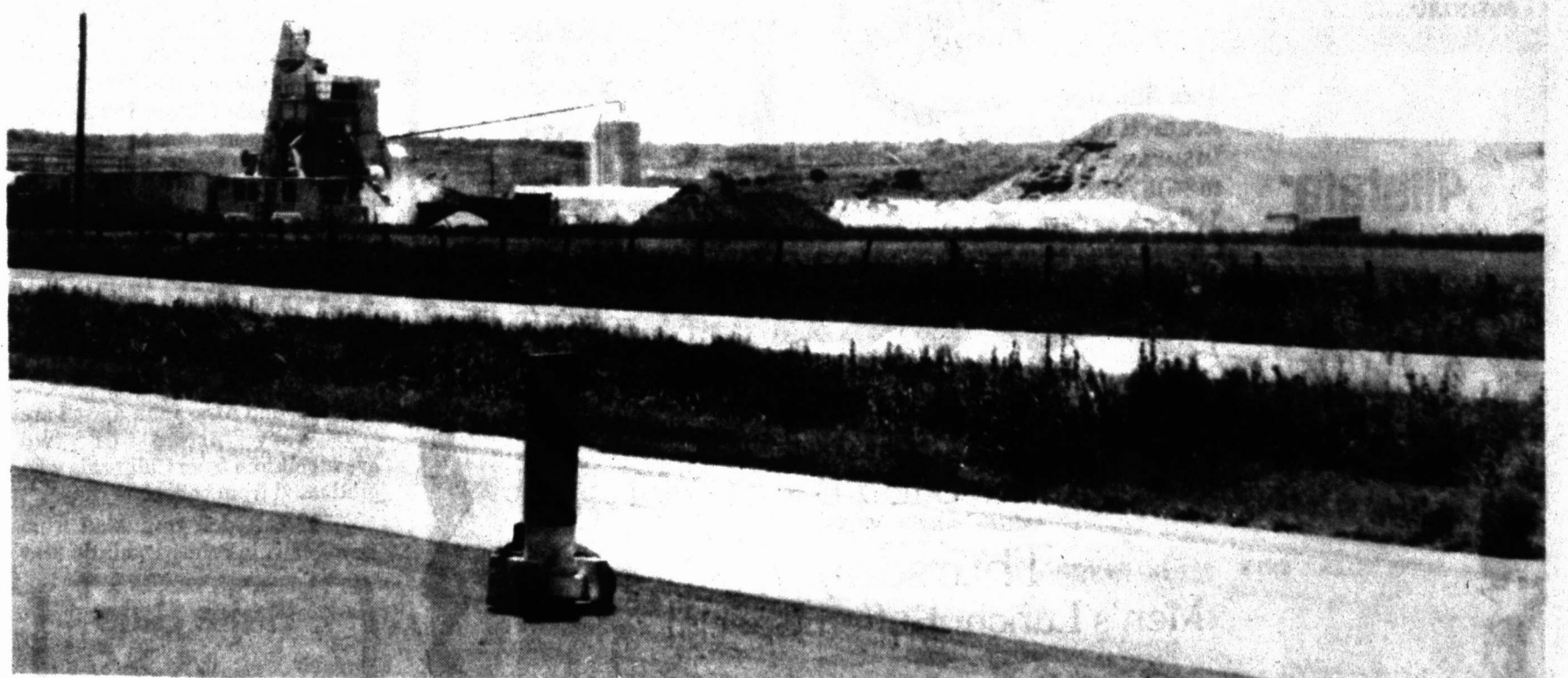
The study's purpose was to improve WTU's efficiency and achieve an optimum staffing level. A seven-member employee task force completed the study in April, and the recommended changes were begun immediately.

Overall, WTU plans to reduce its workforce by about eight percent over the next several years through attrition, like resignations and retirements. The company will do this by reviewing various positions throughout the company. The workforce had already been reduced by 10 percent during the last five years through attrition.

Other basic changes include regrouping operations into four divisions from six districts; establishment of business operations areas within each division to supervise groups of local offices and produce a smaller and more

manageable span of supervision; and the creation of an Operations support group to consolidate the customer accounting and various engineering functions that support customer operations activities. Several departments in WTU's General Office in Abilene have undergone restructuring and reorganization.

Grand Jury Meets

The Donley County Courthouse was a busy place Monday, June 24, as the grand jury met and the court disposed of a number of other cases.

The grand jury indicted two for unauthorized use of a motor vehicle and handed down one indictment for felony driving while intoxicated.

According to County officials, the court indicted John Galloway and Debbie Brownlee on separate incidents of unauthorized use of a motor vehicle, and indicted Thomas James Carter, Jr., for driving while intoxicated. Galloway and Carter pleaded guilty later in the day. Each was assessed a two-year term. (Officials expect the men to actually serve far less time than the sentenced amount.) A trial date is pending in the Brownlee case.

The District Court also granted four divorces and settled several other civil matters.

City Going To Dogs

Editor's Note: Several citizens requested that The Clarendon News publish the city leash law. Key sections are given below.

Section 5. It shall be unlawful for the owner of any dog or cat to permit or allow such dog or cat to run or be at large upon any public highway, street, alley, court, square, park, sidewalk, or other public land, or public property within the corporate limits of the City.

Section 6. It shall be unlawful for the owner of any dog or cat to permit or allow such dog or cat to be at large upon any fenced lot, tract or parcel of land within the corporate limits of the City.

Fireworks Injure Thousands

Fireworks injure nearly 10,000 people every year. A physician at Baylor College of Medicine in Houston says statistics show that many of these injuries are preventable.

"Most injuries from fireworks occur in teenage and pre-teen boys," said Dr. M. Bowes Hamill, assistant professor of ophthalmology at Baylor. "The injuries we most often see, to the hands and eyes, can be prevented by proper, adult supervision."

Children frequently throw firecrackers at each other, causing injury as severe as blindness of

deafness when they explode in midair near the head. Injuries to the hand and face occur when fireworks with short fuses go off while they are still being held.

AT LARGE. At large shall mean not under the control of the owner either by a rope, cord, chain, or other suitable material attached to a collar or harness, or not restrained securely within an enclosure or fence.

Section 9. The act of permitting a dog to bark in such a manner as to unreasonably disturb the inhabitants of the community is hereby declared to be a nuisance.

Section 19. Any dog or cat found trespassing or running at large on any person's private property may be taken up by that person and delivered to the Animal Warden or his deputies

Beef Selections Abound For Summer Grilling Season

Summer in the city means grilling season. The same goes for a day at the lake, a week at the beach or an hour in the country.

Wherever you are when the weather gets hot, nothing satisfies hunger more than a tender, juicy steak. Combine that steak with a Texan's easy access to aromatic woods like mesquite, oak or hickory and a barbecue grill, and you've covered all the basics of a perfect summertime meal.

There are beef cuts that go straight on the grill to combine the subtle flavor of wood smoke with the great taste of today's lean beef. There are also cuts that benefit from a marinade to enhance flavor or tenderness or both before grilling.

In fact, your hardest decision may be what cut of meat to use. Beef offers so large a variety of cuts that consumers may become confused about which are suitable for outdoor grilling.

"Some consumers may choose their beef cuts for tenderness," Pam Wortham, programs coordinator for the Texas Beef Industry Council, says. "Of beef's ten most tender beef cuts, eight are steaks ideal for outdoor grilling. These selections are tenderloin, top blade, porterhouse, T-bone, top loin or strip, round tip and top sirloin. If you can't remember those names, ask your meat market manager for cuts from the rib and the loin. All the most tender selections, except top blade, come from those parts of the beef carcass. They are tender whether they are quality graded Choice or Select."

Another important factor that consumers consider is price. Although tenderloin is always a good choice because it is the essence of tender beef, consumers will find that other cuts offer a high degree of tenderness at a lower cost. For instance, top blade, which comes from the chuck, often sells for \$6 to \$7 per pound less than a comparably sized tenderloin. Many other cuts are also good buys during July when supermarkets traditionally feature beef for grilling.

Some consumers may enjoy complementing beef's flavor by marinating it in spices, herbs, vinegars, oils or other ingredients. Consumers who enjoy marinades can literally shop the entire beef case at the supermarket for the best buy. The reason is that all marinades that include acid from vinegar, lemon or lime juice, wine or salsa also tenderize the cuts.

"When you add tenderizing marinade to many cuts from the chuck and the round, they can be upgraded into an easily grilled steak," Wortham said. "When cooked to medium or rare, you have a tender, juicy and delicious steak that was a great buy."

Texas Sorghum Producers To Elect Directors

Texas sorghum producers will vote by mail later this summer to elect directors to fill five seats on the 15-member Texas Grain Sorghum Board (TGSB). Elections will be held in four of the five TGSB districts this year. Directors will be elected to represent producers in the Panhandle, West Texas, South Texas, and Upper Coast districts.

TGSB administers the funds collected by the statewide assessment on grain sorghum. The assessment is collected on a refund-only basis and is used to fund programs of research, disease and insect control, education and promotion.

Those eligible to vote are persons who are subject to the assessment collected by TGSB, including producers of grain sorghum and owners of la 1991.

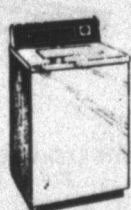

Southwestern Bell Telephone Company (Company), in accordance with the rules of the Public Utility Commission of Texas (Commission), hereby gives notice of its intent to implement a new schedule of telephone rates in Texas for Directory Assistance Services, effective August 1, 1991, unless otherwise determined by the Commission. The Company has filed an application with the Commission to restructure and change the rates for Directory Assistance Service.

To help recover its costs, the Company is proposing to increase the rates for Directory Assistance calls from \$.30 to \$.40 per call (after the three-call allowance). Southwestern Bell is proposing that there be no change in the number of free Directory Assistance calls allowed each month (currently three) and that customers who qualify for exemption of Directory Assistance charges because of visual or physical handicaps continue to be exempt from these charges. The company also proposes to begin charging \$.25 per call for Directory Assistance from pay telephones.

If approved by the Commission, this proposed rate change for Directory Assistance will increase the Company's annual revenues by \$15.4 million, which is an increase of approximately one half of 1 percent in the Company's adjusted revenue for the twelve-month period ending December 1990. This proposed rate change would affect approximately 900,000 residence customers, approximately 155,000 business customers, approximately 500 private pay telephone owners and all customers who make Directory Assistance calls from public pay telephones.

Attorney Fee Rule Changes

Social Security claimants represented by an attorney or other person in pursuing a Social Security claim will be able to pay the representative under a new Social Security rule. The rule permits the parties to agree on a set fee prior to the approval of the claim. Under the present "fee petition system," after a claim is approved the attorney must submit an itemized bill for services, which must be approved by the Social Security Administration. A maximum of 25 percent of back benefits could be paid with appropriate documentation. Under the "fee agreement"

process, the agreement is automatically approved if it is no more than 25 percent of the back benefits, of \$4000, whichever is less. Under this process, no itemized bill is necessary. The new rule gives claimants the advantage of knowing exactly how much they will be charged in pursuing their claims. Both the claimant and the representative may appeal the amount of the approved fee.

A claimant may be represented by the person of his or her choice in any business with Social Security. However, the representative cannot charge or collect a fee without written permission from Social Security. Any representative who charges or collects a fee that has not been approved may be subject to criminal prosecution and may be disqualified from representing Social Security claimants.

Five Precautions for Oral Medicines

Many of the oral medicines (tablets, capsules, or liquids) we take are powerful compounds that modify the body's normal chemical reactions. While some medicines are relatively free of serious side effects, unwanted reactions can occur under certain circumstances. In order to minimize the chances of having reactions to oral medicines, a few precautions are important to remember:

1. Do not take medicine from containers that show signs of tampering.
2. Never give your medicine to someone else. What may be good for you, may not be good for another person.
3. Some medicines should not be taken at the same time alcohol is being consumed. Ask your pharmacist about your medicines.
4. Do not take medicines in the dark. Read the label of all medicines before they are taken to make certain you take them properly.
5. In general, oral tablets and capsules are best taken with a full glass of water. Sometimes it is advisable to take oral medicines on an empty stomach or with food. Ask your pharmacist if you have questions about how your medicines should best be taken.

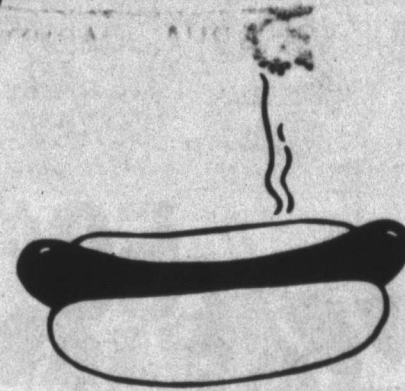

"I recommend that parents take their children to organized fireworks shows, but if they do purchase fireworks, it is important to know how to use them safely and properly," Hamill said. --Never allow fireworks to be used without adult supervision--Never use fireworks in prohibited areas--Always place firecrackers on the ground before lighting them--Never throw firecrackers--Rocket-like fireworks should be launched from the ground, no the hand, and pointed away from people--Select an open field away from buildings to launch fireworks--Carefully read the instructions and warning on fireworks.

Hamill says anyone planning to use fireworks should know first aid measures should injuries occur.

Minor burns, the most common injury, should be treated by running cold water over the site immediately. Apply a cold water compress until the pain subsides and cover with gauze of similar material.

If the eye is injured, inspect the area for any foreign objects on the eyeball or the eyelids. If it is embedded in the eye, if there is bleeding, if sight is diminished or the pupil is not round, attempt no treatment and take the patient to an emergency room immediately. Otherwise, gently rinse the area with clean water until the object is removed.

In the case of an explosion near the ear, perforation of the eardrum is possible. Cover the ear with a clean, dry pad to prevent infection and have a physician examine the area.

A first aid kit is recommended for any outing involving Fourth of July fireworks.

"When I was called the last time I thought I was fixing to be deployed overseas," he said. Instead he spent four months at a navy hospital in Portsmouth, Virginia. "We had a meaningful job and I think I made a difference," said Howard. "But I was glad when it was over, I was ready to come home."

Howard was familiar with the words, having served in the Navy medical corps for 10 years.

Energy Assistance Available

AUSTIN--Some low-income Texans may be eligible for help in paying cooling bills this summer through the Home Energy Assistance Program, according to the Texas Department of Human Services.

The one-time payment is available to many low-income households. Applications for energy assistance were mailed to households that received food stamps, Aid to Families with Dependent Children, or Supplemental Security Income in May. Other low-income individuals may request an application by calling the toll-free number 1-800-252-8060 during the enrollment period of July 1 through July 31.

Eligibility is limited by gross income and resources. Aid is available for a one-person household having less than \$628.49 gross income per month. The gross income limits are \$842.49 for households of two persons, \$1,056.49 for three, \$1,270.49 for four, \$1,484.49 for five, and \$1,698.49 for six.

Households are eligible if the cost for cooling is included in the rent payment or if the household pays a portion of its home energy costs.

Energy assistance checks are sent directly to the people who are eligible for assistance. However, the checks are made payable to the energy provider.

People receiving one of these energy assistance checks should mail it or take it in person to the energy provider business office with their regular energy bill. The check can be cashed only by the energy provider. If the HEAP check is more than the energy bill, the additional amount will be credited to the person's account for the next month's bill. If the energy bill is higher than the check, the person is responsible for paying the difference.

Cancer Screening Clinic Set

The Breast Cancer Screening Program of the Don and Sybil Harrington Cancer Center and High Plains Baptist Hospital of Amarillo will continue community outreach clinics for early detection of breast cancer.

Funding is available through the Texas Cancer Council for screening mammography for Texas residents qualifying for financial assistance.

Early detection of breast cancer is the major goal of cancer control for each woman seen in the clinic. The clinic provides low cost screening which includes a breast exam by a Registered Nurse trained in breast cancer detection, teaching of breast self examination, and a mammogram.

Currently, the most effective method know to win the battle against breast cancer is early detection. Early detection is best done by following the guidelines recommended by the American Cancer Society for breast cancer screening for women who have no signs or symptoms of breast cancer. The guidelines are: 1. Learn and perform breast self examination every month; 2. Have a physical examination every year.; 3. Have a mammogram according to the recommendations by age.

Age - 35 to 40 - One baseline mammogram; 40 to 50 - A mammogram every 1 to 2 years; over 50 - Yearly mammogram.

A clinic will be held on Friday, July 5, 1991, from 10:00 a.m. to 2:30 p.m., at the Clarendon Medical Center Clinic. Exams are done by appointment only. Concerning specific local changes, the new Northern Division includes the Childress district plus the towns of Munday, Spur and Knox City from the Stamford district. Rules Of The Road For Tractor Safety

Operators of farm tractors and trailers who travel on public roads need to be able to see and be seen.

"Visibility is vital because of the short closure time between fast cars and slow tractors," said Thomas D. Valco, safety engineer with the Texas Agricultural Extension Service.

Valco said the National Safety Council estimates that 30,000 accidents, including 175 deaths, annually involve tractors and other farm machinery on public roads.

"These accidents result in serious injuries and costly equipment damage," he said. "Accidents can be reduced if farm equipment operators learn some necessary precautions."

Safety rules of the road, he said, include:

-Allow only licenses drivers to operate farm equipment.

-Equip the tractor with vivid SMV (slow moving vehicle) emblems that are easily seen. Replace faded emblems.

-Turn on the tractor's flashing lights both day and night when on public roads. But, if possible, avoid driving at night.

-Clean soil and dust from all reflectors and road lights, checking daily to make sure they are working.

-Made certain any wide equipment extending into traffic lanes is well marked with reflectors or flashing lights.

-Know how long it takes to get on or completely across a highway after coming to a complete stop.

-Wait for traffic to clear from all directions before entering a public road.

-Drive in the road's right traffic lane near the edge of the pavement. If traffic backs up behind the tractor, slow down and pull off the road to let the vehicles pass.

Erratic Weather Takes Toll On Young High Plains Cotton

If it isn't on thing, it's another. That might well be the motto of Texas High Plains Cotton farmers, who have seen recent

rains, high winds and hail inflict serious damage on young cotton plants.

Heavy thundershowers the first week of June, accompanied by winds as high as 70 miles an hour, blowing sand and hail have producers assessing their fields to see if they must replant. In Gaines County, the state's top producer of cotton, hail severely damages 15,000 to 20,000 acres.

"We started with a relatively dry season that precluded planting of most of the dryland acreage," said Dr. James Supak, Texas Agricultural Extension Service cotton agronomist.

The counties around Lubbock that he serves, dubbed "the world's biggest cotton patch," this year were slated to plant some 3.7 million acres of cotton, about 40 percent of it irrigated. The area annually produces half the state's crop and about 20 to 25 percent of the nation's cotton.

The dryland crop should be planted by May 20 for best results, Supak said. But at the end of May almost a million acres was either unplanted or being planted without adequate soil moisture, in hope of showers to germinate the seed.

"Most of our irrigated acreage got planted in a timely fashion and got off to a pretty good start," Supak said. Then came several days of cool weather that slowed development and in some cases caused problems with seedling disease.

Going into June, without a general rain across the area, "the crop was beginning to make good progress," the cotton specialist said.

Then came the rains, "generally sufficient to allow germination of dryland cotton," Supak said. But for already emerged young plants, the accompanying winds, sand and hail took their toll. The moisture and cooler, cloudy conditions stimulated a resurgence of seedling disease.

"Right now we have a lot of fields that just a few days ago looked pretty good and now are showing the effects of windburn, wet weather blight, some seedling disease damage, and a lot of plants are dying," the agronomist said.

The heaviest wind and sand damage is on the younger cotton.

"These young seedlings are just more vulnerable to that kind of damage," he said, adding that they also are the plants showing the most seedling disease problems.

Older cotton, up for about six weeks, is getting into "that woody stage that resists seedling disease damage, Supak said. "But it's still susceptible to the kind of wind and hail damage we had last week."

Sunshine and warm weather are needed to dry the land and allow farmers to do some tillage to aerate the plants and stabilize the fields to prevent further wind and sand damage, the specialist said.

Farmers have to carefully assess their fields, Supak said.

"They're going to have to make that tough decision whether there's enough stand left out there to keep, or whether the crop should be replanted."
