A Clarendon man is in jail this week on drug-related charges.

Donley County Sheriff Butch Blackburn said his office executed a search warrant on the residence of Billy Gardner at 622 W. White Street on March 25 and found crack cocaine in the house.

Gardner, age 48, was booked into the Donley County Jail on the felony charge of Possession of Crack Cocaine with Intent to Distribute. He was arraigned March 26 by County Judge Jack Hall, and bail was set at \$100,000.



surprising sharp noise suddenly cut through the vehicle interrupting the conversation between Clarendon High School junior Savannah Thackeray and her mother.

It was neither the sound of screeching tires nor the crunch of metal colliding. Rather it was the noise of her mother's slapping hand, scolding another hand in the process of reaching for a cell phone.

As Thackeray's mother Jennifer Haney drew her hand back, she looked at her husband in a scornful manner.

"You really shouldn't text and drive," Haney said.

Just minutes before this transaction took place, Thackeray informed her parents about a video she viewed that day at school warning students about the dangers of texting while driving. Those who saw the video learned a valuable lesson that one distraction while driving can cause serious devastation.

"After I saw the video, it made me think," Thackeray said. "It was scary. I didn't want to text and drive anymore, and I wanted my friends and family to stop too."

The video told the story of an tragic accident that occurred in Utah in 2006. Nineteen-year-old Reggie Shaw was driving his SUV while text messaging his girlfriend when he crossed into the other lane and hit another car carrying two men, who were both rocket scientists. The scientists' car slid into the oncoming lane where a pickup truck hauling a trailer crashed into it, killing the two men instantaneously.

"It kind of creeped me out," CHS junior Dominique Brady said. "I would never want to do that to someone. I can't imagine being responsible for the death of two people just for texting."

But Utah is not the only state that is affected by texting and driving. Even in Clarendon there are drivers who dare to endanger lives by checking text messages.

"I see people texting while driving every day," Donley County Sheriff Butch Blackburn said. "Texting is very dangerous while driving because it takes too much attention away from the driver. It has been the cause of many wrecks."

Out of 109 students surveyed, 75 admit to texting while driving. One of these drivers is senior Jill

"I started texting while driving probably about six months after I got my license," Luna said. "It keeps me busy and awake when I'm on the road, usually on long drives like on the way to Amarillo or Dallas."

Senior Lauren Shelton says her texting while driving makes her feel rebellious.

"My parents tell me every day to stop texting while driving, and they even threaten to take my car away if I don't," Shelton said. "But it's almost just like a habit now. I don't even think about it."

Knowing there are people out there who choose to text behind the wheel has pedestrians like physics and chemistry teacher Bruce Howard practicing their "defensive driving.'

"Texting while driving is not

very wise because it's hard enough to drive as it is," Mr. Howard said. "I'm always watching out to make sure what the other driver is doing."

According to information found on www.KeeptheDrive.com, the number one cause of death among American teens is not drug overdose, violence or suicide, but vehicle crashes mainly due to distractions. Texting is the number one driving distraction among

CHS Student Council members have recognized this fact and plan to dedicate a week solely to raise awareness of the distractions and conditions that can cause wrecks.

"One day will be for texting while driving, and the others will be covering speeding, driving while sleepy, drinking and driving, and driving with no seatbelt," said Brandi Mays, student council president. "We hope that the students will begin to realize how serious some of these distractions can be. Hopefully, it will be eye opening.

Junior Bradley Watson is one of 15 students who have confessed that texting has caused them to swerve to avoid hitting a vehicle.

"One time me and my friend Johnny were coming back to school from lunch, and we were by the Post Office when this woman stopped in front of me to turn," Watson said. "I had to swerve to miss her because I was reading a text. That has actually happened to me twice."

Of the 75 surveyed students who text and drive, 39 consider texting a distraction, while 36 disagree. Sheriff Blackburn says it is a major distraction to all those who text though, and has statistics to

back it up.

"There have been studies that prove that texting while driving is as bad as driving while intoxicated," Sheriff Blackburn said. "It impairs you that much."

In Texas, it is currently only illegal for school bus drivers and those under 18 to talk or text on cell phones while driving. But there is a law waiting to be passed by legislation that will make texting illegal for all those who drive statewide.

Survey results reveal that out of 109 students, 56 think that texting while driving should be against the law, while 53 disagree.

"I think it should be because it's so dangerous and causes many accidents," junior Kelsey Thomas said. "People need to focus on the road when they're driving, not tex-

Reggie Shaw's accident that caused widespread devastation raised awareness of the dangers of texting while driving to both students and teachers.

"Drivers need to think about other people and the effect texting while driving could have on them," Mr. Howard said. "Think of your passengers. I think it would be hard to live with if yourself if you ever killed or seriously injured someone. One mess up can change your life forever."

Students are now spreading the word to their friends and loved ones to stop texting on the road before more lives are permanently changed or even taken away.

"I want to keep those who I care about safe," Haney said. "If I have to, I will continue to slap hands of those who choose to text and drive."

Rescuers save two Amarillo painters

Two Amarillo contractors are lucky to be alive after succumbing to toxic fumes in a rural Donley County location last week.

Sheriff Butch Blackburn said Ricky Lovato and his son, Jerry Wayne Lavato, were working at Melvin Edes place east of Clarendon last Tuesday, March 30, and did not return home when they were expected. Worried relatives called the sheriff's office, and Deputy Vincent Morasco was dispatched to the worksite.

Upon arrival, Morasco found the two men unconscious in the basement where they had been spraying lacquer - a highly flammable substance that emits toxic fumes. The deputy immediately called for EMS and for the Clarendon Volunteer Fire Department's Rescue Squad and also instructed the dispatcher to launch two helicopters.

Morasco, Chancey Cruce, and Deputy Kelly Hill were able to get the younger Lovato out of the building, and volunteer firemen suited up and rescued the father. CPR had to be performed on one of the subjects.

Jerry Wayne Lovato was transported by Associated Ambulance Authority and then by Lifestar to Amarillo, and Ricky Lovato was transported by ambulance and then by AeroCare to Lubbock.

"Due to the swift work of deputies and the fire department, it is believed both men will make a full recovery," Sheriff Blackburn said. "There's no doubt they would not have survived if the deputy hand not checked on them. The deputies, firemen, and EMS need to be commended greatly for a job well done."

Run-off vote is next week

Donley County's Precinct 4 voters will return to the polls next Tuesday, April 13, to determine who will be the Republican nominee for county commissioner.

Dan Sawyer received the most votes in the three-man primary race on March 2 over Joe Hall and Bill Spier, but he did not receive more than 50 percent of the vote, prompting a run-off between Sawyer and Hall. The winner will face Democrat Brad Dalton this fall.

Any registered voter can vote in this run-off except those who voted in the March 2 Democratic

Voters across the county and state can choose between Rick Green or Deborah Lehrmann to be the Republican nominee for Justice Supreme Court, Place 3.

All precinct voting will be conducted at the County Annex from 8 a.m. to 5 p.m. April 5-9 and from 7a.m. to 7 p.m. on Tuesday, April 13.

Early voting began Monday continues through this Friday, April 9.

Obama takes private lenders out of education

Last Tuesday, President Obama signed legislation that takes private lenders out of the business of making federal student loans. Instead, starting July 1, the government will originate the loans directly. This legislation was attached to the final piece of health care legislation that passed last week.

Unfortunately, higher education students, the very people who the government claimed they were helping in jamming this law through Congress, will lose under this ill-designed program. Why? Because they will be forced to rely exclusively on the federal government for student loans. The current delivery channel was working efficiently, and students benefited from the competition. Now, they will be forced to rely on four federal call centers instead of more than 2.000 community and nonprofit lenders nationwide. Plus, the federal government's track record in delivering products (the postal service, Social Security, etc.) isn't that good.

This legislation comes after recent regulatory requirements that will make the paperwork involved in offering private education loans so cumbersome and the loan process so time-consuming that many banks will decide to move away from offering private higher education loans altogether.

For many years, private education loans bridged the gap between school or government financial aid. As the availability and amount of government financial aid continues to shrink, these loans have been instrumental in helping students realize the dream of a college education.

The new regulatory requirements - approved by the Federal Reserve Board and effective Feb. 14 – were enacted in the spirit of stronger consumer protection for student borrowers. As amendments to Regulation Z disclosure requirements for private education loans, they implement provisions of the Higher Education Opportunity Act enacted in August 2008. The requirements apply to any closed-end, non-home secured loan extended expressly, in whole or in part, to be used for post-secondary educational expenses, such as tuition and fees, books, supplies, and room and board. They do not apply to home equity lines of credit.

Bankers are committed to fair and flexible education finance solutions for students and families. We fully support transparency in the application process and welcome competition in the marketplace. However, these new rules, while obviously well-intentioned, definitely miss the mark. For example, the new disclosures rules require three distinct and complicated disclosures at three distinct instances: with the application or solicitation; before the loan is closed; and at consummation. In order for a lender to provide these three required disclosures they must print and mail them at each interval and then patiently wait for the student's response. This will waste time, money and valuable resources and can delay the approval and disbursement process.

In addition, institutions must lock in and honor all credit terms for 30 calendar days after the loan has been approved to provide the applicant time to decide whether or not he or she wants to go through with the transaction. To help the applicant shop around for other loans, we are also required to disclose information about federal student loan programs that may offer less costly alternatives.

Then, after the student accepts the loan, the final disclosures must be provided. The student now has the right to rescind or cancel the loan within three business days. During this period, a bank must delay disbursement of the proceeds until the rescission period expires.

Since many of the students applying for these loans need emergency funding, I don't see how they would benefit by having to wait an additional three days for money they may desperately need as soon as possible. For example, a borrower requesting a \$200 loan for books will now have to go through the same time-consuming process required by the new regulations, including the three required disclosures, as someone requesting funds for tuition and fees or room and board.


These new rules are an example of College Finance 101 at its worst. As a banker, I am totally on board with protecting young borrowers from undertaking unnecessary debt. But, given the nature of higher education loans, it makes no sense, for example, to give the student 30 days after the loan is approved to shop around. This would be too long in many cases to accommodate the time for disbursement to the borrower and school.

Many of these private higher education loans are small dollar and provide a very narrow income stream for financial institutions. For most banks, the costs of compliance and the risks and liabilities of noncompliance are simply too high compared to any positive aspects such loans could bring to them. Since many students turn to private education loans after all other sources of aid have been exhausted, it makes little sense to make the process even more difficult.

This is the absolute worst time for the government to be tinkering with student loans. During these tough economic times, students will be relying more and more on loans, and these changes will affect their ability to get and find loans - both private and federal loans.

The question is: Where are students going to find resources for funding of their educational needs outside of grants and subsidized loans? Unfortunately, the answer may be, they won't.



An open letter to the people of Texas

Thank you for the great privilege and responsibility of representing you in the United States Senate. 

Drugs in the News

Statins May Help People with Asthma Breathe Easier Surprising research out of New York's Beth Israel Medical Center shows that people with asthma who take a cholesterol lowering "statin type" medication may see their lung function improve. Scientists compared the capacity of the lungs to breathe in and out as well as "rescue" inhaler use just before and two months after starting statin therapy. In this short time period, individuals evaluated were able to breathe more air than they could before starting a statin medicine. Also, study participants did not have to use their rescue inhalers as much, indicating they had fewer "asthma attacks". The statins used in this study were simvastatin (Zocor) and atorvastatin (Lipitor).

According to the National Heart Lung and Blood Institute, over 22 million Americans are living with asthma. Asthma causes inflammation in the lining of the lungs that narrows the airways making it harder to breathe. When asthma symptoms flare up, people experience chest tightness, breathlessness, wheezing, and coughing, especially during the night.



NOTICE OF COMPLIANCE TARIFF FILING

Southwestern Electric Power Company (SWEPCO) filed with the Public Utility Commission of Texas (Commission) on April 7, 2010, its Petition requesting approval of its proposed Military Base Surcharge Tariff.

Section 36.354(a) of the Public Utility Regulatory Act (PURA), at Texas Utilities Code § 36.354, provides that each electric utility in an area where customer choice is not available shall discount charges for electric service provided to a military base. Section 36.354(b) of PURA establishes the discount to be provided to military installations as a 20 percent reduction of the base commercial rate that the electric utility would otherwise charge to the installation. Tariff Sheet 10H, available for review at the Commission's website, http://www.puc.state.tx.us, reflects the discount rate.

Section 36.354(c) of PURA provides that the electric utility may assess a surcharge to all its Texas retail customers to recover the difference in revenue between the revenues from the discounted rate for military bases and the base commercial rate. Tariff Sheet No. 52 provides the Military Base Adjustment Factor of \$.0000575 per billing kWh.

SWEPCO has requested that the tariff become effective with the first billing cycle of June 2010.

The Petition has been assigned Tariff Control No. 38117. Persons who wish to intervene in or comment upon this proceeding should notify the Commission.
