#### FIRE AT THORNTON.

#### Several Business Houses Entirely De stroyed by Flames.

Thornton, Tex., Jan. 4.-Fire was discovered yesterday morning at 6 o'clock in J. W. Alston's brick storehouse, which, together with its general merchandise stock, was a complete loss.
