WEST TEXAS STRONG FOR GOVERNOR HOBBY

Dallas, Texas, July 13 .- Adrian Pool of El Paso, who was in Dallas Friday, declares reports being circulated that Ferguson was very strong in West Texas are unjust to West Texas and not warranted by conditions in any considerable portion of West Texas. Corn syrup or other syrup can be used to sweeten cakes, ices, desserts of all kinds, to make pudding sauces, and for canning and preserving. In canning and preserving fruits, one-third by weight of the original amount of sugar used

can be replaced by syrup. Here are some recipes suggested by the United States Food Administration.

SUGAR.



With part of the sugar replaced by corn

syrup. 4 cup fat 5 cup sugar 5 eggs 1 cup sirup 5 cup milk 1 teaspoon singer 4 teaspoon salt 1 teaspoon cinnamon 5 teaspoon cinnamon 5 teaspoon cinnamon 1 teaspoon cinnamon 5 teaspoon allspice 3 % cups barley flour 1 cup raisins syrup. raisins Cream the fat, sugar and egg yolks. Add the syrup, milk and vanilla and mix well. Add alternately the liquid and the dry ingredients sifted together. Add the flavoring and fold in the well-beaten egg whites. Lastly, add the raisins. Bake for one hour in a moderate oven.

1 cup corn syrup 2 cups bolling water 1 cup grated pineapple Juice of 1 lemon White of 1 egg

Combine the ingredients with the ex-ception of the egg white. Cool the mix-ture and freeze it. Add the beaten egg white just before the freezing is com-pleted. EGG FLIP.

TAKING OF TESTIMONY IN CRIMINAL CASES

House Joint Resolution No. 2.

To amend Section 10, Article 1, of the Constitution of the State of Texas, providing for certain rights of accused persons in criminal prosecu. tions and the manner in which the case may be prosecuted, and provid-ing for the procuring of the testimony of the witnesses for defense and prosecution.

Be it resolved by the Legislature of the State of Texas: Section 1. That Section (10) or Article (1) of the Constitution of the State of Texas be so amended that the same will read and hereafter be as follows:

as follows: Sec. (10.) In all criminal prosecu-tions the accused shall have a speedy public trial by an impartial jury. He shall have the right to demand the nature and cause of the accusation against him, and to have a copy there-of. He shall not be compelled to give evidence against himself and shall have the right of being heard by him-self and counsel, or both, shall be con-fronted by the witnesses against him and shall have compulsory process of obtaining witnesses in his favor,




