House flies are the pre-dominant flies found in and around livestock and poultry facilities. Although house flies can develop in just about any type of decaying organic material, the large accumu-lations of manure generated in these facilities has the po-tential to produce significant by opulations. water. Low areas should be filled or should be filled or graded to prevent water accumulation. Watering tanks should be adequately maintained to prevent water from collecting around the base. Manure that accumulates underneath fences or in similar adjacent areas should be removed. Other potential fly breeding materials such as spilled feed and wet bedding also should be removed on a frequent ba-sis.

sis. Although manure manage-ment forms the basis for an effective fly control program, supplemental measures may be needed. Chemical control options include space sprays, residual wall sprays, larvi-cide sprays, baits, and feed additives.
