## Muenster ISD rated Superior in FIRST

Muenster ISD held a public hearing on its Financial Integrity Rating of Texas (FIRST). Nobody came to listen to the report.

Superintendent Clay Richerson explained Muenster's score. Muenster's passing score is 52. The District's score is 65. "We only missed one area," explained Richerson. "That was on our debt-related expenditures is less than \$350,000 per student. For Chapter 41, the lower levels is \$319,000 per student and we're above that. District's five year percent change in students equal or greater than 7%. We have not gained 7%. Or property tax collected per penny of effort better than \$200,000 per student. Again, Chapter 41 puts us over that. So, we got zero points for that. In everything else, we scored perfect on. There are 20 categories and a bottom part that determines our rating. Superior Achievement is 64-70 and we scored 65, so Muenster ISD rated Superior."

Charlie Price of Compass Builders spoke of the construction progress on the new elementary building. There were pictures accompanying the report. He stated, "It is rapidly taking shape and the interior finish out is underway. The exterior, which is more obvious as you drive by the site, work and grading is about 90% complete. The sidewalks are in. Canopy is in the process of being installed." Ceiling tile is being installed, electrical work near completion, and flooring expected soon. Plumbing fixtures are being set in the bathrooms. He hopes to have the building finished in early December allowing a couple of weeks to do the punch list and fine tune it for use in January.

Principal Heers presented a plan from Playworld for two playgrounds - one for Pre-K-3 and the other for 3-6, with a set of swings between the two. She said that the good thing is that the cost didn't go much over budget. "I think that the kids will just be so excited to get a playground again," she not-

ed. The Board approved the Playworld plan to purchase at a cost of \$75,500.78. That is \$500.78 over the budgeted amount.

Heers then reported on the process of selecting furniture for the new elementary classrooms. It began last May with a meeting that included teachers who designed their dream classroom. The quoted cost of the dream classroom furniture was \$172,500. Heers met with the furniture reps again in August to try to get closer to the amount budgeted for furniture - \$90,000. They cut down until the cost would be \$126,000. She added, "They then cut everything out except student desks and chairs, teacher desks, teacher chairs, and an activity table. I call that a stripped down version and it was \$102,800."

After studying the proposal, Heers discovered some errors and needed changes. Furniture for the science lab had not been included either. The final quote with all errors out is \$104,597.76.

Trustee Kim Walterscheid inquired if it were quality or quantity that was cut to reduce the price. Heers said, "The desks that we're getting are your basic rectangular little desks. We wanted the modern that you can group together in sixes and eights. They're not the rectangular. They're more the trapezoid. Those had to be thrown out the window immediately. We're still getting new desks, so we are not complaining. There were teachers who wanted podiums. They're gone."

The Board unanimously approved the bid for \$104,597.76.

Muenster ISD's employee handbook is not specific as to what professional dress should be for teaching staff. Superintendent Richerson remarked, "We have some employees that don't understand what professional dress is, so I wanted to define what that was." He and the principals met and looked at several examples and hand-picked what they felt best fit Muenster ISD. They developed an addendum to the employee dress code that lists what is and is

## Drug unit zeroes in on offenders

"As the Sheriff of Cooke County, I want the citizens of our County to know the Sheriff's Office is continuing its efforts to curb the flow of drugs in Cooke County," stated Sheriff Terry Gilbert.

The Cooke County Sheriff's Office Drug Enforcement Unit (CCSO DEU) has conducted the following operations in Cooke County during the first two weeks of October 2013.

On Friday, Oct. 4, the CCSO DEU executed a search and arrest warrant on a residence in the 700 block of Potter Street in Gainesville. Investigators arrested Marvin Leroy "Bubba" Green, age 43, on a charge of Manufacture/Delivery of a Controlled Substance PG 1 >1<4 grams (more than 1 less than 4). Also arrested was Michelle Ellen Castle, age 36, on a charge of Possession of a Controlled Substance PG1 <1 gram (less than 1 gram). The DEU unit seized approximately 2.5 grams of methamphetamine with a street value of \$250.00, scales, packaging materials, and smoking paraphernalia.

On Monday, Oct. 7, the CCSO DEU investigators interrupted a sale/delivery operation in the 13000 block of S I-35 in Valley View. Gerald Ray White, age 45, was arrested on a charge of Manufacture/Delivery of a Controlled Substance PG1 >4<200 grams (more than 4 less than 200). Investigators seized approximately 11 grams of methamphetamine with a street value of \$1,100.00.

On Tuesday, Oct. 8, CCSO DEU Investigators assisted by CCSO Patrol conducted a traffic stop in the 900 block of West California Street in Gainesville. Stacy Hal Story, age 55, was arrested on a charge of Possession of a Controlled Substance PG1 >1<4 grams (more than 1 less than 4). Investigators seized approximately 1.5 grams of methamphetamine with an estimated street value of \$150.00 along with digital scales and a smoking pipe.

On Friday, Oct. 11, CCSO DEU investigators assisted by CCSO Patrol and the Valley View Police Department, interrupted a sale/delivery operation in 13000 block of S I-35 in Valley View. Gary Allen Cummings, age 45, and Jacob Michael Bowden, age 35, were arrested on a charge of Manufacture/Delivery of a Controlled Substance PG1 >4<200 grams (more than 4 less than 200). Investigators seized approximately 46.5 grams of methamphetamine with an approximate value of \$4,600.00, a 2006 Jeep SUV along with digital scales and packaging materials.

On Tuesday, Oct. 16, investigators with the Cooke County Sheriff's Office Drug Enforcement Unit presented for indictment

## Regents hear reports at October meeting

North Central Texas College Regents heard several reports during their regular meeting held Oct. 21 on the Gainesville campus.

Regents received an update on the financial aid cohort default rates. Last month, the Department of Education released the two-year 2011 cohort default rates and the three-year 2010 cohort default rates. NCTC's default rates have decreased, while the national rates for public community

colleges have increased.

NCTC's two-year default rate decreased from 16.5% to 11.2%, and the three-year rate decreased from 30.2% to 22.8%.

Much of the improvement can be attributed to the efforts by the institution and the financial aid department. NCTC added a financial aid staff member during this past school year and also outsourced the time-consuming financial aid verification process, freeing staff to focus on default prevention.

Regents also heard the quarterly external funding update with special emphasis on technical grant funding.

NCTC received a Department of Labor Matrix grant for \$4.15 million for three years to train individuals in a variety of health care occupations. A total of 1,774 individuals were trained through this program in areas like Certified Nursing Aide, Radiological Technologist, Surgical Technician, Physical Therapy Aide, EKG Technician, Medical Assistant, Certified Medication Aide, Medical Billing/Coding Clerk, Pharmacy Technician, Phlebotomist, Instrument Technician, Licensed Vocational Nurse, and Registered Nurse.

For the 2012 academic year, the Associate Degree Nursing overall pass rate on the first attempt was 92.7% on the state licensing exam, which is above the state average of 86.7%. The Licensed Vocational Nursing pass rate on the first attempt was 93%, while the state average was 87%.

NCTC staff members also updated Regents on grants from the Texas Workforce Commission, Gainesville Economic Development Corporation, and the Texas Higher Education Coordinator Board to train workers in technical skills and buy equipment for the Career Technology Center. Regents were also made aware that NCTC will receive more than \$4.66 million as part of a four-college, multi-state consortium grant as part of an effort to expand demand-driven skills training and strengthen employer partnerships.

The money will be used to expand the College's Information Technology programs to include Cyber Security, CISCO, VoIP Certificate, Databases, Web Design, and Microsoft certifications.

Report-President of Instruction Dr. Brent Wallace gave a voice on the Texas Success Initiative and Adult Basic Education. Now, one statewide assessment instrument will be used with one standard that cannot be raised by institutions of higher education. Students who are unable to successfully place above the state-cut scores for developmental education will be placed in Adult Basic Education.

Dr. Wallace also updated Regents on the June site visit

by the Texas Board of Nursing to review the Licensed Vocational Nursing program. While the report was mostly positive, the state board did find that the Gainesville campus is not in compliance with state requirements for facilities. The board found that inadequate physical facilities and resources limit the program's ability to meet faculty and staff needs.

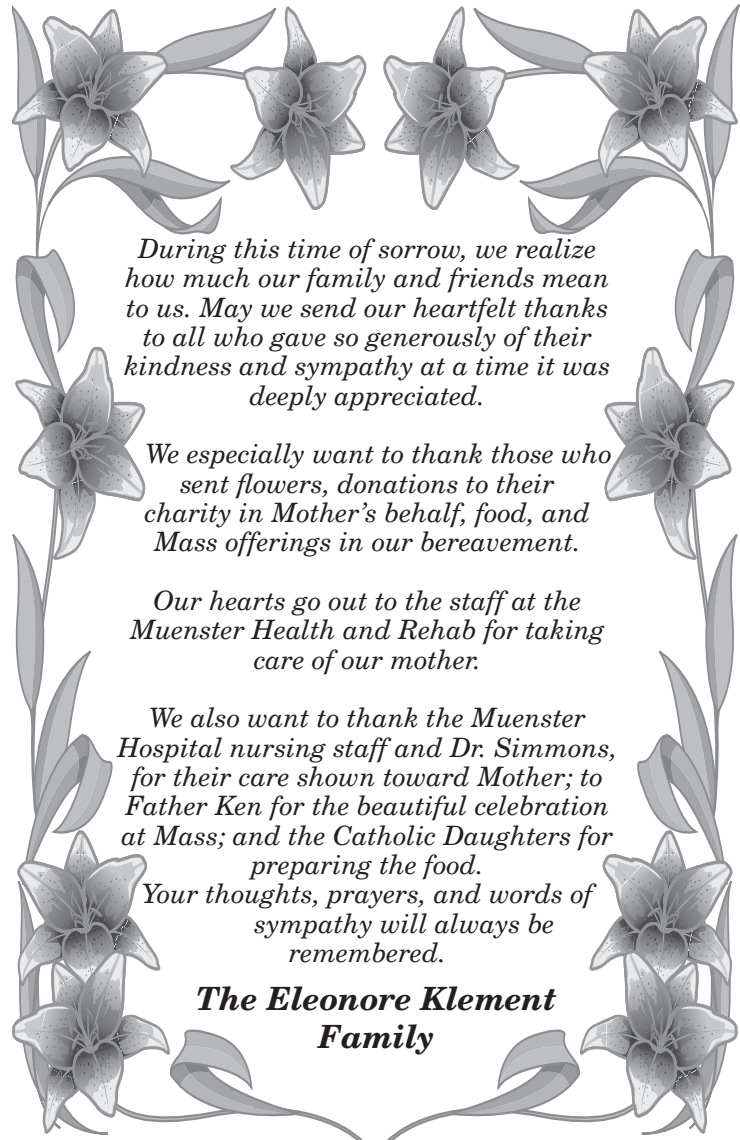
College administrators stated that the upcoming bond proposal, if passed, would alleviate these concerns for more space and up-to-date simulation labs. If the bond proposal fails, the College would immediately have to look for other ways to bring the nursing facilities into compliance.

In the final report, Regents were made aware that the College would be migrating their learning management system (LMS) from ANGEL to Canvas by Instructure by August 2014. The LMS is the primary delivery platform for all online and hybrid courses at NCTC.

In new business, the Board voted to approve a four-day work week for Summer 2014. Like last summer, the new schedule will require employees to work from 7:30 a.m. to 5:30 p.m. Monday through Thursday. All campuses will be closed on Fridays. The schedule runs June 2 to Aug. 1.

Regents approved the appointment of NCTC President Dr. Eddie Hadlock as owner's representative to negotiate a new electric contract. The Board voted to set the December regular meeting for 4 p.m. on Dec. 12.

Regents approved the hiring of Dave Bryan as the Skills Development Grant Coordinator - GE, Kevin Sadowski as Small Business Development Center Business Advisor at the Flower Mound campus, and Bill Winans as Associate Vice-President of Human Resources and Organizational Development.

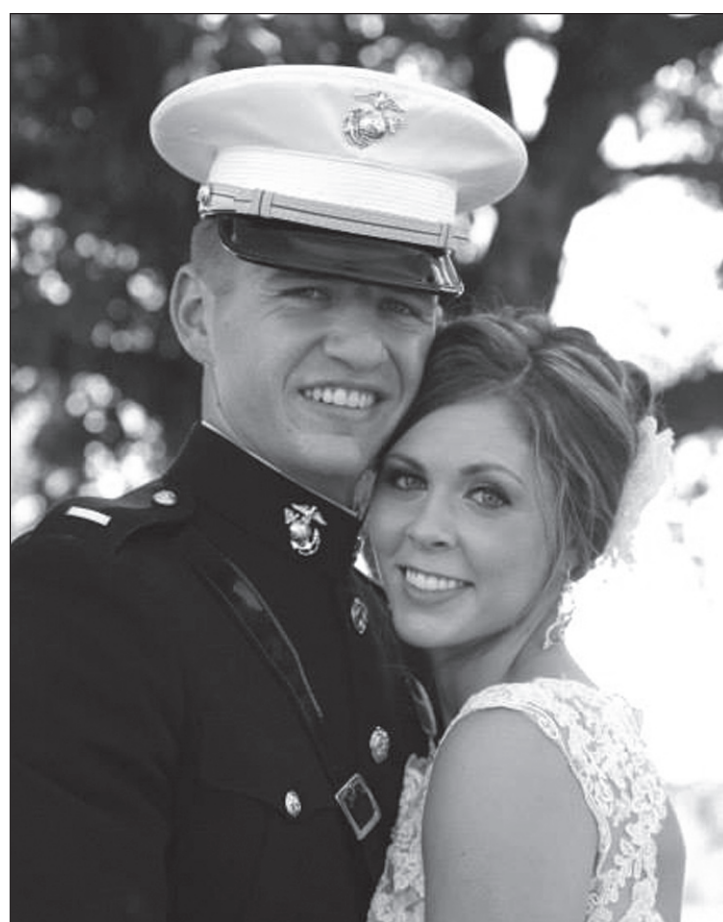

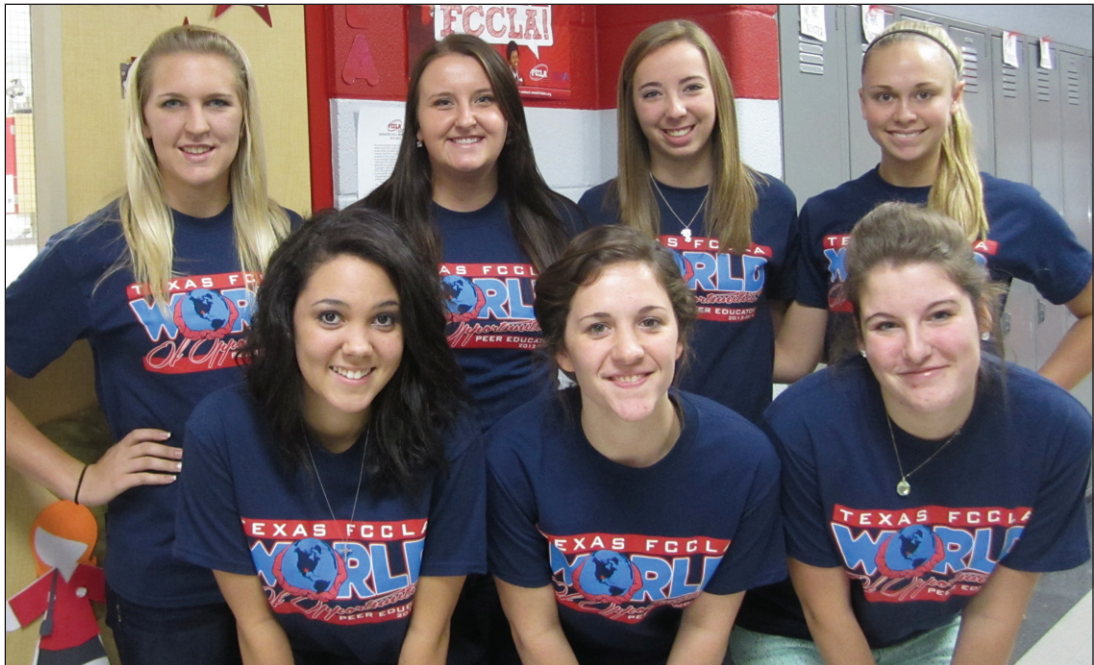


# Local leaders become peer educators

not acceptable for men and for women. They are similar. Since male students are not allowed to wear earrings, the Board decided to add visible body piercings to the men's list of unacceptable attire/grooming. The Board approved the employee dress code addendum with the visible piercings change.

Election judges for the Nov. 5 Chapter 41 election were approved as submitted. They are: Precinct 15 Patsy Bayer, Precinct 17 Jeanette Reiter, Precinct 18 Celine Dittfurth, Precinct 19 Charlotte Klement, and Precinct 21 Carol Klement. Richerson noted that one precinct has only two voters in the school district, but they must set up a poll for them. The voting will be in conjunction with Cooke County's amendment election.

A possible new wind turbine farm north of Muenster was discussed. It would have between 30-50 wind turbines. The closest property leased for the turbine project is within two miles of Muenster. The project area is south of the current wind farm and should be more condensed from east to west.

Due to legislative changes, the District would only re-

ceive \$100 per student in a 3/13 agreement. "It benefits them a lot," noted Superintendent Richerson. "The Legislature changed and now the only benefit we get is \$100 per student." Board President Steve Trubenbach added that they would get 100% on the INS. No action was taken as nothing is definite and would be quite some time since they have not yet applied for federal government approval.

JH/HS Principal Sharon Browning stated that there is about a 96% pass-rate for the just ended six weeks. Ag teachers Daniel Waneck and David Skeans attended the State Fair with students Blair Waneck, Travis Dangelmayr, Allison Haubold,

Jordan Buddy, and Hannah Bayer. Blair took 9th Place with his goat in its class. Hannah's Charolais heifer placed 4th in its class.

Technology Director Jeff Presnall reported that Nortex began the installation of the telecommunications network in the new elementary building. Chromebook implementation is moving ahead with 75 units installed and in use in the classrooms. MISD currently averages 220 live constant computer connections throughout the day.

The final quote for Smart Boards came in just under \$90,000. He is pricing iPads and Chromebooks for the new elementary computer lab and library lab. The football stadium sound system has been repaired. A temporary wireless access point was installed in the varsity football locker room to view films from previous games.

In other business, the Board:

- Heard that delinquent taxes collected in September totaled \$ 7,059.62.
- Approved purchase of Smart Boards for the new elementary facility at a cost of \$89,937 from Summit. The money will come out of the construction fund.

## Tigers out-run Mustang for 18-2 win

The Sacred Heart Tigers improved their District record to 2-1 last Friday in a cold, rainy 18-2 victory over the Fellowship Mustangs. The Tiger offense scored a quick 6, then struggled to get on the board, while the defense kept their visitors out of the end zone.

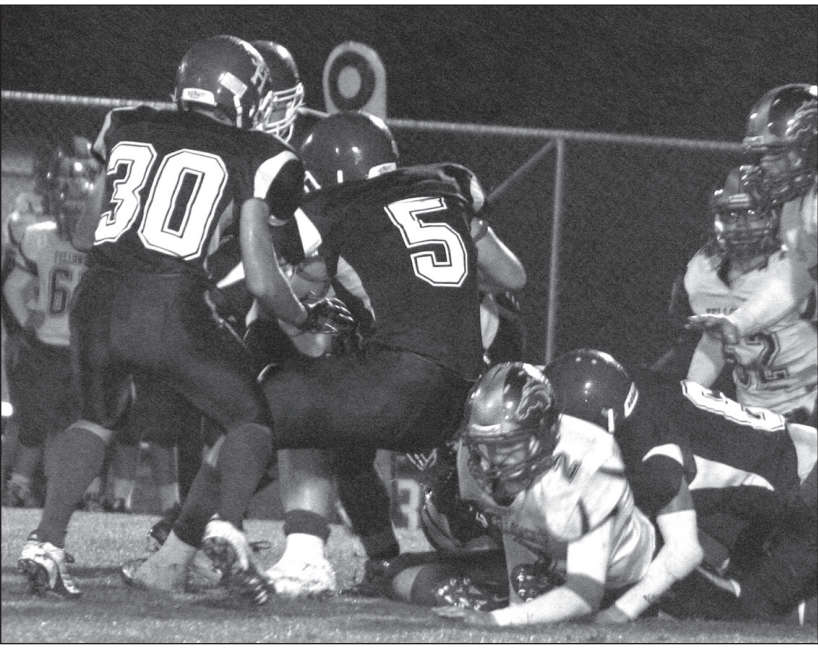

# FARM & RANCH

## New law requires farmers and ranchers to show proof of eligibility for plates, excess weight permits

A new state law requires farmers and ranchers to show their state comptroller-issued Texas Agricultural or Timber Exemption Registration number before obtaining farm license plates and/or temporary excess weight permits at the Cooke County tax office.

"The law will help ensure no one can infringe on the privileges extended to our qualified farmers and ranchers who deserve them," said Billie Jean Knight, the Cooke County tax assessor-collector.

"Unfortunately, as the state has grown so have the number of reports of people abusing the farm plate and permit privileges," Knight said.

The new law will weed out those taking advantage of the system that offers farmers and ranchers reduced vehicle registration and some sale tax fee exemptions.

"But to do that, we will now have to ask farmers and ranchers to show us their Texas Agricultural or Timber Exemption Registration number, which we can verify on the state comptroller's website," Knight said. "So please be sure to bring your

Texas Agriculture or Timber Registration card number to the county tax office when you are applying or renewing your farm plates or applying for a temporary excess weight permit for farm motor vehicles, trailers, and semitrailers."

Vehicles that do not qualify for farm plates include regular passenger vehicles; those used for gainful employment (driving to and from work) or for hire; vehicles owned by farmer cooperatives; and ones used to transport livestock for non-retail purposes.

Types of farm plates include truck, truck tractor, and trailer/semitrailer.

Here are the different types of farm plates and how you may use them:

• **Farm Truck/Farm Truck Tractor Plates.** You can use these plates to transport your own poultry, dairy, livestock, livestock products, timber in its natural state, and farm products to market or to other points for sale or processing. You can transport laborers from their place of residence to your farm or ranch. You can also move materials, tools, equipment, and supplies

from the place of purchase or storage to your farm or ranch, providing you do not charge to move these items and they are exclusively for use on your farm or ranch. The vehicle also may be used to allow you to participate in equine activities or attend livestock shows.

• **Farm Trailer/Semitrailer Plates.** You can haul seasonal agricultural harvests or livestock from the place of production to the place of process or storage and transport farm equipment to your farm or ranch. You can also transport fertilizer and haul cotton seed (as long as you aren't charging) between the place of supply or storage to farms and ranches. If you own a cotton gin, you may take it to other farms, providing you are not charging for the gin's usage and it is being used to by the farmers and ranchers to haul agricultural products (harvests) to a process or storage location or to market. You may also use trailers/semitrailers for you to participate in equine activities or attend livestock shows.

## Cargill announces plans to close Texas feedlot

With several consecutive years of drought combined with cattle herds moving north of Texas, Cargill announced plans to close its cattle feedlot in Texas next summer.

The Lockney facility is the second Cargill-owned property in Texas to shut down, according to *Drovers*. In January, Cargill announced its plans to idle the processing plant in Plainview. The feedlot has a capacity of 62,000 head and employs approximately 45 people.

Recent rains have helped persuade cattle producers to rebuild their cattle herds, but supplies aren't expected to reach normal levels until 2016, Cargill's Director of Communications Michael Martin said.

## Texas state parks remained open despite government shutdown

Although federal parks were temporarily closed, more than 90 Texas state parks remained open during the government shutdown.

The number of visits to Texas' largest state park—Big Bend Ranch State Park—is at 350 for the month, which is nearly the total for the entire month of October 2012, according to the Texas Parks and Wildlife Department (TPWD). The Department attributes the increase to the closure of Big Bend National Park, which is located just east of the Texas state park. Reports also show an increase to Eisenhower State Park on the Texas-Oklahoma border.
