



Let us replenish the seed of faith through... DAILY BIBLE READING, PRAYER & REGULAR CHURCH ATTENDANCE

by Gene Foster, Pastor, Fellowship Baptist Church, Spearman In the classic film, "Ben Hur," one Roman soldier asked another, "How do you fight an idea?" He was speaking of the rapid acceptance, by thousands of people of that day, of Jesus of Nazareth as the Son of God. This was an idea born in huma hearts that both the Roman Empire and the unbelieving Jewish nation of that day sought desperately to extinguish. The second soldier replied, "You fight ideas with ideas." He understood that to kill an idea, one must propose an even more convincing idea or

The enemies of Christ needed to find a counter argument to kill the rapidly expanding idea of Him as the Son of God. How ironic that Jesus Himself offered them the very counter argument that they needed! They merely needed to take it up and use it posthumously against Him if they could.

The counter argument that they needed lays in His own predicted resurrection, for not only did He boldly predict His own resurrection but even the exact time when it would occur. Said the Lord, "For as Jonas was three days and three nights in the whale 's belly; so shall the Son of man be three days and three nights in the heart of the earth " (Matt. 12:40). The Lord was challenging the world to take up the gauntlet and prove Him powerless against death if it could. To prove Him still dead after His stated time of resurrection would be the coup de grace that He was just another of many pretenders to Deity. And if they could do this, the enemies of Jesus Christ could have extinguished forever the flame of Christianity before ever it was struck

Their opportunity was so diabolically simple that it could not have failed to achieve their objectives if they had exercised it. They needed simply to produce His dead body on the fourth day! There was no need to endlessly guard His tomb or to forever debate with His followers. They merely needed to call on the power of the Roman Empire to keep Jesus' body "n the tomb for three days then publicly display it on the fourth. Had they done this, they would have forever extinguished faith in Him as the Son of God and Jesus would have been forever branded an impostor. Those who had clung to hope in Him would have returned in embarrassed silence to their homes and the hold of Christ upon Jewish society, the Roman Empire, and the world since then would have been forever

It is evident that the enemies of Christ failed to capitalize on their golden opportunity for Christianity burst upon the Roman Empire and all their legions could not hold it back. They had the motive and the might, but not the power. People who loved life and were as naturally skeptical as we, went to their graves as martyrs because they were convinced of the truth of Christ's resurrection. Not one apostle ever recanted his testimony of having seen the resurrected Lord and all paid the ultimate price of suffering and/or death for that testimony. We should ask, if they lied, what did they hope to gain? Not only did they bring death and suffering unto themselves, but also to the ones they loved and to multitudes who would believe their testimony of the resurrected Saviour! The world had no idea that could neutralize the resurrection.

The resurrection of Christ is an idea that, like the Master Himself, simply refuses to die. We believers can know that our faith rests upon the unshakeable foundation of real history knowing that His resurrection was but the first of many. Every person who recognizes the all sufficiency of the cross and who places repenting trust in the accomplished work of Christ can know by the Word of God (Romans 10:13) that his or her own resurrection is forever certain!





Early voting for the upcoming School Board elections will be held from April 14-27, 1999. The general election will be held on Saturday, May 1, 1999.

applicants filing for two vacancies each of three-years duration. The seats of school board members Andy Scarborough and Robbie Dewberry will be decided in the election. Filing for these seats are incumbent Andy Scarborough, Jon Garnett, Mark Allen, Carol Dunnihoo, and Glen Ray Mackie.

Nine persons have filed for two seats, each of three years duration at Gruver I.S.D. The seats currently held by Kevin Holt and Corky Chapman will be decided in the election. Those filing for positions are Bill Kelly, Jr., Bill Hadley, Dwayne Thompson, Jody Irwin, Corky Chapman, Ty Williams, Debbie Chisum, Terry Sherrill, and Danny Shults.

Pringle-Morse CISD has not scheduled an election of trustees since only three persons have filed for three school board positions each for three-year terms. Incumbents Lonnie Clemmons and Alan Leach and newcomer Monty Dixon will fill the positions.

Questions have been raised regarding the identification requirements for voters who do not present their voter registration card at the time of voting. State and federal law changes regarding these identification requirements went into effect on September 1. 1997

In the past, identification could be requested but never required of

a voter. This has been changed. Now, if a voter fails to present his or her voter registration certificate, the voter must in every situation either: (1) present proof Spearman ISD lists five of identification or (2) have an affidavit signed by a polling place official attests to the voter's

The election worker affidavit may be used only if the voter has no identification. If a person fails to present his or her registration certificate and fails to present a proper form of identification and neither the election judge nor any clerk can attest to the identity of the voter, the person may not be accepted for voting. The names of voters who are rejected for voting because they fail to present identification or present insufficient identification, must be entered on the "List of Voters Rejected for Voting" and the reason for rejection must be checked.

Any of the following documents will establish identification: a drivers license or personal identification card issued by the Texas Department of Public Safety or similar documents from other states; a form of identification containing a photograph that establishes a person's identity (such as a Sam's card or employee identification card); a birth certificate or other document confirming birth that is admissible in a court of law and establishes a person's identity, United States citizenship papers; a United States passport; pre-printed checks containing the person's name that are issued from a

financial institution doing business in Texas; official mail addressed to the person by name from a governmental agency; two other forms of identification that establish a person's identity (these can be ANY two forms of identification); or any other form

of identification prescribed by the secretary of state's office. To date, the Secretary of State has prescribed by rule that an affidavit signed by a polling place official swearing to a voter's identity may constitute proof of identification.
