



## Long Trip Pays Off For Pearson

THE HANSFORD COUNTY

Editor's Note: The following article is being reprinted from the Sunday, February 1, 2004 edition of the August Chronicle. It was written by Chris Gay, staff writer.

Mark Pearson came to Augusta mainly because of the Western Horseman Cup finals. He'll be leaving the town with a different title.

On Haidas Merlin, Pearson posted 221 to win the Augusta Futurity Classic Open finals by one point Saturday night at Augusta-Richmond County Civic Center.

Pearson of Spearman, Texas, took home the first-place check of \$18,576. Defending champion Mary Ann Rapp of Weatherford, Texas, and Cat Tuesday placed second for \$13,067, while Scotty Rice of Weatherford, Texas, and Dees Cats Meow finished third (219,

"It's a lot of work, getting your horse trained and showing it," Pearson said. "There's a lot of long hours. It just makes it all worthwhile when you do good.

"Everything just fell in place

Showing cutting horses since 1988, Pearson never made the trip to Augusta because of the distance. He decided to make the trek this year because of the inaugural Western Horseman Cup finals and the \$30,000 it offered to the winner.

"That's why I came, because that's a really good deal," he said. "Mr. Morris (W.S. Morris III, Augusta Futurity chairman) puts up a lot of money for one run."

The 37-year-old Pearson and his gelding, by Haidas Little

Pep out of An Apple A Day, shook away the butterflies early in their ride. The two grew more comfortable and cut three cows.

"Haidas was a little bit nervous on that first calf," Pearson said. "About midway through that first calf, he started to settle in. I was probably too nervous starting out. I probably got him nervous. ... About three moves into that first calf, I finally kind of relaxed."

Pearson and his horse marked their score ninth in the 21-horse draw. While he waited, Pearson watched the cattle in case of a workoff, knowing first place wasn't secure.

"Any of them could've moved it," he said. "There were a lot of good horses (left)."

Pearson couldn't have picked much better help for his run. His four helpers included seventime Augusta Futurity champion Phil Rapp, three-time champion Lloyd Cox, Boyd Rice and Kory Pounds.

"My help, I couldn't have done it without them," Pearson said. "They were watching the cattle, paying attention to what had been cut and what looked like they'd be good to work."

Julie McCloud of Millsap, Texas, and High Country Lake led after two go-rounds. The two drew up first in the second bunch of cattle, but failed to put together a consistent run.

"My horse fought me a little bit on my cuts," she said. "I couldn't get him standing up. I didn't start off very good. My cows were good. It was my fault, mine and my horse's, for fighting each other a little bit."

### Walk For Kids' Sake

Walk for Kids' Sake, the annual fundraiser for the local Big Brothers Big Sisters program, will be held Saturday, March 6th, at the Ochiltree County Expo Center. This year's goal is to raise \$25,000.

The Wheatheart Satellite of BBBS of the Texas Panhandle serves Booker and Hansford and Ochiltree counties. The satellite office is financially independent; no funding is received from the parent agency in Amarillo or the national program. "The Walk for Kids' Sake is our only fundraiser," explained Kimberley Lopez, agency case manager.

"WFKS is not a walk-a-thon so it doesn't matter how far or how fast you walk. It's more like a walking party and it's all about having fun and, of course, raising money," Lopez said. "But ultimately it's about matching kids with caring men-

The proceeds from this event and an allocation from United Way (\$4,500) must meet the program's financial needs for the year. Funds are needed to recruit, screen, and train volunteers, supervise matches and reach out to families in our area.

The community based program of Big Brothers Big Sisters matches children ages 6-14 from single parent families with volunteer mentors. The friendship with a committed, caring volunteer, a positive role model, the opportunity to develop and enhance the child's interests, skills and learning experiences and the framework for strengthening self-esteem. The program is provided at no cost to participants.

Studies show that children matched with a Big Brother or Big Sister are less likely to begin using alcohol or other drugs, be truant or act out violently. Their relationships with their family and friends improve and they even get slightly highlike these right here in our communities," added Lopez. Currently, there are nine match-

gram; two of them are in Spearman. There are five children on the waiting list. One is a 10-year-old Little Brother from Spearman who has been waiting for several months.

BBBS also serves local children through a school-based mentoring program, Bigs in Schools. Through this program volunteer mentors meet with students on the school campus during the school day and do not have contact with them outside of school. They talk, play games, do crafts or work on homework. Improvements in attendance, attitude and selfesteem have been observed. Nineteen students in Spearman elementary and junior high schools and ten students in the fourth - sixth grades in Perryton have been matched with mentors through this program this year. "Booker Elementary. school will offer this program in the Fall," Lopez said.

"The program is really growing and we are serving more children than ever before," Lopez said. "It is simply amazing to witness the impact the volunteers have on the lives of these precious kids."

### 69th Annual Hansford Stock Show We've Come A Long Way

From its beginning in 1935, as the Hansford County Baby Beef Stock Show, the Hansford County Stock Show has grown in size, participation, and prestige.

The winner of the first Hansford County Show was Oscar Reimer whose steer weighed 1100 pounds. Reimer also exhibited five steers in the Amarillo Fat Stock Show, one of which, placed seventeen of 169 entrants.

Other exhibitors names listed in the 1935 Spearman Reporter article were George Oakes, Jack Jones, son of Jay Jones of the Oslo community, and a Brillhart boy.

Although the exact year lambs and hogs were added to the stock show has not been traced, four years later in 1939, the show now dubbed the 4-H Club Stock Show listed both hogs and lamb

The 1939 show was held March 4, on Main Street in Spearman on a lot between the Wilbanks Beauty Shop and Baggerly Grocery Store.

Fourteen exhibitors, all boys, competed in the 1939 show which had a new feature added - a

This judging contest, however, differed from the current contest in which groups of young people judge animals.

Cards of the entrants were distributed in Spearman and Gruver businesses for members of the community to try their luck at picking the winning entrants. Winners who came closest to the judge's selections received prizes ranging from \$2-\$7

Money prizes given to winning 4-Her's in 1939 included \$10 for Grand Champion beef, \$3 for grand champion swine, and \$3 for grand champion lamb.

### One Hundred Years Ago

The average life expectancy in the US was 47 years. Only 14 Percent of the homes in the US had a bath-

Only 8 percent of the homes had a telephone.

A three-minute call from Denver to New York City cost eleven dollars.

There were only 8,000 cars in the US, and only 144 miles of paved roads.

The maximum speed limit in most cities was 10 mph. Alabama, Mississippi, Iowa, and Tennessee were each more heavily populated than California. With a mere 1.4 million residents, California was only the 21st most populous state in the Union.

The tallest structure in the world was the Eiffel Tower.

Mr. Will Jarvis, President of the Board of Trustees, announced that a quorum was present and called the meeting to order.



In other action, the board approved the appointment of Sandra Haney, Caroline Kenealy, Diann Crawford, and Brian Holt to serve on the 2003-04 Spearman ISD Textbook Committee. The textbooks up for adoption are biology and ESL (K-8).

The board reviewed and approved Update 72 (legal policies) for incorporation into the Spearman ISD Policy manual. All changes were legal and were the result of changes made during the last legislative session.

Approval was given to Ken Splawn, Interim Elementary Principal, as a PDAS Appraiser for the 2003-2004 school year

the 2003-2004 school year.

Mr. Sumner and Mr. Murphy were approved as administrators to interview and bring recommendation to the board for approval at the regular board meeting in February, a financial advisor to work with the district in facility planning.

Approval was given to modify the contract with Paul Trautman (Facility Consultant) to include the study of the elementary school conversion at an additional fee not to exceed \$7500 to be paid out of the Birdwell Undesignated Funds.

The board did not grant the transportation request of a patron requesting that a non-bus student be allowed to ride the bus three days a week.

Mr. Sumner recognized the board members for January Board Appreciation Month. He presented them with a certificate of appreciation and expressed his appreciation for their service to Spearman ISD.

### INFORMATION AND ANNOUNCEMENT ITEMS

The student enrollment for Spearman ISD was 738 as of January 12, 2004. This is up three students from the December count.

Mr. Sumner reviewed the substitute teacher report from November 17, 2003, to December 12, 2003. The yearly total amount paid for substitutes through December 12 was \$20,665.00. This was approximately a \$7,000.00 decline in substitute cost from last year at this same time. Mr. Sumner informed the board of the District Education Improvement Committee Meeting

to be held on January 14, 2004.

Mr. Sumner reminded the board of the basketball homecoming January 16, 2004, and updated the board on the request for a BE/ESL waiver submitted for the 2003-2004 school year. Mr. Sumner stated that initially we did not ask for an exception waiver; however, after conversation with the Texas Education Agency, he felt that it was necessary to again request a bilingual exception for the district. He said this is the third year that an exemption has been requested and that additional bilingual staff will have to be hired at the elementary level to bring the district into compliance in this area.

Mr. Sumner reviewed the Reading Recovery Report for 2002-2003. Verlan Winegarner provided information regarding the program and the success of the students involved in the program.

Staff Development Logs were provided for each campus for the third six weeks. Mr. Sumner indicated that our staff development activities have been substantially decreased due to budget cuts in staff development this past year.
