Orie Cooksey placed 5th Individual in the Junior Division, out of 770 contestants. He scored 480 points, out of a possible 500



## Wheat Field Day Slated for May 8th

Farmers can update their knowledge of wheat production at a May 8 wheat field day at the AgriPro farm near Lockett, east of Vernon on U.S. Highway 70. Registration begins at 9:30 a.m. in at 10 a.m



Shattered Dreams is a two-day school based program that promotes responsible decision making by high school students regarding drinking and driving by showing them how irresponsibility can end all dreams

For several reasons, this alcohol awareness education program can be more effective than the traditional program conducted prior to such events as spring break, prom night, and graduation. Shattered Dreams requires the active participation of students and parents, educators, and representatives from other segments of the community. The major activity is a dramatic reenactment in front of the school of injuries and death resulting from an auto crash caused by drivers who drink. This involves several students.

Another major activity is the reenactment of the death of those who die every fifteen minutes in auto crashes. Every fifteen minutes, an adult dressed as the Grim Reaper walks through school hallways to the sound of a heartbeat played over the school public address system. He then takes one pre-selected student volunteer out of a class. These student volunteers, known as the "Living Dead", then proceed to a room to have their faces made up with theatrical makeup to make them look dead. Uniformed police who read mock obituaries then present mock noti- the following day. The assembly fications of their death to their classmates and parents. Then they simulate being dead by returning to classes with instructions not to communicate with anyone.

A mock auto crash will be simulated near the high school. The crash victims are then taken to the hospital emergency room and area funeral home. Later, after the day's events, counselors are available in the auditorium for students who did not participate in the event to receive support.

In addition, an overnight leadership retreat for the student volunteers representing those who died simulates for students and their families the experience of being teens who die as a result of alcohol related auto crashes. They also participate in group discussions on topics related to personal power and personal identity and design posters reflecting their discussions. They then share their ideas through poster talks with the larger group.

At the retreat, the ministerial alliance and counselors will help students process their experiences. Students write letters to their families on the theme of "my life has a purpose" to communicate feelings that they would not of been able to share as a result of a premature death. Two letters are selected to be read in a school-wide assembly

features presentations by medical and law enforcement personnel, as well as school staff, parents and students

As part of the assembly, the mayor of Spearman, Steve Benton, will read a document proclaiming May 5th as Shattered Dreams Program Day in Spearman.

Shattered Dreams is unique that it requires a serious long-term commitment by those who sponsor it. The event requires extensive planning by school and community personnel who served on the planning committee. An estimated 2.1 million Americans are victims of physical, psychological or other forms of abuse and neglect each year. The abuse can occur at the hands of paid caregivers or family members. It can occur at home or in settings. institutional care However, because only about four percent of older adults live in facil-

# Hansford SWCD Observes Soil Stewardship Week

The Hansford Soil and Water Conservation District (SWCD) has announced they will join in the national observance of Soil and Water Stewardship Week to take place on April 27 through May 4, 2003. according to an announcement by Willard McCloy, Chairman of the disrict.

The theme of this year's observance is "Food for the Future." Assuring food for the future is the most basic issue any society faces, and one of the most complex. Food for the future will come from those people and nations fortunate enough to have the soil and water for agricultural production, the ability to provide stewardship for the land, and the freedom to pursue their agriculture in peace.

The Hansford SWCD was organized in 1948 for the purpose of offering farmers, ranchers and the local community a voluntary conservation technical assistance program through which individuals could seek and request conservation assistance to meet the capabilities and needs of their land.

"Basically it is the district's responsibility to provide technical assis ance when requested relative to proper soil use and treatment, erosion control practices, solve drainage problems and assist farmers and ranchers with crop, range pastureland and wildlife management along with using trees and/or forest resources to assist in conservation," said McCloy.

The National Association of Conservation Districts has sponsored Soil and Water Stewardship Week in the United States since 1955, in cooperation with the nation's nearly 3,000 soil and water conservation districts.

Informative material on the Soil and Water Stewardship Week theme is distributed each year through local conservation districts to clergy men, lay leaders, civic and educational organizations and to individuals interested in participating in the celebration.

The Hansford SWCD will be delivering church bulletin inserts to local churches in observance of Soil and Water Stewardship Week. We will also take bookmarks to all school libraries as well as the public library



The district site-based committee will route questions and comments to the appropriate committees

### **District Committee (DEIC)** March 20, 2003

\* The DEIC approved the 2003-2004 Instructional Calendar as presented and routed their recommendations to the board of trustees for their approval at the March 24, 2003 regular board meeting.

\* Jarrett Wilde, Spearman Police Chief, spoke to the DEIC committee about preparations by the city and county for possible biological/chemical and terrorist attacks. Chief Wilde is the Emergency Management Coordinator for the city, and Judge Brown is the coordinator for the county. Chief Wilde said in case of an attack that the city has a warning system in place and will notify the schools if an emergency existed.

The committee reviewed the 2001-2002 At-Risk Evaluation and the District's At-Risk Plan (state compensatory education). Mr. Sumner indicated the purpose of the program is to prevent dropouts and at-risk kids from falling through the cracks. He reported that the drop out rates for Spearman ISD was less than one percent, which equals 2 students.

The committee reviewed the Spearman ISD Dyslexia Plan and Guidelines. Less than ten students district wide are identified in need dyslexia services. Katrina Hughes is the dyslexia teacher.

Mr. Sumner informed the com-

mittee of work being done to evaluate the effectiveness of the GT program. He indicated that parent surveys were being sent out and both teachers and GT students would be given the opportunity to provide their feedback/input on the program.

\* The committee recommended that if the County Livestock Show move their show from February 6 to February 13 next year, that the board of trustees change the 2003-2004 instructional calendar to reflect this change

The committee watched a PowerPoint presentation by Mr. Sumner on the upcoming DEC visit.

Karen Hartgraves, GT Program Coordinator, made a presentation on the work of the GT Vertical Alignment Committee. She reviewed the results of the recently administered program surveys. In addition, she highlight-ed recommended changes to the GT Plan/Handbook.



# Come to the CINCO DE MAYO FESTIVAL

The 5th of May is not Mexican Independence Day, but it should be! And Cinco de Mayo is not an American holiday, but it should be. Mexico declared its independence from mother Spain on midnight, the 15th of September, 1810. And it took 11 years before the first Spanish soldiers were told and forced to leave Mexico.

So, why Cinco de Mayo? And why should Americans savor this day as well? Because 4,000 Mexican soldiers smashed the French and traitor Mexican army of 8,000 at Puebla, Mexico, 100 miles east of Mexico City on the

morning of May 5, 1862. The French had landed in Mexico (along with Spanish and English troops) five months earlier on the pretext of collecting Mexican debts from the newly elected government of democratic President (and Indian) Benito Juarez. The English and Spanish quickly made born General Zaragosa, (and the

deals and left. The French, however, had different ideas.

Under Emperor Napoleon III, who detested the United States, the French came to stay. They brought a Hapsburg prince with them to rule the new Mexican empire. His name was Maximilian; his wife, Carolota. Napoleon's French Army had not been defeated in 50 years, and it invaded Mexico with the finest modern equipment and with a newly reconstituted Foreign Legion. The French were not afraid of anyone, especially since the United States was embroiled in its own Civil War.

The French Army left the port of Vera Cruz to attack Mexico City to the west, as the French assumed that the Mexicans would give up should their capital fall to the enemy -- as European countries traditionally did.

cavalry under the command of Colonel Porfirio Diaz, later to be Mexico's president and dictator), the Mexicans awaited. Brightly dressed French Dragoons led the enemy columns. The Mexican Army was less stylish.

General Zaragosa ordered Colonel Diaz to take his cavalry, the best in the world, out to the French flanks. In response, the

French did a most stupid thing; they sent their cavalry off to chase Diaz and his men, who proceeded to butcher them. The remaining French infantrymen charged the Mexican defenders through sloppy mud from a thunderstorm and through hundreds of head of stampeding cattle stirred up by Indians armed only with machetes.

When the battle was over, many

French were killed or wounded and their cavalry was being chased by Diaz' superb horsemen miles away. The Mexicans had won a great victory that kept Napoleon III from supplying the confederate rebels for another year, allowing the United States to build the greatest army the world had ever seen. This grand army smashed the Confederates at Gettysburg just 14 months after the battle of Pueblo, essentially ending the Civil War.

Union forces were then rushed to the Texas/Mexican border under General Phil Sheridan, who made sure that the Mexicans got all the weapons and ammunition they needed to expel the French. American soldiers were discharged with their uniforms and rifles if they promised to join the Mexican Army to fight the French. The American Legion of Honor marched in the Victory Parade in Mexico City.

It might be a historical stretch to credit the survival of the United States to those brave 4,000 Mexicans who faced an army twice as large in 1862. But who knows?

In gratitude, thousands of Mexicans crossed the border after Pearl Harbor to join the U.S. Armed Forces. As recently as the Persian Gulf War, Mexicans flooded American consulates with phone calls, trying to join up and fight another war for America.

Mexicans, you see, never forget who their friends are, and neither do Americans. That's why Cinco de Mayo is such a party -- A party that celebrates freedom and liberty. There are two ideals which Mexicans and Americans have fought shoulder to shoulder to protect, ever since the 5th of May, 1862. VIVA! el CINCO DE MAYO!!
