City, school board elections conducted

Votes cast in the Saturday, May 4 city and school board elections have been totaled. Official results are available from Spearman and Morse, with vote totals in Gruver unofficial until canvassed by the city commission and school board.

The Spearman city election results were canvassed on Monday, May 6 by the Spearman City Council. Mike Cudd, Ed Garner and Steve Benton will officially be installed as Aldermen for the City of Spearman on Tuesday, May 21 at 7:30 p.m.

Vote totals for the candidates in the Spearman city election included: Mike Cudd, 16 absentee and 322 on Saturday, 338 total; Ed Garner, 14 absentee and 307 on Saturday, 321 total; Steve Benton, 14 absentee and 296 on Saturday, 310 total; and Ray Dean Coates, 8 absentee and 81 on Saturday, 89 total.

Overall there were 21 absentee ballots and 397 regular ballots cast in the Spearman city election, for a total of 418 ballots, according to City Secretary Cheryl Gibson.

Votes were also canvassed Monday in the Spearman School Board election, and results in the race for two

seats on that board are also official. Kerry L. Henton and James A. Schnell will become new board members.

Totals in the SISD Board of Trustees election included: James A. Schnell, 319; Kerry L. Henton, 273; Don Hawkins, 188; Mike Garnett, 153; and Joe Clement, 100.

Voters in the Pringle-Morse CISD Board of Trustees election had an easy choice. Incumbents Ron Womble and Bob Womble were unopposed in their bid for that board. Each candidate received 20 votes. Canvassing of that election was done on Tuesday, May 7.

Unofficial vote totals in the race for two positions on the Gruver City Commission included: Mark Irwin, 166; Keith Gibson, 163; and Daniel Boyd, 47. The Gruver City Commission was scheduled to canvass the votes on Wednesday, May 8.

Unofficial results in balloting for two members of the Gruver Independent School District Board of Trustees included: J.W. Ward, 202; Linda Venneman, 180; George B. Odom, 155; and James W. (Wes) Whitaker, 50. The Gruver School Board was also scheduled to canvass votes on Wednesday, May 8.

Unemployment at 3%

Hansford County's unemployment rate for March was 3 percent, according to the Texas Employment Commission.

TEC figures show that during the month of March, Hansford County had a total civilian labor force of 3,660 persons. Of that number 3,549 were

employed and 111 were jobless.

The statewide unemployment rate for March was 6.4 percent, up from 6.2 percent in February. TEC Commissioner Mary Scott Nabers said the number of unemployed Texans trying to find work increased by an additional 27,000 in March, causing the jobless rate to rise.

Spearman joins in rate increase fight

The city of Spearman is joining a coalition of Panhandle communities to fight Texas-New Mexico Power Company's latest request for a rate increase, according to Spearman City Manager Jim Murray.

A news release from Murray stated that he and Spearman Mayor Burl Buchanan went to Dallas to attend a meeting of the cities served by TNP. At that meeting, the cities formed a coalition to fight the TNP rate increase before the Public Utilities Commission.

Murray said that citizens of Spearman can participate in this hearing process by writing the PUC commissioners or by attending the public hearings in Austin, which he feels will begin later this year. Murray said that concerns about the rate increase should be addressed to: Public Information Officer TPUC

The cities formed a steering committee and made decisions about proceeding with opposition to the rate increase before the PUC, according to the news release. The city of Spearman will have one representative on this committee. Murray said that

either he or Buchanan will represent Spearman.

The release said that TNP is requesting a rate increase of \$5.8 million, or 9.63 percent. According to the release, if this increase is granted it would be the third in as many years. The last increase was granted in February of this year.

Murray said that the February increase, and this increase request, were brought about to enable TNP to pay for two generators it had constructed in Robertson County. The February increase was to pay for one generator, and this increase is to pay for the second. In its ruling granting the February increase, the PUC stated that the construction of the second plant was imprudent, according to Murray.

Murray concluded that citizen involvement in these rate increase cases does make a difference. He pointed out that the lawyer for the cities in the last rate increase hearings before the PUC told him that if it had not been for the participation of Spearman residents, the PUC would have granted TNP the full rate increase it asked for. Instead, the PUC cut the request by approximately \$10 million.

Spearman tennis players . . .

Facing tough first rounds

When the Spearman doubles team of Cam Butts and Tamri Townsen, and singles player Kimbre Townsen, play their first matches of the State Tennis Tournament they may well face their toughest opponents of the whole tournament, according to Kurt Ashmore, tennis coach.

Ashmore reported that both the Spearman entrants will have to play opponents from Mason High School. According to Ashmore and others, Mason is a perennial powerhouse in state AA tennis.

Tamri Townsen and Butts will have to face Mason's number one doubles team in their first round match. Ashmore said that he has heard the Mason team plays a defensive style of game. To counter this style, he said, "Cam and Tamri will have to be real aggressive and force the action."

With the team having to play so hard in their first match, Butts' health status becomes a concern. She suffered with a throat infection that put her in the hospital for a few days, and kept her out of the regional tournament. Brandi Schneider

substituted for Butts in the regional tournament and helped the team to finish second, earning a berth in the

Ashmore responded to the Butts health question by saying, "After two weeks of good hard workouts, Cam is back in form and playing well."

Also playing well, according to Ashmore, is Kimbre Townsen. Kimbre will face Mason High School's number two singles player in her first round match. "She (Kimbire) is playing the best tennis she has played all year. If Kimbre plays consistently, the way she has been playing, she has a chance to win it all," Ashmore said.

The Spearman tennis players will play all their state tournament matches at the University of Texas intramural courts in Austin. Matches will start at 9 a.m. on Friday, May 10. The doubles will play then, followed by the singles which start at 11 a.m. If the Spearman players win, they will play a second round Friday afternoon.

If the Spearman players win both rounds on Friday, they will play for the state title on Saturday, May 11. The AA doubles title match will start at 10 a.m. and the singles title match will start at noon.

Tracking medals at state meet

When the finals of the State Track Meet begin Saturday at Memorial Stadium on the University of Texas campus, six young ladies from Gruver High School will be going after state medals.

Cora Meyer will run in the 800 meter run at 12:20 p.m. She will then team up with Holly Venneman, Kasey Davis and Amanda Hiller to run the 1600 relay finals at 2:30 p.m. Gina Hoel is going as an alternate on the relay team. These times are according to the schedule released by the UIL Public Information Director.

Meyer, in the 800 run, may have the toughest time earning a medal, according to Mike Banks, Gruver Lady Hounds track coach. She will have to shave more than four seconds off her best time to be assured of a medal. That is, if the other competitors in the race run

close to their best times. "You never know how they (competitors in a race) will run. Cora is in a good position to win a medal," Banks said.

If Meyer is in a good position to win a medal, then the 1600 relay team is in an even better spot. According to Banks, the relay team has the third best time of all the teams in the state finals. He said the team needs to lose only six-hundredths of a second off their best time to move into second place. He added that improving team speed has been the focus of their workouts this last week. "If we had just had a nice day to run it would have helped," Banks commented.

He said that the girls are all healthy and excited about competing at the state meet. "I am not sure how they are going to run, but as of today we are all healthy and ready to go," he said.

The team will be leaving Gruver on Thursday about noon, according to Banks.

Weekend unites area youths

"Thirty-Something"

All told, 320 people from 15 area churches participated in the "Thirty-Something" worship event, according to event organizer David Furlow, Spearman First Baptist Church youth minister.

According to Furlow, the event got underway Friday afternoon when the 168 teenagers registered for the event were split into 14 study groups that were hosted by 14 Spearman residents in their homes. Each group was then led in study of a curriculum called "The True Test," written by Billy Beacham, president of Student Discipleship Ministries in Fort Worth.

The curriculum, according to

Furlow, deals with the subject of family relations and includes such topics as "The Priority of the Family," "Am I a Part of the Problem or the Solution," and "Reactions Reveal Your Character."

Furlow said that the teenagers were well fed by the 14 food teams that prepared and delivered food and refreshments to the groups. The food teams were made up of volunteers from the Spearman churches. They were organized by Mary Baker and Linda Latta.

The groups were brought together two times during the 30 hours of study. They met on Saturday at noon

for a dinner and a time of recreation. Furlow said that because of Saturday's cold temperatures, the students' participation in the games that afternoon seemed more energetic than he anticipated.

While the students were recreating, the parents were able to attend a seminar conducted by Beacham, based on the curriculum the students were studying. Furlow indicated that though the seminar was sparsely attended, the response to it was very positive. He added that a video tape and written material from the seminar can be obtained by contacting the office of the First Christian Church of Spearman.

The conclusion of the event took place Saturday night at the Lyric Theatre, when all the students and the adult participants came together for what Furlow referred to as the "Main Event."

Furlow described the "Main Event" as a time of music, fun and reflective thought. He said music was provided by guitarist and keyboard player Reagan Felker of Dalhart, and singer Vicki Harrell of Buggalou, La. Illusionist Lyndy Phillips of Abernathy kept everyone entertained with his magic. Furlow said that Beacham concluded the family study curriculum with some well-chosen thoughts.

Furlow concluded with a note of thanks from himself and fellow event organizer Gary Ellsworth, to all the businesses and people of Spearman who donated their time, merchandise and money to make this event such a success.

In addition to interaction with panelists, the seminar's goals are to provide the opportunity to explore America's incentive system and our democratic process and to recognize leadership potential in high school sophomores.

"Hurting parents, God understands how you feel. God lost His kids...and no one can say He didn't raise them right either. He loved them. He spent time with them. He gave them the best of everything. He carefully taught them what not to partake of or even touch. He made sure they understood that their futures depended on their choices. He warned them of the consequences if they strayed from their upbringing. Nevertheless, a bad influence pulled them away and involved them in wrongdoing.

"God found out and confronted Adam and Eve, who acted somewhat like many of today's teenagers. They were evasive and placed blame elsewhere.

Pet Week proclaimed

The week of May 13-18 has been designated as "Pet Week" in Spearman by virtue of a proclamation signed by Mayor Burl Buchanan.

In the proclamation Mayor Buchanan announced that the Hansford County Veterinary Hospital, in conjunction with the City of Spearman Animal Control Department, will conduct a week-long vaccination clinic.

The clinic will be held at the Hansford County Veterinary Hospital, located at 406 S. County Road #1. Hours will be 8 a.m. to 5 p.m. Monday, May 13 through Friday, May 17; and 8 a.m. to noon on Saturday, May 18.

During the clinic, discounted fees will be offered on vaccinations and tests for dogs and cats. They include rabies vaccination, \$7; distemper-parvo, \$17; parvo, \$7; feline leukemia, \$11.50; feline distemper, \$11.50; Cytarab (feline rabies & distemper), \$14; heartworm check, \$11.50; and feline leukemia test, \$14.

City tags for males and spayed females will be \$2, while female dogs and cats will carry a \$5 tag fee.

Mayor Buchanan said in his proclamation that he encourages all owners of pets to help control any outbreak of disease by having their pets vaccinated during the week-long clinic.

Gruver Police Department

Gruver Police Chief Steve Gaines reports his department was called Wednesday, May 1 to assist a resident regain entry to her home in the 400 block of Womble, after locking herself out.

Also on May 4, Gruver police recovered a quantity of alcoholic beverage which had been stashed behind a dumpster in the alley of the 400 block of Cooper. The officer discovered the alcohol after investigation of a vehicle in the alley.

On Sunday, May 5, Gruver police received a report of two runaways, both junior high school students. Gaines said the pair allegedly stole a vehicle and drove to Guymon, Okla., where they were located in a motel by Guymon police. The students were returned to Gruver by their parents, said Gaines.

The Gruver Police Department filed one case in municipal court last week, concerning a traffic violation. Gruver Ambulance

The Gruver Ambulance was put on standby Saturday and Sunday, May 4 and 5, for the Gruver Tri-State High School Rodeo. No injuries were reported.

Gruver Fire Department

The Gruver Volunteer Fire Department responded to two calls during the week of April 22-26, according to Fire Chief Sam Gruver.

The first call came on Thursday, April 25, when a structure fire was reported 14 miles northeast of

Gruver. An outbuilding near a residence was involved, and damage was minor, said Gruver.

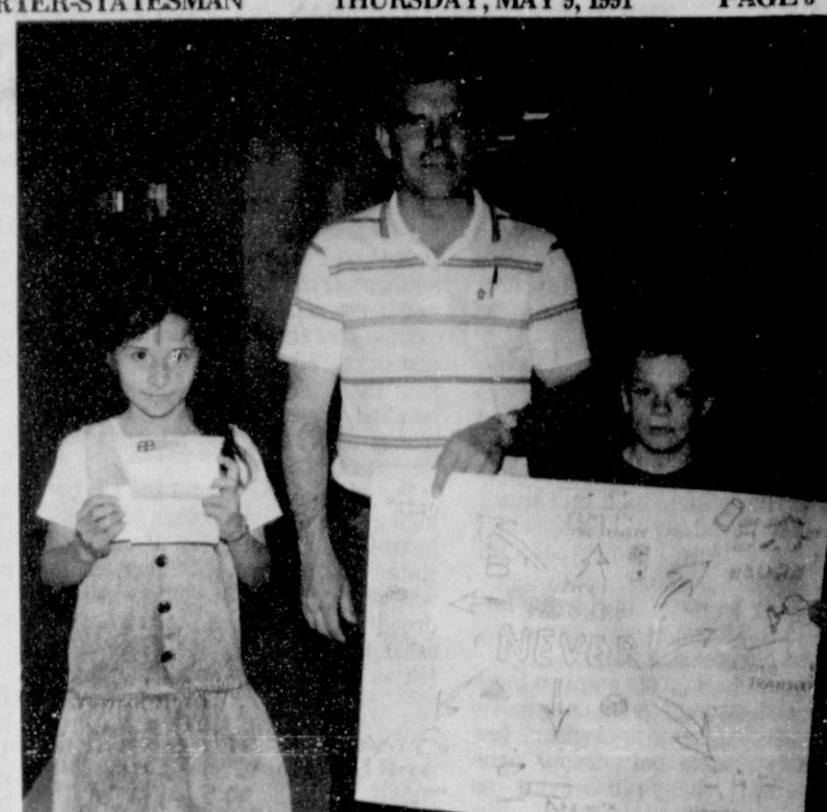

Pledges total \$4,500

Pledges totaling \$4,500 were made during the Golden Spread Senior Citizens Center's annual Radiothon, according to spokesperson Pearl Pierce.

The Radiothon featured local celebrities and talented individuals who contributed their time and effort to raise money for the senior citizens center. During performances carried live on the local radio station, pledges were called in by listeners.

Pierce said the Radiothon is one of the Center's major fundraising

events of the year, contributing money toward operating expenses for the Golden Spread Center. These expenses include recreation, covered dish dinners, arts and crafts, exercises, and also includes assistance with Social Security and Department of Human Services matters for seniors, said Pierce.

She said Golden Spread Center members had constructed a quilt, which was won in a drawing by Kathy Archer of Spearman.

Funding received

Gov. Ann W. Richards announced that the Texas Department of Community Affairs has funded Panhandle Community Services \$31,768 to assist in the prevention of homelessness in the local area.

The organization is one of 56 across Texas that TDCA has chosen to receive assistance.

The funding is part of the \$2,055,737 Emergency Community Services Homeless Grant Program awarded to TDCA in February by the U.S. Department of Health and Human Services.

The program provides a variety of services aimed at the assistance and prevention of homelessness in the local community.

Specifically, it seeks to prevent potential homeless situations through shelters and temporary assistance with bills, such as rent and utilities.

TDCA withheld \$500,000 of the grant to be distributed as performance awards later in the contract year.

The awards will be distributed based on criteria which may include planned performance versus actual performance, cost per client served, types of activities and assistance provided and amount of total grant spent on direct services.

The counties in the service area of Panhandle Community Services include Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray,

Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher and Wheeler.

TDCA was established by the Legislature in 1971 to assist Texas communities in achieving solutions to economic and social problems and to improve the effectiveness of their local government.

March DPS stats

The Texas Department of Public Safety has announced accident statistics for the month of March.

Capt. Rusty Davis, district supervisor of the Amarillo Highway Patrol District comprising of 31 counties, said, "For the month of March, our troopers investigated one fatal accident, 55 personal injury accidents, and 74 property damage accidents. There was one person killed and 78 persons were injured in these accidents."

Sgt. Timothy Thompson of Borger stated, "In Hansford County, our troopers investigated no fatal accidents, one personal injury accident, and no property damage accidents in the month of March. No one was killed and one person was injured in these accidents."

Renovation planned

Linda Cummings and R.L. McFarlin are heading up an effort to fix up the Hansford County War Memorial, located on the west corner of the courthouse lawn.

Cummings said they would like to have the work completed in time for a Memorial Day dedication program.

She said a fund has been established at First State Bank of Spearman to help finance the cost of fixing up the memorial. People interested in donating to the project should address their inquiries to Larry Trosper or Ronda North.

The idea for the memorial, according to Cummings, was first conceived by the Spearman J.C.'s in 1969. The memorial was dedicated in 1970.

Chiseled on the face of the granite monument rising from rock pavement are the names of the Hansford

County soldiers that were killed while serving our country during a time of war.

Cummings said the memorial is currently maintained by the county as part of regular maintenance of the courthouse grounds, and by the Servitors organization. The colorful flowers that are present at the memorial are placed there by people who visit the memorial.

The planned improvements will cost about \$4000, according to Cummings. Work to be done includes replacing the curbing and fence around the memorial, and replacing the rock base with a more attractive material that will be easier to maintain.

Cummings said that anyone is welcome to come help on the project, and that all donations will be greatly appreciated.

On The Go With Joy

Since I'm kind of under the weather, I'm going to give you some thoughts from James F. Hanna, Sr. of Harrisville Road. Since it was handed to me and not mailed, I have no idea where Harrisville Road is located. I suspect it came from back East in Pennsylvania. To those who don't have a sense of humor, don't read any further.

"Dear Editor: I just can't understand inflation. Bein' from the old school, I always remember how many lollipops we could buy for a penny. What can you buy for one cent today? How about the twice as big pack of gum for a nickel? Then there is always them so-called blue jeans. We used to call them bib-less overalls. We bought them for 75 cents during the Depression and there was no spilled paint or holes in them when we bought them. Oh well, times do change, much to my disgust.

"When prices was cheap, so was wages. We used to work for farmers in the neighborhood from sun-up til sun down for \$15 a month plus room and board, however, I liked it better the way it was. I don't adapt readily to change. When we wanted to play any games at our one room school house, we brought from home our own ball and bat or what ever else we wanted to play with. No taxpayer sponsored games then.

"How about all them new versions of the Bible? I call them 'counterfeit.' If the King James Version is good enough for me, it should be good enough for all.

"Where would I look for a young person today who would dig ditches with a pick and shovel for 13 hours per day when he knew he'd get fired if he missed one stroke with his pick or shovel and got paid 32 1/2 cents an hour? This was the way road jobs was just after the Depression. Coffee breaks came many years later.

"Our roads were all mud roads. If a cop caught you driving 35 mph, you got pinched. Oh well, no sweat, we couldn't go over 10 mph on those roads no-how. What became of the gas plug where you could buy a gallon of gas for 14 cents?

"Why do some kids today get a big allowance and have chores to do while we had to do our chores with no allowance? Please don't misunderstand me. I like young people. I just don't understand them. Our progeny numbers 28 people plus spouses and they are all younger people. There are a lot of hard-working people around, they just don't have to work as hard as we did when I was a kid. "Some preachers say things over the pulpit now a days that we young boys figured we'd just go down behind the barn to talk about.

"What became of the family doctor who used to drive eight miles one way on a cold stormy winter's night in his one horse sleigh to deliver a

baby and charged \$5 or would take a peck of potatoes and we allowed he was pretty expensive?

"Many kids waste enough food to feed the hungry in Africa.

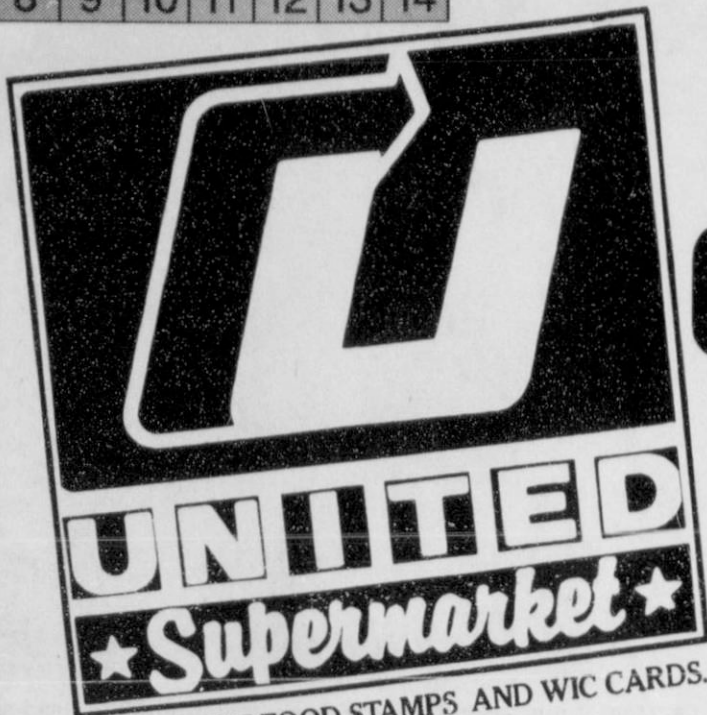

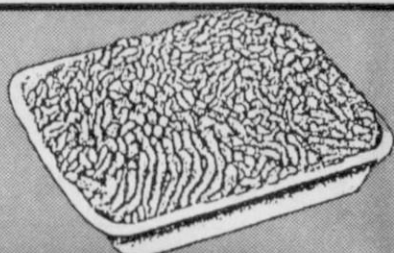

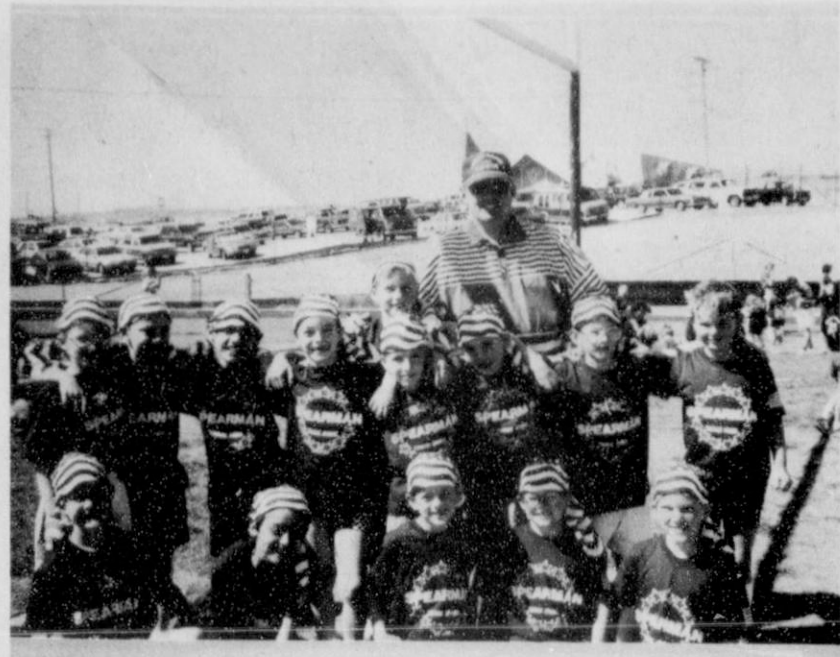

Statement of Intent to Change Rates

In accordance with the regulations of the Public Utility Commission of Texas, Texas-New Mexico Power Company announces the Company's intent to change rates for its entire Texas operations. The effective date of such change is May 17, 1991. All classes of customers will be affected by said proposed changes. The proposed rates will produce an increase in gross revenues to the Company over test year revenues adjusted for test year customer growth and weather and annualization of test year rate increases of \$35,836,827, or 9.63%. TNP is proposing an alternative rate base treatment for Unit 2 of TNP One, the second unit of the Company's generating facility located in Robertson County, Texas. Under this alternative, sale-leaseback treatment will be given to Unit 2, thereby including a lease payment in the cost of service, as opposed to traditional rate base treatment. If adopted, the sale-leaseback plan results in an increase in gross revenues of \$31,210,197, or an 8.38% increase over adjusted test year revenues during the first year of the plan. Texas-New Mexico Power Company provides electrical service to more than 165,011 customers located within the state of Texas.

A complete copy of the requested rate filing package is on file with the Public Utility Commission of Texas in Austin, Texas, and with all cities served by Texas-New Mexico Power Company which have retained original jurisdiction. You may inspect a copy of the filing during normal business hours at each business office of Texas-New Mexico Power Company in your area.

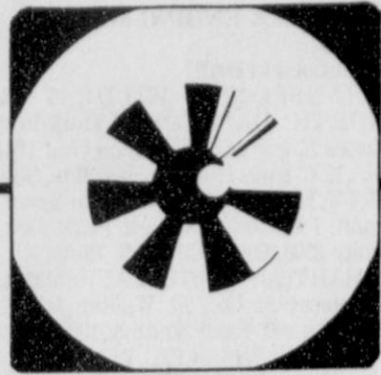

Texas could add billions to economy

Texas could add billions of dollars and tens of thousands of jobs to its economy by processing more of the raw foods and fibers grown in the state, according to the Texas Agri-Business Electric Council.

The growing awareness of this potential economic boom by leaders of business, agricultural and state government is an encouraging sign, said Greg Boggs, agricultural marketing consultant with Southwestern Public Service Company. SPS, along with nine other Texas investor owned electric utilities and Texas A&M University, compose the council.

The potential for ag-processing has been documented by a recent study done by the SPS economic development department. The "Target Growth Study," listed 80 industries which would fit well into the SPS service area. One-quarter of those industries were related to agriculture processing, including such industries as textile mill production, confectionary production and grain mill production.

SPS Economic Development Manager Cheryl Pink said the study demonstrates that ag-related industries should continue to be encouraged to locate to the area. "Communities have been working hard and will continue to work hard to attract such industries," Pink said. "As the cooperation of state and local governments increases, our chances of attracting one of these ag-related industries also increases," Pink added.

Governor Ann Richards earlier this month related that Texas produces a significant amount of the nation's cotton, but most of it is processed

elsewhere into clothing and other goods. In fact, according to a 1989 study by the Agri-Business Electric Council, Texas grows one-third of the nation's cotton, but ships 92 percent of its crop out of state to be processed.

Boggs said Gov. Richards is to be commended for encouraging emphasis on more ag-processing in Texas. "Think of all the jobs that never would have been created if we had shipped all Texas' crude oil out of state to be turned into gasoline and other petroleum products," Boggs said. "Yet, that's just the sort of thing we're doing with much of the Texas' huge agricultural resources."

Texas Agriculture Commissioner Rick Perry also is committing resources toward the development of more ag-processing in the state, Boggs said. "Commissioner Perry knows that the value added by processing is significant," said Boggs "and it's money to Texas economy is losing. For example, the value of corn is more than doubled when turned into corn masa flour for making tortillas and other Mexican-food products. And one dollar's worth of milled corn becomes ten dollar's worth of corn flakes cereal."

The Agri-Business Electric Council is fighting to change the situation. It has produced feasibility studies of increasing the Texas processing of corn, rice, timber and natural fibers, including cotton, wool and mohair. In addition, the council may do feasibility studies of processing vegetables, leather and other agricultural products.
