Spearman City Council holds town meeting to discuss sales tax

The Spearman City Council held a Town Meeting on Tuesday, June 20 at 7:30 P.M. at the City Hall.

The major topic covered in this discussion was a city wide economic development sales tax.

This topic for the City Council Meeting was prompted by a recent meeting of the Spearman business leaders. This new tax has great support from city businesses. Many of the business leaders feel that this tax would be a way to help the economy of Spearman, and in effect, keep the high quality of life in this town.

It was also brought up that Spearman has the one of the lowest town sales tax in the area. Other towns such as Guymon, Hereford and Perryton have all benefited from an increase in local sales tax.

Research is being done by the Chamber of Commerce to see what steps are necessary in implementing this sales tax. The Chamber has already contacted many cities with increased sales taxes for information.

A point made by the Chamber was that most of this work had already been done by the other cities, and all Spearman had to do is follow the example set by these cities.

City Council member, Charles Elliott, has been in favor of a sales tax increase for the past few years

now. He feels the time is right to get this increase in effect.

If passed, this new tax would increase the current sales tax by 1/2 a cent. This increase is projected to generate \$80,000 a year.

In addition to increasing Spearman's funds, this tax would lower property taxes. The sales tax can be linked to a property reduction tax that would result in an actual lowering of property taxes. In essence, cost for purchasing goods in Spearman will slightly increase, and the city taxes themselves will lower the property taxes.

There are two statutes that determine how the money produced from this sales tax would be spent.

The first, is Section 4A. In this section, there would be five corporation directors appointed by the city council. Any or all of these directors can be City Council members. This section can be linked to a property reduction tax on an "all or none" basis.

Additionally, this section deals with a perpetual tax, and it would be more difficult to stop if the City of Spearman wanted to end the tax increase.

The second option is Section 4B. It is this section that seemed to have more support from the City Council and those Spearman citizens present. This section allows for seven directors on the corpora-

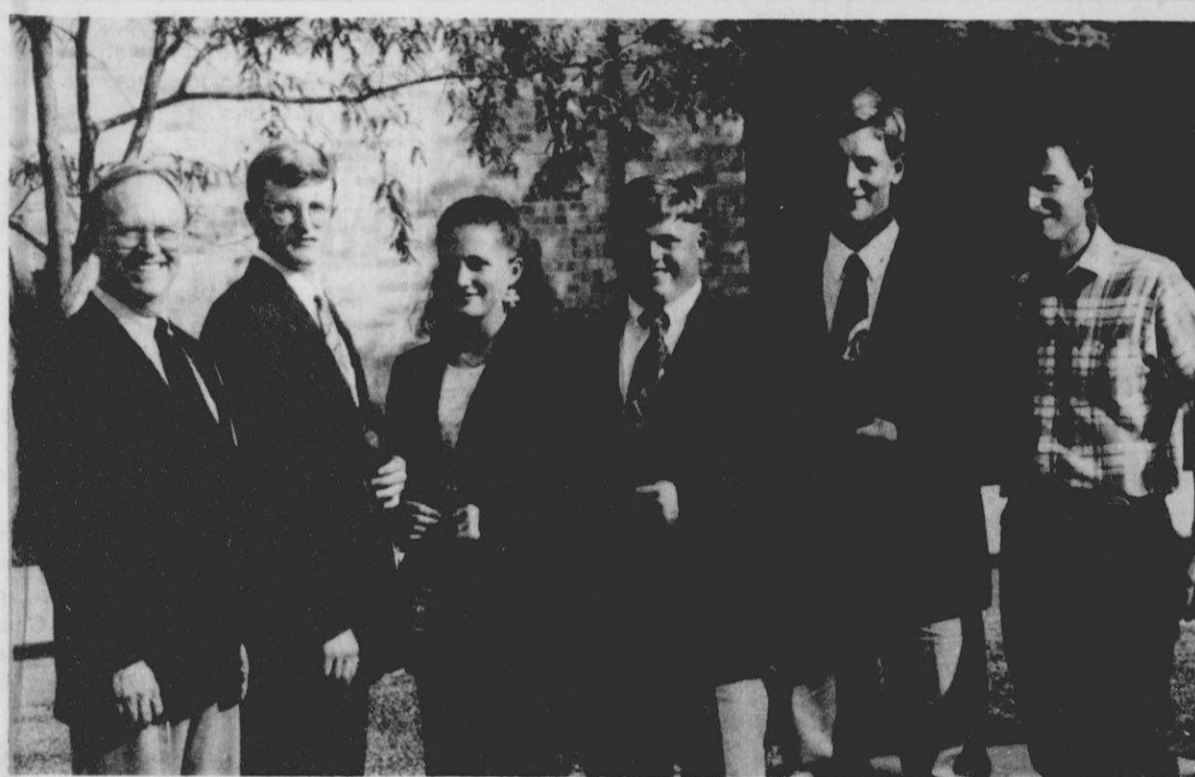
tion board, and three of these directors cannot be City Council members of employees of the city. The property relief tax cannot be linked to this section on an "all or none" basis.

Those present feel this section would give the City of Spearman more legal freedom on how to spend the collected money. It also allows for more flexibility in accommodating city businesses.

With this section, there are many more options if the tax is no longer needed. A general election is one way to end the tax increase. Another choice is for the corporation directors to notify the State Comptroller's Office to put the tax on hold. Also, with the Comptroller's Office, the tax can be "turned off and on" without the need of a general election each time. A final option would be to set time limit on the tax increase.

The City Council has decided to wait for more petitions and public reaction before taking any further action. They are going to take steps to make the options and limitations of the sales tax clear to the citizens of Spearman.

A decision on having the sales tax on this November's ballot will be made by August. If the tax increase is passed, it will not take effect until October of 1996.

Kathy Slough was 5th HI in the contest. Kathy placed 2nd HI in sheep and 8th HI in swine. She is the daughter of Kenneth and Alice Slough of Gruver. Kathy will be a sophomore at Gruver High this fall.

Galen Slough placed 4th in swine judging in the contest. Galen is the son of Kenneth and Alice Slough of Gruver. He is a 1995 graduate of Gruver High School. Galen will attend Butler Co. Jr. College at El Dorado, Kansas this fall on live-

The Hansford County 4-H Livestock Judging team took part in several contests this spring. On April 1, the team travelled to Miami, Oklahoma to compete in the NEO Livestock Contest. The team finished 1st in swine and 5th in reasons. Individually, Hansford County swept the swine division with Galen Slough 2nd, Brandy Morris 6th, Jared Johnson 7th, Kathy Slough 8th, and Scott Stedje 10th. Kathy Slough was 3rd high individual in reasons.

Next, the team went to Levelland to compete at the South Plains contest. In the 4-H division, the team consisting of Jared Johnson, Brandy Morris, and Greg Slough placed 2nd in cattle, 4th in sheep, and 5th overall. The team consisting of Scott Stedje, Galen Slough, and Kathy Slough finished 2nd in swine and 6th overall. Individually, Jared Johnson was 3rd in sheep, 3rd in cattle and high individual in the 4-H division. In swine judging, Scott was 1st and Galen Slough was 5th.

Finally, the team went to Nance Ranch at West Texas A&M University for the District Contest. The team finished 1st in swine, 1st in reasons, 3rd in cattle, 9th in sheep and 2nd overall to win the right to compete at the State Contest. Individually, Galen Slough was 1st in reasons, 5th in swine, 6th in cattle and 4th overall. Kathy Slough was 2nd in reasons, 3rd in cattle, 7th in swine, and 6th overall. Scott Stedje was 1st in swine, 5th in reasons, and 10th overall.

SISD Board engages in meeting

The Board of Trustees of the Spearman Independent School District met in Regular Session on June 15, 1995 at 7:00 P.M. Mr. Craig Schumann, Board President, called the meeting to order.

The Board heard from Kelvin Knauff, City Manager, on the SPS franchise negotiations.

Special reports included information from Alice Peddy of the Hansford County Appraisal District on their proposed budget, decline in property values, and potential effective tax rate. Mr. Murrey also presented the preliminary District Improvement Plan.

Additionally, the Board took action on several other items. They selected Sheri Benton as delegate and Carol Dunning as the alternate to the 1995 Texas Association of School Boards Convention. The Board designated First State Bank on Spearman as the Depository for the District. Also, the TASB Local-

ized Update 48 was adopted.

The use of school tennis courts by the city of Spearman for a June 24-25 Tennis Tournament and the use of school gyms by the City of Spearman for the three-on-three Basketball Tournament July 8-9 were both approved by the Board.

Other items approved by the Board include contracts with Region Service Center XVI for the 1995-1996 school year, the gas/diesel bid from Equity, the minutes from the previous meeting, paying the bills of \$95,848.23, and the budget amendment for Chapter I.

The Trustees also listened to Mr. Murrey present information about the Texas Academic Skills Program (TASP). Prior to enrolling in Concurrent English at Frank Phillips College, the students must pass the TASP unless exempt due to SAT, ACT, or TAAS scores.

Other information items included: Frost National Bank's

transferral of its bond administration business to the Bank of New York, TexPool rating by Standard & Poor's of "AAAm", Senate Bill 826 allowing for alternative capital improvement finance options, and Spearman I.S.D.'s administrative cost ratio of 0.1251 is below TEA's established standard of 0.1561.

Mr. Murrey also presented information on TAAS results and how these were a part of the AEIS Accountability standards. Also, the TASB/TASA Convention arrangements were discussed. An overview of the New Texas Education Code was provided to Board members. Mr. Murrey presented several of the Key Provisions.

In this Open Meeting, the Board accepted the resignation of Cindy Clyburn. They also employed Kara Harrell and Sandy Haney as teachers. The final action of this meeting was to move the July Board Meeting to July 17th. After this, the meeting was adjourned.

Alvarado receives esteemed recognition for her vocal abilities

Carol Alvarado, a Spearman High student, has once again received recognition for her multi-talented singing abilities. Her latest award is nothing new to her, as she has won it before.

Alvarado has been selected as an Outstanding Performer from the 1995 Texas State Solo-Ensemble Voice Contest (TSSEC), which took place at the end of May. Of the approximately 73,000 students participating in the regional UIL music contest and the 24,000 musicians who performed at TSSEC,

only 158 students earned the distinguished honor of being recognized as an Outstanding Performer.

For her impressive performance, Alvarado has received a medal that is identical to those awarded to state champions in all UIL events.

The contest was judged by music educators, university professors, and professional musicians from throughout the United States. The format of the contest provided both a performance evaluation and specialized musical instruction for each student musician.

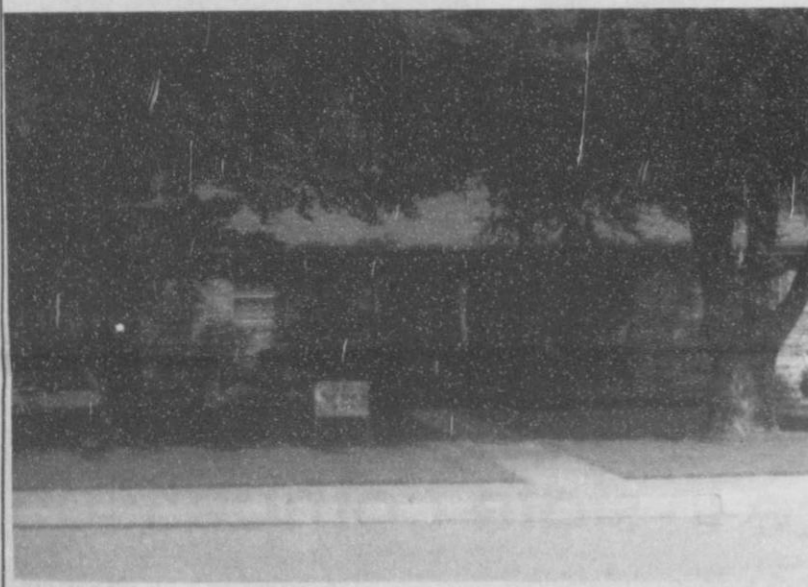

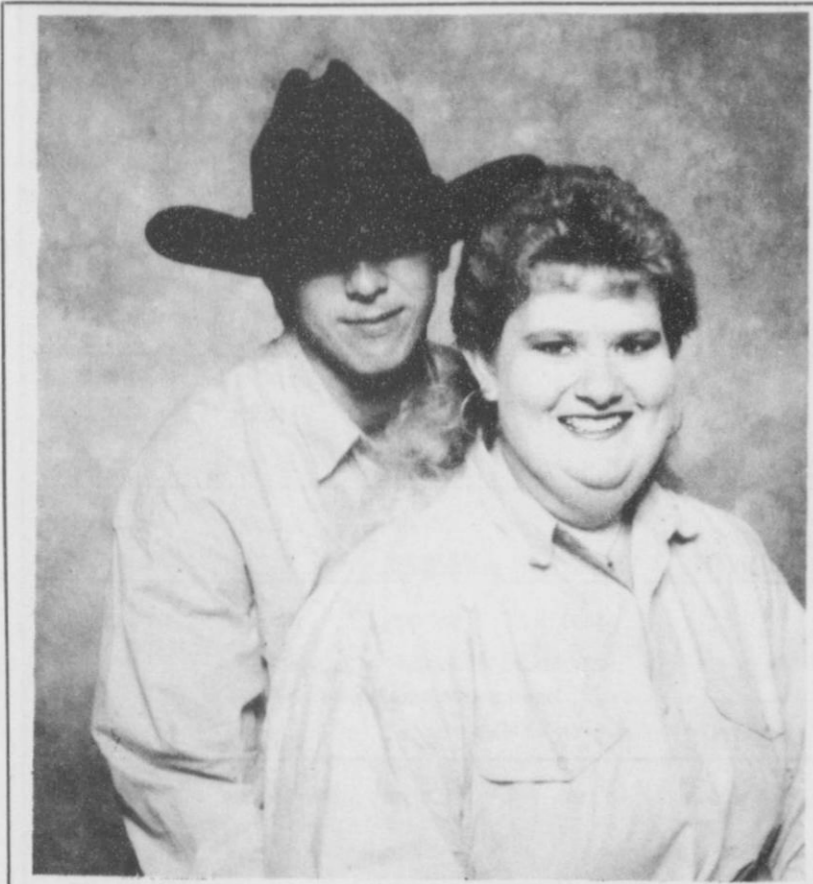

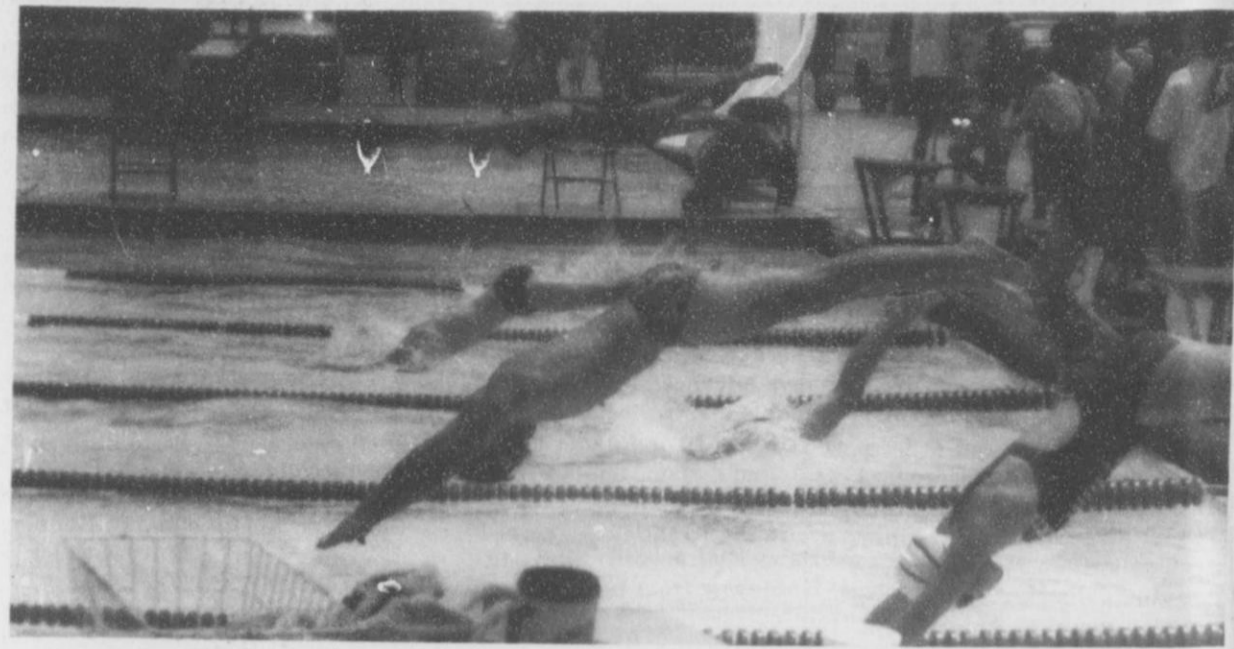

In the 13 and under class, Janae Watley and Krystle Deeds competed for West Texas Thunder.

And in the 11 under class, congratulations to number 32 Kallie and to number 30 Sammie. Their team, Bank Shots, won the championship Sunday, June 4, in big fashion 48-23 over Speed, and they have advanced to Nationals in Kenner, Louisiana in July. Mary Jo Cluck is also a coach of this fine team.

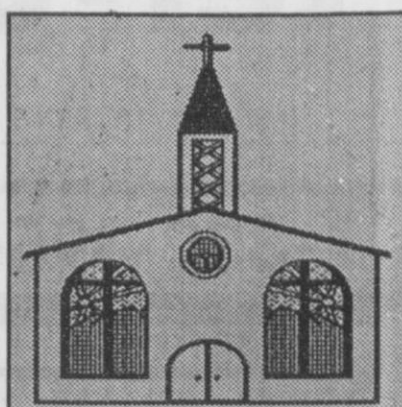

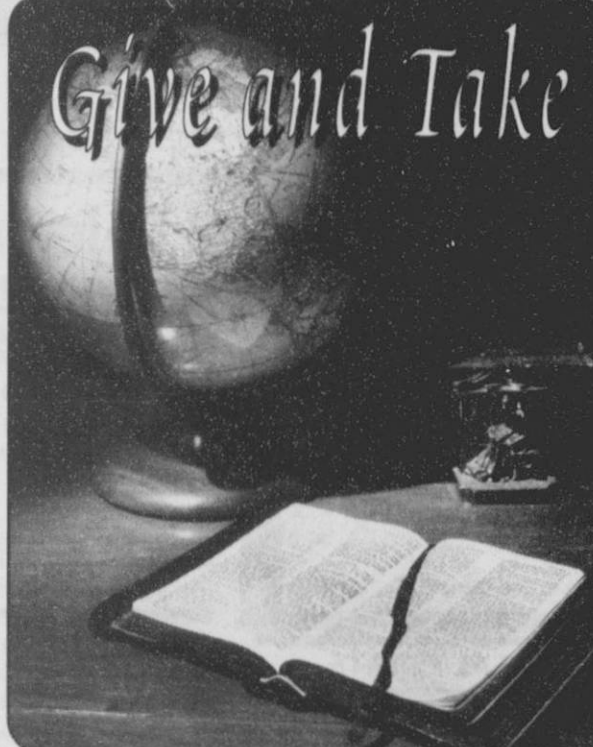
