

Words from Faith & Grace

What is the place of Old Testament scripture? Who are true prophets? Our lessons this week are found in Micah 3:5-12, Psalm 43, I Thessalonians 2:9-20, and Matthew 23:1-12. Micah, inspired by the Lord, takes to task the "prophets" who were leading Israel to sin. These so-called prophets accepted money, praise, and played favorites to please their audiences. Micah tells Israel that Zion shall be as a plowed field, Jerusalem will be a heap of ruins. The true prophet speaks the Lord's word only

The Psalmist sings a song for vindication and defense against ungody people, the deceitful and unjust. He sings for the light of God and His

Paul reminds the Thessalonians that they were witnesses of Paul's upright conduct and his treatment of believers. Paul commends them for being imitators of the Churches of God in Christ Jesus that are in Judea and for suffering the same sorts of persecution. Paul informs them that they are Paul's hope, joy and crown at the Coming of the Lord. The greatest honor that we can have, dear Christian, is to spark the faith of a new Christian and to help sustain that faith.

Jesus addresses both the crowds and His disciples for the second time [the first was the Sermon on the Mount]. Jesus tells them all that the Pharisees are the guardians of the scrolls of the Torah. He wants his followers to believe what the Pharisees read from the Torah. What Jesus condemns is that the Pharisees read the law, but do not live it with a pure heart. Jesus notes that the phylacteries and fringed garments that the devout Jew was to wear were to remind the wearer of his obligation to God and His Law. The Pharisees wore extra-large phylacteries and fringe, to imply that they were more obligated to God; yet, Jesus shows that the Pharisees were hypocrites, they did all their deeds to be seen by others. They loved and coveted the places of honor in public and in the synagogue. They relished being called Rabbi, Teacher, or by other accolades. Jesus tells all to obey the scriptures as read by the Pharisees but not to act like the Pharisees. To be great as a Christian is to be the servant of all. It is not wrong in itself to call a church leader "Father", "Reverend" "Bishop", "Brother", "Sister", "Pastor" for those titles imply the function of service of that individual. What is wrong is for the bearer of the title to accept the title and not the service due from that title. Jesus said, "All who exalt themselves will be humbled, and all who humble themselves

May the Holy Spirit increase in you a spirit of humility and penitence that your service may be pleasing unto God.

Kelli Cummings, 1997 graduate and daughter of Wayne and Carolyn Cummings, lives in Maryville, Tennessee. She works for the Blount County Children's Home and is a Family Advocate for Operation Success to Prevent Child

According to Kelli, the Blount County facility at one time was an orphanage for children. Several years ago they discontinued this function and now work in the community. The facility had multiple rooms, bathrooms and kitchens. There are large family areas with fireplaces, large kitchens and several smaller rooms.

The agency workers took inven-"Sunray is a great team," Gruver tory of the furniture and other items left from the orphanage, doing some re-arranging and cleaning of the facility in preparation for the arrival of evacuees. They prepared for 14 people or families. (As of the time of the interview there was a delay in the arrival due to airport boarding but families were due in the following day).

On their arrival the Center staff was able to draw on local services to provide for counseling, doctors as dead. and prescription medications, setting them up on TennCare (state assisted insurance), contacting schools for placement and sending out feelers for any other services that they need.

One of the local radio stations, WIVK, had a major recruitment for water, food and clothing. Local churches gathered food, clothing and just a mixture of everything that might be needed. Since Blount Children's Home made their initial

are the ones providing assistance to those housed there. Company vehicles and personnel was made available to take the evacuees around as

Kelli told us that one interesting aspect of this crisis is the number of people residing in East Tennessee that have relatives in the southern coastal areas. It is a large outreach of families. Many of those fled the area as the early warnings were given, and because they are not on the Red Cross records compiled after the storm hit in those specific areas, they were having problems getting assistance, even though they are evacuees, also.

There are over 10,000 evacuees expected in Tennessee with 700 in Knoxville. The majority of those were housed in UT's Neyland Stadium or the Knoxville Civic Coliseum.

After this initial interview Kelli called back and reported that the people had arrived. The evacuees were advised to list their information on a web-site, both for themselves and for those that they were looking for. They were also informed that if, after an extended length of time there was no response, they could be presumed

Another Spearman graduate affected by Katrina is Clint Townsen, son of Don and Barbara Townsen. Clint is an Ensign in the Coast Guard stationed at St. Louis.

He was part of a 14-man, 6-boat crew deployed to New Orleans. The crew was divided into search and rescue, followed by armed

crew members watching over them. Since the flood waters were not overall, there would be areas that they would have to carry the boats over islands of land and continue onward to a rescue. Then, on the return trip, they had to carry the boats, and sometimes victims, to the next water and then continue until they reached safety.






