Master Marketer Program Returns January 2002

The Texas Cooperative Extension's popular Master Marketer education program will be returning to the Texas panhandle in January, according to Dr. Steve Amosson, Extension farm management economist.

"We're looking for a few good marketers who wish to update their own skills, and individuals who will help their neighbors do the same," he said.

Now, nationally recognized, the Texas marketing training is an in-depth, intensive risk management education program. Instructors teach participants how to develop marketing plans, evaluate marketing alternatives, manage production and price risk in addition to the skills and discipline necessary to execute the plan.

The 64 hour curriculum is offered as four, two-day sessions held every two weeks. It is the most intensive marketing and risk management training provided by Extension anywhere in the United States, say Texas Extension economists.

The instructors are top professionals from industry and universities around the country. A wide range of topics are covered to enhance marketing and risk management skills.

"We use case study examples and simulation exercises are used wherever possible," said Amosson. Students are able to gain experience using real tools that they will put into action on their own farm and ranch operations.

The Amarillo session will focus on the principle commodities of the area; wheat, feed grains and cattle. Results of a two year post surveys of the first five classes of participants suggests that using what they have learned has increased their gross revenues approximately 3-1 percent (or over \$30,000) on average, annually.

Statewide demand for the program continues to grow. The winter program slated for Amarillo will be held at the Texas Agricultural Research and Extension Center. The first two-day session will begin on January 16-17, 2002 with the following sessions on January 30-31, February 13-14 and February 27-28.

The registration fee is \$250. Participants must maintain a commitment to work with their county agent to try to start or revitalize an existing marketing club.

Program costs primarily are met by grants from sponsors including the Texas Corn Producers Board, Texas Wheat Producers Association, Texas Farm Bureau, the Houston Livestock Show and Rodeo and the Cotton State Support Committee. 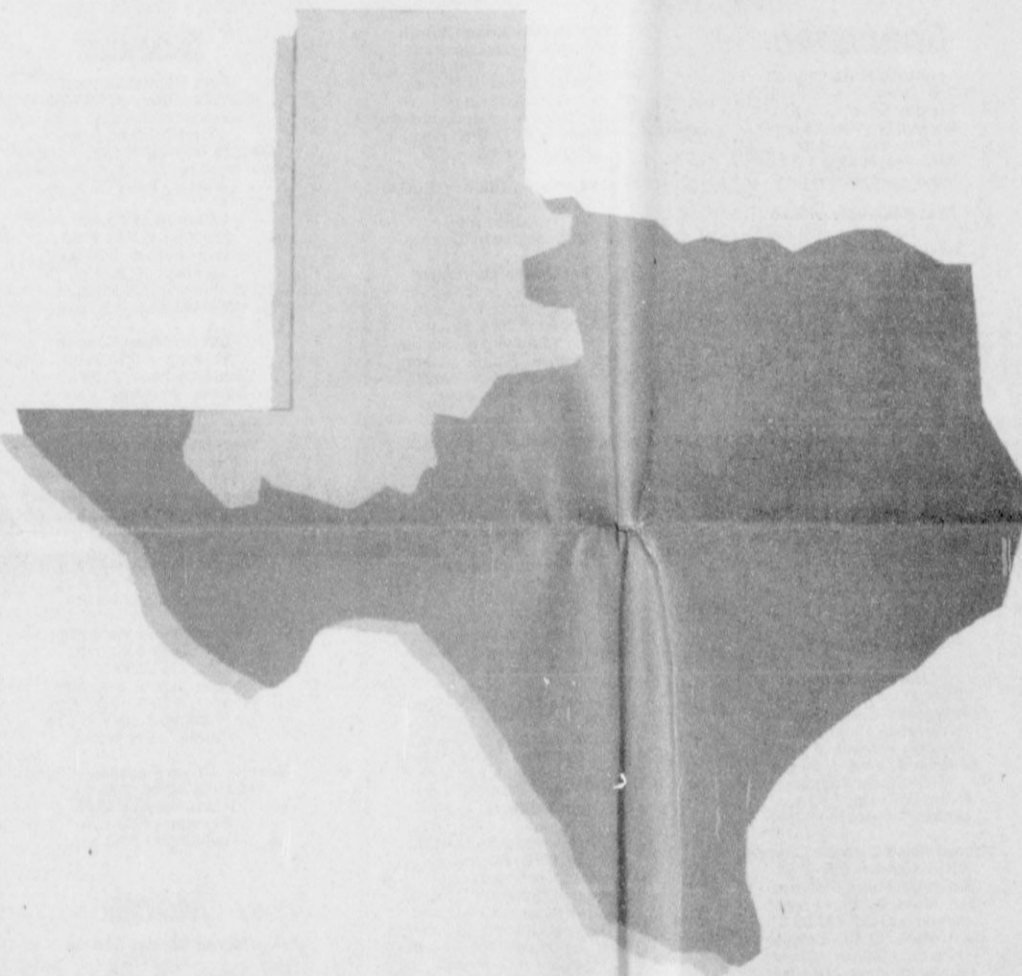
Electric Deregulation Postponed In Texas Panhandle Until 2007

Area Exempted from Competition/Deregulation

Although many companies and marketers are beginning to offer the chance to change electric providers, that choice is not available to residents and businesses in the Texas Panhandle/South Plains region.

As 2002 approaches, you will most likely see several marketing letters and perhaps receive some phone calls from large energy marketing companies asking you to switch to their company. Chances are they do not know where towns like Gruver, Follett, or Briscoe are, or they simply did not take the time to pull all the Panhandle and South Plains addresses from their behemoth databases because a choice for electricity provider will not be available in the region until at least 2007.

Many Texans will have a choice of electric provider beginning in January of 2002, and many companies are trying a shotgun approach to get new business.

Marketing solicitations are even reaching most Panhandle residents and businesses despite the fact that Texas Lawmakers have put deregulation or restructuring of the electric industry in the region on hold until at least 2007. House Bill 1692 was introduced by Warren Chisum of Pampa and was passed into law in 2001 because he and the legislature saw the unique circumstances that the region possesses and also saw that neighboring states of New Mexico and Oklahoma had enacted policy that either delays or slows down their deregulation plans.

Under this bill, deregulation in the region will be postponed until 2007, at the earliest.

Geographically, the area exempted from deregulation by the bill runs west of a line from Childress to Roby and north of Interstate 20 (see map). The postponed area affects members of several electric cooperatives, as well as Xcel Energy customers (formerly Southwestern Public Service Company).

Unlike most of the state, the Panhandle/South Plains is like an island in terms of electricity. It has its own self-contained system of power lines and generation plants and very few interconnections or bridges, so to speak, to other areas. The power consumed here has to be generated here and vice versa. That system, efficient as it is for consumers now, has no surplus power to sell, nor enough transmission line (the large high voltage line used to move power long distances) to accommodate competition. Lawmakers saw that Panhandle residents already enjoyed some of the lowest electricity bills in the country and thought if deregulation was to proceed with the rest of the state, prices could increase. And more importantly, if the power supply was put on the open market, shortages could result.

Until 2007 and when more power plants and lines are built, those hundreds of inevitable marketing letters and phone calls mean nothing to residents and businesses in the Panhandle/South Plains region.

Comptroller Rylander Announces Counties Qualifying For 2002 Tax Credits

Texas Comptroller Carole Keeton Rylander today released a list of 224 counties where businesses can apply for hundreds of millions of dollars in state tax breaks next year.

"Each year I review the economic health of each county and I am pleased to announce this important, new list of counties eligible for these tax breaks," Comptroller Rylander said.

The franchise tax credits for economic development were enacted in 1999 by the 76th Legislature and include a research credit, a job creation credit and an investment credit.

"All three tax credits are real and businesses large and small will benefit," Comptroller Rylander said. "The total dollar amount of the tax breaks will depend on how many businesses take advantage of this tremendous tax credit program."

Research Credit

The research credit is available to firms that perform qualified research activities in Texas. It is based on the firm's increase in research activities during the year compared to a base amount.

Five percent of qualified research expenses will be credited for tax reports due in 2002 and after. The amount of the company's credit may be as large as 50 percent of its franchise tax liability.

Unused credits may be carried over for a maximum of 20 years.

Additional credit is available for qualified research activities conducted in selected counties.

Job Creation Credit

Companies that create jobs in selected counties may qualify for a job creation credit equal to five percent of the wages paid to workers holding those jobs. The credit is five percent a year for five years beginning with the year the jobs are created.

To qualify, a corporation must create at least 10 new full-time jobs, pay at least 110 percent of the county's average weekly wage, pay health benefits and be engaged in manufacturing, warehousing, wholesale distribution, computer services or research.

The credit is limited to 50 percent of the firm's tax liability in the year that credits are claimed. Unclaimed credits may be carried forward for a maximum of five years.

Investment Credit

Corporations that invest at least \$500,000 in machinery and equipment can qualify for a franchise tax credit equal to 7.5 percent of that investment. The investment must be located in selected counties and in the industries listed for the job creation credit.

This credit, too, is limited to 50 percent of the firm's tax liability,

and any unclaimed credits may be carried forward for a maximum of five years.

Strategic Investment Area

The Strategic Investment Area (SIA) is a collection of counties and sub-county areas where job creation, investment and research activities by businesses can earn franchise tax credits. The SIA is determined each September by the Comptroller's Office, and the determination is effective for business activity in the following calendar year.

Comptroller Rylander determined that of the state's 254 total counties, 224 fall wholly or partially in the state SIA for calendar year 2002.

Of those counties, 102 qualify for full-purpose SIA designation based on their relative unemployment rate and per-capita income.

This designation will permit firms engaged in manufacturing, warehousing, wholesale distribution, computer services or research to apply for job creation and investment credits, as well as the research credit bonus.

Hansford County is one of 117 counties to qualify only for the limited-purpose SIA designation based on their population. Corporations engaged in agricultural processing in these counties can apply for the job creation and investment credits.

Hansford County Farm Service Agency Happenings

New Rural Addresses
Producers who have recently had their mailing address changed due to the new 911 addresses need to make sure that you notify the FSA office of your new address. We are starting to have mail returned because of incorrect addresses. This includes some checks and payment notifications.

PFC Information
Farmers in the PFC program recently received a multiple page letter from the FSA office. Please remove it from your burn pile and take a moment to review the information. If your 2002 payment shares are listed as 0.0000, your contract needs to be updated before payment is issued. The letter will also answer questions you have concerning rented land, payments and changes in farming operations. And remember, only those individuals who share in the risk of the crop grown on contract acres may share in PFC payments!

Farm Update Reminder
Have you sold a portion of your farm or have you made changes to your farming operation? In some cases this may require a farm reconstitution. It is important to update your farm records before you request your PFC payment.

Contact the FSA office with any changes so we can update our records and prevent any delays in payments. Any changes in your farming operation also requires an update to your payment limitation information. Also, any changes in entities must be reported to this office. The status date for new entities is April 1, 2002.

2002 Acreage Reporting Requirements
We would like to remind you of the following acreage reporting requirements for the 2002 crop year:

- Wheat Pasture - 15 days prior to turning in cattle
- Native Grass - May 15, 2002
- Forage Crops - 15 days prior to the onset of harvest
- Small Grains for Harvest - May 15, 2002
- Summer Crops for Harvest - July 15, 2002

All crops not considered timely filed, will be assessed a late file acreage reporting fee of \$35 for the first field and \$15 for each additional field thereafter.

Crop Damage
Report crop damage within 15 days of the date the disaster condition occurred or damage to the crop became apparent.

Foreign Investors
Foreign Investors are required to report any land purchases, within 90 days of the transactions, to this office. Failure to do so could result in a penalty of up to 25% of the fair market value of the land.

CRP Sign-up
The FSA office has received word that we will have a CRP sign-up in 2002. We are not sure of the dates at this time, but they will be announced when they become available.

County Committee Elections
Due to an error by the County FSA Office, the election that was held for LAA-1 was in error. The election should have been held in LAA-2. Therefore the Hansford County Office is currently accepting nominations for candidates for LAA-2. Below is a calendar of deadlines for the election process.

January 9 - Final date to receive nominations
February 1 - Ballots will be mailed to eligible voters
February 14 - Final date to return ballots to the county FSA office
February 21 - Ballots will be counted.
