## SENTENCED TO TWO YEARS IN THE PENITENTIARY.

Such Was the Verdict of the Jury in the Third Trial of the

## BRISCOE COUNTY MURDER CASE.

The Town Full of Lawyers, Witnesses and Visitors, Attending the Regular April Term of District Court—Several Cases On the Civil Docket Disposed of.

On Monday Hon. H. H. Wallace, judge of the district court, arrived in town and immediately that court went into session. The following grand jurors were empanneled:

A. J. Lipscomb, foreman; W. D. Keliehor, W. B. Phillips, Geo. L. Muse, C. R. Moreman, J. R. Armstrong, D. R. Gass, J. M. McGlothlin, T. M. Palmer, R. J. Kibbe, S. S. Evants and A. Ragsdale. Noah Taylor and Jas. Carter were appointed bailiffs.

After giving instructions to the grand jury as to their duties the judge retired them and the tiresome task of obtaining a jury to try the Thornton murder case, brought here from Briscoe county, was begun. The jury as finally chosen composed of the following named gentlemen:

W. T. Ross, W. R. Evants, C. L. Bounds, T. R. Reagan, W. S. Higgins, C. T. Splawn, J. E. Ferguson, T. A. Fox, J. W. Bradly, W. H. Clary, R. R. Harris and C. E. Wheeler.

Jack Harwell was appointed to act in Sheriff J. T. Inmon's place on account of the latter's illness.

The counsels for the State were District Attorney Ira Webster of Claude, G. F. Thomas of Bowie, D. B. Hill of Clarendon and Browning & Madden of Amarillo. Messrs. Kinder & Wilson of Canyon, Plemons & Veale of Amarillo, J. N. Stalbird and W. F. Kelly of Silverton defended the prisoner.

This case was tried twice before

once at Claude and once at Tulia

and resulted in a hung jury in
both instances.

The arguments before the jury by the different counsels followed and at 5:45 o'clock on Thursday the

judge made an impartial charge to the jury and the jury retired.

At 2:45 p. m. Friday the jury filed out into the court room and Foreman Ferguson announced that they had agreed upon a verdict, which was that the defendant was guilty of manslaughter and fixed the penalty at two years in the penitentiary. For reasons stated elsewhere we refrain from commenting further on the case or the verdict.

There was one other case on the criminal docket, that of the State vs. W S. Dean. The case was dismissed on motion of the State for reasons filed.

In the civil docket the following cases were disposed of;

The case of the State of Texas vs. W. P. Wright, et al., was discontinued.

In the case of the Western Union Land Company vs. Mike R. and B. G. Duncan, judgment was rendered by default.

The case of C. V. Walker vs. Deaf Smith County was continued.

The case of C. T. Splawn vs. W. M. Zumwalt was compromised by the defendant paying \$250 for the land in litigation.

Judgment was rendered for the plaintiff in the case of R. H. Gough vs. J. L. Moreman, et. al.

Wallace, came in the office and requested us not to publish the proceedings, as it would work an injury to the cause of justice by disqualifying most of the eligible jurors in Randall county from serving on the jury in the case of the State vs. T. J. Thornton (the latter being the father of the defendant in the case tried here) to be held at Canyon, April 25, 1901. this latter case being a companion to the case tried here.

But to the citizens of Hereford, and especially the rising generation, it means that a most beautiful and noble life has passed away, and a life that could be illy spared from those whom she loved and who loved her in return.

Emma Bell Owens was born in Kemper county, Mississippi, June 7, 1877, and was united in marriage with Prof. J. R. Overstreet at Plainview on the 3d day of September, 1899. With her husband she came to Hereford November 1, 1899, and assisted Mr. Ovetstreet in the opening and conducting of the Hereford High School on November 13, 1899.

Her life was devoted to the instruction of the young, both as to their spiritual and intellectual welfare. She taught them on individual lines-talked with them privately and conferred with their parents on those lines and even as death drew near pleaded with her husband to carry on the work she had to leave undone. Her only wish before death o'ertook her was that stie could be permitted to have her children about her for a couple of hours that she might give them one last talk, and it seems a pity that that could not have been the case as it would have done more

good than years of instruction and would have left an impression on their young minds that would be carried to the grave.

Mrs. Overstreet confessed Christ at the age of 16 and has lived the life of a pure, devoted and consistent christain, ever ready to sympathize in time of sorrow, to extend a helping hand in time of need, and was always ready to share in the pleasures or troubles of those who were honored with her acquaintance.

Those who were with her to the last said that death came to her as a sleeping babe. She was cheerful and was as sweet in death as in life. After giving her husband final instructions as to the care of her pupils she looked at the clock and said at three o'clock she would pass away. Just as the clock struck that hour she gave her husband's hand a last loving pressure, smiled and was with her Father in Heaven: May her life and death be ever a shining example to those who knew her and loved her.

The funeral was held at the church Thursday afternoon at 3 o'clock, which was filled to over-flowing by the loved ones she left behind, most of whom went to the grave, there to pay their last respects. It was Mrs. Overstreet's wish that her pupils march behind her remains to the grave, and this wish was carried out.

Mr. Overstreet has the condolence and sympathy of the entire community, and who share with him his great bereavement.

#### ST. ANTHONY SANITORIUM.

An Institution Which Benefits the Entire Plains Country.

Situated about a half-mile to the northward at the head of Polk street, the main thoroughfare of Amarillo, stands an imposing brick structure prettily trimmed with Potter county stone. On first impressions the stranger fails to comprehend why such a magnificent building should be so isolated from the business part of the town, but, on inquiry, readily understands the cause of its isolation, for he is told that it is a hospital, or more properly, the St. Anthony Sanitorium.

It was through the courtesy of Dr. J. W. Pierson of Amarillo, one of the best known and foremost physicians of the Panhandle, that the writer was privileged to inspect the sanitorium.

Upon gaining admittance to the reception rooms, which are fitted up like the parlors of a fine residence, we were met by Mrs. David R. Fly, the charming and estimable wife of the house surgeon, who escorted us throughout the entire building.

First a visit to the kitchen, situated on the ground floor was paid. This department is fitted up with all the latest devices known to the culinary art, and was spotlessly clean. Next we were ushered into the dining room, a place which would make even a well-fed man long to sit at 'he tastily arranged table and enjoy a meal from its dainty china and glistening glassware. A well appointed pharmacy is also on the ground floor.

The resident surgeon's quarters were next viewed and a more exquisitely furnished apartment would be hard to find. The chaplain's room across the hall is also tastily furnished.

Next we ascended the broad staircase to the second floor on which are the patients' apartments, all cosily furnished with a view of making life as pleasant as possible for the sick.

Our attention was first directed to the operating room, which is fitted up with all the latest surgical appliances, and to the sterilizing room, which is patterned after the most up-to-date styles.

The chapel was next to be visited and a model place of worship it is.

There are sixteen private rooms for patients, two of which are specially fitted up, one called the Victoria room, being furnished by Englishmen in memory of their departed queen, and containing a large portrait of her likeness, and the other called the Blue room, which is for use of the more wealthy patients. On this floor are also situated the bathrooms, water being forced through the entire building by means of a windmill and tank.


