## Relief Load Is Reduced 100 Families

### BUDGET ALLOWANCES ARE LOWERED FOR SUMMER MONTHS

Almost 100 families have been relieved from the county relief rolls during the past month. The load is now approximately 250 families as compared with 316 a month ago.

Several factors are responsible for this trend, says Administrator Walter Pickett. The spring rains caused 50 rural families to leave the rolls voluntarily to take up normal farming activities. The rural rehabilitation program is removing a number of farm families and putting them on a credit basis.

A third factor is the re-check of all cases which is now being made. New investigations of all families are being made and those who have not been extended aid in 30 days are being removed.

June allotment of funds has not been delivered, but the family budgets have been reduced 45 per cent with the advent of summer by the state relief office, Pickett said.

The community garden, Highway 33, county roads, city streets, work on the high school building and athletic field, the sewing room and library work are the projects now using relief workers.

## Dust But No Rain Here During Week

It has been trying to rain here for several days, but the best effort has produced only a few drops. And there was a sandstorm last night—and a brief one Monday night.

Wheat allotment checks continue to dribble in to the office of the county agent. This week's receipts total \$7,333.56 thus far. These checks—25 of them—cover last 1933 and first 1934 payments. No last 1934 payments have been received. They are not due until all matters of compliance are straightened out. Compliance papers for 1933 and the last part of 1934 will be started Friday.

### MEMBER OF BYRD PARTY WILL APPEAR AT SCHOOL

Interest is growing daily in the lecture to be given Friday evening in the high school auditorium by Joe Hill, Jr., Antarctic explorer, under the auspices of the Junior Band Mothers. The program will start at 8:15, with admission prices of 40 cents and 20 cents.

Young Hill, son of President J. A. Hill of WTSTC, Canyon, was the youngest member of the Byrd expedition and one of the most popular. Dr. and Mrs. Hill, shortly after the expedition reached civilization, received this letter from E. J. Demas, one of the officials of the expedition:

"I have had the pleasure of associating with your son for the last 15 months. I have had an opportunity to observe him very closely. I have seen him pass through his boyhood to manhood. He is coming back to you a man. He has conducted himself admirably well through everything he came up against. He has the respect and admiration of the camp. He has proven a willing and hard worker. He has shown a great deal of initiative and ingenuity in all that he did. He has reflected all the careful and excellent bringing up. He has conducted himself as a perfect gentleman. You are justified in being proud of him."

Nearly two years ago the Canyon youth wrote from aboard ship en route to Wellington, New Zealand:

"All of the things I ever wished for are here at my finger tips. To think that every day I get to talk to and see the man whom all the world watches and many at most worship (Admiral Byrd) I like the rock and roll of this old tub in heavy seas."

His experience with cars and tractors in this wheat country served him well on the ice, where tractors were used successfully for the first time in low temperatures. Starting the machines in weather as much as 40 degrees below zero was a task which young Hill will explain in his talk.

From Little America, Joe wrote on January 17, 1933:

"You cannot imagine the beauty of these surroundings. There are shades of blue, brown, black, red, and all in every tint known, the gigantic loneliness, inspired by the stillness makes one feel as though someone unknown is guiding his footsteps. Beauty, loneliness, and quiet are the things which make a man return time after time to suffer the hardships of nature's merciless hand. There is wind so strong it presses the breath out, temperatures so low the breath freezes and crackles, and barometer pressures as low as 27.85."

With the speaker here will be Nika, malamute dog used on the ice and given to him by Admiral Byrd. In one letter the explorer wrote to his parents: "The ship is covered from stem to stern with dogs, and they are beautiful, but mean as the Devil!" He was for a time in charge of dogs on The Bear. Part of the time he was Byrd's personal orderly.

## Name Humble On Regional Parks Board

### WARWICK AND JOHNSON CHOSEN TO DIRECT HEREFORD PARK

An advisory board to administer the affairs of Hereford, Palo Duro and Palisades State Parks was appointed last week by Governor Jimmy Allred after his veto of the bill to create a separate board for Palo Duro.

Clyde Warwick of Canyon is chairman of the new group, and County Judge C. W. Humble of Hereford and T. E. Johnson, editor of the Amarillo News, are the other members. They will represent the State Park Board in directing affairs of the three parks in the Panhandle.

It will be the duty of the new board to handle concessions, projects, buildings and general supervision of the parks. Already Humble has started checking all records to see what projects for the Hereford Park have been approved.

A concrete swimming pool will be the major project for this park, Humble declared. Later he hopes to make a fisherman's paradise of the park by exterminating turtles and building raising ponds so as to provide a permanent stock of mature fish for the Tierra Blanca.

Camping and picnicking in the park are to be designated soon, according to Howard Trigg, superintendent. Mr. Trigg asks that persons fishing not molest the young trees in the park. Several have been pulled up or whittled down for use as fishing poles. Either this must be stopped or fishing will be forbidden.

## Racing Champion Is Visitor Here

Kelly Petillo, young Los Angeles race driver who became champion of all the world on Memorial Day by winning the 500-mile sweepstakes at Indianapolis, visited in Hereford this morning. He stopped at Rufus Sewell's station to fill up.

"There's lots of money in the world since last Thursday," he told Sewell. "Before last Thursday I had to rake, scrape and borrow and beg in order to get enough money to enter the race." He was driving a new car given by a manufacturer as a prize to the winner. He was headed for home where he will engage in further races.

## Check Up Use of Erosion Grants

### W. H. Ray Dies Last Thursday At Sanitarium

William H. (Bill) Ray, one of Hereford's pioneer merchants, died last Thursday noon at the hospital following an illness of several weeks. A resident of Hereford since 1905, Mr. Ray had engaged in the jewelry business and was a watch maker from the time he came.

Survivors include three children, Oliver, a professor of electrical engineering at Texas A. & M. College; Mrs. George K. Spangler of Palestine, and Mrs. Ceell Lawrence of Houston; three brothers, J. Ray of Amarillo, J. H. Ray of Washington, Arkansas, and K. A. Ray of Walnut, Mississippi; and a sister, Mrs. J. W. Schnell, Santa Monica, California.

Funeral services were held Friday afternoon at the Black Funeral chapel by Rev. T. C. Willett of the Methodist church. Fall bearers were E. D. Fox, C. C. Rockwell, George Beams, J. H. Pitman, Dew Mercer and Ralph Barnett. Burial was in West Park Cemetery.

Bill Ray came to Hereford in 1905 from Waco and immediately went into the jewelry and watch repair business, an occupation he followed until the time of his death. He was one of the city's best educated men and was a brilliant conversationalist on any sort of subject.

Always fond of sports, Ray made a hobby of fishing and was credited with having caught more big bass in the Tierra Blanca, year in and year out, than any other person. He invented and patented a number of ingenious mechanical devices to use in his fishing.

Mr. Ray was especially proud of the scholarly achievements of his son, Oliver, who was graduated from Hereford High school and Texas A. & M. with highest honors, then went to do research work for one of the big electrical companies in the east, and later became a professor of electrical engineering.

Friends and relatives from throughout the Panhandle attended the funeral.

## City to Observe 'Railroad Week'

Hereford will join in the observance of Railroad Week along with the remainder of Texas next week, June 10 to June 15. Mayor Charles J. Paddock has issued a proclamation making the observance official. Governor Allred has proclaimed the week official throughout the state.

J. E. Beyer, Santa Fe agent, is handling the program in Hereford. He will be in charge of the entertainment at the Lions Club next Wednesday and will present W. E. Dameron in a talk on the development of the railroad industry and what it means to the community.

Open house will be observed in yards, stations and shops and the public at major railroad points will be invited to become more familiar with the details of railway operation.

## Court Studies County Values For Taxation

### TO EQUALIZE PROPERTY ASSESSMENTS FOR ALL OWNERS

Every piece of real property in the county will be indexed and assessed when the Commissioners Court finishes with equalizations being made this week. The court went to work Monday morning with Assessor Jack Newell in checking all valuations of Deaf Smith county.

Their work will consist of inspecting and approving every assessment and checking to see that all property is included in the valuations. If changes in assessments are to be made, property owners will be notified.

If assessments as they are now made or rendered are to stand, no changes will be made. There will be days set during July and August when property owners may appear before the court to discuss valuations and aid in arriving at equitable assessments.

The court is having prepared large maps of the county with the name of the owner and assessed valuation on every piece of land.

## Last Crop Loan Day Is June 15

Saturday, June 15, will be the last day for farmers to make application for spring row-crop loans, announces Miss Peggy Mitchell, who is taking applications at the chamber of commerce office in the city hall.

Summer fallow loans on wheat lands are not yet opened. Crop liens are taken as security on these loans. Money can be used for buying seed or feed for work stock or fuel for putting in the crop.

## Wheat Check-Up To Begin Friday

Wheat compliance papers for the 1935 crop year will be started at the county agent's office Friday, announces Dewey Reed. Farmers are asked to call at the office and fill out the papers.

No days for signing in the various communities will be set, as all the work will be done at the county office here. It is hoped to complete the signing by June 15, and that date has been set as the tentative deadline.

Officials in the wheat section have said allotment payments for drought counties will be made first. Reed pointed out, "Therefore it is up to us to get our papers in. That is why we are urging all farmers to come in and sign the certificates of compliance and complete the contracts."

### COTTON CONTRACTS OF COUNTY ARE FINISHED

The county's cotton reduction program for this year is all set. Four old and 18 new contracts have been made out by the raters. In addition, there are 41 applicants for Bankhead exemption certificates.

The contracts have been completed and sent to the state offices.

A JOINT RESOLUTION proposing to amend Sections 3 and 5 of Article 7 of the Constitution of the State of Texas so as to permit the furnishing of State official text books free to every child of scholastic age, attending any school within the State. BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 3 of Article 7 of the Constitution of the State of Texas be amended so that hereafter it shall read as follows: "Section 3. One-fourth of the revenue derived from the State occupation taxes and poll tax of One (\$1.00) Dollar on every inhabitant of the State, between the ages of twenty-one and sixty years, shall be set apart annually for

the benefit of the public free schools; and in addition thereto, there shall be levied and collected an annual ad valorem State tax of such an amount not to exceed Thirty-five Cents on the One Hundred (\$100.00) Dollars valuation, as with the available school fund arising from all other sources will be sufficient to maintain and support the public schools of the State for a period of not less than six months in each year, and it shall be the duty of the State Board of Education to set aside, under such regulations and in such manner as may be provided by law, a sufficient amount out of the said tax to provide free text books for the use of children within the scholastic age attending any school in this State; provided, however, that should the

limit of taxation herein named be insufficient the deficit may be met by appropriation from the General Funds of the State and the Legislature may also provide for the formation of school districts by General Laws; and all such school districts may embrace parts of two or more counties, and the Legislature shall be authorized to pass laws for the assessment and collection of taxes in all said districts and for the management and control of the public school or schools of such districts, whether such districts are composed of territory wholly within a county or in parts of two or more counties, and the Legislature may authorize an additional ad valorem tax to be levied and collected within all school districts heretofore formed or hereafter formed, for the maintenance of public free schools, and for the erection and equipment of school buildings therein; provided that a majority of the qualified property taxing voters of the district voting at an election to be held for that purpose, shall vote such tax not to exceed in any one year One (\$1.00) Dollar on the One Hundred (\$100.00) Dollars valuation of the property subject to taxation in such district, but the limitation upon the amount of school district tax herein authorized shall not apply to incorporated cities or towns constituting separate and independent school districts, nor to independent or common school districts created by General or Special Law."

Sec. 2. That Section 5, Article 7, of the Constitution of the State of Texas, be amended so that hereafter it shall read as follows: "Section 5. The principal of all bonds and other funds, and the principal arising from the sale of the lands hereinbefore set apart to said school funds, shall be the permanent school fund, and all the interest derivable therefrom and the taxes herein authorized and levied shall be the available school fund, to which the Legislature

And no law shall ever be enacted appropriating any part of the permanent or available school fund to any other purpose whatever; nor shall the same, or any part thereof ever be appropriated to or used for the support of any sectarian school, provided that the State Board of Education may furnish State Adopted text books free to every child of scholastic age, attending any school within the State; and the available school fund herein provided shall be distributed to the several counties as may be provided by law and applied in such manner as may be provided by law."

Sec. 3. The foregoing Constitutional Amendment shall be submitted to the electors of this State qualified to vote on Constitutional Amendments at the election to be held on the Fourth Saturday in August, 1935, at which election there shall be printed on each ballot the following:

"For the Amendment to the Constitution of the State of Texas permitting the furnishing of free text books to every child of scholastic age attending any school within this state."

and

"Against the amendment to the Constitution of the State of Texas permitting the furnishing of free text books to every child of scholastic age attending any school within this State."

and every voter shall mark out with pen or pencil the clause which he desires to vote against, or the word "FOR" or the word "AGAINST" at the beginning of such clause, so as to indicate his vote for or against each of said proposed amendments.

Sec. 4. The Governor is hereby directed to issue the necessary proclamation for said election and shall have the same published as required by the Constitution and laws of this State, and said election shall be held under the Constitution and laws of this State.

Sec. 5. The sum of Ten Thousand (\$10,000.00) Dollars or so much thereof as shall be necessary, is hereby appropriated out of the State Treasury to pay the expenses of the publication and elections provided for in this Resolution.

**HOUSE JOINT RESOLUTION**  
 Proposing an Amendment to Article III, of the Constitution of the State of Texas, by adopting a new section to be known as Section 51-b, which shall read as follows:

"Section 51-b. The Legislature shall have the power by general laws to provide, under such limitations and restrictions and regulations as may be deemed by the Legislature expedient, for old-age assistance and for the payment of same not to exceed Fifteen Dollars (\$15) per month each actual bona fide citizens of Texas over the age of sixty-five (65) years, who are not habitual criminals, nor habitual drunkards, nor inmates in any State support institution; and providing that the requirements for length of time actual residence in Texas shall be less than five (5) years preceding the application for old-age assistance and continuous for one (1) year immediately preceding such application; and providing that the Legislature shall have the authority to accept from the Government of the United States financial aid for old-age assistance; providing for the necessary proclamation and making an appropriation to defray the expenses of proclamation, publication and election.

**BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:**  
 Section 1. That Article III of

the Constitution of the State of Texas, be amended by adding thereto, a Section to be known as Section 51-b, which shall read as follows:

"Section 51-b. The Legislature shall have the power by general laws to provide, under such limitations and restrictions and regulations as may be deemed by the Legislature expedient, for old-age assistance and for the payment of same not to exceed Fifteen Dollars (\$15) per month each actual bona fide citizens of Texas who are over the age of sixty-five (65) years; provided that no habitual-criminal, and no habitual drunkard while such habitual drunkard, and no inmate of any State supported institution, while such inmate, shall be eligible for such old-age assistance; provided further that the requirements for length of time of actual residence in Texas shall never be less than five (5) years during the nine (9) years immediately preceding the application for old-age assistance and continuously for one (1) year immediately preceding such application.

"The Legislature shall have the authority to accept from the Government of the United States such financial aid for old-age assistance as that Government may offer not inconsistent with the restrictions hereinbefore provided."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to the electors of the State of Texas on the fourth Saturday of August, 1935, at which election there shall be printed on such ballot the following clause:

"For the Amendment giving the Legislature the power to provide a System of Old-Age Assistance not to exceed Fifteen Dollars (\$15) per month per person and to accept from the Government of the United States financial aid for old-age assistance."

"Against the Amendment giving the Legislature the power to provide a System of Old-Age Assistance not to exceed Fifteen Dollars (\$15) per person per month and to accept from the Government of the United States financial aid for old-age assistance."

Sec. 3. The Governor of the State of Texas is hereby directed to issue the necessary proclamation for said election and have same printed as required by the Constitution and Laws of this State.

Sec. 4. The sum of Five Thousand Dollars (\$5,000.00), or so much thereof as may be necessary, is hereby appropriated out of the funds in the Treasury of the State, not otherwise appropriated, to pay the expenses of said publication and election.

**HOUSE JOINT RESOLUTION**  
 proposing an Amendment to Article IV of the Constitution of the State of Texas so as to authorize Courts having original criminal jurisdiction to suspend the imposition or execution of sentence and to place the defendant on probation and to reimpose such sentence, under such conditions as the Legislature may prescribe; providing for an election on the question of adoption or rejection of such Amendment and making an appropriation therefor, providing for the proclamation thereof; and prescribing the form of ballot.

**BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:**

Section 1. That Article IV of the Constitution of the State of Texas be amended by adding thereto, between Sections 11 and 12 a new Section to be known as Section 11A, to read as follows:

"Section 11A. The Courts of the State of Texas having original jurisdiction of criminal actions shall have the power, after conviction, to suspend the imposition or execution of sentence, under such conditions as the Legislature may prescribe."

Sec. 2. Such proposed Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at a special election to be held throughout the State of Texas, on the fourth Saturday in August, 1935, at which election all voters favoring said proposed Amendment, shall write, or have printed on their ballots the words:

"FOR the Amendment to the State Constitution authorizing the Courts to place defendants on probation."

and those voters opposed to said proposed Amendment shall write, or have printed on their ballots the words:

"AGAINST the Amendment to the State Constitution authorizing the Courts to place defendants on probation."

If it appears from the returns of said election that a majority of the votes cast are in favor of said Amendment, the same shall become a part of the State Constitution.

Sec. 3. The Governor shall issue the necessary proclamation for such election, and shall have the same published and such election held as provided by the Constitution and laws of this State.

Sec. 4. The sum of Four Thousand Dollars (\$4,000), or so much thereof as may be necessary, is hereby appropriated out of the

State Treasury to pay for the expenses of said publication and election.

### N R A PASSES

NRA is gone! Last week the Supreme Court invalidated the recovery act because of violations of the Constitution in regulations of intrastate commerce and in delegating Congressional power to the chief executive.

As an emergency measure NRA accomplished its ends, regardless of the Court's ruling. It put a minimum to disgraceful wages, abolished child labor and gave demoralized business at least a start toward fair competition.

NRA was a bold and hopeful attempt to face the future. A planned economy, both for the World and the United States, is becoming increasingly necessary. As a people Americans will ultimately find it untenable to be fettered by a Constitution that was made for a vastly different country and different people.

The Christian Science Monitor wonders if "untempered competition—survival of the fittest and extinction of the losers—is a suitable standard for a nation that has outgrown the pioneering stage and entered upon a more mature enjoyment of its resources."

"Will the United States eventually be pushed to try to redefine by constitutional amendment the national powers over commerce? Or will it find solutions for its problems within the lines laid down by the founders of the nation? Their judgment as embodied in the Constitution deserves the profoundest respect, but it does not relieve us of the present generation from the stark necessity of using amid today's conditions our own God-given powers of intelligence, observation and reason."

### UTILIZING RAINFALL

Enough water has flowed over a lot of Plains land in the last two weeks to go a long way toward making a wheat crop next year that would atone for this year's failure. Some energetic people had their land in shape to receive and retain this moisture. Some who just won't work land while it is dry, because it "takes the life out of it" lost a lot of moisture.

Now The Herald doesn't essay to be an advisor on farm practices, but it does pretend to be able to see what is going on and report it truthfully and accurately to its readers.

Sunday a soil augur was used on land that had just recently been chiseled every three feet to an average depth of about eight inches. A test between these chiseled trenches showed sub-soil wet as far as the hole was drilled, forty-two inches. Land that had a similar lay and had been treated similarly, in every respect except it had not been chiseled, had more moisture above the plow pan, but 13 inches below the surface the moisture was negligible. A nearby lake held the bulk of the water that had fallen on it.

Those small chisel furrows, roughly following the contour of the land, retained every drop of water that fell on the land that had been so fortunately worked.

Some of you boys who have been chiding the Herald about a story it carried of improved wheat yield on the North Plains through use of narrow shovels on listers to break the plow pan on wheat land might be interested in digging holes in this land to see about the stored moisture.

We get a lot of rain which is not utilized for crops. Simple farm engineering through contoured rows, terracing and other sensible means of water utilization and erosion prevention hasn't yet come into its full use on the Plains.—Plainview Herald.

**H. J. R. No. 48**  
**HOUSE JOINT RESOLUTION**

proposing an amendment to Section 1, of Article XVII, of the Constitution of Texas, providing that Constitutional Amendments may be submitted by the Legislature at Special Sessions under certain conditions; providing for an election on the question of the adoption of such amendment and providing for the proclamation and publication thereof; describing the form of ballot and making an appropriation therefor.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 1, of Article XVII, of the Constitution of the State of Texas, be amended so as to hereafter read as follows:

"Section 1. How the Constitution is to be Amended. The Legislature, at any biennial session, by a vote of two-thirds of all the members elected to each House, to be entered by yeas and nays on the Journals, may propose Amendments to the Constitution, to be voted upon by the qualified electors for members of the Legislature, which proposed Amendments shall be duly published once a week for four (4) weeks, commencing at least three (3) months before an election, the time of which shall be specified by the Legislature, in one weekly newspaper of each county, in which such a newspaper may be published; and it shall be the duty of the several returning officers of said election, to open a poll for, and make returns to the Secretary of State of the number of legal votes cast at said election for and against said Amendments; and if more than one be proposed, then the number of votes cast for and against each of them; and if it shall appear from said return, that a majority of the votes cast, have been cast in favor of any Amendment, the said Amendment so receiving a majority of the votes cast, shall become a part of this Constitution, and proclamation shall be made by the Governor or thereof; provided, however, that in cases of extraordinary emergency affecting the State as a whole, Amendments to the Constitution may be proposed in the manner hereinabove set out upon the submission of the proposed Amendment by the Governor at any Special Session."

Sec 2. The foregoing Amendment shall be submitted to the electors of this State who are qualified to vote on proposed Constitutional Amendments at an election to be held on the 24th day of August, A. D. 1935, at which election each ballot shall have printed thereon for those favoring the Amendment the words:

"FOR the Amendment to Section 1, Article XVII, of the Constitution of Texas, providing that Amendments to the Constitution may be proposed at Special Sessions of the Legislature under certain conditions." And those against the Amendment shall have printed the words:

"AGAINST the Amendment to Section 1, Article XVII, of the Constitution of Texas, providing that Amendments to the Constitution may be proposed at Special Sessions of the Legislature under certain conditions." Each voter shall strike out with pen or pencil the clause which does not indicate his desire regarding the above proposed Amendment.

Sec 3. The Governor is hereby directed to issue the necessary proclamation for said election, and to have the above proposed Amendment published in the manner and for the time required by the Constitution and laws of this state.

Sec 4. The sum of Five Thousand Dollars (\$5,000.00), or as much thereof as may be necessary is hereby appropriated out of any funds in the State Treasury not otherwise appropriated, to pay for the expenses of said publication and election.



**H. J. R. No. 39**  
**HOUSE JOINT RESOLUTION**

proposing an Amendment to Section 15, of Article 1, of the Constitution of Texas, and providing that the Legislature may authorize the temporary commitment of mentally ill persons, not charged with a criminal offense, for treatment and/or observation without the necessity of a trial by jury.

**BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:**

Section 1. That Section 15, of Article 1, of the Constitution of the State of Texas be so amended as to hereafter read as follows:

"Sec. 15. The right of trial by

jury shall remain inviolate. The Legislature shall pass such laws as may be needed to regulate the same, and to maintain its purity and efficiency. Provided, that the Legislature may provide for the temporary commitment, for observation and/or treatment, of mentally ill persons not charged with a criminal offense, for a period of time not to exceed ninety (90) days, by order of the County Court without the necessity of a trial by jury."

Sec. 2. The foregoing Constitutional Amendment shall be submitted to the qualified electors of the State, qualified to vote on the Constitutional Amendments, at an election to be held throughout the State on the 4th Saturday of August, A. D. 1935, at which election each ballot shall have printed thereon the words:

"For the Amendment of Article 1, Section 15, of the State Constitution by adding to said section a provision to the effect that the Legislature may provide for the temporary commitment of mentally ill persons not charged with a criminal offense by the County Court without the necessity of a jury trial."

"Against the Amendment of Article 1, Section 15, of the Constitution by adding to said section a provision to the effect that the Legislature may provide for the temporary commitment of mentally ill persons not charged with a criminal offense by the County Court without the necessity of a jury trial."

Each voter shall scratch out with pen or pencil the clause which he desires to vote against so as to indicate whether he is voting for or against the proposed Amendment.

Sec. 3. The Governor of this State is hereby directed to issue the necessary proclamation for said election, and have the same published as required by the Constitution and laws of the State of Texas.

Sec. 4. The sum of Five Thousand Dollars (\$5,000) or as much thereof as may be necessary, is hereby appropriated out of any funds in the Treasury of the State not otherwise appropriated to pay expenses of said publication and election.

**S. J. R. No. 6**

**A JOINT RESOLUTION** proposing an amendment to the Constitution of the State of Texas amending Article 16 by adding another section to be known as "Section 61," providing for the abolishing of the fee method of compensating all district officers of this State and county officers in counties of this State having a population of 20,000 or more, and providing that all such district and county officers shall be paid on a salary basis; and providing that the Legislature shall enact law putting this amendment into effect; providing for the submission of this amendment to the voters of this State; and providing that all precinct officers in all counties and county officers in counties under 20,000 population may be compensated on a fee basis or on a salary basis and authorizing the Commissioners' Court to determine whether certain county and precinct officers shall be paid on a fee basis or a salary basis; and providing for the necessary appropriation to defray necessary expenses for the submission of this Amendment.

**BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:**

Section 1. That the Constitution of the State of Texas, Article 16 be amended by adding thereto another section to be known as "Section 61," which shall read as follows:

"Sec. 61. All district officers in the State of Texas and all county officers in counties having a population of 20,000 or more, according to the then last preceding Federal Census, shall from the first day of January and thereafter, and subsequent to the first Regular or Special Session of the Legislature after the adoption of this Resolution, be compensated on a salary basis. In all counties in this State, the Commissioners' Court shall be authorized to determine whether precinct officers shall be compensated on a fee basis or on a salary basis; and in counties having a population of less than 20,000, according to the then last preceding Federal Census, the Commissioners' Court shall also have the authority to determine whether county officers shall be compensated on a fee basis or on a salary basis.

"All fees earned by district, county and precinct officers shall be paid into the county treasury where earned for the account of

the proper fund, provided that fees incurred by the State, county and any municipality, or in case where a pauper's oath is filed, shall be paid into the county treasury when collected and provided that where any officer is compensated wholly on a fee basis such fees may be retained by such officer or paid into the treasury of the county as the Commissioners' Court may direct. All Notaries Public, county surveyors and public weighers shall continue to be compensated on a fee basis."

Sec. 2. The Legislature of the State of Texas is hereby directed, at the first Regular or Special Session after the adoption of this Resolution, to enact such legislation as will be necessary to adequately compensate, on a salary basis, the officers herein referred to in all counties having a population of 20,000 or more according to the then last preceding Federal Census.

Sec. 3. The foregoing Constitutional Amendment shall be submitted to the qualified voters of the State of Texas at a special election to be held on the 24th day of August, 1935, at which election all voters favoring such proposed amendment shall write or have printed on their ballots the words:

"FOR amendment to the Constitution of the State of Texas abolishing the fee system of compensating all district officers, and

all county officers in counties having a population of 20,000 or more) and authorizing the Commissioners' Court to determine whether county officers and precinct officers in counties containing less than 20,000 population may be compensated on a fee basis or on a salary basis."

"AGAINST amendment to the Constitution of the State of Texas abolishing the fee system of compensating all district officers, and all county officers in counties having a population of 20,000 or more) and authorizing the Commissioners' Court to determine whether county officers and precinct officers in counties contain-

ing less than 20,000 population may be compensated on a fee basis or on a salary basis."

Sec. 4. The Governor of the State is hereby directed to issue the necessary proclamation for said election and have the same published as required by the Constitution and existing laws of the State.

Sec. 5. The sum of Five Thousand Dollars (\$5,000.00) or so much thereof as may be necessary is hereby appropriated out of any funds in the Treasury of the State not otherwise appropriated to pay the expenses of said publication and election.



**A JOINT RESOLUTION**  
proposing an Amendment to Article XVI of the Constitution of Texas by striking out Section 20a to Section 20e, both inclusive; prohibiting the open saloon and vesting in the Legislature the power to define and enact laws against such; vesting in the Legislature the power to regulate the manufacture, sale, transportation and possession of intoxicating liquors, including the power to provide for

a State Monopoly on the sale of distilled liquors; providing that intoxicating liquors shall not be manufactured, sold, bartered or exchanged in any county, justice's precinct or incorporated city or town wherein the sale of intoxicating liquors had been prohibited by local option election held under the laws in force at the date of the taking effect of Section 20, Article XVI of the Constitution of the State of Texas, until a majority of the qualified voters of such county or political subdivision shall determine such to be lawful at an election held for that purpose; providing that such shall not prohibit the sale of alcoholic beverages containing less than 3.2 per cent alcohol by weight in cities, counties or political subdivisions in which the qualified voters have voted to legalize such sale under the provisions of Chapter 116, Acts of the Regular Session of the 43d Legislature; providing for an election on the question of the adoption or rejection of such Amendment; prescribing the form of ballot; providing for the proclamation and publication of such by the Governor and making an appropriation therefor.

the qualified voters have voted to legalize such sale under the provisions of Chapter 116, Acts of the Regular Session of the 43d Legislature."

Section 2. Such proposed Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at a special election to be held throughout the State of Texas, on the fourth Saturday in August, 1935, at which election all voters favoring said proposed Amendment, shall write, or have printed on their ballots the words:

"FOR the amendment to the State Constitution repealing State-wide prohibition, prohibiting the open saloon and providing for local option."

And those voters opposed to said proposed Amendment shall write or have printed on their ballots the words:

"AGAINST the amendment to the State Constitution repealing State-wide prohibition, prohibiting the open saloon and providing for local option."

If it appears from the returns of said election that a majority of the votes cast are in favor of said Amendment, the same shall become a part of the State Constitution.

Section 3. The Governor shall issue the necessary proclamation for such election, and shall have the same published and such election held as provided by the Constitution and laws of this state.

Section 4. The sum of Eight Thousand (\$8,000.00) Dollars, or so much thereof as may be necessary, is hereby appropriated out of the State Treasury to pay for the expenses of said publication and election.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article XVI of the Constitution of Texas be amended by striking out Section 20a to Section 20e, both inclusive, and substitute in lieu thereof the following:

"ARTICLE XVI, Section 20.

(a) The open saloon shall be and is hereby prohibited. The Legislature shall have the power, and it shall be its duty to define the term 'open saloon' and enact laws against such.

Subject to the foregoing, the Legislature shall have the power to regulate the manufacture, sale, possession and transportation of intoxicating liquors, including the power to establish a State Monopoly on the sale of distilled liquors.

(b) The Legislature shall enact a law or laws whereby the qualified voters of any county, justice's precinct or incorporated town, or city, may, by a majority vote of those voting, determine from time to time whether the sale of intoxicating liquors for beverage purposes shall be prohibited or legalized within the prescribed limits; and such laws shall contain provisions for voting on the sale of intoxicating liquors of various types and various alcoholic content.

(c) In all counties, justice's precincts or incorporated towns or cities wherein the sale of intoxicating liquors had been prohibited by local option elections held under the laws of the State of Texas and in force at the time of the taking effect of Section 20, Article XVI of the Constitution of Texas, it shall continue to be unlawful to manufacture, sell, barter or exchange in any such county, justice's precinct or incorporated town or city, any spirituous, vinous or malt liquors or medicated bitters capable of producing intoxication or any other intoxicants whatever, for beverage purposes, unless and until a majority of the qualified voters in such county or political subdivision thereof voting in an election held for such purpose shall determine such to be lawful; provided that this subsection shall not prohibit the sale of alcoholic beverages containing not more than 3.2 per cent alcohol by weight in cities, counties or political subdivisions thereof in which
