THE Board of Trade had some good work done on our city park, and upon the incorporation of the city, the park was formally turned over to the city authorities. But a short time had elapsed when the city was no more, and from present indications our park will be in the same predicament, notwithstanding the fact that several thousand trees have been planted therein and more or less money expended in beautifying and improving the park. Cattle are roaming at large therein, which means utter ruin to the trees unless steps are immediately taken to preserve them. It seems a pity that all past efforts to improve and beautify the city park should be allowed to be lost, when a few dollars spent in repairing the fence would save all heretofore spent.

DOING GOOD WORK.

Hereford's Base Ball Team Loses the Rubber Game to Abilene.



Better Service Needed.

R. J. Anderson, a prominent stockman living near Hart in Castro county, was a business caller in town Wednesday and reports his section as flourishing, and being rapidly filled up with settlers. The patrons of the Hart postoffice have a just cause for complaint since the starting place of the Dimmitt stage has been changed, as now their mail is nearly a week old before it reaches them. For instance, Wednesday's Dallas News does not reach them until the following Tuesday. Those interested have petitioned the Washington postoffice officials to establish a mail route from Dimmitt to Running Water via Hart to be run three times a week and we hope that their petition will meet with favor. At present Castro county mail for Running Water, Plainview or other southern inland points on the plains comes to Hereford and lays one day, then goes to Canyon, where it lays another 24 hours and then goes via stage to its destination. If the Dimmitt-Running Water mail route is established all this will be done away with, as there is already a stage line from Running Water to points south.

They will not go to see their own team play ball even when the boys go to the expense of bringing first-class teams from other places to play them. About Macaroni Wheat.

Marcaroni wheat differs radically from the ordinary bread wheats, and in the field looks more like barley that wheat. The heads are flat, compressed and bearded, the beard often being black; the chaff is usually golden yellow, but sometimes black, and the grains are large, broad, yellowish white, and clear, or in wheats of the best quality, sometimes translucent. There are also velvet-chaff varieties. In Europe they are known simply as hard wheats, or durum wheats. The grain is much harder than that of the hardest bread wheats, and in the best varieties contains an unusual amount of nitrogen and a correspondingly small amount of starch. They are extremely resistant to drouth and resist attacks of rust and smuts to an unusual degree. On the other hand they will not withstand hard winters, and are usually grown as spring oats. This fact should not be a strong objection to them, however, for they will behave very differently from the ordinary spring wheats grown in Kansas nd Nea-

braska. South of the thirty-fifth parallel they may be sown in late autumn.

Speaking of crops suitable for semi-arid districts, we usually have especially in mind the benefit of the region and not the crop itself. In the case of macaroni wheats, however, it is not only true that they can be grown in dry districts, but they must be grown there in order to produce the best quality of grain, and up to a minimum of about ten inches annual rainfall, the drier the better, provided the rain falls at the proper time and the soil is of the right kind.-M. A. Carlton, U. S. Department of Agriculture.
