








BonFire By Mike Cogburn



# **Selective Service Registeration**

### **Continues For 18 Year Olds**

Young men are required by law to register with Selective Service within 30 days of their 18th birthday. They may register at any U.S. Post Office.

Registration is a simple process. A man fills out a registration form which asks only for his name, address, phone number, social security number, and date of birth.

The purpose of registration is to have available on a computer the names of men born in 1960, and afterward, who could be contacted quickly if there ever were a national emergency and Congress were to declare an induction.

Peacetime registration will save the United States at least 6 weeks in mobilizing its manpower in an emergency. This is especially important with today's All Volunteer Force. There are only 2 million men in the armed services today, but we would need many more men quickly should an emergency arise-for example, in World War II we had 10 to 16 million men bearing arms depending upon the stage of the conflict.

The new product is made up mainly of two amino acids, phenylalanine and aspartic acid. These, along with other amino acids, are the normal building blocks of protein in foods consumed as part of any healthy diet.

Phenylalanine and aspartic acid combin-



ed in a certain manner produce an intensely sweet-tasting substance called aspartame that is about 180 times sweeter than sucrose (sugar).

Aspartame has FDA approval for use as a sweetner in the following foods:

\* dry, free-flowing sugar substitute for table use in package units not to exceed the sweetening equivalent of 2 teaspoonsfuls of sugar

\* sugar substitute for sweetening hot beverages, including coffee and tea \* cold breakfast

cereals \* chewing gum \* dry bases for beverages, instant coffee and tea, gelatins, puddings and fillings, and dairy products and toppings.

FDA approval is bas-

ed on four additional conditions regarding final product labeling and Searle's record keeping:

\* any food containing aspartame must display a warning statement for phenylketonurics (persons sensitive to phenylalanine, much like diabetics are to sugar) that the product contains phenylalanine.

\* a statement not to use aspartame in cooking and baking must appear on the label. Aspartame breaks down when exposed to prolonged heat, with a consequent loss in sweetness.

\* if a food containing aspartame is represented to be for special dietary use as might be expected of a low-calorie product, the food must be labeled in compliance with


FDA's special dietary foods regulation.

\* Searle Co. is to monitor actual levels of aspartame for the FDA.

Advantages that aspartame is supposed to have over other nonnutritive sweeteners are that it is virtually indistinguishable from sugar in taste, has no bitter or metallic aftertaste, and seems to act like a flavor enhancer for some fruits, such as MSG (monosodium glutamate) does for

high-protein foods. A major disadvantage is that it is not stable to heat for prolonged periods.

**Consumers** sensitive to the somewhat bitter aftertaste often associated with saccharin sweetners will be delighted with this new product as will others who use nonnutritive sweeteners.







The pecan crop is looking very good throughout Eastland County. There is going to be a good supply of high quality pecans. We would like to remind you of the Eastland County Pecan Show which will be held December 11 and 12 at the Eastland County Courthouse. Anyone who grows pecans is eligible to enter the pecan show. An entry consist of 43 pecans of any variety or native pecans from a native tree. Any person may have one entry from each variety he or she grows and as many different native entries as one wishes to enter. There is no fee for entering the pecan show. Ribbons will be given to the first three place entries in each variety class.

Begin now to save the largest and best pecans of each variety. Allow them to dry out in a well-ventilated, shaded area. Store the pecan entries in a place where they will not be damaged or eaten until the pecan



Although many plants contain the toxic material that cause poisoning, those causing the highest mortality in livestock when grazing after they have been frozen and wilted are Johnson and Sudan grasses and sorghum or hybrids of these.

The most dangerous time as far as the grazing of these plants is concerned is following frost, when the plant material begins to wilt. Livestock should not be allowed access to the wilted material until it has dried completely. This usually takes three or four days of good sunlight. New plant growth usually becomes nontoxic and can be grazed within 10 days or two weeks following a

rain.

affected within 10-15 minutes after eating toxic material and can die in two or three minutes. Symptoms may include a brief period of stimulation followed by depression and paralysis. Signs of colic may be present. Difficult breathing and frequent convulsions may result. Death is caused by suffocation since oxygen remains in the blood and is not exchanged to the tissues. This also causes the blood to appear bright red.

If an animal in the herd shows signs of poisoning, remove all the herd from the pasture and call a veterinarian immediately. An antidote to treat affected animals is highly efficient if given early. This product is available from veterinarians.

The overall key to prevent prussic acid poisoning in livestock is to be aware of plant materials that may cause poisoning and then to keep cattle from grazing such plants until a safe period has passed.

### **Build Better Beef Through Breeding**

The following article is being reprinted with permission from the KENTUCKY AGRICULTURAL NEWS. It was written by Dr. Carla Chenette, Extension Beef Cattle Breeding Specialist.

Efficiency is the key to every type of production these days, and the cattle industry is no exception. Cattle producers are constantly striving to increase total pounds of calf weaned per cow. This one trait alone contributes the most to production efficiency and economic gain.

Increasing calf weight at weaning can be accomplished through various means such as improvement of management techniques, selection for genetically superior cows, better nutrition for the herd and of course, the "bull power" behind the herd. Fast gaining bulls postweaning tend to sire fast gaining calves. By all odds, the bull is the most effective way to make genetic progress in a beef herd.

It is an old axoim that "the bull is half the herd." Realistically, the bull is much more important. Research studies have shown the bull is three to five times more important than cows in changing type in a beef herd. Some studies go as far as saving that 90

percent of the genetic improvement realized in a beef herd over a period of years is the result of the bulls used!

A good bull has a lot of "earning power" and he is a long-term investment in the cattleman's future, but where can these genetically superior bulls be found? The genetic power of the cattle industry lies in the top producing purebred herds. Many of the national breed associations are putting much emphasis on performance testing so that top individuals truly are that genetically superior can be identified. Another tool for identifying "herd-improver"

bulls is a central bull testing station. The University of Kentucky, College of Agriculture, **Cooperative Extension** Service and the Kentucky Beef Cattle Association sponsor central bull testing at the UK Eden Shale Farm near Owenton, Kentucky. The central test is a feedlot gain test where all consigned bulls are given an equal opportunity to express their genetic ability to grow. A key to performance testing is that animals are treated alike so that environmental differences are mostly due to genetics; thus truly superior cattle

can be identified.

mulate the test rations recommend and management procedures to allow each bull to gain at a rate near his genetic limit. The testing program consists of a 21 day adjustment period followed by the official 140 day gain test.

To be accepted to the test, a bull must meet any criteria. The bull must be a registered purebred or a recorded percentage bull, meet age requirements, meet weight and frame requirements and have a clean bill of health. All bulls on test are closely monitored for

performance. Each bull is weighed at delivery on days 0, 28, 56, 84, 112, and 140 of the official test. Reports are sent to consignors after each weight period. In addition, 205- and 365- day adjusted weights are calculated, average daily gain on test weight per day of age and the within-breed ratios for all of these traits. Fat thickness, hip height and scrotal circumference are also measured.




