

## **County Election Results**

#### SEE PRECINCT **RETURNS CHART INSIDE PAGE**

About a third (3,815) of the qualified voters in Eastland County turned out Tuesday to vote in the General Election.

In incomplete totals, countians voted against 15 of the Constitutional Amendments and for ten. In totals, countians voted against state school board appointments and against legalizing pari-mutuel wagering.

Statewide incomplete returns showed the state voted for legal wagering and against board appointments.

Statewide, almost the same ratio, reversed, was reflected by Texas voters: 17 amendments passed and eight failed.

# **Wildcats Maul the Tigers**

The Rising Star Wildcats roasted the Blanket Tigers in front of a homecoming crowd Saturday, November 7, 57-14. The Wildcats took an early lead when Blanket was forced to punt on their opening drive. The snap went over the punter's head and into the end zone. The Wildcat defense swarmed and seniors Kerry Hill and Lupe Pavon teamed up for the safety putting the Wildcats ahead 2-0. The Cats started their opening drive on their own 46 yard line. With 6:50 left in the guarter junior Stacy Green ran six yards for the touchdown. Stacy Green's kick for the extra point was good moving the score to 9-0. The next scoring play came when senior David White passed to junior Reil Barron for 47

yards. Barron refused to go down and ran into the end zone with 2:45 left in the first quarter. Once again Stacy Green's PAT was good and the first quarter ended, Wildcats 16, Tigers, 0.

Early in the second quarter the Wildcats struck again when Stacy Green ran one yard for his second touchdown of the night. Green's kick for the extra point split the uprights and with 10:54 left in the first half, the Cats lead 23-0. Blanket finally put points on the scoreboard when they connected on a 73 yard pass play. The PAT was good and the score was 23-7 at 10:19. The Cats retaliated and found the end zone yet again. This time David White passed 19 yards to senior Ronnie Evans. Green's PAT at-

Ninety percent of breast cancers are diagnosed by women or their physicians finding a lump in the breast. Women who are diagnosed with a lump large enough to feel have a 50 percent five year survival rate. A woman who is diagnosed as having breast cancer by mammography, before a lump can be felt, has 97% five year survival rate and a 90% 1C year sur-

The American Cancer Society has established guidelines for mammography in asymptomatic women. (Women who have no symptoms of disease). Those guidelines have been adopted by the American Academy of Family Physicians, American College of Obstetricians and Gynecologists, and The American College of Radiology. Those guidelines are:

I. 35-40 years of age - One baseline mammogram.

II. 40-50 years of age - A mammogram every 1-2 years depending on breast type and risk factor.

V. A symptomatic woman should have a mammogram at any age when she exeperiences a mass, nipple discharge, skin changes or unexplained breast pain.

A screening mammogram is an x-ray of the breast using extremely low dosages of radiation (usually comparable to dental x-rays) and is designed to find very early cancers.

A female technologist who is highly trained in mammography will perform the examination.

## **Back To School In County**

#### By Lula Mae Basham

Griggs school located about one mile Southwest of Romney, was district 17 organized in 1902 consolidated to Cisco in 1930. Named for Louis Jack Griggs as he raised a large family there. Some remember this school and stories of things in this community as far back as 1890. Porch Jack Baptist Church, and the Lutheran Church was about one mile north of the Griggs school. There was a cemetery. There are still reunions in memory of this community, Edith Bostic is secretary. I talk of Aunt

CAPITOL UPDATE by Jim Parker

Rural health care clearly is undergoing an evolutionary process with the end result of that process being an item of significant

speculation and concern. Across my district and in the surrounding rural area rural hospital after rural hospital has closed its door with many more at or near the point of closing. Almost on a daily basis I am asked where this process is going. The truth is, I'm not sure I

know. At least two factors have contributed to the demise of rural hospitals, the first and foremost being Medicare/Medicaid regulations applicable to rural hospitals. A simple operation done in DeLeon, Texas, has a rated amount to be paid by Medicare/Medicaid. That same operation in Dallas has a much higher payment schedule rating and, in San Francisco, still a higher payment rating. For the life of me I cannot see the basis for the difference in the amount Medicare/Medicaid pays, regardless of where the operation is performed.

Many rural hospitals

simply can't measure up to Medicare/Medicaid requirements and if they could, they couldn't compete with larger hospitals.

The other factor that appears to be of increasing importance in the demise of rural hospitals is that local ad valorem taxpayers are consistently demonstrating adamant opposition to a tax structure necessary to fund the operation of rural

hospitals. Two possible solutions are: (1) on the federal level, we need to bring some semblance of reason and reasonableness to the Medicare/Medicaid criteria; and (2) on the local level, perhaps, we need to

study new alternatives to finance hospitals. It has been said that one must be careful not to "ride a good horse to death." Truly, we may have ridden the ad valorem tax horse to death and that may well be the reason for such strident opposition to recent hospital bond issues in my district and in the area. Perhaps, it's time to look at some innovative financing. Innovative methods are available and are being used but it's very difficult to break out of the decades-old method of thinking that ad valorem taxation is the only means of financing available.

By way of prediction, assuming something fairly significant isn't done, rural health care is going to consist of something roughly equivalent to the "minor emergency clinics" that we see so many of in metropolitan areas. They will, of course, take you in, do a quick diagnosis and ship you somewhere else. Unfortunately, for all too many people I fear that "somewhere else" may be the funeral parlor.







**Social Security Will Pay Survivors** 

Social Security benefits can be paid to many survivors of workers who die after working long enough in work covered by Social Security, Glyn Hammons, Social Security mananger in Abilene, said recently. These survivors include

the worker's unmarried children under 18, under 19 if a full-time high school student or over 18 if disabled before reaching 22; a parent caring for a child under 16 or disabled who gets benefits; a widow or widower 60 or older, or 50 or over if severely disabled; and dependent parents 62 or older. In addition, a surviving

divorced wife or husband can generally get the same benefits as a widow or widower if the marriage to the worker lasted 10 years or more.

A lump-sum payment of \$255 can be made to a worker's eligible widow or widower, or, if none, to the worker's child entitled to benefits. It is important for sur-

COLLEGE STATION --Most emloyers seem to be coping fairly well with the implementation of the Immigration Reform Act. Now they face the possibility of a records inspection.

As of September 1 federal officials from either the Labor or the Immigration Department can legally visit a place of business to inspect records., specifically the I-9 forms required for each employee, points out Dr. Dick Edwards, an economist with the Texas Agricultural Extension Service, The Texas A&M University System. Employers should have a handbook which includes a copy of the I-9 form and instructins for completing it. Any Texas **Employment** Commission office can provide information on how to receive a copy of the handbook.

Since immigation reform is an employment law, an employer must ascertain that all persons hired since November 6, 1986 are either American citizens or aliens who have the legal right to work in this country, Edwards points out. He sum marizes the law's provisions: 1. An 1-9 form must be completed on every person hired since November 6, 1986. An I-9 form must even be completed on a spouse or children hired for work. An employer must look at documents which "prove"

identity and eligibility but need not judge their authenticity.

ment.

2. The I-9 form must be completed within three working days of the starting date of employment. Persons hired since November 6 who have yet to fill out an I-9 form should do so right away.

3. No I-9 form is required for a person hired prior to November 6, 1986. This does not mean they are legalized; it simply means that the employer is not liable for fines and sanctions covered by the law.

By Gordon S. Clark What with corporate raiders, leveraged buy outs, hostile take overs and all that other financial jargon I can't keep up with who is skinning whom. Only one thing does seem clear to me and that is that you may not be doing business with the people you thought you were. Some old names will disappear and in other cases the new people cheapen the product and trade as long as they can on the old company reputation.

Sad as it may seem, it has evern been so. Companies merge and the old men pass on. It takes a good organization to escape the malignant forces ir. ine cutthroat world of high finance.

Very very few people recognize the name Atwater Kent. He developed the first superhetrodine radio. Breaking that down to digestable size, he modernized radio to something more like you use today than the old crystal set. until the transistor, his work set the pattern.

The first radio my folks had that I recall was a big 12 tube Atwater Kent and in East Liverpool, Ohio, we listened to station KDKA Pittsburgh, Penn. which was the very first radio station to produce regularly scheduled programming.

I even recall the announcer of the regular mor ning program. He was one

wonder what those old records would be worth today?

Another program, I think, was "Cherrio" but on that bit of trivia I am not certain. Still more trivia many may not recognize is the unusual call lettes of KDKA. Since it was among the first and call letters began rather haphazardly it began with a K while today stations west of the Mississippi have K beginning their call letters and east of the Miss. they are assigned letters starting with ±. Here you may pick up a station with X which originates in Mexico even if the junk advertised is sent for at Clint, Texas.

A friend has an old radio I would like to con him out of. I am not a professional antique collector though some I really love, like my wife in her 60s and Mother who is long past 80. Some people even commercialize on that class of antiques. But my friends radio is a Crosley. WHAT?? You don't remember that name? years until my friend mentioned his radio. A Crosley. How soon the great old companies are forgotten.

I believe he was the race car driver who first went 60 miles an hour then retired saying that cars were getting too fast for him to risk it any more.
