It's gardening time again and many home gardens in Eastland County are getting a good start. We have noticed a lot of people have already set out onion plants. Some are thinking about weed control. We have had several requests this last week concerning chemical herbicides that my be used

effectively in the garden. Weed control in the home garden depends on garden size, kinds of vegetables being grown, and types of weeds.

Weeds (any unwated plants) compete with vegetables for soil moisture and nutrients. They have extensive root systems and flourish under a variety of conditions. Effective control of weeds

depends on how they spread. Crabgrass and other annual weeds survive by seeds. Perennial weeds such as bermuda grass and johnson grass survive both by seed and underground plant parts.
