Webb tapped as Rockwall High School head coach

Rodney Webb, who most recently served as the head football coach and campus athletic director at Mesquite's John D. Horn High School, has been hired to fill the head coaching position and campus athletic coordinator at Rockwall High School.

According to a Rockwall Independent School District news release, Webb's hiring was unanimously approved at the March 1 special meeting of the RISD Board of Trustees.

Webb has 22 years of experience as a teacher and a coach and has worked in several school districts, including the Elgin ISD, Glen Rose ISD, Austin ISD, Garland ISD, Royse City ISD and the Ruidoso Municipal School System in Ruidoso, N.M. He led Mesquite Horn High School to its first five playoff experiences in school history. He was named the 2008 District 11-5A Coach of the Year, the 2007 District 10-3A Coach of the Year and the 2004 District 9-3A Coach of the Year.

Webb holds a bachelor's degree from Tarleton State University. In

2007, he was inducted into the Tarleton University State Athletic Hall of Fame.

"We are so pleased to have Coach Webb as the new head coach of Rockwall High School," RISD superintendent Jeff Bailey said in the news release. "Coach Webb's previous experience and continued level of success will be great assets for that campus and for our district."

Webb's start date at RHS has not yet been determined, according to the news release.

New parks superintendent addresses Royse City council

Brent Stowers, Royse City's new parks superintendent, gave an update at the City Council meeting Feb. 26. He discussed the improvements he plans to make concerning the athletic fields and the city playgrounds.

As part of Stowers' responsibilities, he is to supervise the trimming, mowing and weed control of neighborhood parks. He also oversees landscaping of any city-owned properties and the inside maintenance of facilities such as the museum, the animal shelter, the senior citizen center and the service center.

Of much interest to the City Council, staff members and those in attendance at the meeting, was Stowers' information regarding the upcoming season for West Nile mosquito spraying. He discussed taking samples for the mosquito-borne virus, then making the decision of whether or not there will be a need this year to spray.

At this point, Councilman Tom Crowley asked Stowers if it was important to conduct the testing. Stowers replied that he thought it was important, stating that if it were found that there was not a need this year to spray, it would save the taxpayers a lot of money, for the unnecessary expense. Stowers said he believes that spraying should not be the first option, but the last.

There were no speakers to address the Council during the citizens participation time allotment.

Also on the agenda for the Royse City Council meeting was

to "consider possible continuance of the current mission statement and possible acceptance of the proposed vision statement." Both statements passed by a unanimous vote.

The Mission Statement for the City of Royse City reads: "To preserve our hometown atmosphere, to serve the community through responsible government and provide a safe environment, which promotes, enhances and develops a higher quality of life for our citizens."

The Vision Statement for the City of Royse City reads: "The vision of the City of Royse City is to become the most innovative, efficient, and proactive community in the area-in the eyes of our citizens, merchants, visitors and employees. We expect and demand the best we have to offer by always keeping our five core values in mind." The five core values are:

1. Ethical - We adhere to the highest ethical standards, which include honesty, integrity, and community trust.
2. Professional - We are committed to being accountable, honorable, courteous, conscientious and adhering to the highest established organizational standards.
3. Team Oriented - We work together as a team and recognize that our combined efforts will accomplish more for our community.
4. Dedication - We are professionals dedicated to service by being diligent, loyal, productive and adaptable.
5. Customer Responsiveness - We respond to the needs of our customers in impartial, efficient and timely actions.

Also unanimously passed by the council was a resolution to fund the 2013 Pay Plan for all city employees. This is an incentive, 10-step compensation plan allowing employees to advance their salary each year for 10 years, if submitted and approved by their supervisors.

City Manager Carl Alsbrook gave updates on the Erby Campbell Overpass project, saying "all utility relocations are now moving at a rapid clip," which is good news concerning the upcoming construction of the new Wal-Mart store. As of yet, no beginning construction date has been given by Wal-Mart.

All council members were in attendance as well as Alsbrook, city attorney Jason Day, city secretary Brenda Craft and other staff members. The next council meeting is set for 7 p.m. March 12.

Rockwall Main Street receives recognition

The City of Rockwall received its third annual national recognition for progress in Downtown Rockwall as a designated Main Street community, according to a city news release.

The announcement was made by the Texas Historical Commission's Main Street Program in January at their annual gathering of Main Street managers.

Rockwall's Main Street Manager Bethany Golden works with the local Old Town Shoppes, the Friends of Downtown, the Main Street Advisory Board and other volunteers. Their work has helped attract business, retail shopping and thousands of visitors annually to special events such as the Farmer's Market, Founders Day Festival, the annual Run and multiple holiday events.

The Main Street Advisory Board has awarded 18 façade grants totaling \$16,000, which allows merchants to revitalize the exterior of their buildings. Public and private reinvestment in downtown totals \$2.7 million since the inception of the program in 2009. Later this year, a pre-approved bond project for downtown improvements will begin, adding \$625 million to the reinvestment total when completed, Golden said.

The Main Street Program is a revitalization plan for historic downtown and neighborhood commercial districts based on its Four-Point program - organization, design, promotion and economic restructuring in the context of historic preservation. National accredited Main Street centers show above-average performance in 10 categories on an annual report. A selection criterion focuses on such things as planning, marketing, staffing, volunteer effort and preservation ethic.

Sixty-seven programs were recognized by the commission.

Storm spotter training set March 9 at library

The National Weather Service office in Fort Worth will offer a SKYWARN severe weather program from 11 a.m. to 1 p.m. March 9 at the Rockwall County Library.

Offered in partnership with Rockwall County Emergency Management, the program will include information on thunderstorm formation, ingredients and features associated with severe storms. It also will provide a review of tornado behavior and will provide insight into why some storms produce tornadoes and some do not. Also planned is a discussion of non-threatening clues that may be mistaken for significant

FUMC Heath celebrates fiscal milestone with note burning

 The First United Methodist Church of Heath, under the direction of the Rev. Dean Libby, celebrated a milestone in the church's history on Feb. 24. The congregation gathered to witness a note burning, signifying the church's recent paying off of debt.
 According to Libby, the church had a total debt of \$780,000 incurred from the construction of phase 1 and 2 of the church's buildings. The debt had diligently and responsibly been paid down for the last 13 years. A large gift at the end of 2012 from an anonymous donor allowed the church to cross the threshold of financial freedom.
 Without the financial constraints of mortgage debt, the church now will be able to better focus and utilize its resources towards its ministry work.
 "We are excited how we can find new ways to minister to our community now that we don't have the burden of debt," said Libby.
 In attendance for the special event were FUMC Bishop Mike McKee and District Superintendent Frank Algeria. The three former pastors of the congregation were also invited. The Rev. Reid Fate sent her greetings and congratulations via video message and the Rev. Scott Holcomb-McLain sent his wishes in a letter. Both are on assignment in other churches and were unavailable to attend in person. Carol Ann Ravert, wife of the late Rev. Larry Ravert, attended on his behalf.
 The note was burned during the church's 11 a.m. worship service as a symbolic act of being released from the freedom of debt. Libby explained that it is a rare and special occurrence, as most churches live in debt.
 "We celebrated our release from indebtedness," he said. "We are celebrating God's faithfulness to us in our past, present and into the future."
 The congregation celebrated with a big lunch after the service. Libby said there was lots of excitement, as well as tears of joy.
 "It was a great day as a church family to be together and celebrate the new kinds of ministry we will be able to do in our community," he said.

features. Safety planning – that is, what individuals can do to keep themselves and others safe when threatening thunderstorms are present – also will be reviewed.

The program will be in multimedia format, featuring new photos of storms and some video from the 2012 severe storm season.

"We have quite a bit of new material for this year's spotter training program," said Mark Fox, warning coordination meteorologist at the Fort Worth office. "We will be showing data from the severe weather events of 2012, plus emphasize how your storm observations help to save lives."

The purpose of the training remains constant – spotter training saves lives, according to the NWS news release.

"Weather radar is a great tool, but it only tells part of a storm's story," said Tom Bradshaw, meteorologist-in-charge of the Fort Worth office. "Spotter observations are fundamental to the protection of life. The combination of spotter reports and radar data gives us the best possible picture of the storms and what's going on inside them."

The program will be free and open to the public. No advanced registration is required.

"By coming to this program, you will learn a lot about thunderstorms," Fox said. "Even if you don't become an active storm spotter, you will learn about how storms work and the visual clues you can identify when storms are in your area. This will better prepare yourself and your family for the threats that storms pose."

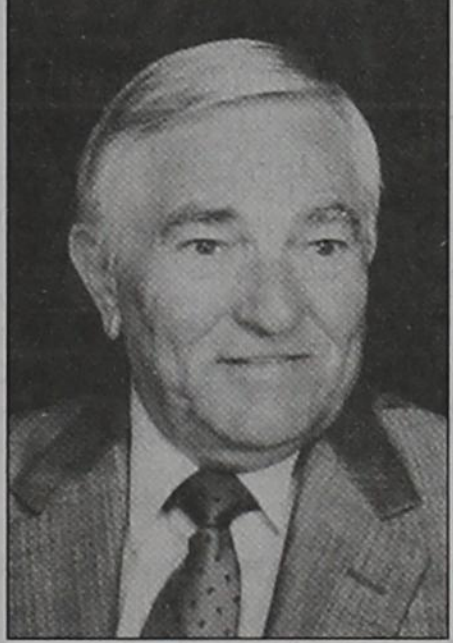

No person naturally enjoys being defrauded of justice, robbed, reproached, mocked, spit on, persecuted, etc. Jesus did not get out of watching the Jewish leaders put him through two mock trials, influence the Roman governor into eventually murdering him. Jesus allowed himself to suffer such tribulation because of the promise of resurrection.

In the end, Jesus was strengthened in meekness and humility because he stayed focused on God's loving and compassionate will.

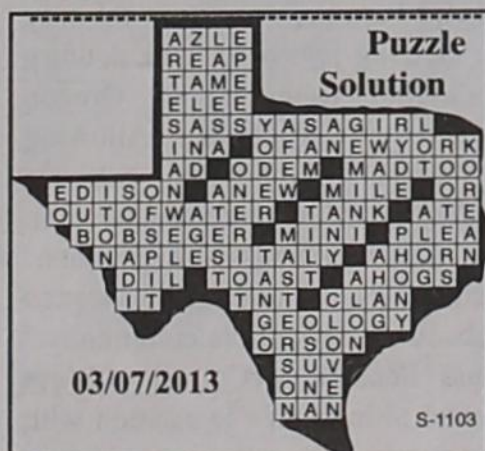

The Federal war on hemp needs abolishing

It is one of the earliest-known domesticated plants. It is resistant to saltwater. It doesn't require pesticides or harsh fertilizers. For hundreds of years all the major European maritime powers needed it to maintain their fleets. Its fiber is suitable for making clothes, paper, building material, and insulation. It can be turned into biofuel and converted to biomass. Mechanical Engineering magazine once hailed it as "the most profitable and desirable crop that can be grown." It has nutritional benefits. It can be used as animal bedding. It can be used in the production of soap and cosmetics. It is biodegradable. Rudolph Diesel designed his engine to run on its oil.

The U.S. Department of Agriculture once extolled it as a high-yield, low-maintenance, excellent rotation crop. The ships of the Pilgrims who landed at Plymouth Rock were equipped with it. The Puritans cultivated it in New England. It was once America's third-largest crop, behind only cotton and tobacco. The first American flags were made from its cloth. It once served in colonial America as legal tender. Its fiber made uniforms for George Washington's soldiers. "Sow it everywhere," implored Washington, who himself planted and harvested it. Thomas Jefferson also grew it and praised it as a cash crop over "pernicious" tobacco. He penned the original draft of the Declaration of Independence on paper made from it. A parachute made out of it once saved the life of the future president George Herbert Walker Bush during World War II. The federal government produced a motivational film in 1942 urging farmers to grow lots of it to help support the war effort. To help farmers cultivate more than 300,000 acres of it during the war years, the government gave farmers subsidies for doing so.

I am speaking of the plant Cannabis sativa, better known as cannabis or hemp. But since it is also known as marijuana, it is classified by the federal government as a Schedule I controlled substance (along with heroin and

LS), and it is therefore illegal on the federal level to cultivate it — not just for recreational use, but for medicinal, therapeutic, or industrial uses.

The plant clearly leads a double life, but because of the federal government's irrational obsession with waging war on marijuana, the focus is always on its darker side.

Although the United States is the largest consumer of hemp products, it is the only industrialized nation that prohibits industrial hemp cultivation. Every industrial product in America made from hemp is legal, but the plant itself is illegal. It remains legal to import raw and refined hemp products. The United States actually exports hemp products made from imported hemp.

Just as many states have legalized marijuana for medical use, and a few states even for recreational use, so some states have legalized the cultivation of hemp for industrial purposes. Nevertheless, because hemp is a controlled substance, it is still illegal under federal law and the federal Drug Enforcement Administration has refused to issue permits for farmers to grow it.

There is an attempt in Congress to change all of this

Two Democratic senators from Oregon, Ron Wyden and Jeff Merkley, just recently introduced a bill (S.359) "to amend the Controlled Substances Act to exclude industrial hemp from the definition of marihuana [sic]." Bills like this normally die in a Senate committee. That is what happened when Senator Wyden introduced the Industrial Hemp Farming Act of 2012 last year. And it is also what happened when Rep. Ron Paul introduced into the House the Industrial Hemp Farming Act of 2011.

This time, however, Senators Wyden and Merkley are joined by two Republican co-sponsors, both from Kentucky: Sen. Rand Paul and Senate Republican Leader Mitch McConnell. According to a press release from McConnell's office,

The Industrial Hemp Farming Act of 2013 would remove federal restrictions on the domestic cultivation of industrial hemp. Specifically, the bill would remove hemp from the Schedule I controlled substance list under the Controlled Substances Act of 1970, and would define it as a non-drug so long as it contained less than 0.3 percent tetrahydrocannabinol (THC).

States are ahead of feds

Oregon is among eight states that have already defined industrial hemp as distinct from marijuana and removed barriers to production, and the Kentucky state Senate Agriculture Committee this week unanimously approved a bill to license hemp producers. However under current law, farmers in states that allow hemp must still seek a waiver from the Drug Enforcement Administration or risk raids and seizures by federal agents.

Said Senator Paul, "The Industrial Hemp Farming Act paves the way to creating jobs across the country — from Kentucky to Oregon and everywhere else. Allowing American farmers to cultivate industrial hemp and benefit from its many uses will boost our states' economies and bring much-needed jobs in the agriculture community." Said Senator McConnell, "I am proud to introduce legislation with

my friend Rand Paul and Senate colleagues that will allow Kentucky farmers to harness the economic potential that industrial hemp can provide. During these tough economic times, this legislation has the potential to create jobs and provide a boost to Kentucky's economy and to our farmers and their families."

Rand Paul leads the way

Senator Paul even testified before Kentucky's Senate Agriculture Committee in favor of hemp while wearing a shirt made of it. "I want to show off my hemp shirt," Paul said. "I had to buy it in Canada though because we have soap manufacturers who would like to use the seed from hemp plant — they got to import it. So, basically, we're exporting our product to Canada. I see no reason why we wouldn't want to be a leader in this industry."

A companion bill (H.R.525) has already been introduced in the House by Rep. Thomas Massie — a Republican from Kentucky. It has several co-sponsors.

That the two senators and a congressman from the Bluegrass State in favor of home-grown industrial hemp comes as no surprise, considering that Kentucky was a center of hemp cultivation after the Civil War. It produced more than 90 percent of the nation's hemp before the Second World War. In Kentucky in 1996, actor Woody Harrelson was arrested after brazenly planting four hemp seeds in full view of the county sheriff's office in Lexington.

Toyota wants hemp production

The Toyota Company, which builds cars in Kentucky, has spoken in favor of hemp legalization, saying it wants to use the fibers in car parts and insulation. Naturally, some law-enforcement groups in Kentucky oppose industrial hemp because they say it is a step that could lead to legalization of marijuana.

Drug warriors who likewise oppose the production of industrial hemp offer all kinds of reasons for their opposition but ignore the real issue.

Whether there are alternatives superior to hemp is not the issue. Whether hemp production would be insignificant compared with flax and cotton is not the issue. Whether other crops provide more nutritional benefits than hemp is not the issue. Whether other crops have textile qualities that are better than hemp is not the issue. Whether other crops that can be turned into biofuel eclipse hemp in terms of efficiency is not the issue. Whether other crops that can be used for biomass exceed hemp in amount of energy they can generate from a given amount of mass is not the issue. Whether a revived hemp industry would be quite unlike the hemp industry of colonial days is not the issue. Whether modern substitutes for hemp are more functional and less expensive is not the issue. Whether the advent of modern synthetic materials has made hemp obsolete is not the issue. Whether plastic offers greater longevity and resilience than hemp fiber is not the issue. Whether hemp is not a viable crop is not the issue. Whether hemp for industrial use is not the panacea that its promoters maintain is not the issue.

Hemp is not the same thing as marijuana

Whether hemp for industrial use would be a Trojan horse for the production of intoxicating marijuana is not the issue. Whether support of legalizing hemp for industrial use is just using its legalization as a springboard to getting marijuana legalized is not the issue. Whether industrial hemp legalization is just a slippery slope to pot legalization is not the issue. Whether advocates of industrial hemp just want to get rich is not the issue.

The real issue is that the federal government has no authority whatsoever to criminalize, prohibit, control, or regulate the planting, growing, harvesting, or selling of any plant regardless of whether it is used for industrial, medicinal, therapeutic, or recreational use.

Every member of Congress who swears an oath to "support and defend the Constitution of the United States" and "bear true faith and allegiance to the same" — regardless of how he personally feels about the government's war on hallucinogenic drugs and regardless of whether his state has potential to sustain a hemp industry — should be clamoring to pass federal legislation that legalizes the production of hemp.

Rockwall High School soccer teams haven't lost in 17 matches

This week's news for the Rockwall boys' soccer team is that RHS gave up its first goal in District 12-5A this season, in its seventh district match. The Yellowjackets won 2-1 despite the goal Tuesday, Feb. 26, by North Mesquite's Abraham Vasquez. The 2-1 victory improved the Jackets' record to 19-2 overall and 7-0 in the district, with a 17-1 goal differential in 12-5A. They have won nine consecutive matches.

Jonathan Otto and Clayton Rittershaus scored the goals for Rockwall, which will be off for 11 days during spring break after Friday's match.

GIRLS' SOCCER: The Lady Jackets also remained undefeated in their new district. They won at home Tuesday 3-1 over North Mesquite. RHS is 9-3-3 overall and 5-0-2 in the district, and is undefeated in its last eight matches.

SOFTBALL: Rockwall limped into Tuesday's District 12-5A opening

game after struggling to score runs last weekend at the Wylie Tournament. RHS lost 1-0 to Sherman, 6-3 in a tiebreaker against Dallas Bishop Lynch and 3-1 against both Mesquite Poteet and Richland. The Poteet loss was especially frustrating because Rockwall managed only one run despite 11 hits, including Hayley Baker's double.

Last week had begun well with the Lady Jackets pounding 18 hits in a 13-5 victory over Frisco Wakeland Tuesday. Winning pitcher Kayla Vandergriff's double was one of their five extra-base hits. Alyssa Henry and Jocelyn Myers each hit a triple.

GYMNASTICS: In the cross-town rivalry, the North team – composed of gymnasts from the Rockwall varsity and junior varsity and Williams Middle School, along with the Utley gymnasts who would go on to RHS – won both the boys' Battle for the Rock Wednesday, Feb. 27, and the girls' North vs.

South City Meet Thursday.

The Yellowjackets' Michael Weidman scored his first perfect 10 in the floor exercise, and finished first all-around as well as in the vault on the high bar. He was second on both the still rings and parallel bars, and 10th on the pommel horse.

RHS' Zach Bennett placed fourth all-around and tied with teammate Irwin for first place in the pommel horse.

The North team edged the South 172.50-168.90.

TRACK: Kerry Anderson won the high jump at 6 feet, 2 inches, and Lee took first place in the pole vault at 13-0, to lead Rockwall to place among 11 teams competing at Wylie Saturday. The Jackets' points to 155 for first-place Lancaster.

Gaines Kinsey had the best overall performance – placing second in the 800-meter run (1 minute, 58.63 seconds) and fourth in the 300 hurdles (42.09 seconds), tying for fifth in the high jump (5-6) and the second place 4X400 relay team. Calvin Fair, Alex Montanez and Wright preceded Kinsey on the team that flew to a time of 3:28.39.

Kaylee Hinton had an even better meet, helping the Lady Jackets to place among 12 teams. Hinton won the long jump at 18-8, the 100 dash at 12.78 and the 100-meter hurdles (15.68). She also was third in the pole vault (9-0) and ran the last leg as Rockwall finished fourth in the relay in 1:48.42. Her relay teammates were Kaitlin Ross, Kennedy and Jordyn Pettigrew.

ALUMNI: Peyton Adamson, a 2010 RHS graduate, averaged 20.5 points per game as Tarleton State's second-leading scorer heading into weekend's Lone Star Conference tournament at the Allen Event Center. The sharp-shooting junior had made 45 per cent (68-for-151) of her attempts and 89.8 per cent (106-for-118) of her free throws. The 5-10 (18-8 overall, 14-6 in the conference) were seeded fourth for the tournament and scheduled to meet Incarnate Word in the quarterfinals Thursday.

Former Lady Jackets teammate Alyssa Lang played in all of Rice's games, and started one, as a freshman. Lang was averaging 2.4 points and 3.1 rebounds per game for the Lady Owls.

Freshman Colton Hargrove of Rockwall has been named the Collegiate Hockey Association Rookie of the Week, once for scoring goals for Western Michigan against Bemidji State and once for scoring the game-winning goal vs. Michigan. WMU, ranked ninth in the nation, won a first-round bye this weekend in the CCHA playoffs. Hargrove, drafted by the NHL's Boston Bruins, graduated from the North Dakota State University while playing for the Fargo Force in the United States Hockey League.

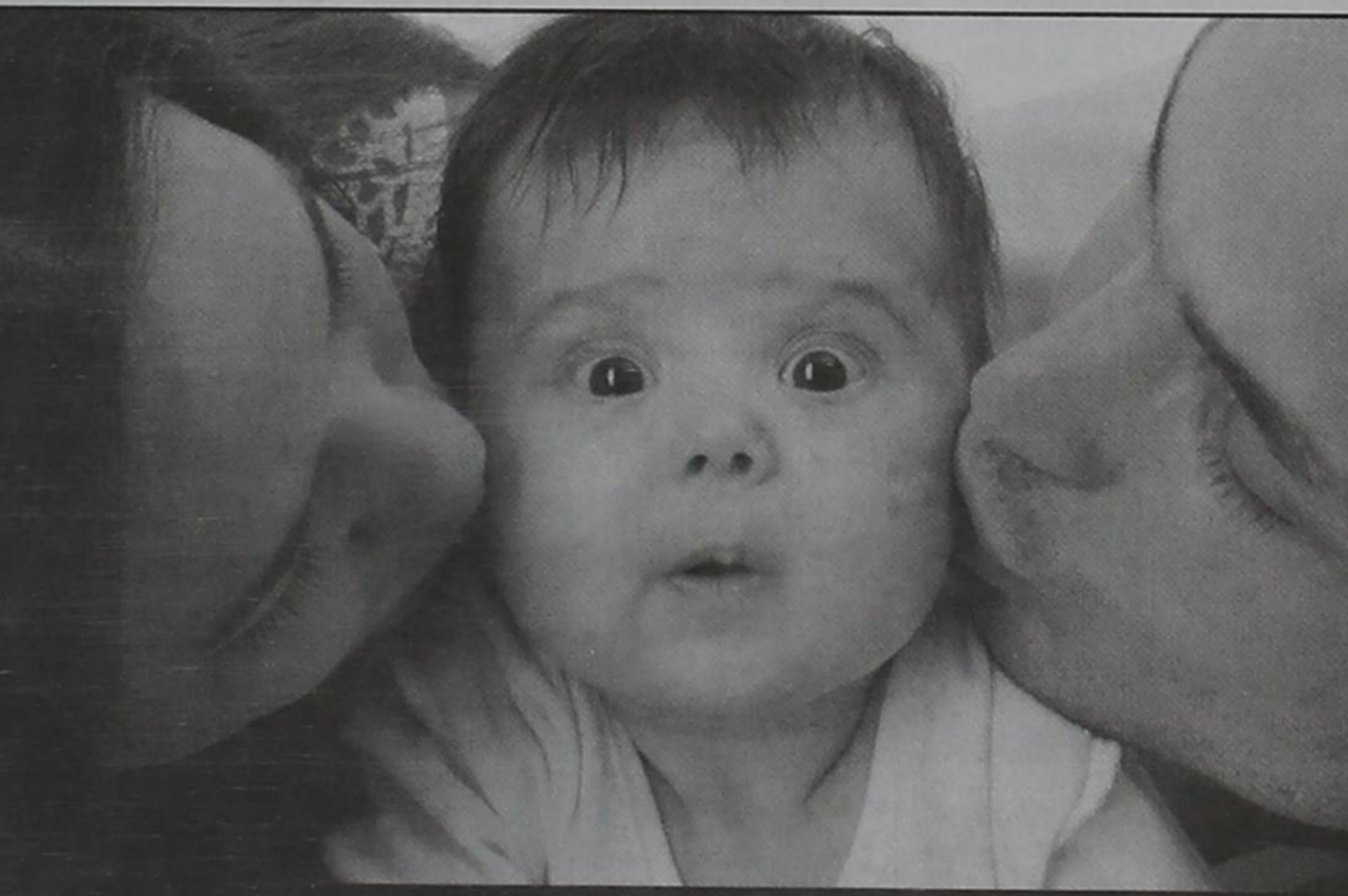
