

Rockwall's Got Talent scheduled for January

It's time for the third annual Rockwall's Got Talent talent show.

Auditions by appointment only will be conducted at the Rockwall Community Playhouse, 609 E. Rusk, on Jan. 5-6. Registration is \$20 per act. Semi-finals will be at 7 p.m. Jan. 11, with finals at 7 p.m. Jan. 18. Prizes include \$1,000 for first place (donated by Community Bank), \$500 for second (donated by Texas

Presbyterian Hospital) and \$250 for third place (donated by North Texas Appliance).

Applications can be downloaded at rockwallcommunityplayhouse.org.

The showcase for gifted entertainers is the brainchild of Rockwall Community Playhouse's board of directors.

Rockwall Community Playhouse, founded in 1995, is located in a tiny East Rusk Street building formerly used as a church. The theater has an entertaining season of musicals, dramas, comedies, children and teen shows each year. Since the auditorium seats just 84, the experience is intimate and after each performance, everyone is invited to the stage to visit with the actors. For the past 18 years, the plays have been chosen to suit the small venue.

In 2006, RCP launched a capital campaign, and with the help of the community, recently paid off the note on a tract of land purchased for a new theater complex. Plans are under way to develop a roomier building on Airport Road. The structure will be large enough to seat 300 people and to store props, sets and costumes. There will be plenty of space for parking, and the facility will allow more flexibility in the type of production that can be staged.

One way the board envisioned to raise money for the project is to showcase the best of the town's performers in a competition with cash prizes. The goal is not only to raise money, but to shine a light on the gifted population of Rockwall, as well.

Last year's winner, Amber Carrington, had a great time during the process.

"It was very cool to meet everyone in the competition," she said. "I was honored to win, because I've lived in Rockwall

since I was in fourth grade and loved representing my city with what I love to do."

Carrington sang Beyonce's song "Listen" for the competition.

"I usually prefer country music," she said. "But I decided to try something different for Rockwall's Got Talent.

Although she has been singing for 10 years, she's never had a vocal lesson.

"I have a musical family, so I guess it's just in my blood," she

said, adding that the best thing about participating in the talent show was that it gave her the confidence to pursue singing as a profession. MOW Senior Services needs financial assistance

Recent cuts in federal and state funding, as well as an increase in the need for local services, has put Meals on Wheels Senior Services of Rockwall in urgent need of financial assistance.

During this calendar year, the agency provided more than 45,000 meals for homebound seniors and the disabled in Rockwall County, in part by local government funding, fundraisers and private donations, according to a MOW news release.

The purpose of the MOW Senior Services program is to keep seniors living independently by providing noontime meals and offering additional support services.

"For many of them, the only person they see all day is the volunteer driver, providing the opportunity for early intervention in life-threatening situations," said Margie VerHagen, executive director of the agency.

To absorb the funding reduction and eliminate the need to implement a waiting list, MOW Senior Services needs community support. There are several ways this can be accomplished, including:



Jesus learned meekness and humility toward God...

The birth of our Lord Jesus involved extremely dynamic events that were unmatched until the death and resurrection of Jesus.

From a precise study of Jesus' conception and birth by harmonizing the Gospels, we can see how Jesus learned through his years how to be meek and humble toward his Father God.

Luke's Gospel reveals the heart of Mary.

"And the angel came in unto her, and said, Hail, you that are highly favored, the Lord is with you: blessed are you among women." God



looks upon the heart, and he knew that Mary would believe His word. It continues, "And when she saw him, she was trouble at his saying, and cast in her mind what manner of salutation this should be." Like any of us, she wondered about what she had heard.

A beautiful part of this record is that God knew in advance that Mary would believe His word. He told her in advance what was to happen. It's also important to note that the name of Jesus is more accurately translated from Joshua which meant God is with us. God was also with Israel through Joshua the son of Nun.

"Then said Mary unto the angel, 'How shall this be, seeing I know not a man?' And the angel answered and said unto her, 'The Holy Ghost shall come upon you, and the power of the Highest shall overshadow you: therefore also that holy thing which shall be born of you shall be called the son of God.""

Please notice the open communication between Mary and the angel who was speaking for God. She asked reasonable questions and the angel answered according to God's will.

"And behold, your cousin Elisabeth, she has also conceived a son in her old age: and this is the sixth month with her, who was called barren.""

Lukes Gospel also covers much detail about the events surroundin fork the birth of John.

"For with God nothing shall be impossible." These words from the King James Bible are more accurately translated "For with Go no word shall be void of power." The angel told the truth, which that any word from God shall not be without power and is absolutei believable unto great and dynamic results.

Next Mary meekly and humbly replied, "'Behold the handmaid of the Lord; be it unto me according to thy word." Without a doubt. would have been at this time when she conceived Jesus.

The Gospel of Matthew reveals how Joseph meekly acted on th word of God that came to him in a dream, and took Mary to be h wife.

With these accounts and more, we can see Jesus' parents were pe fect examples for him to learn from.

Because Mary and Joseph faithfully raised Jesus according to God will, he was prepared to perfectly respond to the great anxiety th: beset him before his terrible suffering. 

Fowler's new book released this month

People all over town want to know where they can get a copy of Sheri Fowler's new book published by Arcadia Publishing titled simply "Royse City." The book came out on Dec. 3.


"I have a passion for history, particularly Rockwall County," Fowler said.

This is the third book she has published in the Arcadia Publishing Images series. The first one was "Rockwall, Texas" published April 2009 and the second was titled "Rockwall (Then and Now)" which came out in January 2011

"Royse City" is filled with more than 180 photographs and history, carrying the reader through the growth of Royse City from the late 1800s until the 1950s. Cotton was the major industry that encouraged so many families to move to this small north Texas town. People in the next town of Fate even put their houses and businesses on logs or rollers and pulled them by oxen to relocate in Royse City.

The photographs and history were compiled from the archives of the Rockwall County Historical Foundation, the archives of the Royse City Zaner Robison Museum and from private collections.

Fowler's book tells of the early settlement of Royse City and how the arrival of the Missouri-Kansas-Texas Railroad from Dallas to Greenville caused the sudden growth of the town. The pictures depict the more than 20 businesses from hotels to cotton gins, and even a furniture store that were established in the town.





Mr. Whittle has filed bankruptcy multiple times over the year ROC with the most recent being March 2010 relating to the Harbo development in Rockwall. In March 2010, Mr. Whittle's Harbe development owed over \$223,000 in delinquent property taxes

Mr. Whittle is currently delinquent thousands of dollars i property taxes on numerous properties he owns in Rockwall Count and the City of Heath. Some of those properties are Buffalo Cree Tennis Village, Bison Meadows Lane, Hubbard Drive, and other too numerous to list.

Mr. Whittle's promises of property tax revenue to the City of Heat on a futuristic development are unreasonable when he is unable t pay the property taxes on his current properties. 

From the American Declaration of Independence:

When in the Course of human events it becomes necessary for one people to dissolve the political bands which have connected them with another and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. - That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. 



"We played well in stretches," said Gabbard, looking for silver linings. In the third quarter, RHHS scored more than half of its points and was outscored just 19-13.

"They're a very good team," the coach said of Rockwall. "They shoot the ball well. They're unselfish. They're disciplined. They have 8-9-10 (offensive sets). Jackets head for district play without Thomas

Rockwall won one game, and lost another game and a player last week. A day after defeating Garland Naaman Forest 68-57 Tuesday, Dec. 11, the Yellowjackets found out the next day that 6-foot-9 sophomore center Elijah Thomas was withdrawing from RHS. He later enrolled at Dallas Prime Prep Academy.

Without Thomas, the Jackets then lost last Friday's game 55-47 at Lovejoy to fall to 10-5. They were scheduled to host Coppell Tuesday before Friday's District 12-5A opener at Tyler Lee. That will be their last game until the post-Christmas Avery Air Invitational at McKinney Boyd.

Before the eventful week, RHS had played in another prestigious tournament, winning three games before losing in the Bob Hayes Jaguar Classic quarterfinals at Austin LBJ.

In that tournament, Rockwall defeated El Paso Americas 64-36, Austin St. Andrew's Episcopal 64-57 and Houston Girls & Boys Prep 64-24 to advance the tournament's single-elimination rounds. Houston Westbury Christian rallied in the fourth quarter for a 49-46 victory over the Jackets.

Against Westbury, RHS missed 7 of 17 free throws. Thomas led the team with 16 points; Austin Grandstaff added 15. Thomas averaged 21.8 points per game, and Grandstaff scored 16.5 per contest in the tournament.

Thomas left averaging 22.1 points in his 14 games for the Jackets. After scoring 30 points at Lovejoy, Grandstaff now is averaging 20.1. In Thomas' absence, Grandstaff now leads the team with 7.3 rebounds and 0.9 blocks to go along with his RHS-high 6.3 assists and 0.8 steals per game.
