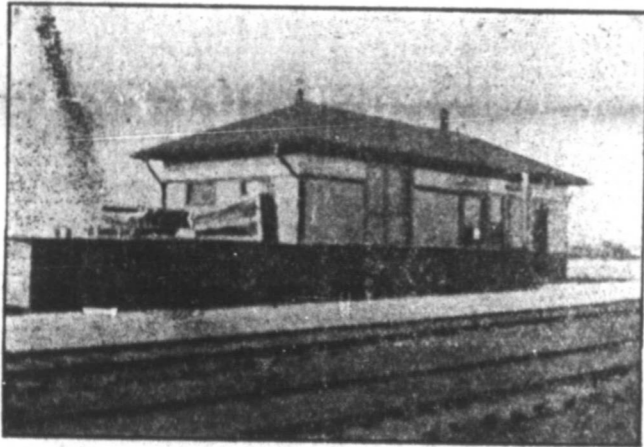

The Association was much pleased this summer to receive from Mr. C. A. O'Keefe, through the organizer or the Association, Mrs. M. B. Smoot, a cash gift of thirty dollars to be used in this worthy cause. Such a kind remembrance merits the heartiest appreciation of our entire people, who trust that happiness be theirs in their new home.

Though the constitution and by-laws prohibit the Association receiving any funds from entertainments of any kind, the membership fee is only twenty-five cents a month, to which every person should belong, thereby enabling the ladies to constantly make improvements and beautify the grounds. It must a comfort to people far distant who have loved ones sleeping here, to know their mound is gently looked after by a band of gentle women, and many times their gratitude has found expression in checks to espouse the cause. May their good work continue that sad hearts may be comforted and the sacred spot be so beautified as to lift one's thoughts to the eternal beauty in the garden above.

Does Not Want to Sell.

Mr. J. B. Farmer, an extra good farmer, who lives up on the Snyder road, called on The Record early this week and brought with him a sample of farm products that are simply a credit to any county on earth. In speaking of the wonderful advancement of this country Mr. Farmer said it had not near reached the top, and that his land was worth \$30 per acre and if any body doubted it and would come out there and see what he had raised and could raise he would convince them that his farm was far better than any black land place in Central Texas. Mr. Farmer is a diversifier and is experimenting with quite a number of different crops. He has introduced the Brazilian Yam Kershaw, outrivaling the famous pumpkin yam potato, and is worth many times more than the potato. He has planted this year a large acreage in goober peas and actually has more hog feed and hay on this land than any one would believe. He says this is a fine hog country, and for poultry it cannot be equalled. Any prospector who will read this and then visit Mr. Farmer's place will be convinced that this is the garden spot of the world. It might be well to say Mr. Farmer does not want to sell.

Thinks We Are Over Grown.

W. A. Smith, of Corsicana, a wealthy citizen who has been for a number of years in the retail, then in the wholesale mercantile business, spent last week here prospecting and is this week up in the Snyder country. Mr. Smith is looking out a location to start his boys in business and he himself desires to go into the real estate business but seems to think that this country has already advanced too rapidly and too far. His argument is that land is priced too high, is beyond its value, yet we can produce more per acre of everything and do it easier than on the Navarro county land, and their price is \$50 to \$60 per acre. Mr. Smith regrets that he did not know of the existing circumstances in this country a year ago. So do we; but The Record firmly believes the opportunity is yet here for investment. He says, "yes, we read all about your country all last year but did not believe it, had no idea that things were like what I know they are." "Why," says he, "if the Navarro people knew what I now know they would come out here in car loads." He then expressed fear of another drouth and doubted the propriety of an investment now. The trouble with Mr. Smith was he was looking for \$3 and \$4 per acre land, but he waited too long.

CITATION.

YOU ARE HEREBY COMMANDED to summon Charles J. Canda, Simeon J. Drake, Daisy Strauss, both individually and as Executrix of the Estate of William Strauss, deceased, and Charles H. Strauss as Executor of the Estate of William Strauss, deceased, all of whom reside in the City and State of New York, and are non-residents of the State of Texas, by making publication of this Citation once in each week for four successive weeks previous to the return day hereof, in some newspaper published in your County, if there be a newspaper published therein, but if not, then in any newspaper published in the 32nd Judicial District; but if there be no newspaper published in said Judicial District, then in a newspaper published in the nearest District to said 32nd Judicial District, to appear at the next regular term of the District Court of Mitchell county, to be holden at the Court House thereof, in Colorado, on the 17th Monday after the first Monday in September, A. D. 1906, the same being the 31st day of December, A. D. 1906, then and there to answer a petition filed in said Court on the 21st day of August, A. D. 1906, in a suit, numbered on the docket of said Court No. 1084, wherein A. P. Rohret is Plaintiff, and Charles J. Canda, Simeon J. Drake, Daisy Strauss, both individually and as the Executrix of the Estate of William Strauss, deceased, and Charles H. Strauss, Executor of the Estate of William Strauss, deceased, are Defendants, and said petition alleging that Plaintiff is a resident of Taylor County, Texas; that each and all the Defendants are residents of the City and State of New York; that the Defendants, Daisy Strauss and Henry S. Strauss, are the duly qualified and acting Executors of the Estate of William Strauss, deceased, and the Defendant, Daisy Strauss, is the sole devisee and legatee under the will of the said William Strauss, as duly made and probated in the proper Court in the State of New York and in the County Court of Mitchell County, Texas, as by law provided.

That heretofore, to-wit—on August 1st, 1906, plaintiff was lawfully seized and possessed of a certain tract or parcel of land, containing 320 acres, lying and being situated in the Counties of Mitchell and Howard in the State of Texas, and known and described as the South one-half (S. 1-2) of Section No. Five (5), in Block No. Twenty-nine (29), Township One North, of the Texas & Pacific Railway Company surveys, located by virtue of Certificate No. 2-1671, issued to said railway company, holding the same in fee-simple, and was in possession thereof.

That on said day and date, to-wit, August 1st, 1906, the Defendants unlawfully entered upon and dispossessed said Plaintiff of said premises, and withhold from him the possession thereof to his damages in the sum of Five Hundred Dollars (\$500.00).

That the rental value of said premises is One Hundred Dollars per annum. That plaintiff claims said land by and under a deed from Charles J. Canda, Simeon J. Drake and William Strauss to F. A. Winn and Mrs. Mattie Winn, dated July 14th, 1890, and recorded in the Deed Records of Mitchell County, Texas, in Book 7, on pages 600 to 603, inclusive, and a Deed from F. A. Winn and wife, Mattie Winn, of date of July 6th, 1906, which is recorded in the Deed Records of Mitchell County, Texas, in Book 19, on page 248, and the payment of each and every one of the nine (9), purchase money notes, described in the deed from said Canda, Drake and Strauss to F. A. Winn and Mrs. Mattie Winn, each of said notes being for Ninety-six (\$96.00) Dollars, and bearing interest at the rate of six per cent per annum from their date, which was July 14th, 1890, whereby said vendor's lien retained in said deed and in said notes to secure their payment was fully discharged and extinguished.

And Plaintiff avers that the claim of the defendants consists in an alleged ownership, of said nine purchase money notes given by said F. A. Winn and Mrs. Mattie Winn, to said Charles J. Canda, Simeon J. Drake and William Strauss as part payment for said land, and of the vendor's lien upon and against said land to secure their payment retained both in said deed and said notes as aforesaid.

Wherefore, premises considered, Plaintiff prays that the Defendants be cited in terms of law to appear and answer this petition, and that on final hearing he do have judgment for the title to and the possession of said premises, for the cancellation of said vendor's lien upon and against said land, for his costs and damages and rents aforesaid, and for such other and further relief, both general and special, legal and equitable, as he may show himself entitled to.

Said petition being endorsed as follows: "This action is brought as well to try title as for damages."

For a fuller statement of Plaintiff's cause of action, reference is hereby given to the Plaintiff's original petition now on file in said Court.

Herein fail not, but have before said Court, at its aforesaid next regular term, this writ, with your return thereon, showing how you have executed the same.

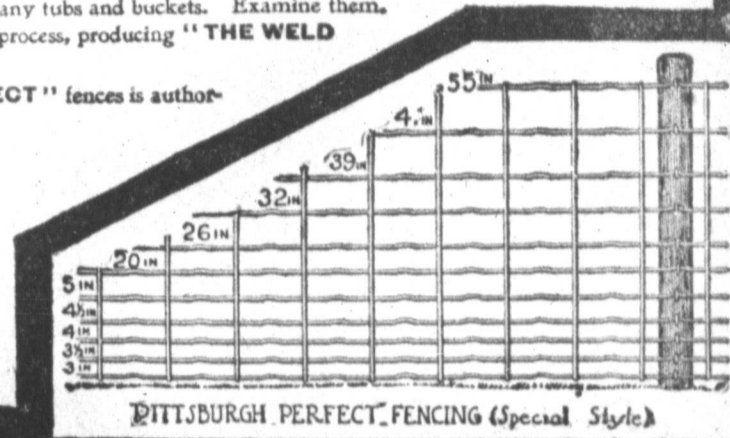

That government ownership cudgel wherewith Mr. Bryan was going to bruise the head of the trusts, has been a boomerang, that cracked his own pate.

Before many years Texas will be gridironed with railroads like Ohio and Iowa. It is said that there is not a spot in either state where the whistle of a locomotive can not be heard.

Mexicans are being imported in great numbers to pick cotton in sections where negroes can't be had. Tho not so fast as the negro, the greaser is cleaner and more careful as a cotton picker.

If you have never thought about whether a laundry would pay in Colorado or not, figure its 2500 population at 25c each per week for 52 weeks in the year more than \$32,000. A snap awaits some enterprising man.

If we enjoyed the blessings and advantages of an incorporated municipality, there are several things that would come to pass which do not now exist. We would have a more sanitary condition of the entire town—public streets, alleys and private premises would be kept cleaner, or somebody would be fined.

The prosperity of every industry and of every individual in the community, means your prosperity to a certain extent. Each one is an integral part of the whole, and whatever effects one, has an influence on all. In trying to tear down a competitor, you are but digging under your own foundation.

Have you considered the importance of good country roads? A town with bad sidewalks or dangerous ones, is as badly handicapped as a county with almost impassable roads. "All roads led to Rome" because they were good ones. All roads in Mitchell county will lead to Colorado if we'll make good ones.

The bureau of road inquiry of the United States has estimated that the average cost of transportation over an ordinary dirt road is 25c per ton per mile. It is reasonable to assume that the average length of the tributary haul to the railroad, is at least 4 miles. This makes the average cost of every ton of stuff the farmer delivers to the railroad \$1.00.

An east Texas exchange avers that Hon. Cone Johnson is after the "job of filling the seat of Chas. A. Culberson in the U. S. senate." It is preposterous to say that he is after the place, but to even mention Johnson's "filling" Culberson's seat, is the limit of absurdity. He'd rattle around in it like a mustard seed in a drum.

The great revolution, which was to have been inaugurated in Mexico, on the 15th, by killing all the foreigners, failed to materialize; in fact there were fewer disturbances on that day than have ever been reported during the celebration of the day of national independence.

The farmers of west Texas are face to face with an anomalous condition on the labor question. Never were the crops as large, and never was labor as scarce and consequently, as high. The great activity in all kinds of construction work at good wages, will keep many out of the cotton field. Unless a fairly good price is maintained for the cotton, it will cost as much to have it picked as the cotton will bring.

Don't whine. The world shuns the whiner, with his confession of defeat. It means that you can't hold your own in the race, and have dropped out of ranks. It means that you haven't the courage to meet difficulties and surmount them alone. It's an evidence that you know yourself beaten and are trying to attach the blame to an "unappreciative world." But the world has no use whatever, for a failure, and whining is but a confession of failure. Every living person has troubles enough of his own and very little patience with yours. If you would have them respected, keep them to yourself.

When the United States paid \$7,200,000 to Russia in 1869 for Alaska, the majority of our own statesmen said we had been bled and that Russia had gotten rid of a worthless possession. But it has proven a very profitable investment. Before the wonderful discoveries of gold, the annual revenues from the seal fisheries amounted to as much as the territory cost. Besides gold there are other minerals in abundance and the finest quality of anthracite coal. The white population is increasing very fast, railroads are being pushed into the interior, and the people are now asking for representation in congress and the privilege of selecting their own governor.

So serious has the insurrection in Cuba become that the United States is sending several war ships there, both to protect American interests and prevent filibustering. Americans are joining both the government and insurgent forces, which alike are offering \$2.50 a day in gold pay. Dispatches say that President Palma has decided to abdicate soon, and ask Uncle Sam to settle the matter.

The enthusiasm of the advocates of spelling reform as ordered by the president, 'has been given a knock-out blow. Some book worm has brought to light an act of congress in 1881 making Webster's dictionary the standard of spelling and pronunciation in all government printing or written transactions.

The town grows apace, but our public advancement does not keep up with private improvement. Many of the newly opened streets, on which are neat and attractive homes, are disfigured in many places by quite a growth of mesquite and other vegetation, detracting greatly from the looks and desirability of the houses.

During the past three months 374 people have been killed by railroad wrecks alone, and more than 1100 more or less injured. For several years the number of deaths by railroad wrecks in the United States have averaged about 1000 per annum, while in England, there was not a person killed by the railroads in any way during two years. The English cars are much lighter than ours, they run much faster and carry no headlight on their engines. But their tracks are so solid, and their system of block signals so perfect that danger of wrecks is reduced to the minimum.

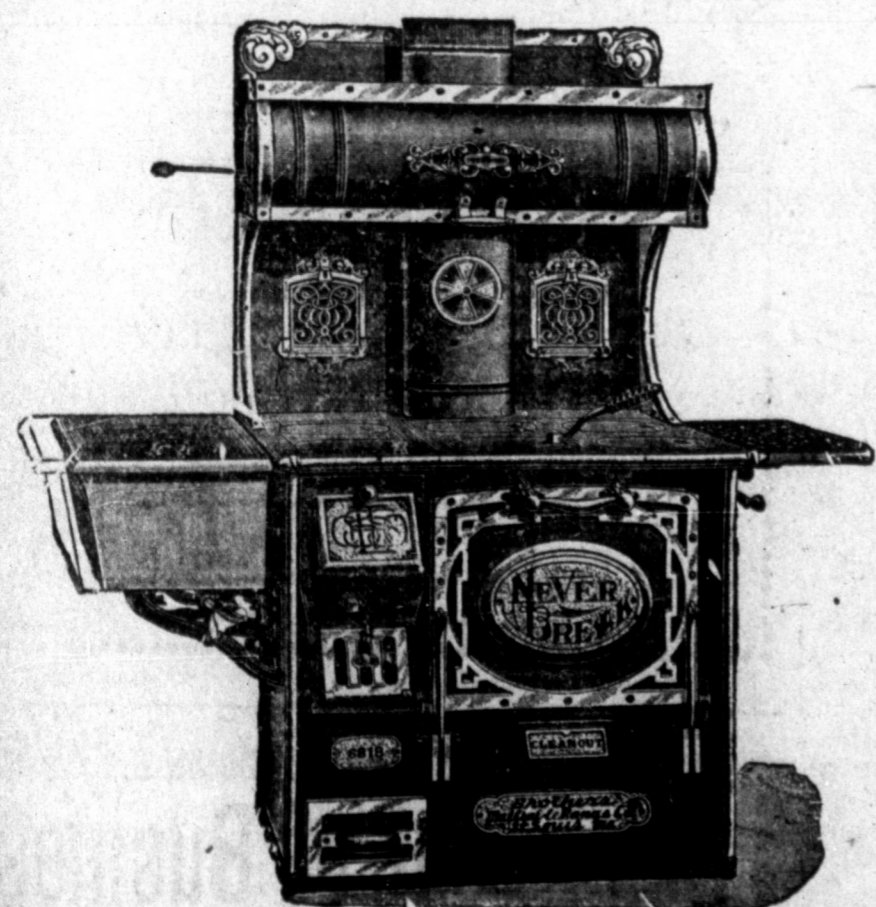

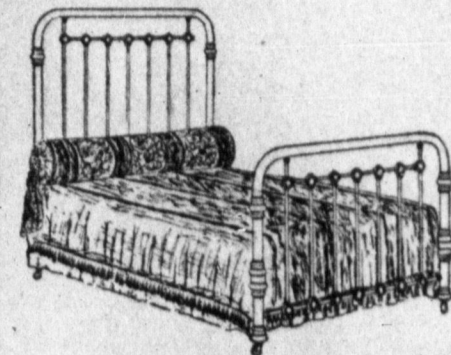

STILL JABBING AT WEST TEXAS.

A keen observer said to me last week: "Do you know that the most gigantic speculation today is not in Wall Street stocks, not in the various cotton and grain exchanges, but in land—the raw lands of West Texas especially. Under favorable seasons and with a heavy influx of settlers from Northern States who are misled in estimating prices by the standards of the more thickly settled communities from which they come; lands have doubled in value in the course of a few months. The infection has spread every where; people have simply gone wild on the subject. It is like a gambling mania. The next drouth that comes will witness loss, suffering, ruination."

It is undoubtedly true that values have gone up at a dangerous rate. The reaction from the collapse of a boom brought about by over-inflation is an unpleasant and costly experiment. Fortunes will be made, and possibly fortunes will be lost. This is a time when a man should rely on his own judgment rather than risk that of another—a time when he should resist the sheep instinct in the average human being. There isn't a bit of need for advising against over-caution—risk nothing, gain nothing; but there is, against making rash decisions. The old Dutchman's warning is in point—"Better look a leedle oudt."

MUST CLEAN UP THE TOWN.

Colorado, Texas, Sept. 13, '06.

We, the undersigned members of the Board of Health of Mitchell County, Texas, recognizing the absolute necessity of removing certain nuisances that are a menace to the public health, urge a general cleaning up of the town of Colorado, and especially the removal of all hogs from the thickly settled portions of town.

Each householder should clean the alleys and streets adjacent to his own premises. All privies, mudholes and obnoxious spots on the premises should be disinfected with lime.

The town is divided into six districts, as follows:

District No. 1. Starting at Lone Wolfe bridge and running west on second street to the river bridge, embracing all that part of Colorado between Second street and the T. & P. railway track.

Dist. No. 2. All territory in town between the T. & P. railway track and the Colorado river.

Dist. No. 3. All north of Second street and west of Elam street.

Dist. No. 4. All north of Second street and between Elam street and Lone Wolfe creek.

Dist. No. 5. All East Colorado, north of the railway track.

Dist. No. 6. All of South Colorado.

The chairman of the said Board of Health shall appoint one physician to inspect one district for a period of two months from date of appointment, at the end of which time each district shall be placed in charge of another member of the said Board.

It shall be the duty of each member of the Board to report in writing any unsanitary condition existing within the district assigned to him for inspection.

The Chairman shall call a meeting of the Board at any time it may be necessary.

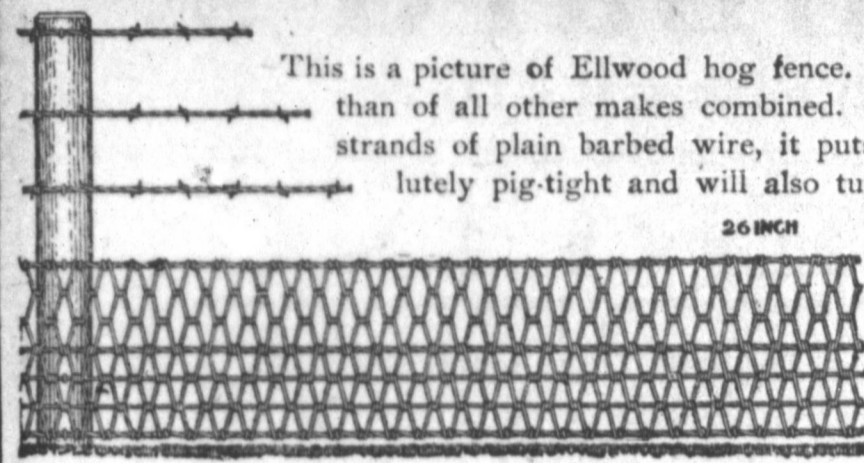
On and after September 20th, 1906, any person failing to comply with these regulations shall be reported to the Health Board, through its Chairman, the county Health Officer. It will then be the duty of the Health Board to file complaint in the proper court that said nuisance or offense against the public health may be abated through a due process of law.

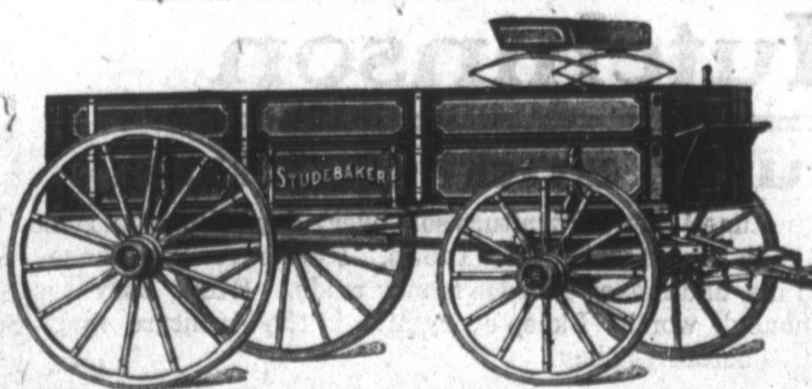

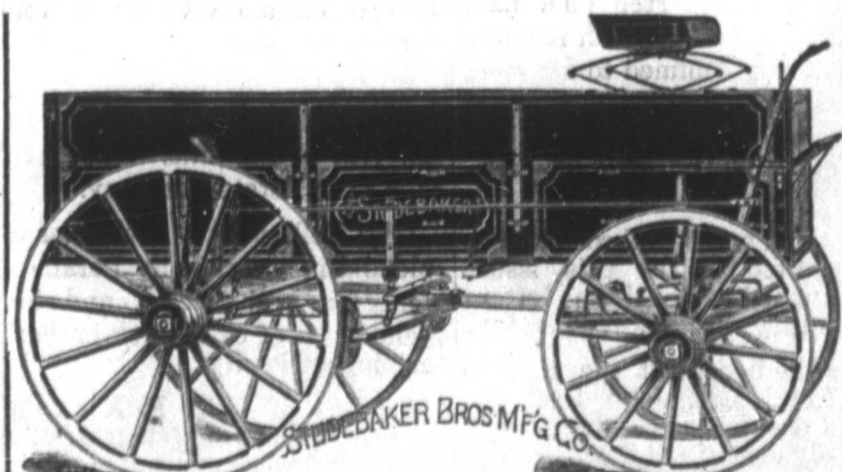
