Voting Opens April 12

The College Trustee run-off election has been set for Saturday, April 29th. If you are a resident of the South Plains Junior College, and Plains Junior College District, and expect to be absent from the District on April 29, you may vote absentee by personal appearance in the County Clerk's office, Court-Levelland, Texas, house, starting Wednesday, April 19, and ending Tuesday, April 25, at 5:00 P.M.

To be qualified to vote absentee, you must have been registered with your respective Tax Assessor-Collector's office of Hockley and Cochran County for at least 30 days prior to election day.

Also those persons who are confined to their homes or hospital, due to illness or physical disability, may vote absentee by mail, provided they make formal request by mail either by personal letter or official application, requesting the County Clerk to mail them a ballot for absentee voting purposes. The applicant by mail, must sign their request in the same signature that appears on their voter registration certificate. Also the applicant by mail, must list their voting box number, certificate number, and return address, either permanent or temporary, to which Clerk is to mail ballot. An affidavit from the applicants Doctor must accompany the request for ballot, stating that the applicant is unable to come to the polls on election day and vote in person, due to their illness or physical disability. When the application is received by the County Clerk, with the proper information given, and with Doctor's certificate, (or affidavit), then the Clerk will mail the applicant the requested material for voting absentee. The ballots will be mailed out starting on the first day of absentee voting, (same being, April 19.) Deadline for receiving the ballot back by mail from the voter will be 5:00 P.M., April 27. All persons 18 years of age or older, having qualified by thirty days or more residence the District, having in registered 30 days or more prior to April 29th. may vote in this election either by absentee or at the polls on election day. Persons residing in Hockley County or that portion of Cochran County that is located in the Whiteface Independent School District may vote in this election.

Visits Ropes

Sheriff Weir Clem has been taking a little time off from. the busy duties of his office and visiting the people and telling them he would like to serve them another term as sheriff. Court has been set for two weeks of the campaign, and makes it extremely difficult for him to let the voters know he is running for re-election.

The Texas Department of Corrections, in an effort to actively combat the growing drug abuse problem, has initiated a program which attempts to strike at the heart of the drug problem by demonstrating what can happen to the drug abuser. "Operation Kick-It," a panel of four inmates, has been touring the state since June, telling the story of drug misuse before Junior and Senior High School Assemblies.

Through this program, the inmates are enabled to speak directly to the public and present their simple message-"Illegal drugs are dangerous. Drug abuse is against the law and you can go to prison for it. We did."

The four volunteer panelists are young, first offenders, age 17-21. Each was convicted for possession of marijuana, one for the sale of drugs.

Each inmate tells briefly about his home life, how he began using drugs and the events leading to his arrest.

"Operation Kick-It," which is funded by a grant from the Governor's Criminal Justice Council, is similar in format to the highly successful "Operation: Teenager," which was established by TDC in 1962. The purpose of this program is to combat crime among youth by presenting an inmate's story of his own road to crime.

The appeal of "Operation Kick-It' is straightforward and sincere. As one inmate panelist summarizes it, "Down at the pen, it's the simple things that count. Don't ignore the simple life, because that's where it's at." This has been recommended for 7-12 grades and this

official application to the County Clerk in writing, asking the County Clerk to mail them a ballot and necessary papers to their permanent address or their temporary address, if they are confined to the hospital. The person desiring to vote absentee by mail must give their name, voting precinct number, voter registration certificate number, and return address. Also, they must sign the letter or official application. If husband and wife are requesting a ballot for absentee voting, they must make separate applications and sign the request by separate signature. The signature must be the same as the name on their voter registration certificate. Also, those persons sick or disabled and request a ballot by mail must have their Doctor sign an affidavit attesting to the fact that the applicant is unable to appear in person at the County Clerk's office, due to sickness or physical disability.

Again, the absentee voting period for the First Primary Election, (County and State Officials). will start April 17th, and end at 5:00 P. M. Tuesday, May 2nd.

In order to vote in this first primary, a person 18 years old or older and a County resident for thirty days or more, must have registered in the office of the Tax Assessor-Collector by 5:00 P. M., April 5th.


