DPS investigates 14 accidents in Hockley County

The Texas Highway Patrol investigated 14 accidents on rural highways in Hockley County during the month of November, according to Sergeant H. E. Pirtle, Highway Patrol supervisor of this area.

These crashes resulted in four persons killed and 17 injured.

The rural traffic accident summary for this county during the first eleven months of 1971 shows a total of 95 accidents resulting in six persons killed and 77 injured.

The rural traffic accident summary for the 60 counties of the Lubbock Department of Public Safety for November, 1971, shows a total of 576 accidents resulting in 20 persons killed and 292 persons injured. This was 19 less accidents, one more fatality, and two less injured than during October.

The 20 traffic deaths for the month of November, 1971, occurred in the following counties: Hockley, four; Lubbock, Palo Pinto, Hansord and Oldham, two each; Bailey, Carson, Childress, Lipscomb, Moore, Terry, Wheeler and Wilbarger, one each.

Census bureau to survey nine types of farms

Shortly after the first of January 1972, the Bureau of the Census will be mailing out "type of farm" survey report forms to a selected group of farmers.

There will be nine different survey forms used. One each for cash grain, tobacco, cotton; potatoes, sugar and other specialized field crops, vegetables, fruit, livestock, dairy and poultry.

Each form is designed to collect information pertinent

to that particular type of farm enterprise. Each form is designed by sections so that if the answer to the lead question is "no" the farmer may skip to the next section.

The trends shown in the 1969 Census of Agriculture indicate that there is an increasing degree of specialization. The completion of the "type of farm" survey report forms will help obtain a truer and more complete picture of this specialization and may set the pattern for future censuses of agriculture.

Cooking Cabbage

Cabbage should be cooked the shortest time possible and with as little water as necessary, advise Extension foods and nutrition specialists. That's the way to save it's high nutritive values.


