Carrie Ethel Moore Blackwell was born on July 10, 1897 in Shanks, Texas. She and her family later moved to Cleburne, Texas. On May 17, 1917 she married Oliver Page Blackwell. Ethel and Ollie moved to the Texas Panhandle near Groom and began their life together. And what a life! They had six children, Guy, Page, Evelyn, Ina Faye, Clona and

Ruth, followed by seventeen grandchildren, forty-one great grandchildren and thirteen great great grandchildren. In 1967, the lively, loving couple celebrated their fiftieth wedding anniversary.

As in any lifetime, there are also hardships, grief, and loneliness. Ethel has faced these adversities many times during her 92 years of life, living during World War II and the depression as

well as losing loved ones such as, her husband, Ollie, two children, Ina Faye and Guy, a daughter-in-law, Lucy and four grandchildren, Floyd Dale, Dee, G.G. and Greg have preceded her in death. receiving new roofs.

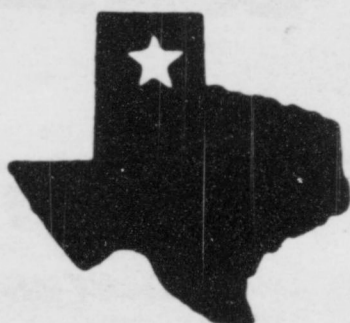
Groom received approximately 2 hundredths of an inch of rain Sunday night in

PRPC Proposes 9-1-1 System

The emergency number concept was introduced in England in 1937. In the USA, it was first used in Alabama in 1968. Since then, more than 1500 communities have implemented the three-digit emergency 9-1-1 number nationwide. Fifty of those systems are in Texas.

Two years ago, a committee of the Panhandle Regional Planning Commission (PRPC) was asked to identify pressing health concerns for the region. It was agreed the biggest problem was emergency health communications. As a result, the PRPC board of directors appointed an advisory committee for emergency communications and the planning process began.

The process included resolutions from each city and county supporting the planning commission's planning effort.

As a result of the planning, 22 locations for public safety answering points (PSAPs) around the Panhandle region have been identified. Although most of them are to be located in the dispatching offices of county sheriff's offices, a few are to be placed in police department dispatching centers.

The 24-hour staff in each PSAP will answer all 9-1-1 calls for the geographic area served by the PSAP. That means, regardless of where the caller is — in town or in the country — only the

three numbers have to be dialed. Existing 7-digit numbers in the Panhandle will not be affected by the new service. The 9-1-1 system will be faster because only those three digits will have to be dialed.

Each PSAP will be equipped with a monitor which will list the calling number. The automatic number identification (ANI) unit will also allow the dispatcher to hold the number on the screen even if the caller has hung up. The dispatcher can either call back and get further information or send

a law enforcement officer to investigate.

In some cases, calls for one county may first be answered in an adjoining county and then transferred. This is because it is less expensive to put telephone exchange offices together in a PSAP than to try to design a system which would stay strictly within county boundaries.

Speed and simplicity are the biggest advantages of 9-1-1, according to PRPC. Regardless of where a person is in the Panhandle dialing those three digits will bring an immediate answer for any emergency, whether it is police, fire or ambulance.

The number is especially critical for small children who might be at home alone when a crisis occurs. It's also important for someone

who might not be able to speak once they have dialed the number.

Under legislation passed in 1987, counties of less than 120,000 population may

join a regional 9-1-1 system. In each county and city, the elected officials are being asked to pass a resolution which directs their telephone

company to add fifty cents to the monthly phone bill.

That money will be used by PRPC to design and implement an emergency

communications system for the region. It will take about two years to install the

system and will cost approximately \$1.5 million. Slightly less than \$1 million will be raised through the monthly fifty cent fee. The rest will come from a surcharge on intrastate long distance calls which will be collected statewide.

Commissioners Consider Salary Increase

Carson County Commissioners received an overview of possible salary increases to be considered in the 1989-90 fiscal budget when the met in regular session Monday morning, July 24. All commissioners were present for the session, along with Judge Roselius, County Treasurer Peggy Butler, County Clerk Sue Persons, County Auditor Agnes Bell, County Tax Assessor-Collector Lloyd Sterling, Greg Rapstine and Jerry O'Neal of White Deer, and Jeri Osborne and Betty Biggs of Panhandle.

The salary charts given to each commissioner were prepared by Judge Roselius from figures discussed in the July 11th Court meeting as they were applied to current salaries of all county employees. No action was taken

on any budget items as work on the proposals is still in its early stages.

A discussion was held on Senate Bill 328 enacted by the 71st Legislature to become effective August 28, 1989. The bill allows the County to add up to \$10.00 on each vehicle registration. Noting that a \$5.00 fee was initiated just one year ago, and that it seems to be a sufficient amount, Commissioners voted to leave the fee at the current \$5.00 level.

Judge Roselius informed the Court that Carson County has been named as a Natural Disaster Area by the U.S.D.A. and that an emergency loan program is available for eligible farmers and ranchers in the county. Emergency loan applications will be received through February 26, 1990 for August 14 at 10:00 a.m.
