# Majority of Hispanic Pulse Survey Respondents Say DeLeon Should Not Be Recalled; Tasers not Safe

By Abel Cruz In an effort to gauge public opinion, El Editor sent out an invitation to a diverse segment of the community inviting them to share their opinions with us about several issues which

have been in the news lately. The issues ranged from renaming a Lubbock street after Cesar Chavez to whether they felt Councilwoman Linda DeLeon should be recalled.

While a higher percentage of respondents felt that she shouldn't, it was closer than we had suspected when we decided

to include the question. 55%% of respondents felt that DeLeon should not be recalled; with 39% saying that she should.

This would seem to indicate that there may be enough dissatisfaction with DeLeon for recall organizers to successfully gather the required number of signatures to force a recall election. What is hard to gauge is just how much her support has eroded since she was re-elected to office in 2006 with close to 70% of the vote. Our results

by Bidal Aguero Lubbock voters were faced and some will again be faced with a hard decision. The election for City Council District 3 has been staged now for ten days

during early vote and polls will again open this Saturday. To date only 1,356 have voted out of

20.098 that are registered. In our opinion only two people have addressed the real issues involved in the election and we tend to say that this election does not only involve precinct 3 but the entire City of Lub-

bock. We say this because at present the Lubbock City Council seems to be going through a tumultuous time in which Citizens have lost confidence in their Council and are wondering what will happen next and how will

it affect our City. By this we mean that having meeting that violates the open meeting laws, having an insurance company that refuses to hand over information and having some citizens of Lubbock conducting a recall for one of the Council members can made the City wonder what is happening and what will happen next.

Those two people are Todd Klien and Kevin Glasheen.

Mr Klien has certainly address the needs of District three and has shown his concern for the area in which he is running. In his statement of purpose Mr. Klien says

"I believe that what matters in politics is what you pledge to do for the people you will represent and not getting lost in petty partisan bickering and division, that we need more citizens involved in the process, that we need someone who understands the needs of regular folks and the importance of making a budget and sticking to it, if you think that it is time for reinvestment of your hardearned tax-dollars back into your district then I am your man."

In an interview with El Editor, Mr. Glasheen stresses and overall look at working to improve our City. He stresses that what is needed is to concentrate on infrastructure and not letting our City become run down. One of Mr. Glasheen's main objectives is to redevelop downtown. He says that downtown could be a tax revenue producing area that would help the City overall.

So who would the citizens of district three be better represented by? Again to us the question is not who would better represent district three but who would help the City come out of its present situation of chaos. Who would be the stronger individual that would lead Lubbock out of this chaos? Knowing both persons personally we can say that both are capable and ready to tackle our City's problems. For this reason we would let you decide. We would suggest that you look hard at both candidates and decide to vote for either Glasheen or Klien. If there is a run-off perhaps we will

have to look harder.

would seem to indicate that DeLeon might have enough District 1 voter support to beat back a recall election.

The issue though seems to have awakened some strong sentiments, at least among some of our respondents.

Another question dealt with the District 3 race which became necessary after the resignation of Councilman Gary Boren. For the most part, respondents see it as a 2 man race; between Todd Klein and Kevin Glasheen. In this race, respondents think Glasheen should win; but not necessarily by a large margin. 48% of respondents think Glasheen should win with 39% going with Klein. At least one respondent pointed out that:

"I would like Todd Klein, but here in Lubbock money talks and it seems that the man with the most word\$ is Kevin Glasheen." Indicating perhaps that in today's politics, people are politically

> savvy enough to know that more often than not, more campaign contributions translates to victory at the polls. Glasheen has raised close to \$19,000 while Klein has managed to raise close to \$5,000.

Another voiced their support for Glasheen saying: "I think Kevin Glasheen will win. He is the

best qualified by far.' It came as no surprise that respon-

# SHANTI'S CALLING: NO MORE DEATHS

Hispanic Link News Service HOUSTON- One of the few times I saw Shanti Sellz was two summers ago. A tall, striking brunette barely into her 20s, the college coed was attending a memorial service for a migrant woman who had baked to death in the Arizona desert.

When photographer Wilhelm Scholz and I arrived at the Arizona-Mexico border south of Tucson, 177 migrants had already died that year in this rough, dry terrain. We were reporting from both sides of the political divide about how people see and experience unauthorized border crossings.

Days before, two volunteers with the humanitarian group No More Deaths had been arrested. Shanti and companion Daniel Strauss had followed a protocol worked out with the Border Patrol while rendering aid to nine persons. Three of them were seriously dehydrated. One was throwing up, which under the summer sun is a dangerous sign. Some had blistered feet.

Shanti and Daniel gave nutrients and water, rendered first aid and received instructions to evacuate those who needed medical attention. Later the Border Patrol arrested the couple on a felony charge of "transporting illegal aliens" and conspiracy. A misdemeanor charge was eventually dropped. They faced a possible 15 years in prison in the indict-

ment. Their defense team was joined by former Arizona Supreme Court Chief Justice Stanley Feldman. Amnesty International expressed to U.S. authorities its concern about the arrest.

A year later, September 2006, a federal judge dismissed the charges. Humanitarian efforts like those of Shanti and Daniel are not against the

Meanwhile, through last year's Sessenbrenner bill, Congress was attempting to prohibit humanitarian efforts like those of Shanti and Daniel. Fortunately, public opinion has moved a light-year forward. Yet, to a large extent those responsible for human trafficking over the border go mainly undetected and the economics that encourage people to leave

their homes go unattended. Governments' failures, on both sides, are often at fault. And the blame is often placed in the wrong direction. The current delays in enacting immigration reforms further stimulate inappropriate responses.

In Oklahoma, for instance, Democratic Gov. Brad Henry is weighing whether to veto a bill that would allow state and local law enforcement to detain persons solely for their presence in the United States. It proposes to cut off jobs and benefits for illegal immigrants.

It includes criminal penalties for people who knowingly transport unauthorized immigrants, and restricts government benefits to them except for medical emergencies.

Similar laws were passed in Georgia and Colorado last year. Such laws cast a wide dragnet. Police officers can become the arbiters of society. Stop and frisk scenarios are obvious. Out go "probable cause" protections embedded in the Constitution.

Of course, such legislation will not stand up in the long run. But in the short term a lot of harassment and havoc and fear will permeate our diverse social fabric.

In fact, that might be their only purpose. With each passing day, Congress appears more interested in public posturing for the next election round than legislating the right public policy. The humanitarian issue that arose two summers ago about border

crossings can become a neighborhood problem when local leaders take a national matter into their own hands. Immigration issues are used to divide us for political gain and not for the purpose of forming a "more perfect union.". More public heroes will arise perhaps to make things right again, but not from the political ranks. That's why everyone should take special note

that Shanti Sellz and Daniel Strauss were this year's recipients of the prestigious Oscar Romero award of the Rothko Chapel in Houston. These college students decided to donate half of the \$20,000 award to the humanitarian group No More Deaths.

## LA VOCACIÓN DE SHAN-TI: NO MÁS MUERTES José de la Isla

HOUSTON-Una de las pocas veces que vi a Shanti Sellz fue hace dos veranos. Una morena alta y llamativa de veintepocos años, la universitaria asistía a un servicio conmemorativo de una mujer migrante quien se había calcinado en el desierto de Arizona.

Cuando llegamos el fotógrafo Wilhelm Scholz y yo a la frontera entre Arizona y México al sur de Tucson, ya había fallecido ese año 177 migrantes en este terreno áspero y árido. Nosotros reportábamos de ambos lados de la división política cómo las personas ven y experimentan el cruzar la frontera sin autorización.

Días antes, dos voluntarios del grupo No More Deaths (No Más Muertes) habían sido detenidos. Shanti y su compañero Daniel Strauss habían seguido un protocolo coordinado de antemano con la patrulla fronteriza al asistir a nueve personas, de las cuales tres estaban seriamente deshidratadas. Una vomitaba, lo cual bajo el sol de verano es una señal de peligro. Algunas tenían los pies ampollados.

Shanti y Daniel proveían nutrientes y agua, cuidados primarios y recibían instrucciones de evacuación de los que necesitaban atención médica.

Más tarde la patrulla fronteriza detuvo a la pareja con un cargo de delito mayor de "transportar a extraños ilegales" y de conspiración. Un delito menor se eliminó, eventualmente. Se enfrentaban con 15 años de cárcel en el proceso de acusación.

Se unió a su equipo de defensa anterior Procurador General del Tribunal Supremo de Arizona, Stanley Feldman. Amnistía Internacional expresó a las autoridades estadounidenses su preocupación con la detención.

Un año más tarde, en septiembre del 2006, un juez federal desestimó los cargos. Los esfuerzos humanitarios como los de Shanti y Daniel no infringen ninguna ley. Mientras tanto, durante el proyecto de ley de Sessenbrenner, el Congreso quería prohibir

los esfuerzos humanitarios como los de Shanti y Daniel. Por fortuna, la opinión pública ha avanzado un año luz. No obstante, en gran parte los responsables del tráfico humano en la frontera operan sin ser detectados y la situación

económica que lleva a que las personas dejen su hogar sigue sin ser atendida. Los fracasos de los gobiernos, de ambos lados, son los que muchas veces tienen la culpa de esto. Y se dirige la culpa, muchas veces, en dirección equivocada. La demora actual en

promulgar reformas migratorios estimulan más las respuestas impropias. En Oklahoma, por ejemplo, el gobernador demócrata, Brad Henry, sopesa si vetar un proyecto de ley que permitiría que el estado y agentes policíacas locales detengan a las personas por la sola razón de su presencia en los Estados Unidos. Propone eliminar em-

pleos y beneficios que reciben los inmigrantes ilegales. Incluye penalidades criminales contra las personas que a sabiendas transportan a inmigrantes sin autorización, y restringen los beneficios de gobierno que les toca, salvo en caso de emergencia médica.

Leyes similares fueron promulgadas el año pasado en Georgia y en Colorado. Estas leyes proyectan una red barredera muy amplia. Los agentes de policía pueden convertirse en los árbitros de la sociedad. Lo obvio sería la realización de detenciones y registros corporales. Al tacho van protecciones de "causa probable" enraizadas en la Constitución.

Claro que tal legislación no durará largo tiempo. Pero a plazo corto, mucho acoso y pánico y miedo infundirán nuestra tela social tan diversa.

En realidad, aquélla podrá ser su solo propósito. Con cada día que pasa, el Congreso aparenta estar más interesado en posturas públicas para la próxima ronda de elecciones que en legislar políticas públicas justas.

El tema humanitario que surgió hace dos veranos sobre el cruzar la fronteras podría convertirse en un problema de barrio cuando dirigentes locales se hacen con un asunto de responsabilidad federal. Los temas de inmigración los usan para dividirnos en pos de ganancia política y no con el propósito de formar "una unión más perfecta".

Es posible que surjan más héroes públicos para arreglar las cosas de nuevo, pero no saldrán de las filas políticas. Por eso que es todos deben prestar especial atención en que este año Shanti Sellz y a Daniel Strauss recibieron el premio prestigioso Oscar Romero de la Capilla Rothko en Houston.

Estos universitarios decidieron donar la mitad de los \$20.000 al grupo humanitario No

#### El Editor, Week of May 10-16, 2007 RELAX - DON'T WORRY-THECHECKS IN THE MAIL

OK. So let's say the city finishes installing their "money making one-eyed bandits" and things are moving along with tickets being issued left and right. They or the contractor American Traffic Solutions (ATF) issue ticket after ticket after ticket. And then one day they look up and realize that a lot of folks haven't been paying their \$75 dollar fine. Since it is a civil fine and there is no criminal penalty, my guess is that a whole lot of folks might just decide not to pay.

The question then becomes; who will be put in charge of collecting "the 30 pieces of silver"? Jere Hart; Lee Ann Dumbauld; the LPD; will the city create a whole new department they'll have to pay salaries to, to collect the fines; American Traffic Solutions?

Never mind that they completely denied the will of the people; and designated themselves as the sole arbiters, judge and jury. Against the wishes and better judgment of the majority of Lubbock residents, (except for the local AJ editorial board which is so out of touch they seem to think this is a good idea) the Mayor, City Manager Dumbauld, Jere "the red light hitman" Hart, and those council members who voted for this disaster waiting to happen, will soon find out that it's easy issuing tickets; it's the collecting part that will prove to be the most difficult. Come to think of it, the editor at the AJ might want to ask some of the newspaper's carriers just how easy it is to collect.

Or, just ask the city of Houston.

Houston has a contract with the same company the city contracted with, American Traffic Solutions (ATS). In Houston if a person gets a citation for running a red light and fails to pay the fine, ATS passes the debt on to an independent collection agency for collection. Most of the time, independent collection agencies will agree to collect the bad debt in return for a certain percentage of what they collect. They are then free to add additional charges such as a collection fee to make the transaction more profitable for them; to list the debt on a person's credit record, and to create general havoc in a person's life. Keep in mind that the person who will be ultimately responsible will be the vehicle owner; which could mean that the owner's credit may be affected even though they may have not been driving the vehicle.

I have no idea if the uncollected fines, which will surely happen here, will be turned over to a private collection company; but it wouldn't surprise me to know that they will or it wouldn't surprise me if Jere Hart and Co. didn't even think about this "minor detail". But we don't know because this particular issue was never discussed in a public forum; at least as far as I know. It may have been discussed in one of those closed door sessions which the city claims did not violate the Texas Open Meetings Act; or maybe at one of Mr. Price's town hall meetings where a quorum of the council was present?

But considering that at least 4 of the cameras will be installed at streets that intersect with I-27, it would not be a stretch to assume that a lot of the traffic going through these intersections might be just passing through. In addition, has anyone ever noticed the large number of New Mexico license plates on Lubbock streets? Do you think out of town drivers will be in any hurry to pay their \$75.00 fine; especially if there's no criminal penalty? And what about those who are in rental cars? Or those who trade their car in after getting "one eyed"? Do the words "the checks in the mail" mean

anything to you?

What is more galling about this whole thing

is the outright refusal of anyone at city hall to respond to media questions or to communicate with the very people they either were elected to represent or who pay their salary. Here's a good example from a local radio

station web site:

"News Radio 1420 contacted Lubbock traffic engineer Jere Hart who refused to comment for this story (about red light camera fine collections). He said the written news release (the release announcing the start of installation) was all that the city wanted to say on the issue."

"Refused to comment"? As city employees neither Mr. Hart, nor Ms. Dumbauld or anyone else involved in this issue gets to decide if they want to comment or not. It is their responsibility and obligation to respond; it is their job to answer these questions so that media outlets can inform the public about what to expect.

All this "secrecy" they engage in, and that's exactly what it is, no need to gloss it over, only invites more questions and makes people conclude there is something they do not want us to know. They act as if they're in a "Father Knows Best" episode and we should all be good little citizens, not ask any questions and go sit in our corners; they seem to think that we should just stop asking questions and go away.

One last thought. If you go online and visit the city's web site; you will read these two statements on the

Mayor's page:

"As elected officials, city employees, and community volunteers, it is important to always remember that we are here to serve our fellow citizens. We must accomplish this objective with modesty, enthusiasm, and the desire to be exemplary in word and deed"

And in an acronym I suspect the Mayor came up with, he states that the letter "I" in the acronym SPIRIT stands for "Integrity - to be forthright and honest in our dealings with the public, other organizations, and each other." And that's how, many Lubbock drivers, might eventually feel as those council members who voted in favor of red light cameras finally get their wish.

The city has quietly placed a news item on their web site announcing the beginning of the installation process of red light cameras.

"Construction and installation of the first 10 red light cameras at Lubbock intersections is set to begin May 10. Camera systems are being installed at the following locations." The statement goes on to list the 10 locations, saying that the installation will be complete at the first 3 locations by June 1 and that construction of the 7 remaining sites should be completed by July 1.

What is missing from the announcement is just when the switch will be flipped and when the cameras will start rolling. And also, why there have only been 10 locations designated instead of 12 as originally planned by the council.

If one was to speculate, it's probably related to the inability to find intersections where enough drivers run red lights to make the cameras pay for themselves; a problem that was discovered after the council voted to approve the camera's installation.

# Richardson races to gain Hispanic recognition

Poll shows majority of Latinos unaware of governor's heritage

If Bill Richardson's mother had been an American banker and his father had been the son of a prominent Mexico City clan, things might be different. As it is, the native Spanish-speaking presidential candidate with an Anglo last name faces a challenge convincing Hispanic voters that he, too, is Hispanic.

`For all the Latinos here, I want you to know that I'm Latino," Richardson said in Spanish at a recent campaign stop in California, according to a report by New American Media, a coalition of ethnic media outlets. "I can't con-· vince people with this last name."

Richardson has repeated that he's running not as a Hispanic candidate but as a "mainstream candidate" who is proud of his heritage. He's also repeated that he's running on his resume and not as "a rock star" like Democratic front-runners Hillary Clinton and Barack Obama.

But in the Hispanic press, Richardson has celebrity status.

At campaign stops in Texas, Spanish outlets arrived en masse.

He's been featured heavily on media such as Telemundo, which asked in one segment whether America was ready for "a Mexican" in the White House.

In Los Angeles, he made history by giving a half-hour radio interview in Spanish to popular radio host Eddie "El Piolin" Sotelo. Univision anchor Maria Elena Salinas greeted him with a . kiss at a convention of Hispanic journalists and wrote a boosterish column about him, "El Presidente Richardson," on her Web site. In New York, Spanish radio station owners hosted a fundraiser for him.

America Rodriguez, a professor of radio and television at the University of Texas at Austin, said Richardson's heritage and fluency in Spanish boosts him out of third-tier status for her and other Latinos.

`When it gets around to election time, we usually hear these candidates speaking this horrible Spanish," said Rodriguez, author of the book Making Latino News. "For Latinos to be hearing someone who speaks our language correctly is very exciting."

'That's what makes him interesting to me," said Rodriguez, who is Cuban American. "Otherwise, he's just another mainstream Democrat."

Despite the Spanish media's excitement over having a candidate who can handle more than `si se puede" and other tired slogans; Richardson has an uphill battle ahead of him with Latino voters, according to one recent national poll.

More than half of Latino voters in 23 states said no Latino was running for president. Only a quarter recognized Richardson as a Hispanic in the race.

The survey of 1,000 voters was conducted during March by Lake Research Partners, a nonpartisan polling firm. It found Hillary Clinton to be the favored Democratic candidate among Latino voters, with 60 percent saying they would vote for her while 9 percent favored Richardson.

And Richardson can't count on votes even among Latinos who recognize him as Hispanic, according to the survey. Richardson's numbers improved among Latinos who recognized him as a Hispanic candidate, but even among those voters, he still trailed Clinton, according the poll.

Clinton recently hired heavyweight Raul Yzaguirre, formerly director of the National Council of La Raza, to direct her outreach

to Hispanics.

That strategy makes good sense, as does Richardson's efforts to reach out to Spanish speakers, said Jim Gonzalez, chairman of the Latino Policy Coalition, which commissioned the poll.

"At this point, Clinton has a lot to protect, and Richardson has a lot to gain," said Gonzalez, whose group represents 14 Latino think \*tanks across the country.

Gonzalez said the poll shows Richardson shouldn't count on getting the Latino vote just because he's Hispanic. "It's not that simple. But as more Hispanics start to learn about him, they're going to be interested in looking into his record."

However, in some circles, Richardson faces an opposite challenge: to convince non-Hispanics that he is a `mainstream" candidate. As the first major Hispanic presidential candidate, Richardson has to walk a tightrope, according to Charlton McIlwain, an assistant professor of culture and communications at New York University who studies the role of race in the media and politics.

"He's playing up his Hispanic roots primarily to appeal to Hispanic voters, but the downside of doing so is that other voters may see that as a negative," said McIlwain, co-author of the blog "This Week in Race."

"In areas of the country where you rarely see Hispanics in prominent positions, voters see minority candidates as being out to represent only minority interests," McIlwain said. "That is the challenge he will face moving on to the national stage."

Richardson ran into a bump on that front recently, when he said he hadn't initially called for the resignation of Attorney General Alberto Gonzales because Gonzales is also Hispanic. Richardson said he wanted to give Gonzales the benefit of the doubt, and he was speaking candidly and not as a "blow-dried" candidate.

The influence of Latino voters is growing. They are expected to make up 8.6 percent of the electorate in 2008 compared to 8.2. percent in 2004 and 7.4 percent in 2000, according to the Pew Hispanic Center in Washington. Latinos have historically turned out in proportionally lower numbers than other ethnic groups.

But the Latino vote is poorly understood, Gonzalez said. "People make wild statements about the Latino vote based on very little evidence. A lot of people just guess."

Such statements were the motivation for Gonzalez's group to conduct polls with much larger samples of Latino voters than had previously been done, Gonzalez said.

The poll found that Latino voters were motivated by pocketbook issues and frustration over the war in Iraq. They gave Bush low ratings and are trending Democratic.

The move by states to "frontload" the primary schedule could make Hispanic voters more influential as states with large Latino populations such as California and Nevada vote earlier in primary elections. Richardson spokeswoman Katie Roberts said it's a mistake to assume Hispanics will be attracted to Richardson solely because of his heritage.

"It's very wrong for a candidate to take any constituency group for granted. He knows he has to earn every vote."

She pointed to a recent endorsement by Hispanics in Politics as evidence the campaign is making inroads.

# Hispanic Groups Protest Immigration Raids

More than 100 Hispanic organizations sent a letter to the White House denoucing raids targeting illegal immigrants and blaming the enforcement actions for a "humanitarian crisis" in the immigrant community.

Addressed to President George W. Bush, the missive's intent was to express "outrage" and "deep concern" over the effect that the raids have had on the Latin American community in recent months, especially on minors.

The groups called on Congress to approve immigration reforms that addressed the realities of the U.S. labor market.

Approximately 3.1 million children born in the United States have at least one parent who is in the country illegally, according to estimates, while some 1.8 million other youngsters live in this country "without papers."

In the letter, the organizations

called on the federal government to take into account the negative impact of the raids on U.S.-born children, who are separated from their parents.

"Workplace raids leave a long-lasting impact, not only on the local economy, but on the children who are separated from their parents as a result of a raid," the letter released Monday said.

Although in many cases U.S. Immigration and Customs Enforcement officials allow single parents to remain free to care for their children, "there are many parents who are transported to ICE detention facilities far from their homes."

After a raid, churches, schools and social service agencies find themselves scrambling to figure out where the parents are and provide for the needs of minors who are practically abandoned, the organizations said.

The letter noted the problems caused by a recent raid in New Bedford, Massachusetts, where a dehydrated baby had to be hospitalized because her mother was detained and could not feed her.

"Our children deserve better, and it is up to the Administration and Congress to deliver to them a sound immigration policy that does not result in parents being separated from their children," the organizations said.

Among the more than 100 signatories from across the United States were the National Council of La Raza, Casa Maryland, Phoenix-based Emigrantes sin Fronteras, the Latino Economic Development Corporation and the Hispanic Chamber of Commerce of Minnesota.

The U.S. Senate plans to begin debate on immigration reform legislation on May 14.





# De La Hoya-Mayweather richest fight in history



Turns out the obituaries written for boxing were a bit premature.

Oscar De La Hoya's fight with Floyd Mayweather Jr. set a record for most televised buys for a fight, according to figures released Wednesday, surpassing Mike Tyson's second fight with Evander Holyfield and making it boxing's richest event.

A total of 2.15 million households paid \$54.95 for the fight,

generating revenue of \$120 million. The previous record set by Tyson-Holyfield was 1.99 million buys.

A person close to the promotion said De La Hoya would end up making about \$45 million for the fight and Mayweather just over \$20 million. That person requested anonymity because the promoters did not want official figures released.

The \$45 million would be the biggest purse paid to a fighter, higher than the \$35 million purses Tyson and Holyfield reportedly were paid for the infamous "Bite Fight."

Mayweather beat De La Hoya on a split decision Saturday night in an entertaining fight that drew a record live gate of \$19 million at the MGM Grand Garden arena. Mayweather won on two of the three ringside scorecards to win the WBC 154pound title.

# Francona advises pitcher to curtail comments

Curt Schilling apologized Wednesday for criticizing Barry Bonds and was advised by his manager to keep some of his opinions to himself.

The Red Sox pitcher leveled the criticism Tuesday on a radio show then backed off his remarks Wednesday in an entry entitled "Public Apology," on his blog.

"Everyone has days and events in life they'd love to push the rewind button on, yesterday was one of those days," Schilling wrote on the blog, 38pitches.com. "Regardless of my opinions, thoughts and beliefs on anything Barry Bonds it was absolutely irresponsible and wrong to say what I did. I don't think it's within anyone's right to say the things I said yesterday and affect other peoples lives in that way.

"As someone who's made it very clear I have major issues with members of the media that take little or no pride in their work it's the height of hypocrisy for me to say what I did, in any forum."

On Tuesday morning on WEEI radio, Schilling criticized the San Francisco Giants slugger, who is 10 homers short of matching Hank Aaron's home run record of 755.

"I mean, he admitted that he used steroids," Schilling said on the show. "I mean, there's no gray area. He admitted to cheating on his

wife, cheating on his taxes and cheating on the game, so I think the reaction around the league, the game, being what it is, in the case of what people think. Hank Aaron not being there. The commissioner (Bud Selig) trying to figure out where to be. It's sad.

"And I don't care that he's black, or green, or purple, or yellow, or whatever. It's unfortunate," he said. "There's good people and bad people. It's unfortunate that it's happening the way it's happening," Boston manager Terry Francona said before the Red Sox game in Toronto on Wednesday night that he urged Schilling to use more discretion.

"Schill came to me," Francona said. "We talked a little bit and I said, 'You probably just need to stay away from some of those things."

He said he'd let Schilling continue writing his blog.

"I don't care, as long as he stays away from certain things," Francona said. "It doesn't make sense. If you want to run for office some day and solve the world's problems, go ahead. Just not while I'm the manager." He also said he didn't know what a blog was until Schilling's stirred controversy and doesn't plan to read

Schilling said on his blog that his comment about Bonds "was a callous, wreckless and irresponsible thing to say, and for that I apologize to Barry, Barry's family, Barry's friends and the Giants organization, my teammates and the Red Sox organization as well as anyone else that may have been offended by the comments I made."

It wasn't so much the flash of Phoenix that ultimately beat down San Antonio 101-81 at the U.S. Airways Center, but the substance of these Suns.

It had been a night when letting the Western Conference semifinal slip away could've cost these go-go Suns future championship chases as currently constituted. San Antonio isn't just an opponent, but a threshold for Phoenix. Perhaps, this was the best these Suns have ever played against the Spurs.

"This team has a psychological hold on us," said Nash, confessing to something with which the Suns had always bristled. "Even if we don't feel it, [the Spurs] must feel it in their locker room."

Deep down, the Spurs do. They don't fear Phoenix, don't believe that finesse and flair will ever be the elixir to San Antonio's tough, tested champi-

onship pedigree. The Suns hadn't beaten the Spurs in a playoff game in the desert since Jake Voskuhl, of all people,

gotten star in Phoenix, lost in the wonder of the back-to-back MVP Nash and the powerful phenom Stoudemire, who had 27 points. Marion always feels under-appreciated, under-valued, but make no mistake: As much as anyone, he's the reason the Suns go to San Antonio for Game 3 on Saturday

with a basketball season. They could live with Tim Duncan getting his 29 points, especially when Kurt Thomas would hold him to two points in the fourth quarter. Thomas moved into the starting lineup to guard Duncan, and ultimately, his nastiness, his edge and his strength to defend Duncan in the playoffs was the reason he was brought here. The Suns didn't come with the double teams on Duncan, just spared Stoudemire the responsibility, freeing him to roam a little on defense, and left Thomas to defend Duncan alone. "Tim is so well-respected, it keeps me out of foul trouble," Stoudemire said.





# Perry Won't Veto Virus Vaccinations Bill

Gov. Rick Perry on Tuesday said he won't veto a bill that would block state officials from

following his order that all sixth-grade girls be vaccinated against a virus that causes cervical cancer.

The Republican

governor accused the state legislators of politicizing the debate over his February executive order that required vaccinations against the human papillomavirus vaccine for girls starting in September 2008.

However, he acknowledged the Legislature's overwhelming disdain for his program and said he will allow the bill to become law without his signature.

"It is time to move this issue from the political arena to the court of public opinion where real lives are at stake," Perry said.

A veto almost certainly would have been overridden by Texas legislators, who have questioned the vaccine's safety, efficacy and cost and complained that the governor's mandate would intrude on families' lives. Lawmakers also were outraged that he didn't consult with them before issuing the order.

The bill they sent to the governor last month bars state officials from requiring the shots for four years. Lawmakers could then extend the ban or allow health officials to add the shots to the list of vaccinations required for school attendance.

The vaccine protects girls and women against strains of the sexually transmitted virus that cause most cases of cervical cancer and genital warts. Merck



# Dramatic Rise in U.S. Kids Hospitalized for Type 2 Diabetes

In another sign of the alarming childhood obesity epidemic in the United States, researchers report a 200 percent increase in the number of children hospitalized for type 2 diabetes.

Type 2 diabetes, which used to be called adult onset diabetes because it was rarely seen in children, is typically diagnosed in patients who are

"Siete millones de personas en el mundo en desarrollo necesitan tratamiento por sida/VIH', dijo Clinton. "Nosotros estamos tratando de satisfacer esa necesidad con las mejores medicinas disponibles en la actualidad, y a precios que pueden ser pagados en países de ingresos bajos y medianos".

Las actividades de la Fundación Clinton son financiadas por UNITAID, una organización formada por Francia y otros 19 países que han destinado una pequeña porción de sus ingresos por impuestos a aerolíneas para programas de VIH/Sida en países subdesarrollados.

overweight. Left untreated, it can lead to such complications as heart disease, blindness, nerve damage and kidney damage.

The dramatic increase in pediatric type 2 diabetes occurred nationwide between 1997 and 2003, according to the study by researchers at New York University School of Medicine.

"The rapid rise in childhood obesity is now common knowledge," said Dr. David Katz, director of Yale University School of Medicine's Prevention Research Center, who was not involved in the study. "Increasingly, so is the concurrent rise in type 2 diabetes in children -- a generation ago, this condition did not exist. What is now called type 2 diabetes was called adult onset diabetes until quite recently."

"Epidemic childhood obesity has transformed a chronic disease of mid-life into a pediatric scourge," Katz added.

For the study, Dr. Rhonda Graves, a pediatrician, and her colleagues used data from nationwide hospital discharge records from 1997, 2000 and 2003. They compared the trends in hospitalization rates, length of stay and costs for children with type 2 diabetes and type 1 diabetes.

They found that rates of hospitalization for type 1 diabetes increased 15 percent between 1997 and 2003, while rates of hospitalizations for type 2 diabetes increased 200 percent.

"These findings, based on hospital records of a nationally representative sample of hospitals in the U.S.A., indicate that type 2 diabetes is increasingly becoming a pediatric illness that results in hospitalizations. It is associated with a very serious number of co-morbidities and complications which may have profound health implications both in childhood and in adulthood," Graves said in a prepared statement.

Graves' team also found that hospitalizations for type 2 diabetes were 1.3 times more likely for boys than girls. Children 9 to 12 years old had the highest rates of hospitalization.

The researchers also found that black, Hispanic and Native American children were at greatest risks of increasing hospitalizations.

The researchers also found that children hospitalized for type 2 diabetes were hospitalized longer than children with type 1 diabetes. Type 1 diabetes is a disease caused by the body's inability to produce insulin, and it's not related to obesity. Insulin is a hormone that converts blood sugar to energy for cells.

The findings were expected to be presented Saturday at the annual meeting of the Pediatric Academic Societies, in Toronto.

"The dramatic increase in hospitalizations for type 2 diabetes in children reported here confirms this trend and further demonstrates that it affects ethnic minorities disproportionately," Katz said.


