



Hispanic Heritage Month 2003 will provide new national exposure for the expanding U.S. Latino population. At the same time, its activist leadership plans to use the occasion to educate Latinos and the broader community alike about gnawing political and social concerns.

Thousands of local and regional events affirming Latinos' cultural roots and contributions are on tap for the celebration, which runs from Sept. 15 to Oct. 15. Many -- from a festival in Huntsville, Ala., and library displays in Dodge City, Kan., to a Mexico-style rodeo and music festival in Birmingham, Ala. -are happening in relatively new surroundings.

In Washington, D.C., and some other metropolitan enclaves, the fiesta atmosphere will provide a backdrop as Latino leaders and advocacy groups stage events to mobilize their constituencies to vote and confront civil rights, employment and educational obstacles.

The Congressional Hispanic Caucus Institute will stage its 2003 Issues Conference from Sept. 22-23 in Washington, D.C. More than 650 Hispanic elected officials, policy experts and community leaders will assemble to present and debate Latino concerns and prepare policy recommendations for the Congress and White House. "It's an opportunity to be part of the formulation process of policy-making," CHCI President Ingrid Durán says. She expects attendance at its 13 summit sessions to increase from last year's 750 to more than 900. The conference will add summits on Corporate America and Banking and Finance, as well as present its first-ever youth track.



Attendance at CHCI's 26th annual \$500-a-plate, black-tie gala Sept. 24 will top last year's 2,200 attendance, she predicts. The event aims to raise \$3.2 million.

Profits from the activities, as with events conducted by other Latino civic groups, are used to support yearround staffing and programs, such as internships, training and regional conferences.

"YA BASTA, enough is enough," concludes Flores.

In 2003, many of the same people are denying Senators who represent minority voters the same opportunity to prevent passage of a redistricting plan that would dilute and diminish the voting rights of their constituents.

"While advocacy groups worked non-stop during Texas' recently concluded legislative session to prevent budget cuts that would have harmed our Latino children, elderly, and disabled; the House and Senate leadership have forced Texas to spend almost \$60,000 a day since June 30th on their frivolouscongressional redistricting effort" said LULAC National President, Hector M. Flores.

The current effort by the leadership to redistrict without the required two thirds will force Senators who represent districts with large minority populations to go against the best interest of their constituents. "This is an attempt to force Hispanic and African American Senators to participate in a process that would threaten the voting rights of millions of Texans. In effect, it's the same thing as forcing them to vote against their own communities" said President Flores. "That is why LULAC members from across the state will rally with other Texans' at 11:30 am on Saturday, August 9th at the south steps of the Capital". LULAC takes seriously its mission to protect those who are standing up for democracy and the best interest of the Latino community. Both Democrats and Republicans have spoken. Over 90 percent of the public comment heard during the Senate and House field hearings across the state was against redistricting. This effort to redraw congressional lines must stop now.

Traficantes de Inmigrantes Van a Jucio Diez miembros de un grupo dedicado a introducir indocumentados en Estados Unidos, al que se atribuye la muerte de 19 inmigrantes abandonados dentro de un camión de remolque en Texas, deberán enfrentar un juicio en México, por delincuencia organizada y tráfico ilegal de personas, informaron esta semana las autoridades.

Un juez federal determinó que había evidencias suficientes para llevar a cabo el juicio de nueve hombres y una mujer, quienes según las autoridades, pertenecían a un grupo supuestamente encabezado por Karla Patricia Chávez, una hondureña que enfrentará un

proceso en Estados Unidos, informó la Procuraduría General de la República.

Los 10 sospechosos fueron detenidos el 8 de agosto, en una serie de redadas que las autoridades realizaron en los estados centrales de San Luis Potosí y Guanajuato, así como en Tamaulipas, en el norte.

Entre los acusados figuran Eliseo e Ismael Peralta, dos hermanos originarios de Guanajuato, quienes habrían organizado un viaje en autobús para llevar a los migrantes hasta la frontera septentrional de México, donde comenzaría la operación para trasladarlos a Estados Unidos.

Más de 70 inmigrantes, originarios de México, Centroamérica y República Dominicana, eran transportados de la ciudad de Harlingen, Texas, a Houston, en un remolque sin ventilación, la

noche del 13 de mayo.

Las autoridades encontraron a 17 inmigrantes muertos en el camión, afuera de una estación en Victoria, Texas. Dos inmigrantes más murieron hospitalizados.

Las víctimas, incluido un niño mexicano de 5 años, fallecieron por deshidratación, hipotermia y asfixia.

Según las autoridades mexicanas, Eliseo Peralta, buscado por la FBI, fue un miembro crucial de la banda traficante supuestamente encabezada por Chávez, una hondureña de 25 años detenida en junio, cuando trató de viajar de su país a Guatemala.

Catorce sospechosos, incluidos estadounidenses y residentes legales, fueron mencionados en una acusación federal emitida en junio, la cual menciona varios cargos por traslado de inmigrantes ilegales.

"YA BASTA, enough is enough," concludes Flores.

¿Donde estan las "Maravillas de un Año" de Ron Unz?

Cuando los californianos aprobaron la propuesta 227 en 1998, la cual prácticamente eliminóla educación bilingue, les vendieron la idea que los estudiantes extranjeros podrian aprender el inglés en un año.

Ken Noonan, superintendente de escuelas del distrito escolar unificado de Oceanside, California, adoptó esta premisa y apoyó la propuesta de Ron Unz. Hoy que se enfrenta con un indice muy alto de desaprobación del examen de salida de las escuelas secundarias de California de parte de los nacidos en el extranjero, Noonan explica que hemos fomentado una esperanza falsa que "una persona puede aprender un idioma en un año o dos".

Claro, es lo que los promotores de la educación bilinge han venido diciendo siempre.

comprender un libro de texto de su grado.

A pesar del alto indice de desaprobación, los titulares de los periódicos continúan repitiendo los "éxitos" del programa de inmersión. Se hacen comparaciones con los programas tradicionales de educación bilinge para mostrar que el programa de inmersión es mejor. Aunque si parece haber habido mejoras, es muy probable que éstas tengan que ver con los cambios en el sistema educativo de California de los últimos años. Los cambios incluyen clases más pequeñas y el ambiente de la fiebre de los exámenes estatales. Los funcionarios de escuelas han sentido mucha presión por producir resultados con tales exámenes. La desaprobación acarrea castigos financieros. Si las notas mejoran, ocurren premios financieros. Es inevitable, entonces, que los maestros enseñen lo que se va a examinar, para asegurar que los números se alcen. A pesar de los "éxitos" celebrados, el 92 por ciento de los niños nacidos en el extranjero no progresan lo suficiente como para pasarse a la instrucción exclusivamente en inglés después de un año de inmersión. No obstante, empiezan a vislumbrarse unos puntos brillantes a pesar de la propuesta 227. Algunas escuelas han pasado de la educación bilinge tradicional hacia convertirse en escuelas de "dos lenguas". En estas escuelas se dictan todos los cursos en dos idiomas.

Chávez en San Francisco, enseña tanto a los niños inmigrantes como los nacidos en los Estados Unidos en inglés y en español. Los niños inmigrantes no sólo retienen su español, sino que también aprenden el inglés rápidamente. Según los resultados del California English Development Test, sólo un 3 por ciento de los niños de la César Chávez tenían proficiencia con el inglés el año pasado. Este año un gran total de 38 por ciento cumplieron con los criterios.

Las escuelas de dos idiomas representan fracción una mínima de la educación estadounidense; sin embargo, sus números aumentan. Existen más de trescientas en todo el país, nueve en el distrito escolar unificado de San Francisco. Los estudiantes que reciben su educación en dos idiomas

de la educación bilingue en California, Arizona y Massachusetts, rechaza la investigación, diciendo, "No vale ni el papel sobre el que se redactó".

Unz logró vender su idea de aprender un idioma en un año como una panacea. No obstante, su iniciativa fracasó en Colorado. Alli, los opositores enfocaron la campaña en la filosofia de dos idiomas, en un intento por fomentar el bilingismo para todos los niños de Colorado.

La mayoría de los californianos carecen de la oportunidad de educar a sus hijos en dos idiomas. Sin embargo, una propuesta de ley recientemente introducida en la legislatura estatal haría que todos los niños del estado sean bilingues. Why Won't Bush Condemn **Rios Montt, the 'Central** American Saddam Hussein'?

We don't need to spend \$4 billion a month to bring a genocidal dictator to justice. Not a single drop of American or non-combatant blood needs to spill in order to punish someone universally acknowledged in the early 1980s to have gassed, tortured and killed as many people as Saddam Hussein.

Instead of sending out several naval fleets to pursue justice, all that's needed are a few airline tickets -- to Guatemala.

U.S. marshals then can simply go to the Guatemalan Congress and arrest the current head of that body, former dictator Efrain Rios Montt. But instead of pursuing justice against the 77-year-old retired brigadier general whom some call the "Guatemalan Saddam Hussein," the interventionist Bush administration responds to Montt's potential return to power with laissez-faire human rights policy. Lack of U.S. government condemnation of the former dictator places the United States in an untenable moral position and endangers the peace and people of Guatemala Following a decision on July 30, 2004, by Guatemala's Constitutional Court clearing the way for a Rios Montt candidacy, Guatemalans and human rights activist are on red alert for the renewed possibility of terrorist attacks -- by their own government. During his 17 months as Guatemala's president, Rios Montt presided over a military responsible for almost half of all atrocities committed in Guatemala over the past 30 years. But as human rights activists like Rosalina Tuyuc wasted little time warning of another potential "genocidio," the Bush administration weakly responded to the possibility of a Rios

for that matter, the entire Central American region, to perpetual neglect. Others think that former President Ronald Reagan's influence on the Bush administration guarantees that the mass graves of Guatemala will not see the light of CNN, though such sites were being uncovered at about the same time as those in Iraq.

Declassified State Department documents released by the Clinton administration in reveal that high-level 1999 U.S. officials knew that Guatemala's mass graves were created after "executions ordered by armed services officers close to President Rios Montt." On Dec. 4, 1982, President Reagan visited Central America and met with Rios Montt, whom he described as a "man of great personal integrity and commitment" who had been "getting a bum rap." Forensic anthropologists later found that three days after the meeting, Rios Montt's military slaughtered more than 300 villagers in the hamlet of Dos Erres.

Un estudio llevado a cabo por Virginia Collier y Wayne Thomas de la George Mason University en Virginia encontró que los niños matriculados en escuelas de dos lenguas rinden más que los estudiantes de programas de educación bilinge tradicionales, así como los que reciben su educación sólo en inglés. Se hicieron evidentes los resultados después de varios años de participación en los programas de dos lenguas.

A month after the massacre, Reagan managed to free military aid to Guatemala that had been frozen in Congress because of human rights concerns.

Many of the same people who crafted Reagan's policies and pronouncements in Central America now shape Bush policy in Iraq. The high moral tone of current Bush administration discourse has its roots in Central America policy by way of high-level policymakers such as former Reagan administration assistant secretary of state Elliot Abrams, who was largely responsible for U.S. policy in Central America in the 1980s. Abrams is now senior adviser on the Middle East at the National Security Council.

The re-emergence of Rios Montt puts the Bush administration in a quandary. Silence in the face of his past crimes looks bad. But bringing attention to Rios Montt's legacy risks the exposure of decades of U.S. support for genocide in Central America. Human rights advocates continue efforts to put Rios Montt on trial for crimes against humanity in Nuremberg-style proceedings. Bush must call on Montt to withdraw his candidacy and submit himself to international tribunals or face arrest. Rios Montt and his cronies threaten a peace already paid for with the lives of hundreds of thousands of innocents in Guatemala.

Where Are Ron Unz's "One Year Wonders"?

When Californians approved Proposition 227 in 1998, which virtually eliminated bilingual education, they were sold the idea that foreign-born

In spite of this high failure rate, newspaper headlines keep repeating the "successes" of the immersion program. Comparisons are made with traditional bilingual education programs to show that things are better with the immersion approach. Although some improvements seem to have occurred, it's quite likely that these have to do with changes made in California's education in the last several years. These include smaller class sizes and the climate of testing fever. School officials have been under a lot of pressure to produce results on tests. Failure to do so brings financial punishments. If scores improve, rewards occur. Inevitably, teachers are forced to teach to the "test" and prep students to make sure the numbers go up. In spite of any touted "successes," 92 percent of foreign-born kids are not progressing enough to shift to English-only instruction after one year of immersion. Yet some bright spots are beginning to emerge in spite of Proposition 227. Some schools have switched from traditional bilingual education to become "dual-language" schools. These teach all subjects in two languages.

Spanish and English. The foreign-born kids are not just keeping their Spanish alive, they are also learning English at a rapid rate. According to

setts, dismisses this research, saying, "It's not worth the paper it's written on."

Unz managed to sell his idea of learning a language in one year as a magic bullet. Yet his initiative failed in Colorado. There, his opponents focused their campaign on the dual-language philosophy, attempting to develop bilingualism for all of Colorado's children.

students could learn English in one year.

Ken Noonan, superintendent of Oceanside Unified School District in California, subscribed to that premise and supported Ron Unz's proposition. Now, faced with a high rate of failure in the California High School Exit Exam by foreign-born students, Noonan explains it by saying that we have built a false hope that "a person can learn a language in a year or two."

Of course, that's what supporters of bilingual education said all along. Research findings confirmed that it takes foreign-born students about five or six years to learn the language well enough to be able to have a chance at competing educationally with kids who have spoken it all their lives.

The promise of Proposition 227 has clearly not been kept. Five years after its passage, California's foreign-born children are not learning English in a year. Statistics by the California Department of Education reveal that only 32 percent of those in the immersion program can speak basic English. Of these, only 7 percent can

César Chávez Elementary School in San Francisco, one such school, teaches both im-

results from the California English Development Test, only 3 percent of the pupils at César Chávez Elementary were proficient in English last year This year a whopping 38 percent met the criteria.

Dual-language schools represent a tiny fraction of U.S. education; yet their numbers are growing. There are more than 300 across the country, nine of them in the San Francisco Unified School Districtalone.

Students educated in two languages develop a mental agility that monolingual children, lack. Their intellectual development is confirmed by research. A study conducted by Virginia Collier and Wayne Thomas of George Mason University in Virginia found those boys and girls in duallanguages schools outperform students in traditional bilingual education programs, as well as those educated in English only. The results become evident after several years of being involved in the dual-language programs.

Education is not a short-term affair.

Ron Unz, who successfully spearheaded the anti-bilingual

Most Californians don't have the opportunity to have their daughters and sons educated in two languages. Yet a bill recently introduced in the state legislature would make every child in the state bilingual. Written by Sen. John Vasconcellos, the proposal is part of the new California Master Plan for Education. Students would begin the study of a foreign language in the elementary grades and continue it into high school.

In essence, California would do what many industrialized nations around the world have been doing for years. But until this program is implemented statewide, parents need to lobby their local school districts and request dual-language schools for their kids.

Being bilingual is a gift not only for immigrant kids, but for those born in the United States, as well, even if it takes more than a year.



Casi cualquier cosa menos el sentido común, por lo visto.

Los \$2.5 mil millones representan el presupuesto anual de Departamento de Justicia Criminal de Texas (TDCJ por sus siglas en inglés). Hace poco, los funcionarios ded TDCJ anunciaron que limitaciones sobre el presupuesto les han obligado a despedir a cientos de consultores de recreación, recorter el personal de la división de libertad condicional y de otras formas recortar gastos innecesarios debido a una crisis financiera a nivel estatal. Con todo esto, resulta más que sorprendente leer que la agencia profesa la voluntad -no, las ganas -- de gastar miles de dólares para llevar a la corte un prisionero por vender sus escritos. El periódico San Antonio Express-News reportó el último 11 de mayo que el prisionero tejano William Bryan Sorens había sido encontrado culpable frente a una audiencia de la prisión por operar un comercio -- el escribir artículos por un estipendio. ("la redacción del prisionero lo tiene cumpliendo una condena más larga"). Los funcionarios del TDCJ no alegan que los artículos de Sorens fueran incendiarias ni difamatorias, ni que incitaran la violencia ni apoyaran la revolución, sino

que estaban los funcionarios enfadados que Sorens escribiera y recibiera dinero por ello. Esto a pesar del hecho que miles de prisioneros del TDCJ comercian con la artesanía que fabrican y un sinnúmero más dibujan y venden su arte, muchos en galerías del mundo libre. El fiscal Carl Reynolds, haciendo alusión a las siniestras consecuencias penalógicas por permitir que la creatividad de Sorens siguiera ilesa -- consecuencias menos penosas, por lo visto, cuando los guardias compran monturas, espuelas y hebillas de los artesanos encarcelados -- juró que el TDCJ está dispuesto a abrir un caso judicial y que ganaría. ¿Qué importa si la agencia en penuria económica tuviera que pagar los costos judiciales? Se había violado una regla y Sorens debía pagar, por temor a que otros prisioneros decidieran ganarse un dinero honesto. Vamos a considerar esta situación. Nuestra sociedad alienta a sus ciudadanos a ser elocuentes y alfabetos, de reunir en un total coherente sus pensamientos y opiniones para poder presentarlos de manera concisa y llamativa. No se encuentran estas habilidades muchas veces en la cárcel, y el estado gasta millones de dólares por año mediante su sistema educativo para inculcar estos mismos atribu-

"La respuesta más simple quiza sea... que los nacionalistas iraquíes están furiosos de que invadimos su país, y que van a bombardear a nuestras tropas y a todos aquellos que nos ayuden", dijo Donovan.

Pero sugiere que es muy comprensible si Al Qaeda o miembros de la Yihad, partidarios radicales del fundamentalismo musulmán, están detrás del último bombazo en Irak. Al Qaeda, afirma, tiene una historia de "no respetar a Naciones Unidas y de atacar blancos de esta organización".

Funcionarios de inteligencia estadounidenses han reportado que fanáticos de otros países · continúan infiltrándose en Irak, ansiosos de oponerse a los intentos estadounidenses.

John Hulsman, investigador de la Fundación Heritage, dijo

Para contrarrestar esta amenaza, Hulsman sugiere que Estados Unidos debe apresurar su programa de manera que los iraquíes tengan más participación en proporcionar seguridad en su país y más poder político.

Texas Dems Demand End of GOP Sanctions

State Senate Democrats in self-imposed exile in New Mexico promised to retaliate with "legal action" against their Republican colleagues if sanctions aren't lifted against them and their staffs.

The two sides have been squabbling since 11 Democratic senators fled to Albuquerque, N.M., on July 28, denying the Texas Senate's Republican majority the quorum it needs to consider a GOP congressional redistricting plan.

The 11 Democrats did not specify what action they would take but said in a letter Monday to Republican leaders that if punitive measures against them were not rescinded by Tuesday afternoon, "we will take appropriate legal action."

Those sanctions come if the Democrats do not pay fines, imposed on them by their Republican colleagues, for missing daily floor sessions. The fines started at \$1,000 a day and quickly moved to a maximum \$5,000 a day per senator.

The punitive measures "seek to punish us, our staffs, and, most important, our constituents, because we dare to stand firm by our convictions and by our duty in the best interest of our constituents," the Democrats' letter said. Lt. Gov. David Dewhurst spokesman Dave Beckwith said there were no plans to change the sanctions or penalties. "We welcome a judicial determination of their claims," Beckwith said.

Republican Sen. Todd Staples said if the Democrats returned to the Senate chamber Tuesday, "I will personally move that we dispense with all penalties, restore all privileges, both sides do away with litigation and resume the work we were elected to do."

The absence of the 11 senators has forced a standstill in the Senate and frustrated Republicans eager to pass a redistricting bill. The measure likely would give Republicans a majority in the congressional delegation dominated 17-15 now by Democrats under boundaries drawn by federal judges after lawmakers failed to come up with a map in 2001

Hispanics, the fastest growing minority in the U.S., have a unique cancer risk profile

Hispanics are less likely than whites to develop and die from the most common kinds of cancer, but they have higher rates of some other kinds of cancer and are more likely to have cancer diagnosed at a later stage, the report says. The report, which appears in the July/August issue of CA: A Cancer Journal for Clinicians, says that, compared to Caucasians, Hispanics: *Have lower incidence and mortality from all cancers combined, as well as from each of the four most common cancers -- lung, breast, colon and prostate. *Have higher rates of some other kinds of cancers, including cancers of the stomach, liver, cervix and biliary tract. *Are less likely to use screening tests for colon, prostate and cervical cancer. *Have higher rates of overweight and lower rates of physical activity, factors increasingly associated with cancer.

As a group, Hispanics have different cancer risks and rates compared to other ethnic groups. Because of that, Hispanics require different cancer prevention methods.





Remaining still unclear is what direction Parcells is leaning in the quarterback battle between Carter and Chad Hutchinson, who did not play against the Texans.

While inquiring minds are still wondering about the Cowboys' murky quarterback situation and how Quincy Carter's strong performance in the 34-6 victory against the Texans impacts the decision, what we have learned is that coach Bill Parcells is just as hard on his team in victory as in defeat.

The Cowboys (1-1) looked like a different team in dismantling the Texans than they did a week earlier in a most distressing and disappointing loss to the Arizona Cardinals in the preseason opener.

In addition to Carter's 140 yards passing and one touchdown performance, the running game came to life with 141 yards on 28 carries, including eight for 38 by starting Troy Hambrick.

The Cowboys got big plays. on offense with touchdown receptions of 30 and 60 yards from receivers Antonio Bryant and Randal Williams respectively and an 83-yard punt return touchdown from rookie Zuriel Smith to contribute to the team's highest point total in any game, regular season or preseason, in three years. The defense stopped the Texans cold, holding them to 3.4

yards per play on the ground, two for 14 on third downs and limiting them to two field goals.

Yet, Parcells, who put the Cowboys through an intense week of practices and expected a better performance, wasn't pleased overall, harping on his team's eight penalties and two lost fumbles.

"It's just a start, something to build on," Parcells said. "It's a little encouraging for me. But I want a smart team and a smart team doesn't get eight penalties and turn the ball over twice. Dumb teams do that."

According to several players, he lambasted the team in postgame locker room following the game over the penalties and turnovers.

Curiously, in the wake of the team's meltdown to the Cardinals a week earlier, Parcells downplayed the impact of five penalties for 39 yards. Yet, eight for 51 against the Texans were cause for an eruption in an otherwise impressive outing.

Parcells pulling psychological strings to keep his team on edge and focused, considering playing well against an undermanned Texans team isn't cause for celebration.

However, he couldn't deny certain team highlights in the game. Carter directed a 10play, 96-yard touchdown drive in the second quarter, going perfect through the air with six completions to six different receivers.

A fumble on the ensuring kickoff set the Cowboys up 30 yards from pay dirt. Carter took advantage with a 30-yard touchdown pass to Bryant on the first play. Hambrick, who scored the earlier touchdown, aided the second one with key blitz pickup to give Carter more time to find Bryant. "I think the biggest thing was when we got that turnover and cashed in right away," Parcells said. "We've got some firepower if we can get the ball to them. Our receivers are a pretty good group. We just have to find a way to get the ball to them.



Martin bails early on news conference with Ali

The first time Laila Ali and Christy Martin got together for news conference punches were thrown and podiums were knocked over.

There was no such excitement at Wednesday's pre-fight gathering. Martin didn't hang around long enough for the fighters to even exchange words.

"Now, I'll just have to talk for both of us," Ali said after Martin made a brief statement, didn't even acknowledge Ali and walked off the stage.

The two biggest names in women's boxing meet Saturday

At the news conference to announce the fight two months ago, Martin and Ali went noseto-nose before scuffling. Both dismiss the suggestion the tussle was staged to help hype the fight.

And both say the disdain they show for each other is genuine.

"The first thing that happened is somebody started running their mouth, and that was Christy. 'Laila Ali ain't nothing. She's just Muhammad Ali's daughter.' Anytime you say that I'm going to take it personally," Ali said.

Martin, naturally, said Ali

"I didn't think I had to have

this fight to legitimize what

started it.

I've done in boxing," Martin told the Associated Press before the news conference. "I think my reputation is already solid. I just thought I would come back because she talks so much. She's so arrogant and so cocky.

"I said I think I'm going to come back, get my self in shape again and show her at 35 years old, giving up 25 pounds, 7 inches, I'm still the best woman pound-for-pound fighter out there."

Before Ali decided to pursue a boxing career, Martin (45-2-2, 31 KOs) was widely considered the best and most popular female fighter in the world. Martin's appearance on the cover of Sports Illustrated in 1997 helped nudge women's boxing into the mainstream. Ali (15-0, 12 KOs), riding her famous father's name, has since taken that mantle. Ali said in the past she would be asked about fighting Martin, but never gave it much thought because of the size difference. Martin exaggerated the disparity, but only slightly. Ali is 5-feet-10 and is expected to weigh-in Friday at 162 pounds. Martin is 5-4 and figures to weigh-in at 144. "I think this a big fight because I've always said that what women's boxing needs is the names. People want to know who's fighting," Ali said. "What makes a fight big is when your opponent is known. She has fans. I have fans. People have seen her fight, they've seen me fight. They know her skills, they know mine. They want to see us fight each other.

South Texas political and community leaders today called on GOP leaders in Austin to "pull the plug" on congressional redistricting efforts," which reached a nadir late last week and this weekend with racist radio ads targeting Texas Sen. Juan "Chuy" Hinojosa of McAllen.

"It is increasingly obvious this Republican power that grab is designed to overturn 40 of successful voting vears rights legislation that guarantees Hispanics and other minorities a voice in the electoral process," said State Rep. Aaron Peña, who this weekend was elected chairman of the Tejano Democrats. "GOP leaders in Washington and Austin are out of control and out of line."

"This radio ad is rooted in racist stereotypes from a generation ago," Maldonado said. "It characterizes the Republican effort to dilute the Hispanic community's voting strength and take us back a generation, too.'

Peña, Maldonado, and other South Texas leaders said the ultimate goal of the right-wing Republican leadership in Washington and Austin is to overturn the Voting Rights Act.

"The Voting Rights Act is the most successful piece of civil rights legislation ever passed by Congress," Maldonado said. "It holds the right-wing racists elements of the Republican Party in check - and that drives the current GOP leadership crazy." The Voting Rights Act was a bipartisan bill originally adopted by the U.S. Congress in 1965 under the leadership of Democratic President Lyndon Johnson and extended in 1970 under Republican President Richard Nixon, in 1975 under Republican President Gerald Ford, and in 1982 under Republican President Ronald Reagan. Hidalgo County Democratic Party Chairman R.D. "Bobby" Guerra said he is appalled by the radio commercial and predicted the tactic will backfire on Republicans.



If you're familiar with these names, then in all probability you are from the Guadalupe Barrio and are at least in your mid to late 40's or older, and you probably have some mixed memories left over from your elementary school days. If you're from this area, as I was, you probably went from being a Guadalupe Giant, to a Thompson Cowboy on 14th and T, and then, unless you had to leave school to help your family, you entered Lubbock High. And if you were lucky enough to be able to stay in school, you probably graduated and were one of the first from your family to do so. Even though you were from a rather large family.

Which, if you come from a large family, spoke to the main issue that has plagued us as a community since the modern educational system has been in place? And that is that the drop out rate among Hispanic students has been and is unacceptable. If you are in your late 40's or older, chances are that if you did drop out of high school, it had something to do with you finding a job and helping contribute to your family. Or it could be that you had fell in love, gotten pregnant or gotten someone in that condition, and were ready to face the world living on minimum wage, cashing your weekly paycheck at Pinkies, and enjoying your newfound happiness?

In many cases though, I wonder if it wasn't because we felt inferior to the majority of the students who did have money in their pockets to eat at the cafeteria, who didn't have to take tacos de "frijoles y blanquillos" or "papas" and eat them behind the school because they were embarrassed, (fast food chains are making millions off of these now, except they call them "burritos"), who wore the best clothes, who spoke the correct English and whose names were pronounced correctly by the teachers and not changed to their English version.? I have a strong suspicion that these challenges we faced had a lot to do with a person's decision to want to leave school. In a lot of other cases, I suspect that it was because parents were just not educated enough or had a strong command of the English language to get involved in the educational process. Or perhaps they were too busy working hard to make ends meet and just didn't have the time?

Last year in 2002, according to the LISD website, there were 12,300 students enrolled in LISD at the secondary level. Of those, 43.2% are of Hispanic descent. If you apply the percentage, then we can assume that a little over 5,000 students in the secondary level are Hispanic. Now, according to state figures, LISD has a drop out rate of 1.1% with the state average at 1%. If we apply the 1.1% drop out percentage, then we can expect that around 50 Hispanic students dropped out last year from the LISD system. Some researchers estimate that figure to be as high as 20% for Hispanics, 7% for Anglos, and 13% for Blacks. Imagine 20% on a national level and you can just see where we're headed as a community and why we're in the shape that we are in. We're headed for a future that will not look much different than the past and the present. If you ask an older person what it takes to do well in today's society, inevitably you will be told that education is one of the things that will make you successful, even though they themselves may not have graduated.

Well education alone may not do it, but it sure will get you in the ballgame.

So why do you think that it is so hard to get that across to a young person? I guess if I had the answer to that question, I would be a millionaire. There are no easy answers, but I'm convinced that one key ingredient is parental support. And that is something that in a lot of cases is sorely missing from some student's lives. There is no substitute for parental support, encouragement, and active involvement with your child's education. Always keep in mind that we have an obligation as parents to make sure that our children's life is better than our generations and likewise for their children ... And believe me, education is one of the pieces to the success puzzle. Don't be afraid to get involved in your child's education. Learn to ask the right questions, know who your kids teacher's are, what kind of grades they're making, what activities they're involved in, etc. Always remembering that your support or non-support will have a lot to do with shaping your children's future. That's a scary thought, but then again, being a parent is not easy! Above all else, keep in mind that if we expect the educational system to change their attitude in their treatment of all minorities, then we have to make our presence felt in the classroom.

As the school year starts, I hope that the excitement I see in kids faces, will carry over to parents. I hope that we realize that our parental duties don't end with buying the school supplies and the designer clothes, and sending our kids off to be educated solely by the school system. I especially hope that we realize that even though teachers have the responsibility to educate our kids, it is not their responsibility to raise our kids. Think about that for awhile, there is a big difference. Keep in mind that, like it or not, we serve as role models to our kids ...

Otherwise, you should prepare your kids for a lifetime of minimum wage jobs; some research shows \$8,000 per year less than a high school grad. Oh sure there are exceptions to the rule, but they are few and far between. We should also prepare them to exist in a world where other's that are more educated make the decisions, decisions that they and their children will have to live with.

This week I leave you with a simple phrase spoken by a man who dropped out of school when he was in the 8th grade. Even though he was uneducated, I think he knew that in order to go down that path that creates a different world and to make a difference, that education would help us to open the door. In the long run I hope that we realize that education is more than just learning how to read and write ...
