Algunos miembros de la comunidad minoritaria de Lubbock reclamaron una victoria parcial al escuchar la decision del Concilio de la Ciudad tocante el renombramiento de la Calle Quirt.

El Concilio decidio este pasado miercoles no aprobar una ley local que prohibia el nombramiento de calles en Lubbock en honor de individuos. Esto fue lo que creo la controversia que se discutió en la junta.

El Concilio iba a votar sobre una enmienda para renombrar la Calle Quirt pero no como se le recomendo por la Comision de Relaciones Humanas (Human Relations Commission) y residentes del barrio negro.

Despues de mucha discusion se decidio posponer accion en contra el nombre de King hasta que hubiera mas investigacion.

El encabezado de la Comision de Relaciones Humanas, Theron Cole, dijo que la decision para posponer accion fue la mejor tomando en cuenta las circunstancias.

Gilberto Flores, miembro de esa misma Comision dijo que estaba agradado con la decision porque fue interpretada como modo de "quitarse la muleta por lo pronto" de parte del concilio.

Continuó Flores diciendo que "ojala que ellos (la ciudad) no piensen que hayan perdido algo o que se hayan puesto en la defensiva, porque al forsar el Concilio, podemos dañar oportunidades en el futuro cuando se nos afrontan otros temas."

Mas que 75 Chicanos y Negros asistieron en la junta para dirijir su discordia en cuanto la decision del Concilio a nombrar un lago en honor del Dr. King, en vez de la Calle Quirt. La opinion general era que al pedir la calle no era tan grande la proposicion y que si hubiera

sido de parte de anglos, la solicitación se hubiera aprobado inmediatamente.

Mas de 1,400 firmas se recogieron en favor del renombramiento de la Calle Quirt y dijo el Señor Harold Chapman que "si se ignoraba la petición, el Concilio estaba diciendo que los ciudadanos minoritarios y especialmente los Negros eran entenados de la ciudad."

A pesar de que la mayoría de la gente ha expresado que no se aceptará nada menos que el darle el nombre de King a la Calle Quirt, el Mayor Dirk West y otro miembro del Concilio, Bill McAlister, dijeron que les daba miedo comensar una multitud de solicitaciones para renombrar calles en honor de otras personas.

Sin embargo, el representante estatal, Froy Salinas, quien representa esa parte de Lubbock afectado, dijo que dos otras ciudades han honrado a Martin Luther King con calles y no se les ha ocurrido muchos problemas. Ademas, dijo que al nombrar la calle, lo cual se ha pedido por los residente de ese barrio, un sentimiento de positivismo se engendrará. Tambien ayudará desquitar el imagen de Lubbock que es racista, como se nota en las otras partes de Tejas. Añadó que esto le asistira a pasar legislación favorable a esta region.

Despues de toda la expresion de sentimiento, el Consejero McAlister hizo la moción de esperar con esta situación hasta que se hiciera mas investigacion.

Opiño que lo mas dañoso para Lubbock era el separar la comunidad. A pesar de todo, se indico que la cuestion de honrar el Rev. Martin Luther King con una calle se tardará hasta la junta mensual de Concilio en Enero.

Se juntaron mas de 75 personas este pasado miercoles por la mañana en la sala de el Concilio de la ciudad para pedir una simple cosa. Que se nombrara la calle Quirt, o es mejor decir que se re-nombrara en honor del Dr. Martin Luther King, Jr.

Como todos debemos de saber el Dr. King fue una persona muy especial que murio peiliando por los derechos de la gente negra y al igual la gente pobre. Sin sus esfuerzos todavia hubiera poll-tax, escuelas segregadas, y discriminación. El Dr. King murio a manos de un asesino racista quien concio el poder que nuestra gente estaba alcansando siguiendo un lider como el Dr. King.

Cual es el problema entonces en honrar al Dr. King. Segun los del Concilio, no quieren hacer un precedente para que todo mundo pida que se nombre una calle o calles por diferentes personas. Piensan que todo mundo va pedir que se nombre una calle por su abuelo, su tio, osu suegra. Ellos dicen "donde vamos a poner un hasta aqui?"

Esto para nosotros es un modo de "quitarse la muleta." Realmente no quieren nombrar la Calle por un negro, ya que todavia hay muchos racistas en esta ciudad y el Concilio, aunque quizas ellos no sean racistas, saben que tendran reaccion de los racistas.

Como se expreso en la junta, por uno de los participantes "no es tanto que tenemos piel negra, es que el gringo esta impuesto a que siempre seamos esclavos y cuando pidemos algo lo hagamos con el sombrero en la mano."

Esto se vió muy difinitivamente cuando el Consejero Aderton dijo que la manera en la cual se presento la solicitación fue casi como una ultimátum y que a el no le gustaba.

Para nosotros los comentarios hechos durante la junta como "si no recibemos lo que pidemos, nos vamos a recordar de sus acciones (las del concilio) cuando se llege la eleccion," o comentarios como "la mayoría de nuestra gente demanda que se nombre la calle en honor del Dr. King," no son ultimatumos. Son la realidad y tienen razon.

Para nosotros, las acciones de el Concilio de la Ciudad fueron irresponsables ya que una vez mas se ignora los deseos de la comunidad minoritaria. Como siempre nuestras opiniones, a pesar de que 1,400 personas firmaron una petición pidiendo el cambio, nos son tan considerados como unas cuantas llamadas que dice el Concilio que recibio.

Esta irresponsabilidad si debe de ser recordada en la siguiente eleccion.

It was not surprizing to read in today's paper that Lubbock was ranked 20th on the list of most segregated schools in the nation. If this list was available in 1970, it would probably be ranked 2nd or 3rd. The irony of it is that Lubbock keeps falling in the same mudhole time after time and refuses to accept reality for what it was and has been for a very long time. Were Lubbock to have followed suit when other areas in the nation were making attempts to meet the pluralistic ideals which this country claims to stand for, it would not have fallen in the mudhole it presently finds itself in.

Things would be simple if Lubbock authorities were to find their keys to unlock their closed minds and accept facts as they stood, when their anglo forefathers were running this city and as they stand now while they hold the reins of power. It may well be that there is no immediate solution because of traditional values and beliefs. By this I mean that perhaps the problem is that each generation of anglos in this city have passed on to the next generation the kinds of values and beliefs which are almost impossible to change. Perhaps they just don't like to smell tacos or menudo cooking next door. Perhaps they are insecure to have that beautiful bronze face living next door. I don't know!! One thing is certain, Lubbock authorities have something else coming if they are under the impression that they are going to pull the wool over Chicano's eyes. A vast majority of Chicanos, who have been simmering in the back burner since the civil rights movement, are gathering their resources, doing their homework, compiling their information, and will soon be powerful enough to bring legitimate changes to this city. Baby we have just broken ground. My suggestion to Lubbock authorities is plain and simple: This is a pluralistic society and if changes need to come about such as integration to meet these ideals, then integration ought to occur!

And don't give me the political rap about the government getting too involved with local or state affairs because there are times when ethnic members of the community are lacking political clout and are unable to bring justice, and therefore require the Government's hands to assist them. Oh! and another suggestion is this:

Adjust to the smell of menudo. The line has been drawn and we refuse to allow anymore irradiation of our beautiful culture or selling ourselves short for a few token pats on the back.

The Hispanic Agenda: 1980 And Beyond

The following essay is authored by LULAC Essay Scholarship contest winner Peter Escobedo. Escobedo is a 22-year old University of San Francisco student majoring in Public Administration.

During the next decade people will witness significant changes as Hispanos progress and become a political power within the dominant Anglo-American society. Birth rates, immigration, and history all indicate, Hispanos will soon be the nation's largest minority, and extremely young one at that. Experts have estimated that over fifty percent of all Hispanos are under the age of nineteen. In comparison to average age figures for Anglo-Americans, the average age of Hispanos is more than ten years younger. Considering these factors, one cannot deny that the future holds great promise for a diverse yet growing Hispanic presence.

An ever increasing social consciousness is essential for the attainment of positive and progressive changes so desperately needed by the Hispanic community. Inadequate educational systems, high unemployment, relative deprivation, and political impotency are only a few of the problems commonly associated with the Hispanic community. Concerted efforts must be made to mobilize, organize, and educate Hispanos.

Some people feel a return to the "civil rights era of the 1960's and early '70's is imminent, where people will turn to the streets to voice their demands. Recent trends to the right, along with fiscal conservatism have created financial cutbacks, and in some instances, even reversed the gains made during the civil rights era. Hispanos can not afford to lose in this struggle, hence an all-out offensive must be waged, aspiring to achieve greater social recognition along with increased political effectiveness. The political climate dominating the next decade will be extremely intense and rapidly changing Hispanos must infiltrate the system at every step of the game. Through organized input into the political system people will learn to mandate change. With practical experience Hispanos shall eventually bring about changes that can benefit their own communities.

Education is one area in dire need of attention, especially for Hispanos, presently the most undereducated of all American citizens whereas only forty percent have completed high school. Quality education is a right and should not be a privilege of the

elite. At the same time education must be made relevant to the student. While Bilingual, Bi-cultural education is very conducive to learning, the present funding levels for these programs needs to be greatly increased so that more students would be involved.

At the university level, ethnic studies should be made available to all students. Furthermore degrees, both graduate and under-graduate, should be offered to those wishing to major in the field of ethnic studies. Very recently Chicano studies has been introduced on a few campuses, however, support for these programs is sorely lacking in the over-all administration. It is imperative that broadbased support be established for all these programs. Affirmative Action in education received a setback with Bakkkc at the University of California at Davis. These attacks against all minorities need to be strongly objected to by means of organized protest. Hispanos must struggle through every step of the way in receiving a quality education. History proves this; educational opportunity programs, finicial aid and other types of assistance programs were not won just by illustrating the need. People must remember that others lost their lives fighting for these programs, and hopefully their contributions will never be in vain. The few people who are todah receiving an education as a result of this, should in turn share their experience. Hispano lawyers, doctors, business people and educators must return to their communities so that their acquired knowledge and skills can be shared.

People's value systems should be prepared to optimistically accept change. Hispanic role-models and leadership will give a positive direction. At the same time cultural values need to be evaluated and strengthened. It is a well know fact that culture and language play a major role in the everyday lives of Hispanos. In many ways it has proven instrumental in uniting the interests of the people. This same uniting force behind the culture and language must be understood so that it can be made a conscious objective. The unique culture, language and heritage of Hispanos must be maintained by the tight family structure. This strong foundation will help promote success, which is not commonly found in the Hispanic community.

Recent figures show the unemployment rate for Hispanos is more than fifty percent higher than the national average. Concurrently the latest income figures from the Census Bureau show the median income for Hispano families was \$5,320.00 lower than the Anglo-American family. In a country where all people are supposed to be created

equal, one surely would question why such blatant inequities exist today. Hispanos need to penetrate the job market at every level. No longer shall Hispanos be satisfied with just any type of job, demands will be made to obtain even the most technical and advanced jobs. Whereas Affirmative Action is needed to develop and expand a qualified Hispanic labor pool, employers shall no longer be able to say they cannot find any qualified Hispanos to fill the position. Objectively speaking however one looks at the present economic situation, it cannot be said that discrimination has not played a role in creating these inequities. Discrimination is an ugly sickness, one that has even been known to kill if not openly dealt with. For some reason, public awareness and exposure always seems to be a good cure for this sickness. So when discrimination is experienced in any form, one must expose it by any means possible, even if only suspected.

Efforts must also be made in the area of community development. Public work programs and other government funded operations such as, SER, Jobs For Progress, should be recognized as positive steps toward developing better communities for all people to live in. When people are conscious of relative deprivation, they will seek out to attain maximum gratification. Consequently millions of people immigrate to this country everyyear, the greatest percentage coming from Mexico. This immigration has far-reaching effects in the Hispanic community, calling for better relations to be established with Mexicans and their government, although some progress has been made in this direction, there is still plenty of room for improved communications. The Immigration and Naturalization Service, I.M.S., was founded with good intentions,

however for too long the I.N.S. has effectively operated as a personnel office for big corporations which in turn blatantly exploit this country every year, the greatest percentage coming from Mexico. This immigration has far reaching effects in the Hispanic community, calling for better relations to be established with Mexicans and their government, although some progress has been made in this direction, there is still plenty of room for improved communications. The Immigration and Naturalization Service, I.N.S., was founded with good intentions, however for too long the I.M.S. has effectively operated as a personnel office for big corporations which in turn blatantly exploit this undocumented labor pool. This historical role of the I.N.S. must be criticized sharply. Being aware of the negative relationship existing between the I.N.S., he wanted Hispanos to support the I.N.S. as a friendly institution. However this cannot be achieved until the I.N.S. in practice, erases their disregard for human rights in the Hispanic community.

In summary, overall respect for the rights and needs of the Hispano is long overdue. Soical awareness and appreciation will help instill pride and a potive self-image within the Hispanic community. However one must realize that these changes will experienced strong opposition by reactionary forces trying to protect their status quo. Hispanos must be strong and united in their future struggles, and remember that conditions will not change overnight. Patience, endurance, and positive leadership will be necessary in overcoming this opposition. Sincere dedication and organized efforts will pay off in the long run, and at the same time protect the interests of the Hispanic community.

Quién puede obtener Medicare?

Prácticamente cualquiera que tenga 65 años o más es al Medicare. También, las siguientes personas menores de 65 años son elegibles:

- Las personas incapacitadas que han estado recibiendo beneficios del seguro social por incapacidad o anualidades del ferrocarril por incapacidad por 2 años consecutivos o más; y
- Las personas aseguradas bajo el seguro social o el sistema de retiro ferroviario que necesitan tratamiento de diálisis o trasplante de riñón debido al fallo permanente de riñón. Esposas, esposos, o hijos de personas aseguradas podrán ser elegibles también si necesitan diálisis o trasplante del riñón.

Que tantas partes tiene Medicare?

Medicare consiste de dos partes—seguros de hospital y seguro médico. La parte del seguro de hospital del Medicare ayuda a pagar por el cuidado que usted recibe como paciente en un hospital y por cierto cuidado despues de dejar el hospital. La parte del seguro medico de Medicare ayuda a pagar por los servicios de su médico, servicios de hospital como paciente externo y muchos otros asesorios médicos y servicios no cubiertos bajo el seguro de hospital.

- Que es lo que el seguro médico de Medicare no cubre?
- El seguro médico no cubre algunos servicios o accesorios. Por ejemplo, no puede pagar por:
 - Servicios o accesorios que no son necesarios para el diagnostico o tratamiento de una enfermedad o lesión.
 - Exámenes físicos de rutina y exámenes de laboratorio directamente relacionados con esos exámenes.
 - Drogas por receta y medicinas patentes.
 - Lentes o espejuelos y exámenes de la vista para recetar estos.
 - Audífonos y exámenes del oído para recetar audífonos.
 - Dentaduras y cuidado dental de rutina.
 - Servicios de quehaceres del hogar y comidas entregadas a domicilio.
 - Cuidado de enfermería en su hogar a tiempo completo.
 - Zapatos ortopédicos.
 - Artículos de conveniencia personal.
 - Las primeras 3 pintas de sangre que reciba en cada año calendario. (Usted no tiene que pagar por las 3 primeras pintas de sangre si las reemplaza como miembro de un plan de donantes de sangre o consigue que alguien haga una donación de sangre a favor de usted.)

Who can get Medicare?

Practically everyone 65 or older is eligible for Medicare. Also, the following people under 65 are eligible:

- Disabled people who have been entitled to social security disability benefits or railroad disability annuities for 2 consecutive years or more; and
- People insured under social security or the railroad retirement system who need dialysis treatments or a kidney transplant because of permanent kidney failure. Wives, husbands, or children of insured people also may be eligible if they need maintenance dialysis or a transplant.

How many parts are there to Medicare?

Medicare has two parts—Hospital insurance and medical insurance. The hospital insurance part of Medicare helps pay for inpatient hospital care and for certain followup care after you leave the hospital. The medical insurance part of Medicare helps pay for your doctor's services, outpatient hospital services, and many other medical items and services not covered under hospital insurance.

What is it that Medicare medical insurance does not cover?

What is it that Medicare medical insurance does not cover?

Medical insurance does not cover some services or supplies. For example, it cannot pay for:

- Services or supplies that are not necessary for the diagnosis or treatment of an illness or injury.
- Routine physical checkups and tests directly related to such examinations.
- Prescription drugs and patient medicines.
- Glasses and eye examinations to fit glasses.
- Glasses and eye examinations to fit hearing aids.
- Hearing aids and examinations for hearing aids.
- Dentures and routine dental care.
- Homemaker services and meals delivered to your home.
- Full-time nursing care in your home.
- Orthopedic shoes.
- Orthopedic shoes.
- Personal comfort items.
- The first 3 pints of blood you receive in each calendar year.

(You do not have to pay for the first 3 pints if you have them replaced through a blood plan or have someone donate blood for you.)

FARMWORKERS SUE HOSPITAL

Two farmworkers from Dimmitt have filed a \$1 million lawsuit against the Plains Memorial Hospital and its administrator for allegedly causing the death of their son by refusing him medical treatment.

The hospital, administrator Jack Newsom, the Castro County Hospital District and its board of directors were named as defendants in the suit, filed Monday in Amarillo federal district court.

The complaint states that on Dec. 8, 1978, the Aguinas rushed their 11 month-old son to Plains Memorial Hospital, but were refused admission by Newsom because they could not pay a \$225 deposit. Newsom was indicted by a Castro County grand jury last December on a misdemeanor charge of failing to provide emergency medical assistance. The case ended in a hung jury.

"They (the parents) were told the baby could be admitted, but they didn't speak English and I think that was the cause of the whole problem," Newsom said at time.

Newsom said at the time. "We instructed our hospital personnel that in cases involving children they may be process directly to nurses station prior to any mention of financial requirements."

The Aguinas contend their civil rights were violated by the defendants' failure to notify patients of the availability of such care and to determine their eligibility for treatment, and by the defendants' refusal to admit and treat patients before they paid substantial deposits.






Hispanics and Violation of the Immigration and Nationality Act Section 287: Powers of Immigration Officers & Employees

Hispanics and others are undergoing immigration search by unauthorized individuals and INS personnel are frequently searching homes without warrants. The fact that most aliens and Americans of Hispanic ancestry are not cognizant of Section 287 of the Immigration and Nationality Act is providing a means where an individual's rights are arbitrarily violated. Even churches are becoming targets for the Immigration and Naturalization Service in their search for illegal aliens.

INS personnel can request alien and/or naturalization information from any individual without a warrant. "Any officer or employee of the Service authorized under regulations prescribed by the Attorney General shall have power without warrant...". There are numerous institutions throughout the U.S. which are arbitrarily running INS checks on individuals whom they may suspect of being illegal aliens, though at times these individuals turn out to be U.S. citizens; some of these institutions are even recording and photocopying immigration information as is normally done by the INS. Of course, certain authorized INS individuals, with reasonable doubts, can search a person outside his/her home. "Any officer or employee of the Service designated by the Attorney General, whether individually or as one of a class, shall have power and authority to administer and to take and consider evidence concerning the privilege of any person to enter, re-enter, pass through, reside in

the United States, or concerning any matter which is material or relevant to the enforcement of this Act and to the administration of the Service." Therefore, not every INS employee or the local police in any part of the U.S. has the right to search individuals without warrants under all conditions. There is only one particular instance in which an authorized INS personnel can search an individual without a warrant: "...if he has reason to believe that the alien so arrested is in the U.S. in violation of any such law or regulation and is likely to escape before a warrant can be obtained for his arrest..." Searching every person suspected of being an illegal alien without a warrant as happens in particular areas of the U.S. is in violation of this section; it is about time for the Civil Rights Commission to begin looking into this practice.

INS personnel cannot search anyone at home without a warrant. Many Hispanics are searched at home without a warrant by both authorized and unauthorized individuals

(usually local police). Section 287 is quite clear on this point: "to have access to private lands, but not dwellings..." In effect, only authorized INS persons can search a home and only with a warrant.

All residents of the U.S. are entitled to religious freedom. The raiding of areas surrounding churches for illegal for illegal aliens on Sundays is a common practice in some communities. How long are Hispanics going to tolerate this harassment?

Aliens and naturalized citizens need to become aware of Section 287 of the Immigration and Nationality Act in order to avoid harassment by unauthorized INS personnel, local police, and other institutions within their communities. Police departments and other non-immigration institutions have got to realize that matters relating to immigration and naturalization are to be handled exclusively by the INS; and INS personnel must have a warrant if they expect to legally search a person's home for immigration or naturalization purposes. The Native Americans

had an inefficient immigration service, but they did not violate the civil rights of those immigrating into what is now the U.S.
