
## **Lions hear** update on Girlstown

In a District Court jury trial May 1, presided over by Judge Kelly G. Moore, Vidal Zarate Garcia received a suspended sentence of five years for a burglary of a habitation cause. The defendant had successfully completed a term in the Texas Boot Camp Program. He will be under community supervision five years, must pay \$296 court costs, a fine of \$1,000 and \$500 attorney fees. He must also perform 240 hours community service, and attend weekly AA meetings. He was represented by Attorney Warren New, and Criminal District Attorney Richard Clark represented the state.



Plains Lions Club members last Thursday heard Dan Adams, Administrator of Girls Town USA describe the ongoing success of the home for girls from troubled backgrounds located near Sundown and Whiteface.

Adams said Girls Town is licensed as a basic care facility for teen girls aged 13 to 18. Currently 54 girls call the facility home, and attend public schools at Whiteface. The operation is unique in its funding. The Girls Town operation is one of five entities stemming from the original Cal Farley Boys Ranch, all organizations operating on private donations and an endowment worth some \$400 million. The current Girls Town budget is \$2.5 million, with another budgeted half million dollars for improvements and additions. Adams said a new housing unit at the operation will be completed in 2000, the home for an additional 12 girls. A new Chapel is scheduled for opening in 2001.

Adams said girls noware accepted at the home mainly from families living in this general area of Texas and New Mexico. " The closer their families are, the more likely it is for the girls to continue to have some contact with family members. Virtually all the enrolled girls are from homes with serious social problems."

Adams said the new, incoming girls usually have little or no self esteem, and most suffer from the "Whipped Puppy" syndrome... they would prefer to be at home, longing for conditions which simply don't exist within their family. Some girls need more supervision than others, and discipline in their new environment is necessarily strict. Adams said in the past, girls running away from the facility was all too common, with most similar homes for either boys or girls averaging around two runaways per month. He said in the last eight months, none of the Girls Town residents had attempted to flee.

A number of housing units on the Girls Town campus house the youngsters. Both husband and wife teams and shift workers oversee activities of the girls in the housing units. Adams said the girls attending Whiteface schools take part in the same activities as all the orher students including all girls sports, and UIL activities. Three Girls Town students performed in the one act play Whiteface performed in Austin.

During their senior year, the girls engage in activities out of the classroom which will help them become self reliant and self supporting. Many find part time jobs, learn to operate vehicles and other skills necessary when they leave the home for the real world.

The Plains Lions annually donate money directly to the girls for personal clothing during the Christmas season.



## **Disaster Relief Trailer Ready To Roll**

The ambitious program started several months ago at First Baptist Church is in the stretch run of completion. While a few more wrinkles will be added to the interior of the impressive Disaster Relief Trailer, parked in front of the Church Sunday morning, it could be on the road in hours if an emergency arose, ready to daily feed thousands of victims of storms or other disasters throughout the country.

The relief feeding program involving the state of the art ' traveling mess hall' is a joint effort by FBC, the American Red Cross, and the Southern Baptist Convention and Texas Baptist Mens organization. There are now nine such trailers in the state, and the tenth is being completed.





The 28 foot trailer is powered by an electric generator driven by a Kubota diesel engine. The self contained unit is capable of feeding 10 to 15 thousand people daily. Some 30 FBC men have taken Red Cross and Texas Baptist Men training in the operation of the relief trailer. Dozens of volunteers worked on completing the interior work on the custom built trailer The unit will soon be stocked with long life food staples, and a water purification system will be installed, capable of purifying 20 gallons of water per minute. Pastor Bill Wright told CCN, "We all pray the trailer will never be needed, but if a disaster occurs, and people need food, we're ready to help."

## **\$ 12 Billion In State School Taxes**

Average '99 school tax rate remains same - first time in 15 years

Texas independent school districts (ISDs) reported to the Comptroller's Property Tax Division (PTD) a total of almost \$12 billion in 1999 school property taxes. This \$651 million increase was about 6% above the 1998 total school taxes. The 1999 average statewide tax rate remained almost the same as in 1998, the first time that has occurred in 15 years.

About 36% of Texas school districts reduced their local adopted tax rates, while 35% of the districts increased their rates.

The school property value reports are for 1,035 school districts. The reports do not include school taxes by special county equalization districts and South Texas ISD.

The state's largest urban districts accounted for 29 of the total '99 school taxes. While Houston ISD's '99 tax rate was the same as in '98, its total tax levy rose more than 8% to exceed \$755 million. Dallas ISD gained 10% in total taxes to total \$700 million, keeping the same rate as in '98. Both districts saw a strong economy adding properties to their tax base. With a '99 tax rate increase of less than 3%, Plano ISD saw the largest increase in total taxes at 15%, reaching almost \$326 million, while Austin ISD's taxes exceeded \$455 million, a 14% increase over '98.

The 50 largest ISDs, or 5% of all districts, accounted for 60% of the total '99 school taxes. Humble dropped its tax rate 8.3%, and total taxes declined almost 5%. Denton ISD was second with a rate decrease of 8.1%, but gained almost 3% in total taxes.

The '99 average statewide tax rate remained

almost the same at \$1.452 per \$100 of value. The '98 average was about \$1.451 per \$100 in value. The average rate calculation used adopted tax rates divided by the number of ISDs reporting.

The adopted '99 tax rates ranged from a low of \$0.8344 per \$100 in Glen Rose to a high of \$1.8929 in Allen ISD in Collin County. For the second year, Lake Travis ISD had the second highest tax rate at \$1.8884, lower than \$1.9452 in '98.

Taxpayers in 374 districts - about 36% - reduced their tax rates. Some 297 districts, about 29%, kept the same rate as in '98. Another 364 districts, or 35%, saw their tax rates rise in '99. School property tax rates may consist of two parts: a maintenance and operations (M&O) rate and an interest and sinking fund (I&S) rate. The M&O rate covers general operating costs. The I&S rate, usually the debt rate, is used to rapay a district's debt.

State law places a tax rate cap of \$1.50 on M&O rates. School boards in 154 ISDs, about 15%, adopted an M&O rate at the rate cap, compared to 106 ISDs, 10%, in 1998. 305 ISDs have rates between \$1.40 and \$1.50

About 37%, 382 districts, do not have a debt rate for repaying obligations. Of 653 ISDs with debt rates, seven districts have a debt rate of more than \$0.40. Plains ISD's M&O tax rate is \$ 1.50 per hundred of value, and no debt. Allen, an entomologist with the Arkansas Cooperative Extension Service in Monticello, Ark., succeeds Osama El-Lissy in the position that oversees the technical aspects of eradication in Texas. El-Lissy is now operations officer for cotton pest programs at USDA.

other publications, and has served as an editor for the Journal of Cotton Science. He has also served on a number of entomology-related task forces and committees.



To the fine people of Plains-America,




