



When confronted with aggressive drivers, the DPS recommends that you: *Put your pride in the back seat and move aside. * Do not speed up, block lanes. slam or tap on brakes. *Report extreme cases of reckless driving to the appropriate authorities. * Do not retaliate, gesture or make eye contact. * Make sure everyone is buckled up.

CDA reports 'Scam Artists' still at work

Criminal District Attorney Ri- his spiel with. " I strongly inchard Clark furnished CCN information indicating fraudulent scam artists do not take holidays from efforts to bilk the public's bank accounts.

Copies of two letters sent to CNN from the CDA office at first glance appear so poorly written, so filled with grammatical errors, almost nonsensical in their message, to warrant tossing in the trash, but apparently the lure of easy money is so appealing, suckers continue to be born very regularly. And unfortunately, many times the elderly are victims.

One letter supposedly originated in South Africa, written by one 'Dr. Amos Tilehle, a top official in the Presidency'. The good Doctor explains he and partners are in possession of some \$15 million, the excess of an 'over invoiced' foreign country contract. Because of South Afica laws, their government officials cannot be beneficiaries of such contracts. The good Doctor seeks a 'reliable partner in your country 'to accept delivery of the \$15 million, which will then be split 75% to he and his partners, 25% to the letter recipient. All he needs to do, of course, is supply the Doc with a bank account number for the transaction. The good Dr. concludes

The other scam letter bore all types of official looking seals and stamps, and purported to be an official notice from the International Lottery de la Primitiva ,with headquarters in Madrid. Spain. The letter is addressed to 'Lottery Beneficiary'

"We are pleased to inform you of the release of the sum of six hundred fifteen thousand Euros which represents your share of our recent lottery". The letter continues, urging the reader to exercise caution in making the winning public information, and contains a name and phone numbers of the foreign operations officer of River Plate Seguros S.A., Madrid, Spain. who should be contacted for further instructions for claiming and receiving the money. That phone call, of course, would include requesting the lottery winner's bank account number, social security number - another example of identity

If a reader receives similar correspondence which sounds too good to be true, it probably is. and should be reported to postal authorities.

flashing lights or honking. *Using high beams in traffic. *Not allowing adequate time for a given trip.

During the Thanksgiving holiday, Highway Patrol troopers and other Texas law enforcement agencies will target speeders, drunk drivers, seat belt violators and aggressive drivers. Texas DPS is participating in the 'Click It or Ticket Texas' campaign, which is aimed at increasing and enforcing seat belt and child seat usage. This year's campaign focuses on increasing seat belt use among pickup drivers and passengers and is called 'Buckle Up In Your Truck.' DPS has a zero tolerance policy toward seat belt violations, and fines range up to \$200, plus court costs.

Texas also participates in Operation CARE (Combined Accident Reduction Effort). Operation CARE is a nationwide effort by all state police agencies to reduce fatalities during holiday periods.
